1. **Minutes of the BOG's meetings dated 25<sup>th</sup> July - Confirmation of.**

The Board of Governors confirmed the minutes of the meeting held on 25<sup>th</sup> July, 2011.

2. **To consider compliance verification assessment report of Sree Narayana Institute of Medical Sciences, Chalakka.**

Read: the matter with regard to compliance verification assessment report of Sree Narayana Institute of Medical Sciences, Chalakka.

The Board of Governors considered the compliance verification assessment report of Sree Narayana Institute of Medical Sciences, Chalakka and decided to grant renewal of permission for admission of 3<sup>rd</sup> batch of 100 MBBS students for the academic year 2011-2012. Decision recorded on the file.

3. **The Assam Rural Regulatory Authority Bill, 2004 – Request made by Ministry of Health & F.W. for comments of MCI.**

Read: the matter with regard to Assam Rural Regulatory Authority Bill, 2004

The matter was deferred for the next BOGs meeting.

4. **Amendment to Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998 - Regarding non-medical faculty shall be treated at par with medical faculty for the respective post in the concerned department except for the post of Head of the Department.**

Read: the matter with regard to Amendment to Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998 regarding non-medical faculty shall be treated at par with medical faculty for the respective post in the concerned department except for the post of Head of the Department.

The Board of Governors directed the office to collect all the inputs with respect of post of head of department headed by non-medical teachers in pre & para clinical subjects from the premier medical institutes vis-a-vis PGI, Chandigarh & AIIMS, New Delhi and place the matter in the subsequent BOGs meeting.

5. **Amendment to Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998 (eligibility of teachers for the newly notified broad and super specialty courses)**

The Board of Governors deliberated on eligibility of teachers for the recently notified broad and super-specialty courses recently notified enlisted under:-

1. M.D. Emergency Medicine
2. M.D. Infectious Disease
3. D.M. Pulmonary Medicine
4. D.M. Rheumatology
5. D.M. Child Adolescent Psychiatry
6. D.M. (Paediatrics Gastroenterology)
7. D.M. (Paediatric Cardiology)
8. D.M. (Cardiac Anaesthesia)

The Board observed that the current practice of two years training prescribed in the super-specialty subjects after MD/MS is less than the training period prescribed for super-specialty course (DM/M.Ch.) in a given subject. Since the matter needs detailed discussion on eligibility requirement for faculty posts for all super-specialty courses, the matter with relevant details and Regulations be placed in the subsequent BOG meeting.

6. **Repeal of Regulations on Graduate Medical Education, 1997 and enactment of Indian Medical Graduate Regulations, 2011.**

7. **To consider the course of action on Contents curriculum for Undergraduate courses prepared by the constituted Board of Specialty, MCI.**

8. **To consider the course of action on curriculum for Postgraduate courses. prepared by the constituted Board of Specialty, MCI**

The matter was deferred for the next BOGs meeting.

9. **To consider the framing of law to punish students of MBBS involved in impersonation cases.**

Read: the matter with regard to framing of law to punish students of MBBS involved in impersonation cases.

The Board of Governors considered the matter with regard to framing of laws to punish students of MBBS involved in impersonation cases. Since this is a serious offense decided that –

- If a person is found to be impersonated for the purpose of appearing in the examination for admission into MBBS/PG course, he/she shall be debarred for admission in the MBBS course forever.
- If the impersonator involved in unfair activities, is a medical student, his/her admission in MBBS course shall be cancelled and debarred from admission to MBBS/PG course forever.
- In case the impersonator is a registered medical doctor, his/her registration shall be suspended permanently and the name removed from the Indian Medical Register.
- In case of other impersonator, they shall be debarred for taking such examinations forever.

Further the Board decided that if impersonation in postgraduate entrance exam is found by the doctors, both the impersonated & impersonator doctors will be debarred from taking such exams in future and their registration shall be suspended permanently and their names be removed from the Indian Medical Register. In case the impersonator is doing postgraduation, his/her admission in postgraduate course shall be cancelled.

**10. Consideration of the proposals for starting of Postgraduate Courses received u/s 10A of the IMC Act, 1956 – pre PG inspection regarding.**

Read: the matter with regard to consideration of the proposals for starting of Postgraduate Courses received u/s 10A of the IMC Act, 1956 – pre PG inspection regarding.

The Board of Governors deliberated on the above matter and decided for pre-PG assessment of only those medical colleges which are due for periodic assessment for continuation of recognition. The application for starting/increase of PG seats of such medical colleges shall be processed further following grant of continuation of recognition. In addition, the Board of Governors directed the Council to amend the qualifying criteria and place a draft of the modification in qualifying criteria laid down in the Regulations of Opening a new or higher courses of study or training so that only colleges which are recognized and those who have been granted continuation of recognition in time as the case may be, shall be eligible for starting/increase of seats of postgraduate courses.
