1. Minutes of the BOG's meetings dated 13.09.2011 - Confirmation of.

The Board of Governors confirmed the minutes of the meeting held on 13.09.2011.

17. Proceedings of the hearing of representatives of Sikkim Manipal Medical College for increase of seats.

The Hon'ble High Court of Sikkim vide its order dated 16.09.2011 directed the council as under:

1. Mr. B.R. Pradhan, learned Sr. Advocate appearing on behalf of respondent No. 2, MCI submits that necessary inspection in terms of Order dated 24.08.11 was conducted on 8th and 9th September, 2011. A copy of the inspection report dated 09.09.2011 has been placed before the Court, but without it being supported by an affidavit. It is, therefore, directed that the report be filed duly supported by an affidavit on or before the next date.

2. Considering the fact that the statutory hearing in terms of Section 3B (b) (ii) of the Indian Medical Council (Amendment) Act, 2010 (No. 32 of 2010) has been fixed by the respondent No. 2 on 19.09.11, it would be appropriate if this matter is taken up after completion of the hearing.

3. List on 22.09.2011.

4. A copy of the Report dated 09.09.2011 and a letter bearing No. MCI-37 (1)/2011-Med/35710 dated 14.09.2011 have been handed over to Mr. Udaya Holla, learned Senior Counsel representing the petitioners.

5. Keeping in view the larger public interest involved in the case and the Schedule of admission to the medical college, the respondent No. 2 is directed to ensure that the hearing is completed on 19.09.2011."

In compliance to above order the college authorities were provided an opportunity of hearing on 19.09.2011. ACCORDINGLY, PROF. DR. R.N. SALHAN, PRO. VICE CHANCELLOR, SMIMS, GANGTOK, MR. P.C. RASTOGI, VICE PRESIDENT, MANIPAL EDUCATION & MR. K.V. MATHEW, CONSULTANT, MEMG, APPEARED BEFORE US FOR THE SAID COLLEGE. A COPY OF WRITTEN REPRESENTATION DATED 19.09.2011 ALONGWITH DOCUMENTS WITH TOTAL PAGES 414, WHICH

INCLUDES 1 TO 8 PAGE OF WRITTEN SUBMISSION AND 9 TO 414 OF ANNEXURE WERE SUBMITTED BY THE PARTY. PROF. R.N. SALHAN MADE THE ORAL SUBMISSIONS ON BEHALF OF THE SMIMS.

The Board of Governors deliberated on the matter and decided to pass the order to be communicated to the Hon'ble High Court of Sikkim for the above matter listed on 22.09.2011.

The matter of registration of Doctors, who have completed their medical graduation from the Angeles Universities Foundation, Philippines and have passed screening test was apprised by Dr. Sangeeta Sharma, Secretary, Medical Council of India. The Law officer apprised the members about the order of the Hon'ble High Court, Delhi directing MCI to verify whether the qualification which the students claim to possess was recognized in Philippines and whether with this qualification is recognized in Philippines for practicing medicine. The Secretary informed, in addition, documents of these students have to be verified through the Indian Embassy in Philippines.

The Board was informed that there were several other registration matters pending in the MCI in respect of students who have obtained medical qualifications from United Arab Emirates (Dubai), West Indies, and Seychelles. The Board of Governors directed the Council to prepare documentation as in the case of Angeles University and to put up all the similar matters pertaining to the Registration with the complete details including the year of admission of the students, details of the training in the country and abroad by the concerned Foreign Universities.

The meeting ended with the vote of thanks by Dr. Sangeeta Sharma, Secretary, MCI.
