1. **Minutes of the last meeting of the Executive Committee – Confirmation of.**

The minutes of the last meeting of the Executive Committee held on 24/10/2000 were confirmed.

2. **Minutes of the last meeting of the Executive Committee – Action taken thereon.**

The Executive Committee noted the action taken on the minutes of the last meeting held on 24/10/2000.

In the last meeting of the Executive Committee held on 24.10.2000 under item No. 5 i.e. “Recognition/approval of Santosh Medical College, Ghaziabad for the award of MBBS degree granted by Ch. Charan Singh University, Meerut”, it was decided that names of the students admitted in excess at Santosh Medical College, Ghaziabad along with any relevant document be provided to Dr. B.C. Chhapparwal Vice-President as desired to get the matter legally examined by him. The Committee also decided that wherever the excess admissions have been made over and above the sanctioned capacity by MCI, information pertaining to that also be provided to him for taking similar action in those matters. Accordingly, the documents were provided/sent to Dr. Chhapparwal.

During the present meeting Dr. Chhapparwal informed that he had consulted the matter with his lawyer who opined that no medical college is authorised to admit excess number of students against NRI quota and also against the sanctioned intake of any medical college and MCI should take action against those medical colleges who are admitting excess number of students u/s 10B of the I.M.C. Act,1956. The Committee requested Dr. Chhapparwal to send a copy of the legal opinion sought by him to the Council office for further consideration.

3. **Recognition of Manipal College of Medical Sciences, Pokhara, Nepal for the award of MBBS degree granted by the Kathmandu University u/s 12(2) of the IMC Act, 1956.**

Read : The Council Inspectors report (13<sup>th</sup>,14<sup>th</sup> & 15<sup>th</sup> Dec., 2000) carried out for recognition of Manipal College of Medical Sciences, Pokhara, Nepal for the award of MBBS degree granted by the Kathmandu University u/s 12(2) of the IMC Act, 1956.

The Executive Committee considered the Council Inspectors report (13<sup>th</sup>,14<sup>th</sup> & 15<sup>th</sup> Dec.,2000) and noted the following:-

1. That the Dean of the college does not possess the required teaching experience.
2. The minimum percentage of marks for passing the final MBBS examination is 40% as against the 50% marks as per Regulations of the Council on Graduate Medical Education.
3. There is no examination in Paediatrics, either separately or as a component of General Medicine and no Paediatric case is kept either as a long case or a short case during the examination of general medicine.
4. The training for the clinical subjects starts only in the 3<sup>rd</sup> MBBS and not from the 2<sup>nd</sup> MBBS as per the MCI Regulations, hence, the total training for the clinical subjects is only 2 ½ years instead of 3 ½ years.
5. There is no examination for the subject of Community Medicine at the end of 2<sup>nd</sup> MBBS though it is taught along with the other subjects.
6. Shortage of staff as per MCI requirements:
  1. Professor – 2: (1 in Anaesthesia, 1 in Radiology)
  2. Readers – 2: (1 in Forensic, 1 in Dentistry)
  3. Lecturer – 2: (1 in Anaesthesia, 1 in TB & Chest)
7. Other deficiencies/observations made in the inspection report.

In view of above, the Executive Committee decided not to recommend recognition of Manipal College of Medical Sciences, Pokhara, Nepal for the award of MBBS degree granted by Kathmandu University u/s 12(2) of the I.M.C. Act,1956.

Office Note: The Committee advised the office that Inspectors may be directed in writing that they may not give their recommendations on the inspection reports carried out by them. The last para i.e. “conclusion” on page 25 of the inspection report of Manipal College of Medical Sciences, Pokhara, Nepal, be deleted.

4. **Vinayaka Mission’s Kirupananda Variyar Medical College, Salem – Recognition/approval of the college for the award of MBBS degree granted by the T.N. Dr. M.G.R.M edical University, Chennai.**

Read : The Council Inspectors report (21<sup>st</sup> & 22<sup>nd</sup> Dec., 2000) carried out to assess the physical and other teaching facilities available at Vinayaka Mission’s Kirupananda Variyar Medical College, Salem along with the standard of examination held by T.N. Dr. M.G.R.Medical University, Chennai for recognition of the college for the award of

MBBS degree granted by T.N. Dr. M.G.R. Medical University, Chennai.

The Executive Committee considered the Council Inspectors report ( 21<sup>st</sup> & 22<sup>nd</sup> Dec.,2000) carried out to assess the physical and other teaching facilities available at Vinayaka Mission's Kirupananda Variyar Medical College, Salem along with the standard of examination held by T.N. Dr. M.G.R. Medical University, Chennai and letter dated 21.01.2001 received from the Dean of the college and decided to recommend that Vinayaka Mission's Kirupananda Variyar Medical College, Salem established u/s 10A of the I.M.C. Act,1956 be recognised/approved for the award of MBBS degree granted by T.N. Dr. M.G.R. Medical University, Chennai with an annual intake of 100(one hundred) students.

5. **Padmashree Dr. D.Y. Patil Medical College for Women, Pimpri – Recognition/approval of the college for the award of MBBS degree granted by the Pune University.**

Read : The Council Inspectors report (26<sup>th</sup> , 27<sup>th</sup> & 28<sup>th</sup> Dec., 2000) carried out to assess the physical and other teaching facilities available at Padmashree Dr. D.Y. Patil Medical College for Women, Pimpri, Pune along with the standard of examination held by Pune University for recognition of the college for the award of MBBS degree granted by Pune University.

The Executive Committee considered the Council Inspectors report (26<sup>th</sup> , 27<sup>th</sup> & 28<sup>th</sup> Dec., 2000) carried out to assess the physical and other teaching facilities available at Padmashree Dr. D.Y. Patil Medical College for Women, Pimpri, Pune along with the standard of examination held by Pune University and noted the following:-

1. Though the number of teaching beds/units & their speciality-wise distribution is adequate, however, more space is required between teaching beds.
2. The unit-wise distribution of beds have not been numbered and earmarked as per Council norms.
3. Nursing stations have not been organised for proper patient care.
4. basic facilities as required needs to be upgraded for better patient care in wards.
5. Various registers like treatment, admission and discharge have not been maintained properly.
6. In Obst. and Orthopaedic wards patients were admitted, not for the purpose of teaching training as required.
7. The record keeping both in OPD and IPD have not been properly maintained and the basic equipment required for proper examination and diagnosis are not provided in all OPDs. and operation theatres and not earmarked speciality-wise.
8. The clinical material available in the hospital is not adequate as required under Council norms for 100 admissions for want of proper registration and record keeping.

9. Other observations/ made in the inspection report.

In view of above, the Executive Committee decided not to recommend recognition/approval of D.Y. Patil Medical College for Women, Pimpri, established u/s 10A of the I.M.C. Act,1956 for the award of MBBS degree granted by Pune University .

6. **Starting of new medical college at Gangtok by Sikkim Manipal University of Health, Medical Technological Sciences u/s 10A of the IMC Act, 1956.**

Read : The compliance verification inspection report (26<sup>th</sup> & 27<sup>th</sup> Nov., 2000) carried out for starting of new medical college at Gangtok by Sikkim Manipal University of Health, Medical Technological Sciences u/s 10A of the IMC Act, 1956.

The Executive Committee considered the compliance verification inspection report (26<sup>th</sup> Nov.,2000) carried out on receipt of the compliance report on rectification of deficiencies pointed out in the previous inspection reports (May,2000) and noted the following regarding the clinical material :-

1. that the average OPD daily attendance in the hospital owned by the applicant is 110 to 130 per day. For 150 admissions, nearly 600 patients per day are required at the time of inception and finally 1200 patients per day. Hence the OPD attendance at present is grossly inadequate.
2. Regarding the bed occupancy on the day of inspection i.e. 26-11-2000, the bed occupancy to the tune of 90% was shown. However, in view of the less OPD attendance 75% to 90% cannot be comprehended. The number of operations performed major and minor from January 2000 to 20<sup>th</sup> Nov., 2000 which is one per day respectively is also very inadequate. Hence the clinical material is grossly inadequate for 150 admissions required at the time of inception.

The Executive Committee taking into consideration the above facts and also noting that the clinical material is even inadequate for 50 admissions (the minimum number of 200 patients per day in the OPD at the time of inception and finally 400 patients per day) but considering the status of the State and that less medical colleges are available in north eastern sector, decided to recommend to the Central Govt. to issue Letter of Intent for starting of a new medical college at Gangtok u/s 10A of the I.M.C. Act,1956 with an annual intake of 50 (fifty) students.

7. **Starting of Christian Medical College, Dichpalli, Hyderabad Distt., Andhra Pradesh by Church of South India Trust Association Medak Diocesan Education Society u/s 10A of the IMC Act, 1956.**

Read : The compliance verification inspection report (30<sup>th</sup> & 31<sup>st</sup> Oct., 2000) carried out for starting of Christian Medical College, Dichpalli, Hyderabad Distt., Andhra Pradesh by Church of South India Trust Association Medak Diocesan Education Society u/s 10A of the IMC Act, 1956.

The Executive Committee considered the compliance verification inspection report (30<sup>th</sup> & 31<sup>st</sup> Oct.,2000) carried out on receipt of compliance on rectification of the deficiencies pointed out in the MCI inspection report (27<sup>th</sup> & 28<sup>th</sup> January,2000) and noted the following:-

1. The construction of girls and boys hostels, & para clinical departments has not started as yet and further no satisfactory provision has been made to provide facilities for the same.
2. The old OPD though has been enlarged but still is not adequate spacewise.
3. The following deficiencies still exist in the pre-clinical department:
  - (i) The practical laboratory of amphibian, mammalian and clinical physiology is still small and each laboratory can accommodate only 25-30 students.
  - (ii) The space available for the museum in Anatomy is still short. The office rooms of the teaching staff are small in size and not properly provided for. The pre clinical departments are located in different blocks separated from each other and the department of Anatomy is located in two separate blocks.

The construction of permanent pre-clinical departments has not started as yet.
4. The hospital though has the required 300 beds but it has yet to become adequately and properly functional. Bed occupancy as recorded in the inspection report was 16% on the day of inspection. Even this occupancy is not easily acceptable because of the following reasons:-
  1. The records presented both in OPD and Indoors were bizarre and wanting in terms of credibility. Most of the patients were admitted a day or two before the inspection day and their history sheets were either blank or absolutely incomplete.
  2. The diagnostic and investigative facilities are very restricted. There are no facilities for histo-pathological and microbiological investigations. The x-ray department has only one fixed x-ray machine of 100 MA and there is no facility of reporting the findings.
  3. The ECG technician did not even possess the basic knowledge of its mechanism for taking the tracings.
  4. The entire hospital is unitary in character and there is no unitwise composition or distribution of teaching beds.
5. The wards of orthopaedics, medicine and pediatrics located in different blocks, were previously used as residences. These blocks are interconnected by rough and uneven roads and the wards lack even the basic facilities.

6. Clinical Material:

The institution has limited OPD space and very restricted investigative and diagnostic facilities, hence, daily OPD attendance of 700-800 patients cannot be imagined. The registers are not maintained properly. The casualty section provided with 4 beds does not have the basic facilities. On the day of inspection these 4 beds were occupied by the employees of the institution. Even the major specialities do not have the OPD attendance of 10-15 patients per day.

7. In the available 3 operation theatres, there is no alternative source of electric supply, there is no continuous water supply, no proper sterilization facilities are available, As per their own register, on average, one operation in a week or sometimes in a fortnight is being done. Most of these are minor operation carried out under local anaesthesia.
8. There is no centralised operational office space for any of the clinical departments. Even a proper sitting room is not available for clinicians.

9. Shortage of Staff:

The institution has the following shortage of staff:-

1. Readers/Assoc.Prof. – 4: (Biochem.-1, Paed. –1, Obst. & Gynae.-1, Radiology – 1)
2. Lecturer/Asstt.Professors– 3 (Anaes.-1, Radiology -1, Dentistry–1)
3. Tutors/Registrars/Demonstrators – 4 : (Anaesthesia – 2, Radiology-2)
4. Junior Residents – 24: (General Medicine – 4, General Surg.– , Ortho.– 2, ENT – 1, Obst. & Gynae. – 1)

Total shortage - teaching faculty - 11  
Junior Residents – 15

Total – 26 out of 73 required i.e. 15% which is more than the permissible 5% limit.

10. Other observations/deficiencies pointed out in the inspection report.

In view of the above, the Executive Committee decided to reiterate its earlier decision taken at its meeting held on 2.2.2000 to recommend to the Central Govt. not to issue Letter of Intent for starting of Christian Medical College, Dichpalli Nizamabad Distt., Andhra Pradesh by Church of South India Trust Association Medak Diocesan Education Society u/s 10A of the I.M.C. Act,1956.

8. **Starting of new medical college at Chitradurga by Sri Jagadguru Murugharajaendra Vidyapetha, Chitradurga – Grant of Letter of Permission by the Central Govt.**

Read : The compliance verification inspection report (13<sup>th</sup> & 14<sup>th</sup> Dec., 2000) carried out for grant of Letter of Permission by the Central Govt. for starting of new medical college at Chitradurga by Sri Jagadguru Murugharajaendra Vidyapetha, Chitradurga.

The Executive Committee considered the compliance verification inspection report (13<sup>th</sup> Dec.,2000) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the MCI inspection report (Oct.,2000) and noted the following:-

1. On seeing the records of October, November and December, it is noted that the clinical material has suddenly increased from 80 patients per day in the month of Oct.,2000 to 335-473 in the month of December (upto 12<sup>th</sup> Dec.,2000) i.e. very near to the day of inspection. Same is the case for the indoor bed occupancy. The bed occupancy has suddenly increased from 24-60% in the month of Oct.,2000 to 80-89% in the month of December (upto 12<sup>th</sup> Dec.,2000) i.e. very near to the day of inspection.
2. That though the Govt. of Karnataka vide its order dated 28.1.1999 has permitted the applicant authority to utilise the facilities of District Hospital, Chitradurga, the administrative control to treat, manage and operate the patients and also to monitor the various units functioning in the District Hospital, Chitradurga by the teachers of the medical college has not been provided in the MoU, hence, the attachment of this hospital cannot be accepted.
3. Other observations/deficiencies pointed out in the inspection report.

In view of above observations, the Committee decided to defer consideration of issue of Letter of Permission for establishment of Medical College at Chitradurga by Sri Jagadguru Murugharajaendra Vidyapetha, Chitradurga. It was further decided to observe the availability of the clinical material in this institution for a period of 3 months for which another inspection be carried out to assess the availability of the clinical material.

9. **Narayana Medical College, Nellore managed by Narayana Educational Society, Nellore – Renewal of permission for admission of 2<sup>nd</sup> batch of students.**

Read : The Council Inspectors report (Dec., 2000) of Narayana Medical College, Nellore carried out for renewal of permission for admission of 2<sup>nd</sup> batch of MBBS students at the college.

The Executive Committee considered the Council Inspectors report (Dec.,2000) and decided to recommend to the Central Govt. to renew the permission for admission of 2<sup>nd</sup> batch of students in the 1<sup>st</sup> MBBS course at Narayana Medical College, Nellore with an annual intake of 100 (one hundred) students.

10. **Recognition of MBBS degree granted by Bharati Vidyapeeth(Deemed University) in respect of students being trained at Bharati Vidyapeeth Medical College, Dhankawadi and also continuance of recognition of MBBS degree.**

Read : The Council Inspectors report (20<sup>th</sup> & 21<sup>st</sup> Nov., 2000) carried out to verify the compliance received from the Dean, Bharati Vidyapeeth Medical College, Dhankawadi on rectification of the deficiencies pointed out in the periodical inspection report (Feb., 2000) and also the standard of examination held by Bharati Vidyapeeth (Deemed University) for recognition of the college for the award of MBBS degree granted by the Deemed University and continuance of recognition of MBBS degree.

The Executive Committee noted that Bharati Vidyapeeth Medical College, Dhankawadi, is recognised by the MCI for the award of MBBS degree under Pune University and further that from the year 1996-97 the college has been affiliated to Bharati Vidyapeeth (Deemed University) which will be awarding the degree to the candidates who have passed their final MBBS examination in Nov.,2000.

As MBBS degree granted by Pune University in respect of students being trained at Bharati Vidyapeeth Medical College, Dhankawadi is already recognised and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956, the Committee decided to recommend that MBBS degree granted by Bharati Vidyapeeth (Deemed University) in respect of students being trained at the above said medical college be recognised and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 being change of affiliation of the University keeping in view the following decision taken by the Executive Committee at its meeting held in June,1998:-

“No inspection is required where there is change of name and change of affiliation of the University or the college whose medical qualifications are already recognised and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 unless the Executive Committee decides otherwise.”

The Executive Committee further considered the inspection report (20<sup>th</sup> & 21<sup>st</sup> Nov.,2000) carried out for verification of the compliance submitted by the authorities of Bharati Vidyapeeth Medical College, Dhankawadi on the deficiencies pointed out in the periodical inspection report (Feb.,2000) and noted the following:-

- 1 The Central library is short of books and is subscribing to lesser number of journals. After five years, the number of books required in the central library for 120 annual admissions are 8200 whereas the institutional library has only 7613. The library is subscribing to only 64 journals against the requirement of 100 per year under the Council regulations.
- 2 The rural health training centre at Sonapur is in poor shape and require repairs.
- 3 The institution is having 7 operation theatres against the requirement of 10. There are no fixed days for any surgical units and the total working is haphazard which interferes with regular and proper teaching of the students.
- 4 The incinerator has not been installed as yet.
- 5 The residential accommodation available for resident doctors is inadequate.



- 6 Clinical material available is inadequate for 120 annual admissions.

The average OPD attendance per day is 200, the average bed occupancy is 65-70%, the total major surgeries performed are 3-4 per day and the number of normal deliveries conducted per month are only 45-50.

- 7 Shortage of Staff:

Assoc. Prof./Reader-4; (Physiology-1, Pathology-2, Forensic Medicine-1)  
Asst. Prof./Lecturer-5; (Anatomy-4, Biochemistry-1)  
Tutor/Demonstrator/Registrar-2; (Microbiology-1, Anesthesia-1)  
Junior Residents-12; (Pediatrics-4, TB & Chest-2, Skin & STD-1, Psychiatry-2, Orthopedics-1, ENT-2)

Total Shortage: Teaching Staff – 11 out of 171 required.  
Junior Residents – 12 out of 65 required.

8. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Executive Committee decided to issue a show cause notice to the concerned authorities of the institution as to why steps should not be initiated to reduce the number of seats in consonance with the facilities available at the college and further decided to give one month's time to the institution to respond to the show cause notice. Copy of the letter sent to the authorities be marked to the Chief Secretary, Secretary (Medical Education), Director of Medical Education, Registrar of the University, Member of the Council representing the State and the Central Govt..

11. **MBBS (Pondicherry University) continuance of recognition in respect of students being trained at JIPMER, Pondicherry.**

Read : The Council Inspectors report (17<sup>th</sup> & 18<sup>th</sup> March, 1997) along with the compliance received from the authorities of JIPMER, Pondicherry on rectification of the deficiencies pointed out in the inspection report for Continuance of recognition of MBBS degree granted by Pondicherry University in respect of students being trained at JIPMER, Pondicherry.

The Executive Committee considered the Council Inspectors report (17<sup>th</sup> & 18<sup>th</sup> March, 1997) along with the compliance received from the Director, JIPMER, Pondicherry vide letter dated 31.10.2000 and decided to recommend that recognition of MBBS degree granted by Pondicherry University in respect of students being trained at JIPMER, Pondicherry be continued with an annual intake of 75 (Seventy five) students.

12. **MBBS(The T.N. Dr. M.G.R. Medical University, Chennai) – Continuance of recognition in respect of students being trained at Chennai Medical College, Chennai.**

Read : The compliance verification inspection report (28<sup>th</sup> Nov., 2000) for Continuance of recognition MBBS degree in respect of students being trained at Chennai Medical College, Chennai.

The Executive Committee considered the compliance verification inspection report (28<sup>th</sup> Nov., 2000) carried out on receipt of the compliance from the authorities of Chennai Medical College, Chennai on rectification of the deficiencies pointed out in the

periodical inspection report (Sept.,98) and noted the following:-

1. As per policy of the State Govt. of Tamil Nadu 69% seats for admissions to MBBS course fall under the reserved category which is much more than the permissible limit of 50% as allowed by the Hon'ble Supreme Court of India. In addition seats are also reserved for special category of students.
2. The rotation of the teaching staff of the medical college in Tamil Nadu to District Hospitals/Health Services is not acceptable. A separate teaching cadre should be created so that the teaching staff is rotated/transferred/promoted within the teaching institutions only.
3. Following shortage of staff still persists for the number of admissions being made at the college:-
  1. Professor – 1 (PSM)
  2. Reader – 1 (Physiology)
  3. Lecturer – 4 (Anatomy-1, Physiology –2, Radiology-1)
  4. Tutor – 10 (Physiology –4, Pharmacology-2, Pathology-4)

Total deficiencies 16 out of 250 = 6.4% which is more than the permissible limit of 5%. This deficiency will further increase taking into account the postgraduate courses being conducted at the institution.

4. Other observations/deficiencies pointed out in the inspection report.

The Committee deferred the consideration of the matter of continuance of recognition of MBBS degree granted by the Tamil Nadu Dr. M.G.R. Medical University, Chennai, in respect of students being trained at Chennai Medical College, Chennai and directed the office to obtain the legal opinion regarding the reservation policy being followed by the State Govt. of Tamil Nadu for further consideration in the matter.

13. **MBBS(The T.N. Dr. M.G.R. Medical University, Chennai) – Continuance of recognition in respect of students being trained at Stanley Medical College, Chennai.**

Read : The compliance verification inspection report (6<sup>th</sup> & 7<sup>th</sup> Nov., 2000) for Continuance of recognition MBBS degree in respect of students being trained at Stanley Medical College, Chennai.

The Executive Committee considered the compliance verification inspection report (6<sup>th</sup> & 7<sup>th</sup> Nov.,2000) carried out on receipt of the compliance from the authorities of Stanley Medical College, Chennai on rectification of the deficiencies pointed out in the periodical inspection report (April,98) and noted the following:-

1. As per policy of the State Govt. of Tamil Nadu 69% seats for admissions to MBBS course fall under the reserved category which is much more than the permissible limit of 50% as allowed by the Hon'ble Supreme Court of India. In addition seats are also reserved for special category of students.

2. The rotation of the teaching staff of the medical college in Tamil Nadu to District Hospitals/Health Services is not acceptable. A separate teaching cadre should be created so that the teaching staff is rotated/transferred/promoted within the teaching institutions only.
3. Following shortage of staff still persists for the number of admissions being made at the college:-
  1. Reader/Assoc.Prof.– 6 (1 – Pharmacology, Preventive & Soc.Med.-2, Paed.-2, Orthopaedics – 1)
  2. Lecturer/Asstt.Prof. – 14: (Anatomy-3, Physiology –1, Bio-physics –1, Pharmacology – 1, Pharmaceutical Chemistry – 1, Forensic Medicine – 1, Preventive & Soc. Med.-2, Epidemiology – 1, Statistics – 1, Radiology-2)
  3. Tutor/Demonstrator/Registrar – 5 (Anatomy –1, For.Med.-1, Preventive & Soc.Med.-1, Orthopaedics – 1, Radiology – 1).
  4. Junior Residents – 12 : (Psychiatry –3, Orthopaedics – 9)

The above deficiency of staff will further increase taking into account the postgraduate courses being conducted at the institution.

4. The institution does not have any residential accommodation for staff in the campus. Only resident doctors have been provided accommodation in the campus and for warden of the hostel.
5. The museum though has required number of specimens and models but it is in a pathetic state.
6. Other observations/deficiencies pointed out in the inspection report.

The Committee deferred the consideration of the matter of continuance of recognition of MBBS degree granted by the Tamil Nadu Dr. M.G.R. Medical University, Chennai, in respect of students being trained at Stanley Medical College, Chennai and directed the office to obtain the legal opinion regarding the reservation policy being followed by the State Govt. of Tamil Nadu for further consideration in the matter.

14. **MBBS(The T.N. Dr. M.G.R. Medical University, Chennai) – Continuance of recognition in respect of students being trained at Madurai Medical College, Madurai.**

Read : The compliance verification inspection report (29<sup>th</sup> & 30<sup>th</sup> Nov., 2000) for Continuance of recognition MBBS degree in respect of students being trained at Madurai Medical College, Madurai.

The Executive Committee considered the compliance verification inspection report (29<sup>th</sup> & 30<sup>th</sup> Nov., 2000) carried out on receipt of the compliance from the authorities of Madurai Medical College, Madurai on rectification of the deficiencies

pointed out in the periodical inspection report (April,98) and noted the following:-

1. As per policy of the State Govt. of Tamil Nadu 69% seats for admissions to MBBS course fall under the reserved category which is much more than the permissible limit of 50% as allowed by the Hon'ble Supreme Court of India. In addition seats are also reserved for special category of students.
2. The rotation of the teaching staff of the medical college in Tamil Nadu to District Hospitals/Health Services is not acceptable. A separate teaching cadre should be created so that the teaching staff is rotated/transferred/promoted within the teaching institutions only.
3. Following shortage of staff still persists for the number of admissions being made at the college:-
  1. Professor – 1 (TB & Chest)
  2. Associate Prof. – 4: (Pharmacology –1, Pathology-2, Radio-Diagnosis-1)
  3. Lecturer – 9 (Anatomy-2, Pharmacology-1, Pathology-1, PSM-1, Epidemiology (PSM)-1, Radio-Diagnosis – 3).
  4. Tutor – 9 (Physiology – 2, Pharmacology-2, Pathology-2, Micro.-1), General Medicine – 1, Dentistry – 1).

The above deficiency of staff will further increase taking into account the postgraduate courses being conducted at the institution.

4. Other observations/deficiencies pointed out in the inspection report.

The Committee deferred the consideration of the matter of continuance of recognition of MBBS degree granted by the Tamil Nadu Dr. M.G.R. Medical University, Chennai, in respect of students being trained at Madurai Medical College, Madurai and directed the office to obtain the legal opinion regarding the reservation policy being followed by the State Govt. of Tamil Nadu for further consideration in the matter.

15. **MBBS(The T.N. Dr. M.G.R. Medical University, Chennai) – Continuance of recognition in respect of students being trained at Thanjavur Medical College, Thanjavur.**

Read : The compliance verification inspection report (14<sup>th</sup> & 15<sup>th</sup> Nov., 2000) for Continuance of recognition MBBS degree in respect of students being trained at Thanjavur Medical College, Thanjavur.

The Executive Committee considered the compliance verification inspection report (14<sup>th</sup> & 15<sup>th</sup> Nov.,2000) carried out on receipt of the compliance from the authorities of Madurai Medical College, Madurai on rectification of the deficiencies pointed out in the periodical inspection report (April,98) and noted the following:-

1. As per policy of the State Govt. of Tamil Nadu 69% seats for admissions to MBBS course fall under the reserved category which is much more than the permissible limit of 50% as allowed by the Hon'ble Supreme Court of India. In addition seats are also reserved for special category of students.

2. The rotation of the teaching staff of the medical college in Tamil Nadu to District Hospitals/Health Services is not acceptable. A separate teaching cadre should be created so that the teaching staff is rotated/transferred/promoted within the teaching institutions only.

The Committee deferred the consideration of the matter of continuance of recognition of MBBS degree granted by the Tamil Nadu Dr. M.G.R. Medical University, Chennai, in respect of students being trained at Thanjavur Medical College, Thanjavur and directed the office to obtain the legal opinion regarding the reservation policy being followed by the State Govt. of Tamil Nadu for further consideration in the matter.

16. **MBBS(Amravati University) – Continuance of recognition in respect of students being trained at Dr. Panjabrao Alias Bhusaheb Deshmukh Memorial Medical College, Amravati.**

Read : The compliance verification inspection report (6<sup>th</sup> & 7<sup>th</sup> Nov., 2000) for Continuance of recognition MBBS degree in respect of students being trained at Dr. Panjabrao Alias Bhusaheb Deshmukh Memorial Medical College, Amravati.

The Executive Committee noted that periodical inspection for continuance of recognition of MBBS degree granted by Amravati University in respect of students being trained at Dr. Panjabrao Alias Bhusaheb Deshmukh Memorial Medical College, Amravati was carried out by the Council Inspectors in July,97. The compliance report on rectification of the deficiencies pointed out in the inspection report received from the college authorities was verified earlier by the Council office on two occasions i.e. in April,99, Feb.,2000 however, recognition of MBBS degree was not continued in view of the deficiencies detected in the compliance verification inspection reports. This is the 3rd compliance verification inspection conducted by the Council.

On considering the compliance verification inspection report (6<sup>th</sup> & 7<sup>th</sup> Nov.,2000), the Committee noted the following:-

1. **Clinical Material:**

The average bed occupancy as well as OPD attendance during the last one year is much lower as compared to the bed occupancy and OPD attendance shown on the day of inspection (OPD attendance in Feb.,2000 inspection report 35% and Nov.,2000 inspection 29% whereas on the day of inspection it was 60% and 70% respectively). It is therefore difficult to comprehend this large variation in the availability of the clinical material.

2. **Medical College Hospital:**

The construction of the medical college hospital is slow. As per the revised undertaking given by the college authorities during inspection on 7.11.2000 – the on going construction work of two wards (60 beds each) and the construction of operation theatres complex of four OTs shall now be completed by 31<sup>st</sup> March,2001 whereas as per the earlier undertaking it was to be completed by Dec.,2000.

The functioning of the radio immune assay laboratory has not started as yet.

3. Still the mechanised central laundry and incinerator have not been provided.
4. The central sterilization unit which has been delivered in June,2000 is not installed in the new operation theatre as yet.
5. Audiometry room which has been provided is not satisfactory and neither it is air conditioned.
6. X-ray machines 500 MA, Endoscopy unit for Obst. & Gynae., USG unit-1 has not been purchased as yet.
7. Space provided for staff rooms in the clinical departments is not adequate.
8. Adequate boarding and lodging arrangement for interns has not been made in any of the available 3 Rural Health Centres.
9. Hostel facilities have been provided to the limited nursing staff. No quarters have been constructed for Residents and Nurses so far.

10. Shortage of staff:

Readers – 4 : (Anatomy-2, Forensic Medicine –1, Anaesthesia – 1).

Lecturer – 3 : (Anatomy –2, Forensic Medicine – 1)

Junior Resident – 1 (Psychiatry – 1)

In the department of Biochemistry the entire staff is non-medical except one Demonstrator.

In view of above, the Committee decided to give three months time to the institution to comply with all the deficiencies for further consideration in the matter.

17. **To consider the inspection report of Bangalore Medical College, Bangalore carried out to assess the facilities available at the College for teaching and training of 150 MBBS students.**

Read : The inspection report of Bangalore Medical College, Bangalore carried out to assess the facilities available at the College for teaching and training of 150 MBBS students.

The Executive Committee considered the Council Inspectors report (24<sup>th</sup>, 25<sup>th</sup> & 26<sup>th</sup> August,2000) carried out to assess the facilities available at Bangalore Medical College, Bangalore for teaching and training of 150 MBBS students and noted the following:-

1. The Principal does not have any control over the teaching hospitals which are under the administrative, financial and functional disciplinary control of the respective Superintendents. As per Regulations of the Council all the teaching hospitals shall be under the academic, administrative and disciplinary control of the Dean/Principal of the medical college or medical institution.

2. The auditorium does not have permanent seats and is used also for indoor games.
3. There is no examination hall as yet.
4. Common rooms are located in the auditorium with no attached toilet facility. It should be located in the main college building.
5. There is no independent staff for animal house.
6. Although the central library has adequate floor area, the whole complex needs to be reorganised so as to provide adequate number of seats for undergraduates, postgraduates and the staff.
7. There is no supportive staff for the Medical Education Unit.
8. A statistical unit needs to be established.
9. The Central photography and audiovisual unit should be provided with additional physical facility and the required staff.
10. There shall be regular postgraduate qualified staff at the Health Centres to strengthen the proper supervision and training programme.
11. Hostels at the Rural and the Urban health centres are not available.
12. The accommodation for girls/boys hostels is not as per the Council regulations with updated ancillary facilities. The number of seats needs to be increased both for boys and girls hostels.
13. Indoor games facility does not exist.
14. S.D.S. Hospital and Bowering hospital are far away from the college campus and students are required to use their own transport. However, as per regulations of the Council arrangements should be made by the college to provide its own transport.
15. Examination rooms and teaching rooms exist at the out-patient level should be provided in the wards as per the Council regulations.
16. Casualty services at Bowering Hospital need to be upgraded to provide adequate equipments for resuscitation and surgical procedures.
17. Appointments to the posts of Professors in various departments are made without putting any experience as Associate Professor/Reader which is contrary to the regulations of the Council.
18. There is no residency system.
19. There is no CT scanning facility.
20. Equipment in CSSD and laundry needs addition to conform to the Council norms.

21. Deficiency of teaching staff:

1. Professor – 1 (Psychiatry)
2. Reader – 9 : (Physiology-1, Pharmacology –2, PSM-2, Pathology-2 and Forensic Medicine – 2)
3. Lecturer – 12 : (Anatomy –1, Biophysics – 1, PSM –2, Biochemistry –1, Pharmacology –1, Epidemiology –1, Statistics – 1, Radio-Diagnosis – 2, Anaesthesia – 2)
4. Tutor – 23: (Anatomy –4, Physiology –2, Biochemistry –2, Pharmacology –4, Pathology –4, Anaesthesiology – 7)

The above deficiency of staff will further increase taking into account the postgraduate courses being conducted at the institution.

22. Other deficiencies/observations made in the inspection report.

In view of above, the Executive Committee decided to issue a show cause notice to the concerned authorities of the institution as to why steps should not be initiated to reduce the number of seats in consonance with the facilities available at the college and further decided to give one month's time to the institution to respond to the show cause notice. Copy of the letter sent to the authorities be marked to the Chief Secretary, Secretary (Health), Director of Medical Education, Registrar of the University, Member of the Council representing the State and the Central Govt.

18. **Deletion of column ( I ) i.e. “requisite recognised postgraduate qualification in the subject” against the post of Assistant Professor/Lecturer in the Deptt. of Dentistry in the MCI Regulations on Minimum Qualifications for Teachers in Medical Institutions, 1998.**

Read : The matter with regard to deletion of column ( I ) i.e. “requisite recognised postgraduate qualification in the subject” against the post of Assistant Professor/Lecturer in the Deptt. of Dentistry in the MCI Regulations on Minimum Qualifications for Teachers in Medical Institutions, 1998.

The Executive Committee considered the matter with regard to deletion of column ( I ) i.e. “requisite recognised postgraduate qualification in the subject” against the post of Assistant Professor/Lecturer in the Deptt. of Dentistry as prescribed in the MCI Regulations on Minimum Qualifications for Teachers in Medical Institutions, 1998 and decided to recommend to the Council that qualifications and teaching experience for various posts in the department of Dentistry should be as per the qualifications & teaching experience prescribed by the Dental Council of India in its Regulations which are as under:-

**MINIMUM BASIC QUALIFICATION AND TEACHING EXPERIENCE  
REQUIRED FOR TEACHERS FOR UNDERGRADUATE DENTAL STUDIES**

1. Principal/Dean: Same qualifications as prescribed for a Professor.  
Experience as Professor for not less than 5 years.



2. Professor: A BDS degree of an Indian University or an equivalent qualification with postgraduate qualification in the subject and with 5 years teaching experience after the postgraduate qualification as Reader.
- However, for the purposes of teaching Oral Anatomy and Histology, Dental Materials and Community Dentistry a candidate with BDS or equivalent qualification with 10 years teaching experience in that subject may be considered for the post of a Reader till such time postgraduate training facilities in this subject is available in our country. However, such a candidate without post-graduate qualification cannot be considered for the post of a Professor.
3. Associate Professor: A BDS degree of an Indian University or an equivalent qualification with postgraduate qualification in the subject and with 3 years teaching experience as Reader after he gets his postgraduate qualification.
4. Readers: A BDS degree of an Indian University or an equivalent qualification with postgraduate qualification in the subject and with 3 years teaching experience after postgraduation in the subject of specialisation.
5. Lecturer: A recognised BDS degree of an Indian Univ. or an equivalent qualification with 6 months experience as House-Surgeon.
6. House-Surgeons: A recognised BDS Degree of an Indian University or an equivalent qualification.

19. **Additional name of Hospitals recognised by the Council for purpose of compulsory rotating internship training – Information thereon.**

The Executive Committee noted the additional name of Hospitals recognised by the Council for purpose of compulsory rotating internship training as under:-

20. **Removal of the name of deceased person from the Indian Medical Register.**

Read : The matter with regard to cancellation of registration from I.M.R. in respect of Dr. Atma Ram Sharma registered in Rajasthan Medical Council under registration No. 1346.

The Executive Committee noted letter dated 21.11.2000 received from the Registrar, Rajasthan Medical Council, Jaipur intimating that Dr. Atma Ram Sharma, registration No. 1346, has expired and hence, his name has been erased from the register of the Registered Medical Practitioners.

21. **Medical College, Bhavnagar – Recognition of the college for the award of MBBS degree granted by Bhavnagar University.**

Read : The compliance verification inspection report (12<sup>th</sup> Jan., 2001) for recognition of Medical College, Bhavnagar for the award of MBBS degree granted by Bhavnagar University.

The Executive Committee considered the compliance verification inspection report (12<sup>th</sup> Jan.,2001) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the MCI inspection report (July,2000) and noted the following:-

1. Facilities provided in the students common room (for boys & girls) are still not adequate mainly in terms of furniture, recreation room etc.
2. Lifts in the college building are still not installed.
3. Girls intern hostel facilities though now provided, but is still dormitory type.
3. The services of laboratories such as Biochemistry, Haematology presently are not available on emergency basis.
4. Histopathological work has though improved (50 tissues/month) but looking at the histopathology needs of surgical and other departments, there is great need for proper coordination between pathology and other concerned departments of the hospital, so that full capacity is utilized and quality patient care is offered by the teaching institute.
5. Though the Pathology department has been shifted to new college building, but it has only one practical laboratory as against the two as required under the Council Regulations. Even the laboratory tables have not been provided with drainage and water connection.
6. Supervision by PSM Department needs to be strengthened at RHTC as interns are posted at the centre for training.
  
7. 25% of non-teaching staff is from general pool of Department of Health of the State Govt. This staff often is transferred affecting the working of the college and the hospital.

8. Other deficiencies/observations made in the inspection report.

In view of above, the Committee decided not to recommend recognition of Medical College, Bhavnagar for the award of MBBS degree granted by Bhavnagar University and further decided to give three months time to the institution to comply with the deficiencies pointed out in the inspection report and to send a compliance to that effect to the Council for further consideration in the matter.

22. **Starting of new medical college at Lucknow by Era Educational Trust, Lucknow u/s 10A of the IMC Act, 1956.**

Read : The Council Inspectors report (12<sup>th</sup> & 13<sup>th</sup> Jan., 2001) for starting of new medical college at Lucknow by Era Educational Trust carried out in compliance of the order passed by the Hon'ble Supreme Court on 5/4/2000.

The Executive Committee considered the Council Inspectors report (12<sup>th</sup> & 13<sup>th</sup> Jan.,2000) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of new medical college at Lucknow by Era Educational Trust u/s 10A of the I.M.C. Act,1956 with an annual intake of 100 (one hundred) students.

23. **Starting of new medical college at Ujjain by Ujjain Charitable Trust Hospital and Research Centre, Ujjain, Madhya Pradesh u/s 10A of the IMC Act, 1956.**

Read : The compliance verification inspection report (8<sup>th</sup> & 9<sup>th</sup> Jan., 2001) for starting of new medical college at Ujjain by Ujjain Charitable Trust Hospital and Research Centre, Ujjain, Madhya Pradesh u/s 10A of the IMC Act, 1956.

The Executive Committee considered the compliance verification inspection report (8<sup>th</sup> & 9<sup>th</sup> January,2001) carried out on receipt of the compliance report on rectification of the deficiencies pointed out in the MCI inspection report (Sept.,2000) and decided to recommend to the Central Govt. to issue Letter of Intent for starting of new medical college at Ujjain by Ujjain Charitable Trust Hospital and Research Centre, Ujjain u/s 10A of the I.M.C. Act,1956 with an annual intake of 100 (one hundred) students.

24. **Increase of MBBS seats from 50 to 100 at NKP Salve Instt. of Med. Sciences, Nagpur u/s 10A of the IMC Act, 1956.**

Read : The Council Inspectors report (9<sup>th</sup> & 10<sup>th</sup> Jan., 2001) for increase of MBBS seats from 50 to 100 at NKP Salve Instt. of Medical Sciences, Nagpur u/s 10A of the IMC Act, 1956.

The Executive Committee considered the Council Inspectors report (9<sup>th</sup> & 10<sup>th</sup> Jan.,2001) and decided to recommend to the Central Govt. to issue Letter of Intent for increase of MBBS seats from 50 to 100 at NKP Salve Instt. of Medical Sciences, Nagpur u/s 10A of the I.M.C. Act,1956.

25. **Increase of MBBS seats from 50 to 100 at Karnataka Instt. of Med. Sciences, Hubli u/s 10A of the IMC Act, 1956.**

Read : The Council Inspectors report (11<sup>th</sup> & 12<sup>th</sup> Dec., 2000) for increase of MBBS seats from 50 to 100 at Karnataka Instt. of Med. Sciences, Hubli u/s 10A of the IMC Act, 1956.

The Executive Committee considered the Council Inspectors report (11<sup>th</sup> & 12<sup>th</sup> Dec.,2000) and noted the following:-

1. Staff:

That a large number of teachers i.e. almost 85 in number and also Director & Principal of the college are on deputation, hence, are not the regular employees of this institute. The faculty on deputation cannot be considered as per the prescribed Regulations. In addition to the staff working on deputation the following deficiencies in staff are also existing:-

1. Professor – 2 (TB & Chest – 1, Dentistry – 1)
  2. Readers/Assoc.Prof. – 7 (Biochemistry –1, Pharmacology-1, PSM-1, Pathology-1,Paed.-1, Anaes.-1, Radio-diagnosis-1)
  3. Lecturer – 2 (Biophysics – 1, Statistics – 1)
  4. Tutors – 2 (Anatomy – 2)
2. That the Principal of the college does not have academic, administrative and disciplinary control of the hospital.
  3. That the department of Psychiatry is using 45 beds of the Mental Hospital, Dharwad and the same are being monitored by only Lecturer.
  4. Complement of staff in the Animal House and Artist & Photography Section is not as per MCI norms.
  5. There is no day-to-day supervision by the Department of Community Medicine over the training programme conducted at the Rural and Urban Health Training Centres.
  6. Girls hostel has not been provided with visitor room and standby generator and furniture for the reading room.
  7. OPD does not have all the necessary areas as per Council regulations. Even the basic requirements like examination tray, x-ray viewing box have not been provided.
  8. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Executive Committee decided to recommend to the Central Govt. not to issue Letter of Intent for increase of MBBS seats from 50 to 100 at Karnataka Instt. of Medical Sciences, Hubli u/s 10A of the I.M.C. Act,1956.

26. **MBBS(Mahatma Gandhi University, Kottayam) – Continuance of recognition in respect of students being trained at Medical College, Kottayam.**

Read : The compliance verification inspection report (22<sup>nd</sup> & 23<sup>rd</sup> Nov., 2000) for continuance of recognition of MBBS degree granted by Mahatma Gandhi University, Kottayam in respect of students being trained at Medial College, Kottayam.

The Executive Committee considered the compliance verification inspection report (22<sup>nd</sup> & 23<sup>rd</sup> Nov.,2000) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the periodical inspection report (April,98) and noted the following :-

1. **Shortage of staff:**

Professor – 1: (Radiology)

Associate Prof. – 5: (Anatomy –1, Pathology –3, PSM – 1)

Lecturer – 6 : Biophysics – 1, Pharmacology –1, Pathology –1, PSM-1, Epidemiology (PSM) – 1, Radiology –1)

Tutors – 7: (Physiology –3, Pathology –4)

The above deficiency of staff will further increase taking into account the postgraduate courses being conducted at the institution.

2. **Shortage of beds:**

Obst. & Gynae. – 9

TB & Chest – 10

3. No adequate supervision by PSM department both at UHTC/RHTC has been provided.
4. Though cubicles have been created however, x-ray viewing box, examination tray, finger stals, proctoscope etc. have not been provided in each examination cubicles.
5. No separate demonstration room has been provided for the department of Pharmacology.
6. Other deficiencies/observations made in the inspection report.

In view of above, the Committee decided to give 3 months time to the institution to comply with the deficiencies pointed out in the inspection report and send a compliance to that effect for further consideration in the matter.

27. **MBBS (Kanpur University) - Continuance of recognition in respect of students being trained at GSVM Medical College, Kanpur.**

Read : The letter dt.21/10/2000 received from the Principal, GSVM Medical College, Kanpur requesting to grant one year time for rectifying the deficiencies pointed out in the periodical inspection report (Feb., 1997) carried out by the Council Inspectors for continuance of recognition of MBBS degree granted by Kanpur University.

The Executive Committee noted that periodical inspection for continuance of recognition of MBBS degree granted by Kanpur University in respect of students being trained at GSVM Medical College, Kanpur in Feb.,1997 and the inspection report was considered in the various Committees from time to time, however, in view of the shortage of staff and infrastructural facilities, the Committee did not recommend continuance of recognition of MBBS degree.

The Committee further noted that it at its meeting held on 24.07.2000 while considering the compliance report received from the Principal, K.G. Medical College, Lucknow on the deficiencies pointed out in the periodical inspection report (Oct.,95) decided to request the Chief Secretary, Govt. of U.P. to intimate the latest status of the Societies which have been formed for upgrading the status of the medical colleges of U.P. State. The Chief Secretary was also requested to intervene in the matter personally and advise all the college authorities of the State of U.P. to send a proper compliance report after rectification of the deficiencies pointed out in the periodical inspection report of the respective medical colleges within 3 months for finalising the matter of continuance of recognition of MBBS degree granted by the respective universities.

It also noted that a D.O. letter was received from the Chief Secretary, Govt. of U.P. in response to the above decision of the Committee which was considered by it at its meeting held on 24.10.2000. Regarding the present status of the Societies he informed that the State Govt. had decided to form individual societies to run the medical colleges of the State. This order of the Govt. was struck down by Hon'ble High Court and they have appealed against this order. But not to loose further time, the State Govt. has already moved requisition to the U.P. Public Service Commission to make selection so that existing teaching posts can be filled up. They have also initiated action to hold D.P.C. so that large number of vacancies, which are to be filled up by promotion, would be filled up during the next 2 months.

The Committee appreciated the action taken by the Chief Secretary of U.P. and further decided to give 3 months time for rectification of the deficiencies pointed out in the periodical inspection report of the State medical colleges in U.P. carried out for continuance of recognition of MBBS degree and sending a detailed compliance report.

The Committee considered the letter dated 21.10.2000 from the Principal, GSVM Medical College, Kanpur received in this office on 01.11.2000 requesting to give one year time for filling up of the various teaching posts and rectification of the other deficiencies pointed out in the periodical inspection report carried out in Feb.,97. The Committee did not agree with the request of the Principal to give one year's time, however, decided to give final 3 months to the institution for rectification of the deficiencies and sending a compliance report for further consideration in the matter. If no reply is received within the stipulated period, action be initiated as deemed fit under the I.M.C. Act,1956.

28. **Graduate Medical Education Regulations – Supplementary examination regarding.**

Read : The matter regarding permitting the students who have passed the supplementary examination of phase I to join the main batch for 2<sup>nd</sup> phase of MBBS in view of the clause 7(7) of the Graduate Medical Education Regulations, 1997.

The Executive Committee noted that it at its meeting held on 2.2.2000 on considering the letter dated 21.1.2000 received from the Dean, Pt. J.N.M. Medical College, Raipur regarding permitting 18 students passing the supplementary examination of phase I, to join the main batch had decided that students passing the supplementary examination should not be allowed to join the main batch for the next phase but will have to undergo the full period of training for the 2<sup>nd</sup> phase and so on.

It further noted that as per the Council instructions the medical college had not allowed students who had passed the supplementary examination in first MBBS held in Dec.,1999 to join the main batch for 2<sup>nd</sup> phase of MBBS. A number of students had filed writ petition in the M.P. High Court, Jabalpur against the above decision of the Executive Committee requesting for placing them in the main batch for the 2<sup>nd</sup> MBBS IInd phase.

The Committee reconsidered the matter and decided to recommend to the General Body of the Council to delete the clause 7(7) as contained in the Council Regulations on Graduate Medical Education,1997 which reads as under:-

“7(7) Supplementary examination may be conducted within six months so that the students who pass can join the main batch and the failed students will have to appear in the subsequent year.”

29. **Regarding grant of permission to visually handicapped candidate Mr. Christ Sudarshan P. Toppo to appear in the final MBBS examination at AIIMS, New Delhi.**

Read : The matter regarding grant of permission to visually handicapped candidate Mr. Christ Sudarshan P. Toppo to appear in the final MBBS examination at AIIMS, New Delhi in view of the notice issued by the National Human Rights Commission to the MCI.

The Executive Committee deliberated in the matter and decided to constitute a Sub-Committee consisting of the following 2 members for examining the whole issue and preparing guidelines for admissions into medical course for persons with disabilities:-

30. **Allotment of MBBS seats to the persons with disabilities in pursuance of order dated 13.6.2000 of High Court of Guwahati in W.P. No.41/2000 – Case of Miss Binita Senapati.**

Read : The letter dt.6/12/2000 received from the Central Govt., Ministry of Health & F.W. conveying the approval of the Central Govt. for creation of one additional seat in the MBBS course over and above the approved intake during the year 1999-2000

at Silchar Medical College, Silchar to accommodate the petitioner – Miss Binita Senapati, D/o Shri Jatindra Nagh Senapati in Writ Petition © No.41/2000.

The Executive Committee noted the letter dated 6.12.2000 received from the Central Govt., Ministry of Health & F.W. conveying the approval of the Central Govt. for creation of one additional seat in the MBBS course over and above the approved intake during the year 1999-2000 at Silchar Medical College, Silchar to accommodate the petitioner – Miss Binita Senapati, D/o Shri Jatindra Nagh Senapati in Writ Petition © No.41/2000.

31. **Removal of name of deceased person from the Indian Medical Register.**

Read : The letter dt.9/1/2001 received from the Registrar, Rajasthan Medical Council intimating that Dr. Govind Lal Mathur who was registered with that Council has expired 4/1/2001 and his name has been erased from the Register of the Registered Medical Practitioners.

The Executive Committee noted the letter dated 09.01.2001 received from the Registrar, Rajasthan Medical Council, Jaipur intimating that Dr. Govind Lal Mathur, registration No. 101, has expired and hence, his name has been erased from the register of the Registered Medical Practitioners.

32. **Establishment of new medical college at Medak Distt. A.P. by Apollo Hospital Educational & Research Foundation, Hyderabad – Refund of application fee.**

Read : The letter dt.15<sup>th</sup> Dec., 2000 received from the Administrator, Apollo Hospital Educational & Research Foundation, Hyderabad requesting to refund the full amount of application fee i.e. 3.50/- lakhs submitted by them with their application for establishment of medical college at Medak Distt.

The Executive Committee noted that application along with copy of the Court order dated 21.1.1999 for establishment of new medical college at Medak Distt. A.P. by Apollo Hospital Educational and Research Foundation, Hyderabad u/s 10A of the I.M.C. Act,1956 was received through the Central Govt. vide its letter dated 16.3.1999.

The Hon'ble High Court vide its order dated 21.1.1999 directed the Council to conduct inspection of the premises of petitioner without reference to the Essentiality Certificate of the State Govt. The Hon'ble High Court further directed the second respondent i.e. the Govt. of A.P. to consider the case of the petitioner for grant of essentiality certificate in accordance with the rules without reference to the previous contained in GOMS No. 128-HM&FW Deptt. dated 30.4.1998.

The MCI Counsel appeared before the Hon'ble High Court and defended the writ petition by filing its counter affidavit in the matter.

In the meantime the Govt. of A.P. had released a notification dated 3.7.99 inviting fresh application to establish new medical college mentioning that the applications already submitted and pending are not valid. In compliance to the same the authorities of Apollo Hospital had submitted fresh application to Govt. of A.P. and had also withdrawn the writ petition filed by them.

It further noted that as per request of the authorities of Apollo Hospital Educational & Research Foundation, Hyderabad 50% amount of the application fee i.e. 1.75 lakhs has already been refunded by the MCI though the fee is non-refundable. It



also noted that request of the authorities for refund of full amount of application fee i.e. 3.50 lakhs was considered by it at its meeting held on 26.5.2000 and the Committee did not agree to refund of full amount of application fee.

The Executive Committee considered the letter dt.15<sup>th</sup> Dec., 2000 now received from the Administrator, Apollo Hospital Educational & Research Foundation, Hyderabad in response to the above decision of the Committee claiming that they are eligible to receive full amount of application fee i.e. 3.50/- lakhs as the decision to withdraw the application was not theirs, they were compelled to withdraw the application as per the Govt. of A.P. instruction/notification.

The Committee decided to reiterate its earlier decision taken at its meeting held on 26.5.2000 not to refund the full amount of application fee as requested.

33. **Starting of medical college – Aarupadai Veedu Medical College at Pondicherry by TKVTSSMECT, Salem – Grant of Letter of Permission by the Central Govt.**

Read : The compliance verification inspection report (10<sup>th</sup> & 11<sup>th</sup> Jan., 2001) for grant of letter of permission by the Central Govt. for starting of medical college, Aarupadai Veedu Medical College at Pondicherry by TKVTSSMECT, Salem.

The Executive Committee considered the compliance verification inspection report (10<sup>th</sup> & 11<sup>th</sup> January,2001) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the MCI inspection report (Oct.,2000) and noted that the following deficiencies still exist:-

1. The statistical unit and medical education unit are not properly equipped and made functional.
2. No hostel facilities for boys and girls are available and also no hostel for nurses and Resident Doctors are available.
3. The clinical material is inadequate.
4. The records of the hospital relating to patients are not maintained properly. It is totally inadequate and deficient in all areas such as indoor wards, operation theatres, labour room, casualty and laboratories etc.
5. The Medical Record Department is not functioning properly. No system of recording/filing is being followed.
6. The casualty functioning is unsatisfactory as no records are maintained and no duty register for doctors is available.
7. The central sterilisation facilities are not provided.
8. The construction of the building is poor and the problem of seepage still exists.
9. No residential quarters for teaching staff are available.
  
10. The incinerator has been provided next door to the laundry which is not in conformity with the basic principles of hospital waste management.

11. Shortage of staff:
  1. Professors/Readers – 2 (1 in Paed. & 1 in Ortho.)
  2. Prof./Reader/Lecturer – 2 (1 in Forensic Med. & 1 in PSM)
  3. Reader – 1 (Physiology)
 Total shortage 5 out of 63 required i.e. 7.7% which is more than the permissible limit of 5%.
12. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Executive Committee decided to recommend to the Central Govt. not to issue Letter of Permission for starting of Aarupadai Veedu Medical College at Pondicherry by TKVTSSMECT, Salem u/s 10A of the I.M.C. Act, 1956.

34. **To note the letter of Intent/Permission/Renewal of Permission issued by the Central Govt. for starting of new medical colleges/increase of seats in MBBS course u/s 10A of the IMC Act, 1956.**

The Executive Committee noted the Letter of Intent/Permission/Renewal of Permission issued by the Central Govt. for establishment of new medical colleges/increase of MBBS seats u/s 10A of the IMC Act, 1956 as under:-

35. **MBBS(The T.N. Dr. M.G.R. Medical University, Chennai) – Continuance of recognition in respect of students being trained at Tirunelveli Medical College, Tirunelveli.**

Read : The compliance verification inspection report (4<sup>th</sup> & 5<sup>th</sup> Jan., 2001) for

continuance of recognition of MBBS degree in respect of students being trained at Tirunelveli Medical College, Tirunelveli.

The Executive Committee considered the compliance verification inspection report (4<sup>th</sup> & 5<sup>th</sup> Jan.,2001) carried out on receipt of the compliance from the authorities of Tirunelveli Medical College, Tirunelveli on rectification of the deficiencies pointed out in the periodical inspection report (Dec.,98) and noted the following:-

1. As per policy of the State Govt. of Tamil Nadu 69% seats for admissions to MBBS course fall under the reserved category which is much more than the permissible limit of 50% as allowed by the Hon'ble Supreme Court of India. In addition seats are also reserved for special category of students.
2. The rotation of the teaching staff of the medical college in Tamil Nadu to District Hospitals/Health Services is not acceptable. A separate teaching cadre should be created so that the teaching staff is rotated/transferred/promoted within the teaching institutions only.

The Committee deferred the consideration of the matter of continuance of recognition of MBBS degree granted by the Tamil Nadu Dr. M.G.R. Medical University, Chennai, in respect of students being trained at Tirunelveli Medical College, Tirunelveli and directed the office to obtain the legal opinion regarding the reservation policy being followed by the State Govt. of Tamil Nadu for further consideration in the matter.

36. **MBBS (Bombay University) – Continuance of recognition of MBBS degree in respect of students being trained at Seth G.S. Medical College, Mumbai.**

Read : The compliance verification inspection report (19<sup>th</sup> & 20<sup>th</sup> Dec., 2000) for continuance of recognition of MBBS degree granted by Bombay University in respect of students being trained at Seth G.S. Medical College, Mumbai.

The Executive Committee considered the compliance verification inspection report (19<sup>th</sup> & 20<sup>th</sup> Dec.,2000) carried out on receipt of the compliance from the authorities of Seth G.S. Medical College, Mumbai on rectification of the deficiencies pointed out in the periodical inspection report (Dec.,1997) and noted the following:-

1. Shortage of staff:
  1. Professor – 1: (TB & Chest)
  2. Assoc.Prof./Reader – 3: (Forensic Medicine – 1, General Medicine-1, Radiology – 1)
  3. Asstt.Prof./Lecturer – 6: (Biophysics – 1, Anatomy –1, Pharmaceutical Chemistry –1, Statistics – 1, General Medicine – 1, Skin & STD – 1)
  4. Tutor/Registrar/Demonstrator – 3 (Anatomy)

The complete staff in the department of Biochemistry is non-medical.

2. The shortage of one unit in General Medicine still exists as was in the periodical inspection report.
3. Other deficiencies pointed out in the inspection report.

In view of above, the Committee decided to give 3 months time to the institution to rectify the deficiencies pointed out in the compliance verification inspection report and send a compliance report to that effect for further consideration in the matter.

37. **MBBS ( Devi Ahilya Vishwavidyalaya, Indore) - Continuance of recognition in respect of students being trained at M.G.M. Medical College, Indore.**

Read : The matter with regard to continuance of recognition of MBBS degree in respect of students being trained at MGM Medical College, Indore and also letter dt.9/1/2001 received from the Principal Secretary, Govt. of M.P. regarding carrying out the inspection of medical colleges of M.P.

The Executive Committee noted that inspection for continuance of recognition of MBBS degree granted by Devi Ahilya Vishwavidyalaya, Indore in respect of students being trained at M.G.M. Medical College, Indore was carried out by the Council Inspectors in Feb.,98.

The inspection report was first considered by the Committee at its meeting held on 16.3.98. As the deficiencies especially with regard to staff for the number of admissions being made by the college authorities were still persisting, 3 months time was granted to the institution to send a detailed compliance report.

Further the latest staff list received from the college authorities along with the inspection report was last considered by the Committee at its meeting held on 16.6.99 wherein the Committee decided to verify the same by way of an inspection. However, inspection for verification of the same has not yet been carried out as per request of the Principal Secretary, Govt. of M.P. and also the college authorities to postpone the inspection to later dates on the grounds that they are in the process of removing the deficiencies and appointing the teaching staff.

The Committee considered the letter dated 9.1.2001 received from the Principal Secretary, Govt. of M.P. regarding carrying out the inspection of medical colleges of M.P. and informed that Deans of respective colleges have already started necessary recruiting procedures, and, have advertised to obtain applications. He has requested that inspection of medical colleges of M.P. be undertaken only after the vacant posts have been filled and they will advise separately about suitable dates of inspection around the end of March,2001.

In view of above, the Committee decided to give final 3 months time for sending the compliance report on rectification of the deficiencies pointed out in the periodical inspection report of the State Medical Colleges of M.P. for further consideration in the matter.

38. **Periodical inspection carried out for Continuance of recognition of MBBS degree in respect of students being trained at Medical Colleges in the State of Bihar.**

Read : The letter dt.18/1/2001 received from the Secretary to the Govt. of Bihar Deptt. of Health (Medical Education, Family Welfare & Indigenous Medicine) requesting to grant 6 months time for sending the compliance report in respect of the medical colleges in the State of Bihar.

The Executive Committee noted that periodical inspection for continuance of recognition of MBBS degree in respect of students being trained at the following medical colleges in the State of Bihar was carried out by the Council Inspectors as mentioned below:-

The matter of continuance of recognition of MBBS degree granted by the respective universities is pending for want of proper compliance report on rectification of the deficiencies pointed out in the periodical inspection reports in respect of each medical college.

The Committee further noted that as per request of the Secretary to the Govt. of Bihar, vide D.O. letter dated 21.8.2000 time upto Feb.,2001 had been granted for submission of the compliance report by the college authorities.

The Committee considered the D.O. letter dated 18.01.2001 now received from the Secretary to the Govt. of Bihar in continuation to his previous letter dated 21.8.2000. He has informed that during the intervening period, various steps have been taken by the State Govt. for filling up of vacant posts. The new rules are almost ready and actual process of posting is to take off very soon. It is further informed that the State Govt. is also releasing adequate extra funds for improving the infrastructure deficiencies pointed out by the MCI. The colleges are being directed to utilize this money for removing the deficiencies pointed out by the MCI. The Govt. has been pleased to constitute Monitoring Committees for all the medical colleges of the State headed by the respective divisional commissioners. The respective Collectors, SPs and Engineers of the works department as well as two public figure are members of the Committee and they have been entrusted with the task of toning up the affairs at the medical college & hospitals. Steps have also been taken to ensure attendance and availability of the teacher doctors and para medical staff. He has therefore requested to grant further period of 6 months for final compliance in all the cases.

In view of above, the Committee decided to give final 3 months time i.e. upto April,2001 for submission of the compliance report by the college authorities after rectification of the deficiencies pointed out in the periodical inspection report in respect of each medical college.

39. **Reservation of seats in medical courses for persons with disabilities.**

Read : The matter with regard to reservations of seats in medical courses for persons with disabilities.

The Executive Committee decided to constitute a Sub-Committee under the chairmanship of Dr. Ananda Kannan, Vice-Chancellor, the Tamil Nadu Dr. M.G.R. Medical University to frame guidelines for making reservation of seats into medical courses for persons with disabilities. The recommendations thus submitted be again brought back before the Committee.

40. **Inclusion of the basic principles and concepts of Ayurveda, Homeopathy, Unani, Siddha and Yoga in the course of MBBS.**

Read : The matter with regard to Inclusion of the basic principles and concepts of Ayurveda, Homeopathy, Unani, Siddha and Yoga in the course of MBBS.

The Executive Committee considered the matter and decided to form a Sub-Committee under the chairmanship of Dr. K. Ananda Kannan, Vice-Chancellor, the Tamil Nadu Dr. M.G.R. Medical University, Chennai, to study the recommendations of the Department of ISM & Homeopathy and advise regarding introduction of basic principles and concepts of Ayurveda, Homeopathy, Unani, Siddha and Yoga in the course of MBBS.

41. **Enhancement of the age group of patients seen by paediatricians from the current 12 years to 18 years.**

Read : The letter of the President Indian Academy of Paediatrics received through the Central Govt. vide letter dt.13/12/2000 with regard to enhancement of the age group of patients seen by Paediatricians from the current 12 years to 18 years.

The Executive Committee considered the letter dated 13.12.2000 enclosing therewith the proposal of the Indian Academy of Paediatrics, with regard to enhancement of the age group of patients seen by Paediatricians from the current 12 years to 18 years seeking comments of the Council thereon and decided to convey that the matter is outside the purview of the Medical Council of India.

42. **To grant Provisional Registration u/s 25(1) of the IMC Act, 1956 – Dr. Anupama Goyal, M.B.Ch.B. Makerere University in Kampala, Uganda.**

Read : The matter with regard to grant Provisional Registration u/s 25(1) of the IMC Act, 1956 – Dr. Anupama Goyal, M.B.Ch.B. Makerere University in Kampala, Uganda.

The Executive Committee considered the matter with regard to grant of Provisional Registration u/s 25(1) of the IMC Act, 1956 to Dr. Anupama Goyal, M.B.Ch.B. Makerere University in Kampala, Uganda and did not agree to grant provisional registration. in the absence of final degree of passing the qualification .

43. **To grant of Provisional Registration u/s 25(1) of the I.M.C. Act, 1956 after obtaining M.D.(Physician) degree from institute of Erstwhile USSR.**

Read : The matter with regard to grant of Provisional Registration u/s 25(1) of the I.M.C. Act, 1956 after obtaining M.D.(Physician) degree from institute of Erstwhile USSR.

The Executive Committee did not agree to grant provisional registration u/s 25(1) of the I.M.C. Act, 1956 to Mr. Jay Sudhir Kothari and Mr. Vikas Sharma after obtaining M.D.(Physician) degree from institute of erstwhile USSR as they have not studied one year required preparatory/language course before being admitted to the medical course.

44. **Additional name of Hospital recognised by the Council for purposes of Compulsory Rotating Internship Training – Information thereon.**

The Executive Committee noted the additional name of Hospital recognised by the Council for purpose of compulsory rotating internship training as under:-

45. **Santosh Medical College, Ghaziabad – Recognition/approval of the college for the award of MBBS degree granted by Ch.Charan Singh University.**

Read : The compliance verification inspection report (19<sup>th</sup> & 20<sup>th</sup> Jan., 2001) for recognition/approval of Santosh Medical College, Ghaziabad for the award of MBBS degree granted by Ch.Charan Singh University, Meerut.

At the outset Vice-President, Dr. B.C. Chhapparwal informed the committee that this agenda item should not be considered as the matter is subjudice. However, after detailed deliberations, it was decided to take a decision on the compliance verification inspection report (19<sup>th</sup> & 20<sup>th</sup> Jan., 2001) carried out on receipt of the compliance report through the Central Govt., Ministry of Health & F.W. vide their letter dated 29.11.2000. The Executive Committee noted the following deficiencies in the compliance verification inspection report.

1. College Building:

The 4<sup>th</sup> and 5<sup>th</sup> floors were under construction during the October 2000 inspection and as per the undertaking given by the institution, these were to be completed in 7 weeks time.

However, no work on the 4<sup>th</sup> & 5<sup>th</sup> floors of the college building has been done since the last inspection, except work has started for creation of research laboratories for certain departments but it is still incomplete.

Certain of the toilets attached to the HOD rooms are still not functional even in the occupied portions of the building.



2. SHORTAGE OF STAFF FOR 50 ADMISSIONS:

Assoc. Prof.-1 (Obst. & Gynec.-1)

Sr. Residents - 5 (Gen.Med.-1, Psychiatry-1, Gen. Surgery-3)  
Jr. Residents-7 (Gen.Med.-2, Psychiatry-2, Orthopedics-2,  
Obst. & Gynae.-1)

Note:

1. There is a shortage of 8% and is mainly of senior & junior residents.
2. 17 Professors, 2 Assoc. Professors, 7 Demonstrators/Sr. Residents & 25 Jr. Residents joined the institution and 4 demonstrators/Sr. Residents and 24 Jr. Residents left the institution in last 3 months.

3. Clinical Material:

The clinical material specially in relation to surgeries performed, casualty/emergency attendance, deliveries conducted and lab investigations etc. are not adequate and it has not shown any improvement since the last inspection. The average daily OPD attendance is also, less as against the required daily OPD of 400 patients.

4. Hospital:

The attachment of MMG Distt. Hospital, Ghaziabad for clinical teaching and training of the students is not acceptable as the institution as per the project report should have provided adequate facilities including the clinical material in its own hospital by this time.

5. Maintenance of inadequate indoor records:

The morbidity data of the hospital should be maintained as per the WHO international classification of diseases. However, the medical record officer who has recently joined needs training in medical record keeping so that the hospital records are analyzed & maintained as required.

6. Health Centres:

As per regulations of the Council, the institution has to make arrangement of stay of interns at least in one of the rural health centres on regular & permanent basis in proper building with adequate boarding & lodging facilities. This has not been done so far. The arrangement of Jahangirpuri centre is not satisfactory specially for the interns' stay in that locality. Even the space of this centre is not adequate.. An urban health centre needs to be developed as per MCI norms.

7. Central Sterilization Services Department:

There are still only two autoclaves in Central Sterilization Services Department. One more autoclave is required for this department.

8. Central Laundry:

Central laundry has not been provided so far.

9. Incinerator:

The institution has provided a bucket & a rope with a pulley arrangement to bring the hospital refuse from the ground floor to the top of the building where the incinerator has been installed. This arrangement is not at all satisfactory and is unacceptable. The institution will have to make arrangement so that the lift goes upto the top of the hospital or a ramp is made to carry hospital refuse and also to remove the ash.

10. Departmental Libraries:

All the clinical departments are short of departmental library books and their proper upkeep & space.

11. Basic & para clinical departments:

A The shortage of one adequate size demonstration room and research laboratory continues in **Deptt. Of Anatomy**.

B Still, there is no separate research laboratory in **Physiology Deptt.**

C **Deptt. Of Pathology:** Still, there is no separate research laboratory. The blood bank is yet to become functional as still the authorities are waiting the licence from the licencing authority.

Still the service laboratories of Histopathology, Cyto-Pathology and Hematology need to increase their workload as at present the workload is not adequate.

20 specimens have been added to the museum since the last inspection. However, proper catalogues for the use of the students need to be improved by providing sketch and labelled diagrams of the museum specimens.

D **Deptt. Of Microbiology:** Still all the service laboratories of Bacteriology including Anaerobic, Serology, Virology, Parasitology, Mycology, Tuberculosis do not have adequate space. These are functioning only on a counter in the Outpatient department. There is no anaerobic laboratory. The work of all these labs is still inadequate.

E **Deptt. Of Forensic Medicine:** Separate departmental library cum seminar room is available now. The staff room is still combined for all the staff members. The necessary permission is still awaited from the State Govt. for the conduct of post-mortems.

12. **Staff rooms** are available alongwith the OPD rooms for only one unit staff. Staff rooms need to be provided for the staff of all the units in all the clinical departments.

13. Other observations and deficiencies pointed out in the report.

In view of above, the Committee decided to reiterate its earlier decision taken at its meeting held on 24.10.2000 not to recommend recognition/approval of Santosh Medical College, Ghaziabad for the award of MBBS degree granted by Ch. Charan Singh University, Meerut and not to renew the permission for the admission of the 6<sup>th</sup> batch of students at the college.

46. **MBBS (MAHE, Deemed University) – Continuance of recognition in respect of students being trained at Kasturba Medical College, Manipal.**

Read : The compliance verification inspection report (8<sup>th</sup> & 9<sup>th</sup> Jan., 2001) for continuance of recognition of MBBS degree granted by MAHE Deemed University.

The Executive Committee considered the compliance verification inspection report (8<sup>th</sup> & 9<sup>th</sup> Jan.,2001) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the periodical inspection report (May,1998) and noted the following:-

I. That out of the total admissions being made at Kasturba Medical College, Manipal and Kasturba Medical College, Mangalore 25% of the seats are being filled up with NRI/Foreign quota and the remaining 75% under the general category quota. Further all the students admitted against NRI/foreign quota of both the colleges are being placed at Kasturba Medical College, Manipal for the entire MBBS course. The general category candidates admitted against the Kasturba Medical College, Manipal are being sent to the Mangalore medical college for the entire MBBS course in lieu of the NRI/foreign quota admitted against the Mangalore Medical College. Thus the admissions against NRI/foreign quota fixed as 15% by the Hon'ble Supreme Court is being violated by the institution. Moreover, the number of admissions made against the NRI/foreign quota has been exceeded in the year 2000-2001 beyond the 25% i.e. 26.2%. Further, approximately 50% of the total seats are being filled up by the NRI/foreign students each year at Kasturba Medical College, Manipal which is also a total violation of the NRI quota fixed by the Hon'ble Supreme Court for one particular medical college. To quote an example out of the total 248 admissions made at the college during the year 1999-2000 at Kasturba Medical College, Manipal, 134 students belonged to general category and 114 belonged to NRI/foreign quota.

II. The following deficiencies still persist:-

(i) Lecture theatres:

None of the lecture theatres available can accommodate 250 students i.e. total number of annual admissions for the MBBS course. According to MCI norms & requirements, the college needs to have 3 lecture theatres with sitting capacity of 350-500 and one with the sitting capacity of 700-800 students.

(ii) Auditorium:

The auditorium is small keeping in view the annual admissions i.e. 250 students.

(iii) In the animal house, the Veterinary Officer is still part time. The college needs to have full time Veterinary Officer.

(iv) Composition of units and placement of beds:

Though the total number of beds required is available, the composition of most of the general wards is mixed with patient of sub-speciality also occupying some of the beds. Even the single units of medicine & surgery etc. are also not at one place together. They are spread out in different floors and different wards.

(v) Clinical material:

Daily average out patient of all the hospitals is between 1608 to 1890 for the year 2000. The minimum attendance required for 250 admissions is around 2000.

Bed occupancy:

Average bed occupancy for the year 2000 has been between 65% to 73% of all the hospitals whereas the required bed occupancy is 80%.

(vi) Clinical postings:

Clinical postings of the students are not as per MCI norms. Still they are posted in the sub-speciality of Urology, Cardio-thoracic Surgery, Plastic Surgery, Nephrology and Oncology. They need to be posted in the department of General Surgery and General Medicine.

(vii) Casualty & Medico-legal services:

The number of medico-legal postmortems i.e. 174 only continues the same as has been noted in the previous inspection report (May,98). This is inadequate for 250 admissions. Two postgraduate students (residents) are posted by rotation once in a fortnight for 24 hours continuance duty. This arrangement is not adequate. Regular full time casualty Medical Officer needs to be posted in the casualty. The postgraduate students then can be posted with the casualty Medical Officer for learning under the overall supervision of the casualty incharge.

(viii) Teaching facilities:

Though some improvement has taken place, however, proper examination cubicles for various disciplines capable of accommodating 10-15 persons apart from the clinician and the patients should be made available. Each clinical department should have enough staff rooms for the sanctioned strength of staff, seminar-cum-departmental library rooms and departmental offices etc.

(ix) At present the institution has two peripheral health centres i.e. 1. Dr. TMA Pai Rotary Hospital, Karkala and (2) Rural Maternal and Child Welfare Home. However, as per requirement of the MCI, the institution should have 3 Rural Health Centres with residential facilities for the stay of interns and one Urban Health Centre. The total period in the Community Medicine at present is two months for internship training instead of the required 3 months. One month of Community Medicine internship posting is being given to Paediatric at present which is not as per MCI norms.

(x) The practical labs of Physiology, Histology and pharmacology remains the same as has been noted in the last inspection report. These labs are required to be enlarge to accommodate 125-140 students.

(xi) Staff shortage:

Professors – 3 (Forensic Medicine – 1, Ophth.-1, Radio-Diag.-1)

Readers – 5 (Forensic Medicine –1, TB & Chest – 1, General Surgery –2, Radio-Diag.-1)

Asstt.Prof./Lecturer – 1 (Forensic Medicine –1)

III. Other observations/deficiencies pointed out in the inspection report.

Noting the above deficiencies in the infrastructure facilities and he observations regarding the admissions made at the college in excess of the NRI quota fixed by the Hon'ble Supreme Court at 15% and also that all the NRI/foreign students selected against this college and Kasturba Medical College, Mangalore are being placed at Kasturba Medical College, Manipal for their entire MBBS course which is in total violation of the orders of the Hon'ble Supreme Court and further that seats in the NRI quota at Kasturba Medical College, Manipal have been increased to 50%, the Executive Committee decided to issue show cause notice to the college authorities as to why steps be not initiated for recommending taking action u/s 19 of the Indian Medical Council Act,1956 to the Central Government. The authorities be advised to respond within a period of one month to this show cause notice failing which necessary action as deemed fit will be initiated.

47. **MBBS (MAHE, Deemed University) – Continuance of recognition in respect of students being trained at Kasturba Medical College, Mangalore.**

Read : The compliance verification inspection report (10<sup>th</sup> & 11<sup>th</sup> Jan., 2001) for continuance of recognition of MBBS degree granted by MAHE Deemed University.

The Executive Committee considered the compliance verification inspection report (10<sup>th</sup> & 11<sup>th</sup> Jan.,2001) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the periodical inspection report (May,1998) and noted the following:-

I. That out of the total admissions being made at Kasturba Medical College, Manipal and Kasturba Medical College, Mangalore 25% of the seats are being filled up with NRI/Foreign quota and the remaining 75% under the general category quota. Further all the students admitted against NRI/foreign quota of both the colleges are being placed at Kasturba Medical College, Manipal for the entire MBBS course. The general category candidates admitted against the Kasturba Medical College, Manipal are being sent to the Mangalore medical college for the entire MBBS course in lieu of the NRI/foreign quota admitted against the Mangalore Medical College. Thus the admissions against NRI/foreign quota fixed as 15% by the Hon'ble Supreme Court is being violated by the institution. Moreover, the number of admissions made against the NRI/foreign quota has been exceeded in the year 2000-2001 beyond the 25% i.e. 26.2%. Further, approximately 50% of the total seats are being filled up by the NRI/foreign students each year at Kasturba Medical College, Manipal which is also a total violation of the NRI quota fixed by the Hon'ble Supreme Court for one particular medical college. To quote an example out of the total 248 admissions made at the college during the year 1999-2000 at Kasturba Medical College, Manipal, 134 students belonged to general category and 114 belonged to NRI/foreign quota.

II. The following deficiencies still persist:-

(i) Lecture theatres:

None of the lecture theatres available can accommodate more than 150 students. This means no lecture theatre can accommodate the total number of students admitted every year i.e. 250.

The students have to be divided into two batches for even didactic lecture. This is not congenial for uniformity in teaching.

According to the MCI norms the college should have 3 lecture theatres with sitting capacity of 350 to 500 and one with sitting capacity for 700 to 800 students.

(ii) Beds & Units:

The units in relation to Psychiatry with 10 beds in Wenlock District Hospital and 25 beds in KMC Hospital, Attavar are not as per MCI norms. Similarly there are 15 neonatal beds in Govt. Lady Goschan Hospital and 15 beds in of Obst. & Gynec. in University Medical Centre which are also not at one place, are not as per MCI norms.

(iii) **Staff Rooms:** In Govt. hospitals the staff rooms are not available as these hospitals are short of space. In the Attavar Hospital some staff rooms have now been made available. Similarly some staff rooms have been provided in the University Medical Centre. However, still about 30% of the clinical staff members are without staff rooms in these two hospitals. The **clinical departments** should be provided with centralised office space having staff rooms, departmental office, seminar room, departmental library and postgraduate research lab wherever required.

(iv) Clinical Material:

Average daily out patient attendance and average daily bed occupancy for the year 2000:-

From the above, the total OPD attendance per day of all the hospitals comes to about 942-1033 against the daily requirement of 2000 patients and the bed occupancy is also much less than the required 80%.

(v) **Teaching facilities:** The teaching facilities in Govt. hospitals are grossly inadequate because most of the OPDs. are single room affair.

(vi) Casualty and medico-legal department:

Two postgraduate students (Residents) are posted by rotation once in a fortnight for 24 hrs. duty in the casualty. This arrangement is not adequate. Regular full time casualty Medical Officer need to be posted in the casualty. The postgraduate students than can be posted with the

casualty Medical Officer for learning under the overall supervision of the Medical Officer incharge of the casualty.

Only Govt. Wenlock District Hospital is allowed to conduct medico-legal postmortem. Last year about 670 medico-legal postmortems were conducted which are grossly inadequate for 250 admissions.

(vii) **Clinical laboratories :**

The clinical laboratories in Govt. Hospitals, KMC Hospital and TMA Pai Hospital are only doing basic routine investigation.

Only in University Medical Centre facilities for specialised investigation are present. Efforts should be made to have these investigations in all hospitals for prompt and proper patient care and students teaching. These labs should not be used only as collection centre.

(viii) **Central Sterilization:** The Govt. hospitals do not have any central sterilization section available.

(ix) **Central laundry :** Mechanised laundry atleast in one of the hospitals owned by the institution should be provided.

(x) **Pre and para clinical departments:**

Most of the laboratories can accommodate only 50-60 students.

The size of the laboratories should be increased to 120 to 150 sitting capacity as required under MCI norms for 250 admissions.

(xi) **Staff shortage:**

Paediatric-1, TB & Chest – 1, Radio-

(xii) Adequate ratio between medical and non-medical staff has not been maintained in Physiology, Biochemistry and Microbiology.

III. Other observations, remarks and deficiencies are noted in the report.

Noting the above deficiencies and the observations regarding making admissions against the NRI quota against this college over & above the 15% quota fixed by the Hon'ble Supreme Court and also that the students admitted against NRI/foreign quota of this college are being placed at Kasturba Medical College, Manipal, the Executive Committee decided to issue a show cause notice to the college authorities as to why steps be not initiated for reducing the number of seats in consonance with the infrastructure facilities available at Kasturba Medical College, Mangalore. The authorities be advised to respond to the show cause notice within a period of one month for further consideration in the matter.

48. **Appointment in the Council office.**

The Executive Committee noted and approved the following appointments made in the Council office during the year 2000.

49. **Extension to Dr. J.K. Tandon as Whole-time Inspector in the Council office on consolidated salary.**

Read : The matter with regard to extension of the services of Dr. J.K. Tandon on consolidated salary.

The Executive Committee noted that the post of Whole-time Inspector in the Council office though has been advertised on two three occasions could not be filled up because of non-availability of a suitable person for this post. The Committee further noted that the post has again been advertised and the applications to that effect have been received. The process for filling up of this post is in progress. However, taking into consideration the work load of inspections, the Committee decided to grant extension of service to Dr. J.K. Tandon as Whole-time Inspector on a consolidated salary w.e.f. 01.02.2001 for a further period of six months or till the new incumbent joins whichever is earlier.

50. **Extension to Dr. R.D. Bansal as Whole-time Inspector in the Council office on consolidated salary.**

Read : The matter with regard to extension of the services of Dr. R.D. Bansal on consolidated salary.

The Executive Committee noted that a post of Whole-time Inspector has been advertised and the applications to that effect have been received. The process for filling up of this post is in progress. However, taking into consideration the work load of inspections, the Committee decided to grant extension of service to Dr. R.D. Bansal as Whole-time Inspector on a consolidated salary w.e.f. 01.04.2001 for a further period of six months or till the new incumbent joins whichever is earlier.

51. **Extension to Dr. D.S. Dubey as Whole-time Inspector in the Council office on consolidated salary.**

Read : The matter with regard to extension of the services of Dr. D.S. Dubey on consolidated salary.

The Executive Committee noted that Dr. D.S. Dubey had been appointed as whole-time inspector on regular pay scale on the recommendation of the Selection Committee duly approved by the Council for a period of one year w.e.f. 19.01.2000 which has expired on 18.1.2001. However taking into consideration the work load of inspections, the Committee decided to grant extension of service to Dr. D.S. Dubey as Whole-time Inspector for another one year on regular pay scale.



52. **Extension to Shri R. Srinivasan, Co-ordinator, Medical Education Unit of the MCI on consolidated salary.**

The Executive Committee ratified the action taken by the President of the Council to extend the services of Shri R. Srinivasan, in the Medical Education Unit of the MCI for a further period of six months from 16.12.2000 to 15.06.2001 to co-ordinate the various activities relating to medical education.

53. **Extension to Shri A.S. Rahi, Deputy Secretary in the Council office.**

Read : The matter with regard to extension of services of Shri A.S. Rahi, Deputy Secretary (non-medical) in the Council office.

The Executive Committee noted that extension of service to Shri A.S. Rahi, Deputy Secretary (non-medical) for a period of one year w.e.f. 01.04.2000 was granted earlier. Seeing the work load of the legal cases and other activities in the Council and also noting the fact that two Deputy Secretaries (Medical) have resigned and left and the process is on for filling up these posts, decided to grant extension for a further period of one year on expiry of the previous term to Shri A.S. Rahi, Deputy Secretary (Non-medical) in the Council office.

54. **Computer Education – Undergraduate courses – Compulsory - Starting postgraduate courses.**

Read : The letter dated 18.1.2001 received from Dr. K. Ananda Kannan, Vice-Chancellor, The Tamil Nadu Dr. M.G.R. Medical University, Chennai inclusion of computer education/learning to the existing curriculum for medical graduates and for starting of postgraduate degree course in M.D.(Medical Informatics).

The Executive Committee considered the letter dated 18.1.2001 received from Dr. K. Ananda Kannan, Vice-Chancellor, The Tamil Nadu Dr. M.G.R. Medical University, Chennai inclusion of computer education/learning to the existing curriculum for medical graduates and for starting of postgraduate degree course in M.D.(Medical Informatics). The Committee appreciated the idea/suggestion given by Dr. Ananda Kannan, however did not agree for inclusion of the same to the existing curriculum for the time being and for starting of postgraduate course in M.D.(Medical Informatics).

55. **Nomenclature of the medical colleges/institutions in the country – Letter of Dr.S.K. Mittal, Member, MCI.**

Read : The letter dated 17.1.2001 received from Dr. S.K. Mittal, Member, MCI regarding nomenclature of the medical colleges/institutions in the country.

The Executive Committee considered the letter dated 17.1.2001 received from Dr. S.K. Mittal, Member, MCI regarding nomenclature of the medical colleges/institutions in the country and decided that MCI has no role to play regarding the nomenclature to be adopted by the applicant authorities for naming the medical colleges which they wish to establish.

56. **Establishment of new medical college at Sullia, Karnataka by Academy of Liberal Education ®, Sullia, Karnataka – Permission regarding.**

Read : The letter dated 5.01.2001 received from the Central Govt., Ministry of Health with regard to establishment of new medical college at Sullia, Karnataka by Academy of Liberal Education ®, Sullia, Karnataka.

The Executive Committee noted that matter with regard to establishment of new medical college at Sullia, Karnataka by Academy of Liberal Education ®, was considered by it at its meeting held on 24.10.2000 where it was decided to inform the Central Govt. that the applications where the applicant do not possess single piece of land as required under the Qualifying Criteria cannot be considered by the Council. The Committee also noted that this decision was communicated to the Central Govt. vide Council office letter dated 13.11.2000 and in response to that reference, Central Govt. vide its letter dated 5.01.2001 has informed that the proposal of Academy of Liberal Education ®, Sullia, Karnataka was received in Feb.,2000 i.e. prior to enforcement of MCI regulations of 1999. The Central Govt. has further informed that new regulations may not be applied to old cases.

The Committee deliberated in the matter and decided to reiterate its earlier decision already communicated to the Central Govt. that the applications where the applicant do not possess the single piece of land for starting the medical college as required under the Qualifying Criteria cannot be considered.

57. **News items appearing in the important dailies being published through out the country on the functioning of the Council – Regarding.**

The Executive Committee noted that certain news items appeared in the Indian Express, the Times of India, the Asian Age etc. on 8<sup>th</sup> & 9<sup>th</sup> December,2000 which had the origin from the PTI in connection with certain reports indicating certain observations perpetrated to have been made by the Delhi High Court against the Council. The Committee also noted that certain vested interests misused these news items and exploited them in damaging the reputation of the Council as a whole.

The Committee further noted that a petition by MCI was filed before the Hon'ble High Court of Delhi for passing an appropriate order clarifying the correct position. This petition came up for hearing before the same bench of Hon'ble High Court on 10.1.2001 where the Hon'ble Court was pleased to pass the following order :-

“CM 400/2001 in CW 2276/2000

It is clarified that this court did not pass any order or gave any findings as may form the basis of alleged press reports annexed with the application.

The application stands disposed off.”

The Committee appreciated the efforts put in by the President, MCI for redeeming the fame of the Council.

The Executive Committee at its meeting held on 22.01.2001 considered the Council Inspectors report (20<sup>th</sup> & 21<sup>st</sup> Nov., 2000) carried out to verify the compliance received from the Dean, Bharati Vidyapeeth Medical College, Dhankawadi on rectification of the deficiencies pointed out in the periodical inspection report (Feb., 2000) along with the standard of examination held by Bharati Vidyapeeth (Deemed University) for recognition of the college for the award of MBBS degree granted by the Deemed University and continuance of recognition of MBBS degree and it was decided as under:-

“The Executive Committee noted that Bharati Vidyapeeth Medical College, Dhankawadi, is recognised by the MCI for the award of MBBS degree under Pune University and further that from the year 1996-97 the college has been affiliated to Bharati Vidyapeeth (Deemed University) which will be awarding the degree to the candidates who have passed their final MBBS examination in Nov.,2000.

As MBBS degree granted by Pune University in respect of students being trained at Bharati Vidyapeeth Medical College, Dhankawadi is already recognised and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956, the Committee decided to recommend that MBBS degree granted by Bharati Vidyapeeth (Deemed University) in respect of students being trained at the above said medical college be recognised and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 being change of affiliation of the University keeping in view the following decision taken by the Executive Committee at its meeting held in June,1998:-

“No inspection is required where there is change of name and change of affiliation of the University or the college whose medical qualifications are already recognised and included in the 1<sup>st</sup> Schedule to the I.M.C. Act,1956 unless the Executive Committee decides otherwise.”

The Executive Committee further considered the inspection report (20<sup>th</sup> & 21<sup>st</sup> Nov.,2000) carried out for verification of the compliance submitted by the authorities of Bharati Vidyapeth Medical College, Dhankawadi on the deficiencies pointed out in the periodical inspection report (Feb.,2000) and noted the following:-

1. The Central library is short of books and is subscribing to lesser number of journals. After five years, the number of books required in the central library for 120 annual admissions are 8200 whereas the institutional library has only 7613. The library is subscribing to only 64 journals against the requirement of 100 per year under the Council regulations.
2. The rural health training centre at Sonapur is in poor shape and require repairs.

3. The institution is having 7 operation theatres against the requirement of 10. There are no fixed days for any surgical units and the total working is haphazard which interferes with regular and proper teaching of the students.
4. The incinerator has not been installed as yet.
5. The residential accommodation available for resident doctors is inadequate.
6. Clinical material available is inadequate for 120 annual admissions.

The average OPD attendance per day is 200, the average bed occupancy is 65-70%, the total major surgeries performed are 3-4 per day and the number of normal deliveries conducted per month are only 45-50.

7. Shortage of Staff:

Assoc. Prof./Reader-4; (Physiology-1, Pathology-2, Forensic Medicine-1)  
Asst. Prof./Lecturer-5; (Anatomy-4, Biochemistry-1)  
Tutor/Demonstrator/Registrar-2; (Microbiology-1, Anesthesia-1)  
Junior Residents-12; (Pediatrics-4, TB & Chest-2, Skin & STD-1, Psychiatry-2, Orthopedics-1, ENT-2)

Total Shortage: Teaching Staff – 11 out of 171 required.  
Junior Residents – 12 out of 65 required.

8. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Executive Committee decided to issue a show cause notice to the concerned authorities of the institution as to why steps should not be initiated to reduce the number of seats in consonance with the facilities available at the college and further decided to give one month's time to the institution to respond to the show cause notice. Copy of the letter sent to the authorities be marked to the Chief Secretary, Secretary (Health), Director of Medical Education, Registrar of the University, Member of the Council representing the State and the Central Govt."

The matter along with the above recommendations of the Executive Committee is placed before the General Body of the Council for its consideration and approval.

The Executive Committee noted that a post of Whole-time Inspector has been advertised and the applications to that effect have been received. The process for filling up of this post is in progress. However, taking into consideration the work load of inspections, the Committee decided to grant extension of service to Dr. R.D. Bansal as Whole-time Inspector on a consolidated salary w.e.f. 01.04.2001 for a further period of six months or till the new incumbent joins whichever is earlier.

The Executive Committee noted that Dr. D.S. Dubey had been appointed as whole-time inspector on regular pay scale on the recommendation of the Selection Committee duly approved by the Council for a period of one year w.e.f. 19.01.2000 which has expired on 18.1.2001. However taking into consideration the work load of inspections, the Committee decided to grant extension of service to Dr. D.S. Dubey as Whole-time Inspector for another one year on regular pay scale.

Subject:- **Deletion of column ( I ) i.e. “requisite recognised postgraduate qualification in the subject” against the post of Assistant Professor/Lecturer in the Deptt. of Dentistry in the MCI Regulations on Minimum Qualifications for Teachers in Medical Institutions, 1998.**

The Executive Committee at its meeting held on 22.01.2001 considered the matter with regard to deletion of column ( I ) i.e. “requisite recognised postgraduate qualification in the subject” against the post of Assistant Professor/Lecturer in the Deptt. of Dentistry in the MCI Regulations on Minimum Qualifications for Teachers in Medical Institutions, 1998 and decided as under:-

“The Executive Committee considered the matter with regard to deletion of column ( I ) i.e. “requisite recognised postgraduate qualification in the subject” against the post of Assistant Professor/Lecturer in the Deptt. of Dentistry as prescribed in the MCI Regulations on Minimum Qualifications for Teachers in Medical Institutions, 1998 and decided to recommend to the Council that qualifications and teaching experience for various posts in the department of Dentistry should be as per the qualifications & teaching experience prescribed by the Dental Council of India in its Regulations which are as under:-

**MINIMUM BASIC QUALIFICATION AND TEACHING EXPERIENCE  
REQUIRED FOR TEACHERS FOR UNDERGRADUATE DENTAL STUDIES**

1. Professor: A BDS degree of an Indian University or an equivalent qualification with postgraduate qualification in the subject and with 5 years teaching experience after the postgraduate qualification as Reader.

However, for the purposes of teaching Oral Anatomy and Histology, Dental Materials and Community Dentistry a candidate with BDS or equivalent qualification with 10 years teaching experience in that subject may be considered for

the post of a Reader till such time postgraduate training facilities in this subject is available in our country. However, such a candidate without post-graduate qualification cannot be considered for the post of a Professor.

2. Associate Professor: A BDS degree of an Indian University or an equivalent qualification with postgraduate qualification in the subject and with 3 years teaching experience as Reader after he gets his postgraduate qualification.

3. Readers: A BDS degree of an Indian University or an equivalent qualification with postgraduate qualification in the subject and with 3 years teaching experience after postgraduation in the subject of specialisation.
4. Lecturer: A recognised BDS degree of an Indian Univ. or an equivalent qualification with 6 months experience as House-Surgeon.
5. House-Surgeons: A recognised BDS Degree of an Indian University or an equivalent qualification.”

The above recommendations of the Executive Committee are placed before the General Body of the Council for its consideration and approval.

28. **Graduate Medical Education Regulations – Supplementary examination regarding.**

Read : The matter regarding permitting the students who have passed the supplementary examination of phase I to join the main batch for 2<sup>nd</sup> phase of MBBS in view of the clause 7(7) of the Graduate Medical Education Regulations, 1997.

The Executive Committee noted that it at its meeting held on 2.2.2000 on considering the letter dated 21.1.2000 received from the Dean, Pt. J.N.M. Medical College, Raipur regarding permitting 18 students passing the supplementary examination of phase I, to join the main batch had decided that students passing the supplementary examination should not be allowed to join the main batch for the next phase but will have to undergo the full period of training for the 2<sup>nd</sup> phase and so on.

It further noted that as per the Council instructions the medical college had not allowed students who had passed the supplementary examination in first MBBS held in Dec., 1999 to join the main batch for 2<sup>nd</sup> phase of MBBS. A number of students had filed writ petition in the M.P. High Court, Jabalpur against the above decision of the Executive Committee requesting for placing them in the main batch for the 2<sup>nd</sup> MBBS IInd phase.

The Committee reconsidered the matter and decided to recommend to the General Body of the Council to delete the clause 7(7) as contained in the Council Regulations on Graduate Medical Education, 1997 which reads as under:-

“7(7) Supplementary examination may be conducted within six months so that the students who pass can join the main batch and the failed students will have to appear in the subsequent year.”

20. **Removal of the name of deceased person from the Indian Medical Register.**

Read : The matter with regard to cancellation of registration from I.M.R. in respect of Dr. Atma Ram Sharma registered in Rajasthan Medical Council under registration No. 1346.

The Executive Committee noted letter dated 21.11.2000 received from the Registrar, Rajasthan Medical Council, Jaipur intimating that Dr. Atma Ram Sharma, registration No. 1346, has expired and hence, his name has been erased from the register of the Registered Medical Practitioners.

31. **Removal of name of deceased person from the Indian Medical Register.**

Read : The letter dt.9/1/2001 received from the Registrar, Rajasthan Medical Council intimating that Dr. Govind Lal Mathur who was registered with that Council has expired 4/1/2001 and his name has been erased from the Register of the Registered Medical Practitioners.

The Executive Committee noted the letter dated 09.01.2001 received from the Registrar, Rajasthan Medical Council, Jaipur intimating that Dr. Govind Lal Mathur, registration No. 101, has expired and hence, his name has been erased from the register of the Registered Medical Practitioners.
