1. (a) **Minutes of the meeting of the Executive Committee held on 31.1.2002 – Confirmation of.**
- (b) **Minutes of the meeting of the Executive Committee held on 31.1.2002 – Action taken thereon.**

It was decided that the minutes of the meeting held on 31.1.2002 be recorded correctly as per the observations already made in the meeting of the Executive Committee held on 18.2.2002 and the action taken report on the corrected minutes be brought before the next meeting of the EC.

2. **Minutes of the meetings of the Executive Committee held on 18.02.2002 and 04.03.2002 – Confirmation of.**

Minutes of the meeting of the Executive Committee held on 18.02.2002 and 04.03.2002 which were declared illegal by the Administrator were confirmed by the General Body of the Council at its meeting held on 30th April/1st May,2002 where it was also resolved that the recommendations of the Executive Committee made in these two meetings be approved for execution of the orders.

3. Minutes of the meeting of the Executive Committee held on 24.04.2002 – Confirmation of.

The minutes of the last meeting of the Executive Committee held on 24.04.2002 were confirmed with the following modifications:-

1. Page – 1 para 3 i.e. “but the Administrator stated that he was not aware of these fact.” The Committee decided to delete this line.
2. On page 3 para 1 the last two lines reading as “However, it was informed that the statements of the Administrator are being challenged by some members in the court” were deleted in light of the fact that one of the members clarified that the application has not been filed in the court challenging the statements of the Administrator, but the application has been moved requesting the Hon’ble Court to get impleaded as one of the party in the matter.
3. On page 4 in para 2 last lines reading as “The Administrator said that he had a bitter experience of their meeting on 18.2.2002 and declaring their tape recording/listening session as Executive Committee” were objected to by the members and request was made to delete these lines stating that there was nothing to cause the bitter experience. However, deletion of these lines was not agreed upon by the Administrator.
4. Page 4 para 4 the line reading as “Administrator informed that he has filed an IA before the Hon’ble Supreme Court.”

The matter with regard to bearing the charges on the IA filed by the Administrator was discussed when the Executive Committee unanimously resolved that as the Council and Executive Committee were not taken into confidence by the Administrator before filing any IA and further that the Administrator is defending himself and not the Council by the Advocates engaged by him, the legal expenses incurred on defending this IA, will be borne by the Administrator himself and not by the Council.

The Administrator, however, recorded his note of dissent on the above resolution and clarified that all such cases filed by him are in the capacity of Administrator of the MCI and there are no personal or private cases involved. All the legal fees of the professionals are to be paid by the MCI as a part of the pre-requisite as spelt out in the judgement of the Hon’ble Delhi High Court dated 23.11.2001.

The members of the Committee, however, did not agree with the above statement of the Administrator and reiterated that since the Administrator is defending himself through this IA and not the MCI before the Hon’ble Supreme Court, the legal expenses incurred on this IA shall be borne by the Administrator himself and not by the MCI.

5. Page 7 point No. 5 & 6 regarding appointment of Inspectors for the medical college(s) Karimnagar and Kuppam : The Administrator pointed out that in the meeting of the EC on 24.4.2002, the Committee appointed inspectors only for inspection of medical college at Karimnagar and medical college at Kuppam while there were many more colleges where inspectors were to be appointed.

The members took objection to the above statement that only two colleges were picked up for appointment of inspectors whereas the fact was that in action taken report it was informed that the compliance has been received and inspectors are being appointed/appointed by the Administrator. As per the decision taken by the Executive Committee that the Inspectors will be appointed by the EC itself as per the regulations and that wherever the inspections have not been carried out however, inspectors have been appointed by the Administrator the list be provided to the EC for changing the inspectors appointed by the Administrator and further that the names of these two colleges were in front them under action taken report the inspectors were appointed by the Committee.

Dr. Usha Sharma who was authorised by the Council on behalf of the Executive Committee expressed her inability to take up this assignment in future. It was decided that Dr. P.C.Kesvankutty Nair, Vice-President of the Council be requested to provide the names of the Inspectors out of the list provided wherever there is a need to change any inspector at the last moment due to unavoidable circumstances and also in an emergent situation.

6. On page No. 8 para 2 “Administrator observed that the procedure-----
-----laid down procedure”.

The members objected to the above statement and unanimously resolved to condemn strongly the Administrator and Secretary for distorting and writing false facts in the minutes which action maligns the image of members of the Executive Committee to a great extent.

The members opined that the minutes were dictated in the meeting itself because of the previous experience of distortion of facts which took place while recording the minutes of meeting held on 31.1.2002 inspite of audio tapes being readily available with the office.

7. On page No. 9 point 14 reading “Administrator informed the members-----members themselves”. It was decided that this point be deleted which was agreed upon by the Administrator.
8. On page No. 23 under the item No. 21 pertaining to renewal of the permission for admission of 5th batch of students at Rangraya Medical College, Kakinada. Under point No. 9 the following be deleted/expunged as it is not under the purview of the Inspector to make suggestions contrary to the regulations:-

“However it is strongly suggested that to begin with, at least, 50% of the clinical staff should be fulltime.”

9. Page 26 – The minutes recorded under the Item No. 27: **Establishment of new medical college at Karakonam, Kerala by CSI South Kerala Medical Mission, Kerala u/s 10A of the IMC Act,1956 - last para reading** “The Administrator informed the members that he had gone as an Administrator to verify the details along with an Inspector which is very much part of his authorised duties.”

The members did not agree and approve the above statement of the Administrator as according to them once he has accompanied the other inspector i.e. Dr. J.K. Tandon for this inspection he was part of the inspection team.

4. Minutes of the last meeting of the Executive Committee – Action taken thereon.

The Executive Committee noted the action taken by the office on the various items included in the minutes of the last meeting held on 24.04.2002 with following modifications:-

1. Page 4 para 2 “The members of the Executive Committee -----in the next meeting of the Executive Committee.”

As no action has been taken by the Administrator, the Executive Committee members after certain discussion opined unanimously that the Administrator should write a letter to CBI apprising regarding the whole case requesting them to investigate the facts of the case. Administrator agreed to take up the matter with CBI.

2. Page 7 point No. 3 – “The Committee-----will be paid by the Administrator”

Under the action taken report it was only recorded ‘noted’.

The Executive Committee informed that the matter was also discussed in the General Body meeting held on 30th April/1st May,2002 where the decision taken by the Executive Committee that “the lawyers who were appointed by the Administrator will not be paid by the Council and will be paid by the Administrator”.

The Committee directed the Secretary to write a letter in this reference to the Administrator and to the Govt. of India and further decided to recover the fees paid to the lawyers engaged by the Administrator in personal capacity..

The Committee appointed a Committee comprising of following members to make a panel of Advocates and the panel so drawn out be placed before the next meeting of the Executive Committee:-

1. Dr. Ved Prakash Mishra
2. Dr. Kesvankutty Nair
3. Dr. D.K. Sharma

The Committee also decided that the office may provide a list to the Committee mentioning details of fees paid to Shri Maninder Singh per case during the last 5 years along with the expenditure incurred on the Advocates engaged by the Administrator.

Administrator, however, recorded his note of dissent. He stated that there are no personal or private cases being filed by him. All cases are being filed as Administrator of the MCI and in pursuance of the directions of the Hon'ble Delhi High Court under which he has been appointed.

Administrator enquired from the members about the rule regarding action to be taken by the office on the minutes of the meeting. He was informed that according to regulations in case no correctness/suggestions are received from the members within 15 days of the despatch by the Secretary, the decision recorded there in shall be given effect to.

It was also informed that as per the existing practice the matters which were of urgent nature, decisions pertaining to those were being communicated to the Central Govt./authorities concerned immediately.

It was decided that the matters requiring urgent attention i.e. pertaining to court cases etc. or where the Executive Committee has decided in the meeting itself that the action be carried out, decisions will be communicated to the concerned authorities otherwise all minutes will be given effect to as per the provisions of the regulations.

3. On page 7 point No. 4: "The Executive Committee had also -----
-----rules and regulations.

Under action taken report it was mentioned that "Letter not sent as per the directions of the Administrator".

The Executive Committee took a serious objection for not withdrawing the letter dated 20.1.2002 addressed to the members of the inspection team inspite of repeated directions. It was directed that the letter of withdrawal be sent immediately.

The Administrator agreed and directed the office to send the letter.

Deferred Items of the Executive Committee meeting held on 24.04.2002

29. Continuance of recognition of MBBS degree granted by NTR University of Health Sciences in respect of students being trained at Deccan Medical College, Hyderabad.

Read : The letter dt. 14.2.2002 received from the Managing Director Deccan college of Medical Sciences for continuance of recognition of MBBS degree granted by NTR University of Health Sciences in respect of students being trained at Deccan Medical College, Hyderabad.

The Executive Committee considered the matter with regard to continuance of recognition of MBBS degree granted by NTR University of Health Sciences, Vijayawada in respect of students being trained at Deccan College of Medical Sciences, Hyderabad along with the latest list of the teaching staff furnished by the College authorities vide letter dated 21.05.2002 and noted that most of the deficiencies with regard to the teaching staff have been removed which work out to be less than 5%.

As the last inspection of the college was conducted in August,1999, i.e almost three years back, the Committee decided to carry out fresh inspection to asses the infrastructural facilities available at the college for teaching and training of 150 students as per the MCI norms. The Committee appointed following inspectors for the same:-

1. Dr. C.A. Desai, Ahmedabad
2. Dr. Ananda Kannan, Chennai
3. Dr. Chandanwale Ajay, Mumbai.

30. Continuance of recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur.

Read : The matter with regard to Continuance of recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur.

The Executive Committee considered the matter with regard to Continuance of recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur and noted the following:-

1. Periodical inspection for continuation of recognition of MBBS degree was carried out by the Council in Oct.,1995.

2. As no compliance regarding rectification of the deficiencies pointed out in the inspection report was received inspite of sufficient time given to the college authorities, the General Body at its meeting held on 17.3.1998 decided to represent to the Central Govt. to withdraw the recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at BRD Medical College, Gorakhpur u/s 19 of the Indian Medical Council Act,1956 in view of the gross deficiencies pointed out in the over all infrastructural facilities.
3. The decision of the General Body was communicated to the Central Govt. on 28.04.1998 and accordingly the Central Govt. requested the Govt. of U.P. to obtain explanation of the Gorakhpur University and BRD Medical College, Gorakhpur, on the recommendations of the Council as per provisions of Section 19 of the I.M.C. Act,1956.
4. The Central Govt. vide their another letter dated 20.11.1998 forwarded the compliance report submitted by the college authorities and requested the MCI to carry out the fresh inspection of the college.
5. In light of the Central Govt.'s letter inspection of the college was carried out on 14th & 15th Oct.,1999 and the inspection report was considered by the Executive Committee at its meeting held on 04.11.1999.
6. Upon consideration of the inspection report, the Committee noted that the college was admitting 105 students each year against the approved intake of 50 students in violation of the Regulations of the Council. It also noted the gross deficiencies with regard to the teaching staff even for 50 annual admissions and the gross deficiencies in over all infrastructural facilities including teaching beds.
7. In view of above, the Committee decided to reiterate the decision taken by the General Body to withdraw the recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at BRD Medical College, Gorakhpur. The Committee further decided to direct the college authorities to stop admissions in the postgraduate medical courses which were being conducted by the institution.
8. The decision of the Executive Committee was communicated to the Central Govt. vide MCI letter dated 26.11.1999 and the Central Govt. requested the then Secretary, Medical Education, Govt. of U.P. to take appropriate steps to rectify the deficiencies within 3 months and to send a compliance to that effect to MCI under intimation to the Ministry so as to avoid possible de-recognition of the institution.

9. In response to above, the Govt. of U.P. informed the Central Govt. that they had decided that the medical colleges in UP shall admit the number of students as determined by the MCI for MBBS course. They further informed that the process of giving autonomy to the medical colleges in U.P. is almost complete and facilities will be developed by the colleges to ensure that they fulfil the minimum requirements of medical colleges prescribed by the Council.
10. The matter was again considered by the Executive Committee at its meeting held on 26.05.2000 and the Committee gave six months time to the institution to rectify the deficiencies pointed out in the inspection report for 50 (fifty) admissions
11. Six months time as granted by the Executive Committee on 26.05.2000 have already been over and no compliance has been received from the college authorities inspite of a D.O. letter dated 11.4.2002 sent to the Secretary, Medical Education, Govt. of U.P. requesting to personally intervene in the matter and direct the authorities to send the compliance.

Noting all the above mentioned facts, the Committee decided to reiterate the decision representing to Central Govt. to withdraw the recognition of MBBS degree granted by Gorakhpur University in respect of students being trained at B.R.D. Medical College, Gorakhpur w.e.f. the academic session 2002-2003.

31. MBBS(Devi Ahilya Vishvidyalaya) – Continuance of recognition in respect of students being trained at M.G.M.Medical College, Indore.

Read : The matter with regard to continuance of recognition of MBBS degree granted by Devi Ahilya Vishvidyalaya in respect of students being trained at M.G.M.Medical College, Indore.

The Executive Committee considered the matter with regard to continuance of recognition of MBBS degree granted by Devi Ahilya Vishvidyalaya in respect of students being trained at M.G.M.Medical College, Indore and noted the following:-

1. Periodical inspection for continuance of recognition of MBBS degree was carried out in Feb.,1998.
2. The inspection report was considered by the Committee on 16.3.1998 where the Committee noting the deficiencies with regard to teaching staff did not recommend continuance of recognition of MBBS degree and gave 3 months time to the institution to send a compliance report.

3. The compliance received from the college authorities was again considered by the Committee at its meeting held on 23.3.1999 where the Committee noted that the deficiency of staff still persists for the present number of admissions being made by the college i.e. 140 students.
4. The Committee decided to issue a show cause notice to the concerned authorities as to why steps should not be initiated to reduce the number of seats in consonance with the facilities available. The Committee gave one month time to the institution to respond to the show cause notice.
5. The decision of the Committee was communicated to the college authorities on 17.4.1999 in response to which the Dean, of the College vide his letter dated 14.6.1999 furnished the staff list. The same was considered by the Executive Committee at its meeting held on 16.6.1999.
6. Since the Dean had not provided any information pertaining to the staff available for departments of TB & Chest Diseases, Skin & STD, Psychiatry and further that the deficiencies with regard to other staff were still persisting in terms of regulations, 1999 prescribed by the Council in Standard Requirements for a medical college for 150 admissions, the Committee gave 3 months time to the institution to rectify all the deficiencies and send a compliance to that effect.
7. The compliance as received from the college authorities was placed before the EC on 4.11.1999 where it was decided to verify the same by way of an inspection.
8. Inspection to verify the compliance was conducted by the Council on 27th & 28th Sept., 2001.
9. The compliance verification inspection report was considered by the Executive Committee at its meeting held on 16.10.2001 where the Committee noted the following:-

(i) Shortage of staff

Professor – 1 (Anatomy)

Reader – 11 (Anatomy-1, Biochemistry-1, Pathology-2, Micro.-2, Forensic Medicine-2, Gen. Med.-1, Anaes.-1, Radio-Diag.-1)

Lecturers – 12 (Anatomy-1, Biochemistry-1, Pharma.-2, Path.-2, For. Medicine –1, Genl. Med.-3, Dermatology-1, Radio-Diag.-1)

Demonstrator/Senior Resident – 10 (Anatomy-3, Physiology-1, Biochemistry-3, Microbiology-1, PSM-1, Dermatology-1)

Junior Residents –3 (Dermatology-3)

- (ii) Additional shortage of staff due to postgraduate admission requirements:

Reader –9(Anatomy-1,Physiology-1,Pharma.-1,Path.-1,PSM-1, Medicine-2, Anaes.-1, Radio-Diagnosis-1).

Lecturer – 9 (Anatomy-1,Pharmacology-1,Pathology-1, PSM-1, Medicine-3, Anaes.-1, Radio-Diagnosis-1).

Demonstrator – 3 (Anatomy-1, Physiology-1, PSM-1).

- (iii) The shortage of staff for undergraduate requirement was 13% against the permitted 5% and the shortage of staff including postgraduate admission requirements was 19% against the permitted 5%.
- (iv) All the staff of Biochemistry department was non-medical.
- (v) Nine Lecturers had joined the institution on contractual basis for a period of three years in the month of July, August and Sept.,2001 which was not acceptable.
- (vi) There were 53 general duty medical officers working in the hospital. Their designations need to be made teaching designations i.e. Demonstrators/ Registrars/Senior Residents/Tutors.
- (vii) The departments of Skin & STD and TB & Chest Diseases were not separated from the department of Medicine.
- (viii) It was reported that at the time of inspection there was no power in the institution for about 45 minutes and none of the power generators functioned. The inspecting team was informed that there was a daily power cut of two hours in the morning since last two months. The college authorities must ensure uninterrupted electric supply at least to the vital areas and functions by way of providing powerful generators.

10. In view of above, the Committee decided to issue a show cause notice to the concerned authorities of the institution as to why action be not initiated to reduce the number of seats in consonance with the teaching staff available at the college and not complying with the deficiencies as pointed out in the periodical inspection report (Feb.,98) inspite of sufficient time granted to them from time to time. One month's time was again granted to the institution to respond to the show cause notice.

11. In reply, the Dean vide his letter dated 10.1.2002 informed that regarding the shortage of staff in the medical college, Indore all efforts have

been made to fill up the posts. The contractual appointments were made as per Govt. policy and directives.

12. A letter dated 07.01.2002 had also been received from the Director, Medical Education, Govt. of M.P. intimating that they are in continuance process of rectifying the deficiencies with regard to teaching staff in the medical colleges.

Since nothing has been heard after Jan.,2002 and matter for continuance of recognition is pending for more than 4 years, the Executive Committee decided to recommend to the Council to reduce the number of seats from 140 to 100 in 1st MBBS course in consonance with the teaching facilities available at M.G.M. Medical College, Indore from the academic year 2002-2003.

**32. MBBS (Rajiv Gandhi University of Health Sciences)-
Continuance of recognition in respect of students being trained at
Bangalore Medical College, Bangalore.**

Read : The compliance verification inspection report (28th & 29th Nov., 2001) for continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences in respect of students being trained at Bangalore Medical College, Bangalore.

The Executive Committee noted that an inspection to assess the infrastructural and other facilities for training and teaching of 150 students at Bangalore Medical College, Bangalore was carried out by the Council on 24th -26th August,2000.

In view of the various deficiencies detected in the inspection report the Committee at its meeting held on 22.1.2001 decided to issue a show cause notice to the college authorities as to why steps should not be initiated to reduce the number of seats in consonance with the facilities available at the college.

The Committee further considered the compliance verification inspection report (28th & 29th Nov.,2001) carried out on receipt of the compliance on rectification of the deficiencies pointed out in the inspection report (Oct.,2000) and noted that the following deficiencies with regard to teaching staff and other infrastructural facilities still persist:-

1. Shortage of staff:-

Professor – 1 (Psychiatry –1)

Associate Professor – 7 (Physiology-2, Pharmacology-1, Micro.-1, Forensic Medicine –2, PSM –1)

Assistant Professors – 9 (Anatomy –2, Physiology-1, Lecturer in Biophysics –1, Microbiology-1, Forensic Medicine-1, PSM –2, Lecturer cum Epidemiologist –1)

Tutor/Sr. Resident – 17 (Anatomy-5, Physiology-3, Biochemistry-1, Pharmacology-2, Pathology-4, Forensic Medicine-2)

Total – 34.

2. There is also gross shortage of para medical staff for 150 admissions.
3. Appointments to the post of Professors in various departments are made without putting any experience as Associate Professor/Reader which is contrary to the regulations of the Council.
4. The auditorium presently available is not having permanent seats. It is used for conducting examinations. It is not used for indoor games. Minto Ophthalmic Hospital is having its own gallery type auditorium with fixed furniture having 500 seats in the same campus instead of required 750 to 1000 seats.
5. Examination hall is not available with required number of seats i.e. 375. It is having only 80 seats.
6. Adequate accommodation is not available in the hostels for girls and boys. Only accommodation for 391 students is available as against the requirement of 750.
7. Casualty services at Bowering Hospital need to be upgraded to provide adequate equipment for resuscitation and surgical procedures.
8. There is no residency system.
9. There is no CT Scanning facility.
10. Departmentwise deficiencies:

Anatomy department:

- Demonstration room II should be provided 75 to 100 seats with furniture.
- Histology practical laboratory should have 90 workplace.

Physiology department:

- Each practical laboratory should have 90 work place.

Biochemistry department:

- Two demonstration rooms each having 75 to 100 seats are required.

Pharmacology department:

- Demonstration room II should have 75 to 100 seats.
- Each practical laboratory should have 75 to 100 seats.

Pathology department:

- One more practical laboratory for 90 students should be provided.
- Practical laboratory should not be used by Microbiology department.
- Two demonstration rooms each having 75 to 100 seats should be provided.

Microbiology department:

- One more demonstration room having 75 to 100 seats should be provided.
- Student practical laboratory should be commissioned as per Council guidelines immediately.
- Independent museum should be established.

Forensic Medicine Department:

- The departmental library cum seminar room needs to have an independent facility and addition of new books.
- There is no separate research laboratory.
- Office accommodation needs to be provided for junior members of the teaching and non-teaching staff.
- There should be two demonstration rooms each having 75 to 100 seats with furniture.

Preventive and Social Medicine:

- Each demonstration room should have 75 to 100 seats.

11. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Executive Committee decided to recommend to the Council to reduce the number of seats from 150 to 100 in 1st MBBS course in consonance with the teaching facilities available at Bangalore Medical College, Bangalore from the academic year 2002-2003.

33. Continuance of recognition of MBBS degree granted by Bharti Vidyapeeth (Deemed University) in respect of students being trained at Bharti Vidyapeeth Medical College, Dhankawadi, Pune.

Read : The compliance verification inspection report (8th & 9th Nov., 2001 for continuance of recognition of MBBS degree granted by Bharti Vidyapeeth (Deemed University) in respect of students being trained at Bharti Vidyapeeth Medical College, Pune.

The Executive Committee noted that the periodical inspection for continuance of recognition of MBBS degree granted by Bharti Vidyapeeth (Deemed University) in respect of students being trained at Bharti Vidyapeeth Medical College, Dhankawadi, Pune was carried out by the Council Inspectors on 15th-17th Feb., 2000. It further noted that on receipt of compliance on rectification of the deficiencies pointed out in the above inspection report, another inspection to verify the same was carried out on 20th & 21st Nov., 2000 which was considered by it at its meeting held on 22.1.2001.

The Committee in view of the deficiencies pointed out in the inspection report with regard to teaching staff, clinical material and other infrastructure facilities did not recommend continuance of recognition of MBBS degree and decided to issue show cause notice to the concerned authorities as to why steps should not be initiated to reduce the number of seats in consonance with the facilities available at the college and gave one months time to the institution to respond to the show cause notice.

In response to the above show cause notice, the institution authorities forwarded a compliance which was again verified by the Council Inspectors on 8th & 9th Nov., 2001.

The Committee upon consideration of the compliance verification inspection report noted that the following deficiencies with regard to teaching staff and clinical material are still persisting:-

1. Shortage of staff:

Professor – 1 (Paediatrics)

Associate Professor/Reader – 6 (Anatomy-1, Physiology-1, For. Med.-1, Prev. & Social Medicine –1, Radiology –2)

Assistant Professor/Lecturer - 5 (Anatomy-3, Gen. Med.-1, Radiology-1)

Tutor/Demonstrator/Registrar – 7 (Biochemistry-1, Pharmaceutical Chemist –1, Pathology-1, Psychiatry –1, Gen.Surg.-2, Anaesthesia –1)

Total shortage: Teaching staff 19 out of 171 required.

Jr. Residents 12 out of 65 required.

2. The clinical material available particularly the average OPD attendance and average bed occupancy continues to be on the lower side and is inadequate. Against the requirement of daily OPD attendance i.e 960 for 120 annual admissions, it varies from a low of 428 to a high of 479 during the last 3 months.
3. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Executive Committee decided not to recommend continuance of recognition of MBBS degree granted by Bharti Vidyapeeth (Deemed University) in respect of students being trained at Bharti Vidyapeeth Medical College, Dhankawadi, Pune. The Committee further decided to give 3 months time to the institution to rectify the deficiencies pointed out in the inspection report Nov.,2001 and to send the compliance to that effect.

35. Liberalisation of guidelines for establishment of new medical college – Matter raised in Lok Sabha on 8/8/2001 during zero hours by Shri Lakshman Seth M.P. – Regarding.

Read : The matter with regard to liberalisation of guidelines for establishment of new medical college.

The Executive Committee considered the matter with regard to liberalization of guidelines for establishment of new medical college i.e. possession of 25 acres of land, 300 bedded hospital and providing of bank guarantee raised by Shri Lakshman Seth, Hon'ble MP during the zero hours in the Lok Sabha on 08.08.2001.

The Committee did not agree to liberalise the guidelines for establishment of new medical college which have been prepared keeping in view the various aspects which are essential for establishing a proper medical college. These guidelines have been approved by the Central Govt. and notified in the Gazette of India on 28th August,1999.

36. Clarification regarding marks distribution for Surgery including Orthopaedics in the MBBS professional examination – Regarding.

Read : The letter received from Dr.(Mrs.) Usha Sharma, Dean, Faculty of Medicine, Ch.Charan Singh University, Meerut regarding conduct of examination of Surgery as per old regulation till the approval of the Central Govt. is received on the amendment sent by the MCI.

The Executive Committee considered the letter received from Dr.(Mrs.) Usha Sharma, Dean, Faculty of Medicine, Ch. Charan Singh University, Meerut intimating therein that as per the earlier regulations, the subject of Surgery was allocated 400 marks including 100 marks for Orthopaedics leaving behind 300 marks for Surgery paper. However, in the new regulations (Graduate Medical Education Regulations, 1997), the total number of marks allocated to the subject of Surgery has been reduced to 300 marks out of which 75 marks have to be allocated to Orthopaedics leaving behind 225 marks for Surgery. .

The Executive Committee noted that following amendments to distribution of marks in the subject of Surgery in the recommendations of the Council on Graduate Medical Education Regulations,1997, duly approved by the General Body of the Council which have already been sent to the Central Govt. for their approval:-

Note: (i) 25% marks out of the total in viva voce, clinical examination and internal assessment shall be allotted for Orthopaedic Surgery.

(ii) Paper I of Surgery shall have one section in Orthopaedics. The questions on Orthopaedic Surgery shall be set and assessed by examiners/teachers in Orthopaedic Surgery. There shall be one external examiner and one internal examiner for Orthopaedics in addition to examiners for General Surgery.

The Committee further noted that approval of the Central Govt. on the recommendation of the Council has not been received, it decided to request the Central Govt. to expedite their approval to the amendments proposed by the Council.

37. Suggestion for amendment to Graduate Medical Education Regulation regarding supplementary examination.

Read : The letter dt. 25th Oct., 2001 from Dr.S.K.Mittal , Director-Professor & Head, Deptt. of Paediatrics, Maulana Azad Medical College, New Delhi, regarding amendment to Graduate Medical Education Regulations, 1997.

The Executive Committee considered the letter dt. 25th Oct., 2001 from Dr.S.K.Mittal , Director-Professor & Head, Deptt. of Paediatrics who pointed out that the inherent contradiction in holding the supplementary examination within 4-6 months and the requirement that the supplementary batch can join the main batch. Dr. Mittal has stated that these two conditions are obviously not possible to be met specially after the first professional examinations as the supplementary batch cannot join the main batch if examination are held 4-6 months after the final exams and that the Delhi University is holding the supplementary examination within 4-6 weeks of the final examination. He has requested that the regulations need to be immediately looked into in view of a large number of students missing their clinical postings and lectures because of the continuous system of internal tests, examinations etc. in the second professional.

The Committee noted that the provision existing in the Graduate Medical Education Regulations, 1997 i.e. “Supplementary examination may be conducted within 6 months so that the students who pass can join the main batch and the failed students will have to appear in the subsequent year” was amended by the General Body of the Council at its meeting held on 14.2.2001 in view of the petition filed by some of the students of in the High Court of Madhya Pradesh at Jabalpur as under:-

“Supplementary examination may be conducted within four to six months and the students who pass the examination shall not be allowed to join the main batch for teaching, training and examination but shall be treated as a separate batch i.e. supplementary batch.”

The above amendment was sent to the Central Govt. for their approval u/s 33 of the I.M.C. Act,1956. The approval of the Central Govt. is still awaited.

The Committee decided to request the Central Govt. to expedite their approval on the amendment proposed by the Council.

38. Inclusion of Blood Transfusion as a subject in the course curriculum of Undergraduate Medicine (MBBS).

Read : The matter with regard to inclusion of Blood Transfusion as a subject in the course curriculum of Undergraduate Medicine (MBBS).

The Executive Committee considered the letter dated 22.10.2001 received from Shri J.V.R. Prasada Rao, Special Secretary & Project Director, Govt. of India, National AIDS Control Organisation, Ministry of Health & F.W. to include Blood Transfusion as a subject in the course curriculum of undergraduate medicine (MBBS) to ensure good clinical practice and proper use of blood and blood products by all clinicians.

The Committee did not agree with the suggestions of Shri JVR Prasada Rao for inclusion of blood transfusion as a subject in the MBBS course as a postgraduate course is already available in the subject and moreover adequate knowledge imparted for Blood Transfusion at undergraduate teaching and also during internship training.

39. Representation regarding allotment of marks for Orthopaedics in final MBBS Examination.

Read : The representation regarding allotment of marks for Orthopaedics in final MBBS Examination.

The Executive Committee considered the representation dated 03.11.2001 of the President, Indian Orthopaedic Association regarding allotment of marks in Orthopaedic in the final MBBS examination. He has suggested that same status should be given for Orthopaedic as has been for Ophthalmology and Oto-Rhino-Laryngology by including a separate practical examination and 100 marks to be allotted to Orthopaedic and making it mandatory for Undergraduates to pass separately in Orthopaedic.

The Committee did not agree with the suggestions of the President, Indian Orthopaedic Association to allot separate marks for Orthopaedic in final MBBS examination as the General Body of the Council has already recommended amendments to the Regulations proposing allotment of 25% marks out of the total in viva voce, clinical examination and internal assessment for Orthopaedic Surgery (specifically under the subject of Surgery).

Further the total marks for Surgery have been increased from 300 to 400 which means allotment of 100 marks exclusively for Orthopaedic.

In view of above, the Committee decided to request the Central Govt. to expedite their approval to the amendments.

40. Eligibility of colour blind students for admission to MBBS course – Reg.

Read : The matter with regard to Eligibility of colour blind students for admission to MBBS course.

The Executive Committee decided to refer the matter to the General Body for its consideration.

41. SLP(C) Nos. 503-504/2002 filed by the Chairman, Board of Management KLE Society & Ors. Versus Dr.R.R.Patil & Ors. In the Hon'ble Supreme Court of India.

Read : The SLP(C) Nos. 503-504/2002 filed by the Chairman, Board of Management KLE Society & Ors. Versus Dr.R.R.Patil & Ors. in the Hon'ble Supreme Court of India.

The Executive Committee noted the judgement dated 13.3.2002 of the Hon'ble Supreme Court of India in SLP(C) Nos. 503-504/2002 filed by the Chairman, Board of Management KLE Society & Ors. Versus Dr.R.R.Patil & Ors. in the matter of admission to postgraduate medical courses in the medical colleges in Karnataka.

42. To grant Registration to Dr. Murad Rahman u/s 25(1) and 13(3) of the Indian Medical Council Act, 1956.

Read : The matter with regard to grant Registration to Dr. Murad Rahman u/s 25(1) and 13(3) of the Indian Medical Council Act, 1956.

The Executive Committee considered the above matter and did not agree to accept the recommendations of the Registration and Equivalence Committee with regard to grant of registration to the candidates not meeting with the laid down eligibility criteria possessing medical qualification in a foreign country:-

“The Committee was of the unanimous opinion that like it is in India, even in some other countries, the medical graduates degree should be accepted only after the candidate has got 10+2 with Biology as against the present policy of accepting equivalent qualification of 10+2 without Biology passed in other countries. This will maintain the uniform standard of medical graduates who come to India for practicing.”

The Executive Committee further noted that the above matter had already been dealt by the General Body at its meeting held on 29.10.98 where the following decision taken by the Committee was approved:-

“The Executive Committee in pursuance of provisions of Section 13 of the I.M.C. Act,1956, while adhering to the earlier decisions of the Council regarding eligibility criteria applicable in case of Indian nationals possessing recognised qualifications under this Section, decided that in case the candidates have passed qualifying examination from the same country where they have obtained the medical qualifications recognised under the said section, shall be eligible for registration in India provided they fulfil the eligibility criteria for admission into medical course in that country at par with Nationals of that country. Further that these candidates fulfil other requirements of the Act and policy decisions/regulations of the

Council with respect of Nationality, internship/practical training, submission of affidavit/any other documents and payment of fee etc. uniformly applicable to others."

43. Recognition of Sheth Kasturbhai Lalbhai Hospital & Sant Shiromani Ramji Bawaji Annakshetra, Luxmipura for purposes of Compulsory Rotatign Internship Training.

Read : The Council Inspector report (6th & 7th January 2002) for recognition of Sheth Kasturbhai Lalbhai Hospital & Sant Shiromani Ramji Bawaji Annakshetra, Luxmipura for purposes of Compulsory Rotating Internship Training

The Executive Committee considered the Council Inspector's report (6th & 7th Jan.,2002) and decided to recognise Sheth Kasturbhai Lalbhai Hospital & Sant Shiromani Ramji Bawaji Annakshetra, Luxmipura for purpose of Compulsory Rotating Internship Training in the following subjects:-

Medicine
Surgery
Orthopaedics
Paediatrics
Obst. & Gynae.
Ophthalmology

47. Rajah Muthiah Medical College, Annamalainagar - renewal of permission for admission of 5th batch of students against the increased intake i.e. from 125 to 150.

Read : The Council Inspectors report (15th & 16th April, 2002) for renewal of permission for admission of 5th batch of students against the increased intake i.e. from 125 to 150 at Rajah Muthiah Medical College, Annamalainagar.

The Executive Committee considered the Council Inspectors report (15th & 16th April,2002) and decided to recommend to the Central Govt. to renew the permission for admission of 5th batch of students against the increased intake i.e. from 125 to 150 at Rajah Muthiah Medical College, Annamalainagar for the academic session 2002-2003.

48. Continuance of recognition of MBBS degree granted by Saurashtra University in respect of students being trained at M.P. Shah Medical College, Jamnagar.

Read : The letter dated 8/11/2001 from the Dean, M.P. Shah Medical College, Jamnagar requesting to grant six months time w.e.f. 15th Nov., 2001 for submission of the compliance on rectification of the deficiencies pointed out in the periodical inspection report carried out in Jan., 1994.

The Executive Committee considered the matter with regard to continuance of recognition of MBBS degree granted by Saurashtra University in respect of students being trained at M.P. Shah Medical College, Jamnagar and noted the following:-

1. Periodical inspection of M.P. Shah Medical College, Jamnagar for continuance of recognition of MBBS degree was carried out in Jan., 1994.
2. The inspection report along with the compliance on the remarks made in the inspection report was considered by the Executive Committee at its meeting held on 8/1/1996.
3. The Executive Committee recommends that recognition of MBBS degree granted by Saurashtra University in respect of M.P. Shah Medical College, Jamnagar be continued subject to immediate rectification of deficiencies pointed out in the inspection report within six months.
4. Further compliance report received from the college authorities was considered by the Executive Committee at its meeting held on 8/3/1997.
5. Since the deficiencies were still persisting the Committee gave 3 months time to the institution to rectify the same and send the compliance. The President was authorized to take a decision on receipt of the compliance.
6. Compliance report received in response to the above decision was put up to the President for consideration. Since the deficiencies were still persisting the President gave final 3 months time to the institution to rectify the deficiencies.
7. Compliance along with the list of the teaching staff received from the Dean, M.P. Shah Medical College, Jamnagar was considered by the Executive Committee at its meeting held on 2/7/98.
8. From the compliance report the Committee observed that though there was improvement in the staff deficiencies as compared to the last inspection report, yet certain deficiencies in the staff were still persisting. The Committee granted six months time to the institution to rectify the deficiencies and send a detailed compliance report.

9. Compliance report received from the college authorities was considered by the Executive Committee at its meeting held on 16/6/99, where the Committee noting the deficiencies of staff for the present number of admissions being made by the college authorities i.e 175 gave 6 months time to the college authorities to comply with the above deficiencies and send a compliance.

10. In response to above decision, the Dean, M.P. Shah Medical College, Jamnagar vide letter dated 11th May, 2000 had submitted the compliance on the general remarks mentioned in the inspection report and list of the staff in position as on 11/5/2000.

11. A letter In this connection was also received from the Commissioner Health, Medical Services and Medical Education, Govt. of Gujrat intimating that the Govt. is in the process of filling up of teaching and other posts at M.P. Shah Medical College, Jamnagar. Moreover the State and the Saurashtra region in particular is facing drought situation, and Govt. is engaged in taking mitigating measures. He had requested to give at least 3 months time for filling up the various posts and submission of the compliance.

12. Three months time as requested was granted by the Executive Committee at its meeting held on 26/5/2000. No further compliance report was received however, a letter dated 19/1/2001 was received from the Dean, M.P. Shah Medical College, Jamnagar requesting to grant six months time in view of the earthquake in the Gujarat State. Time as requested was granted to the college authorities for submission of the compliance.

The Committee further considered the letter dated 8/11/2001 received from the Dean, M.P. Shah Medical College, Jamnagar requesting to grant extension of six months more time for submission of compliance report w.e.f. 15th Nov., 2001 on the grounds that the State Govt. is still very much occupied with the various health problems which had arisen due to earthquake.

Six months time w.e.f. 15th Nov., 2001 as sought by the Institution for submission of the compliance has already been over and no further communication has been received. In light of the facts stated above, the Executive Committee decided to recommend to the Council to reduce the number of seats from 175 to 100 in Ist MBBS course in consonance with the teaching facilities available at M.P. Shah Medical College, Jamnagar from the academic year 2002-2003.

49. Standard requirement of Medical Council of India in relation to appointment of teaching staff in Medical Colleges – Extension of honorary system existing in medical colleges.

Read : The letter dated 23rd Oct., 2001 from the Govt. of India, Ministry of Health & F.W. extending the system of appointment of

Honorary/part-time teachers in medical colleges for a further period of 5 years from the date of issue of the letter.

The Executive Committee considered a copy of letter dated 23.10.2001 received from the Central Govt. addressed to all the State/UT Health/Medical Education Secretaries, all the Vice-Chancellors of Universities/Deemed Universities, The Principal/Dean, all the Govt. & Private Medical Colleges in the country wherein it was stated that “after considering the various representations received in this Ministry for extension of the system of appointment of Honorary/Part-time teachers in some of the medical institutions, it has been decided to extend the system of appointment of Honorary/Part-time teachers in medical colleges for a further period of five years from the date of issue of this letter. This decision has been taken keeping in view the dearth of experienced teachers and the financial constraints being faced by some of the colleges. However, in the meanwhile, all the colleges/institutions shall also take all possible steps to appoint teachers on regular basis as laid down in the "Minimum Standard Requirements for a Medical College for 50/100/150 Admissions Regulations,1999" and the “Postgraduate Medical Education Regulations,2000.”

The Committee noted that the matter with regard to appointment of honorary teachers in medical colleges was earlier considered by the Sub-Committee where it was decided as under:-

“The Committee recommends that the appointment of honorary/part-time staff for teaching and administrative positions in medical institutions be extended upto 1995 and not beyond. This decision is taken in view of the difficulties experienced by many institutions which are being run with honorary or part-time practicing staff.”

The above decision of the Sub-Committee was approved by the General Body of the Council at its meeting held on 04.01.1992 which was conveyed to the Central Govt. on 23.3.1995 for their approval u/s 33 of the I.M.C. Act,1956.

In response to above, the Central Govt. vide their letter dated 08.03.1995 conveyed its decision as under:-

- “1. As per the norms prescribed by the MCI the minimum number of teaching staff should be in position in a medical college and the staff should be appointed on full time basis only.
2. A new schedule may be drawn for elimination of part-time/honorary teachers and a deadline should be fixed beyond which no extension should be given to those teaching staff who are completing their tenure before the appointment date (which should not be in any case later than 30.6.1996).

3. Those amongst the teaching staff whose contracts/tenure would expire after the deadline date may be served with a notice that their service will end on or before the said date (to be specified in the notice).
4. Measures be taken by medical colleges to fill up the posts hitherto filled on part-time honorary basis and new appointments should be made before the deadline date.
5. Honorary appointments of staff may be made only in exceptional cases to take advantage of professional excellence of highly talented practitioners for the purpose of scientific advancement but these should be in addition to the prescribed minimum norms of Medical Council of India for full time teachers.”

The above decision of the Central Govt. was circulated to all the concerned authorities vide MCI letter dated 17.07.1995. Subsequently the Council received representation from Honorary Medical Officers Associations, Bombay, and the matter was considered by the Council where it was decided to inform the Central Govt. that “the Honorary System stands extended for a period of another five years” and the same was communicated to the Central Govt. vide letter dated 01.03.1996.

The Central Govt. vide their letter dated 07.03.1996 accepted the Council recommendations and agreed to extend the Honorary System of teachers for a period of five years beyond 30.06.1996.

Accordingly, a circular dated 18.04.1996 was sent to all the concerned authorities for their information and compliance.

Further, the MCI vide its letter dated 25.05.2000 had brought to the notice of the Central Govt. that in accordance with the Council Regulations on Minimum Standard Requirements for a medical college for 50/100/150 admissions annually Regulations, 1999) "teaching staff of all departments of medical college shall be fulltime". It was requested to withdraw administrative instructions for extending the system of appointing Hony/Part-time teaching staff in medical institutions.

In reply the Central Govt. vide its letter dated 17.5.2001 had informed that it has been decided with the approval of the competent authority to extend the system of appointment of honorary/part-time teachers in medical colleges for a further period of one year i.e. upto 30th June,2002. The Central Govt. also requested that this decision may be brought to the notice of all medical colleges/universities.

The above letter of the Central Govt. was placed before the Executive Committee at its meeting held on 2.8.2001 for its information which was noted by the Committee.

Now the Central Govt. vide its letter dated 23.10.2001 has again extended the system of appointment of Honorary/Part-time teachers in medical colleges for a further period of five years from the date of issue of the letter i.e. 23.10.2001.

The Committee decided to obtain the legal opinion from the Ld. Solicitor General of India or the Ld. Additional Solicitor General of India in view of the Council Regulations on Minimum Standard Requirements for a Medical College for 50/100/150 Admissions Annually – 1999 where it has been prescribed that “teaching staff of all departments of medical college shall be full time”.

50. Nomination of Council Members on the DPC/Selection Committee.

Read : The matter with regard to nomination of Council members on the DPC/Selection Committee.

The Executive Committee considered the matter with regard to nomination of Council members on the DPC/Selection Committee and decided that the members on the DPC/Selection Committee be nominated as and when required.

52. Modification of Application Forms for Registration.

Read : The modified application form for registration.

The Executive Committee approved the modified application forms and checklist for registration as approved by the Registration & Equivalence Committee.

54. Civil Appeal No.2779 of 2000 Medical Council of India versus Indian Doctors from Russia Welfare Associations & Ors. {with C.A. Nos. 2808/2000, 2809/2000, 2811-2863/2000, 2787-2803/2000, 2804-2807/2000, 2810/2000, 2782-2786/2000, T.P.[C] No.103/2000 and W.P.[C] No.215/2001 dated 8/3/2002 – Judgement of the Hon’ble Supreme Court dated 8/3/2002.

Read : The Civil Appeal No. 2779 of 2000 Medical Council of India versus Indian Doctors from Russia Welfare Associations & Ors. {with C.A. Nos. 2808/2000, 2809/2000, 2811-2863/2000, 2787-2803/2000, 2804-2807/2000, 2810/2000, 2782-2786/2000, T.P.[C] No.103/2000 and W.P.[C] No.215/2001 dated 8/3/2002 – judgement pronounced by the Hon’ble Supreme Court on 8/3/2002 pertaining to grant of registration to the candidates possessing M.D. (Physician) qualification granted by Institutions in erstwhile U.S.S.R. (Russian Federation & Ors CIS countries).

The Executive Committee considered the above matter along with the judgement of the Hon’ble Supreme Court dated 08.03.2002 pronounced in the matter and decided to form a Sub-Committee consisting of following

members to go into the details of the students who have benefitted by the said judgement, to see the modalities worked out for implementation of the judgement and also to look into the complete details of the case as defended by the Council:-

Additional Items:

1. Continuance of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at Kasturba Medical College, Manipal and Kasturba Medical College, Mangalore.

Read : The Council Inspectors report (Jan., 2001) of Kasturba Medical College, Manipal & Kasturba Medical Mangalore compliance received from the Registrar, MAHE for continuance of recognition of MBBS degree granted by the deemed University.

The Executive Committee considered the matter with regard to continuance of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at KMC, Manipal and KMC, Mangalore along with the decision taken by the Committee at its meeting held on 22.1.2001.

Upon consideration of the inspection reports of the institutions carried out by the Council Inspectors in Jan.,2001 at K.M.C. Manipal and KMC, Mangalore, the Committee had noticed that out of the total admissions being made at Kasturba Medical College, Manipal and Kasturba Medical College, Mangalore 25% of the seats are being filled up with NRI/Foreign quota and the remaining 75% under the general category quota. Further all the students admitted against NRI/foreign quota of both the colleges are being placed at Kasturba Medical College, Manipal for the entire MBBS course. The general category candidates admitted against the Kasturba Medical College, Manipal are being sent to the Mangalore medical college for the entire MBBS course in lieu of the NRI/foreign quota admitted against the Mangalore Medical College. Thus the admissions against NRI/foreign quota fixed as 15% by the Hon'ble Supreme Court is being violated by the institution. Moreover, the number of admissions made against the NRI/foreign quota has been exceeded in the year 2000-2001 beyond the 25% i.e. 26.2%. Further, approximately 50% of the total seats are being filled up by the NRI/foreign students each year at Kasturba Medical College, Manipal which is also a total violation of the NRI quota fixed by the Hon'ble Supreme Court for one particular medical college. To quote an example out of the total 248 admissions made at the college during the year 1999-2000 at Kasturba Medical College, Manipal, 134 students belonged to general category and 114 belonged to NRI/foreign quota.

The Committee also noted the deficiencies pointed out in the inspection report with regard to infrastructural facilities, clinical material in the hospital, teaching facilities in Govt. Hospital, shortage of staff etc. for the number of admissions being made at the colleges.

In view of above, it was decided to issue a show cause notice to the concerned authorities regarding the admissions made at the college in excess of the NRI quota fixed by the Hon'ble Supreme Court at 15% and also that all the NRI/foreign students selected against Kasturba Medical College, Manipal and Kasturba Medical College, Mangalore are being placed at Kasturba Medical College, Manipal for their entire MBBS course which is in total violation of the orders of the Hon'ble Supreme Court and further that seats in the NRI quota at Kasturba Medical College, Manipal have been increased to 50%.

The Executive Committee further considered the reply received from the Registrar, MAHE, regarding the admission against NRI quota and the compliance regarding rectification of the deficiencies pointed out in the inspection report of two medical colleges.

Regarding admission against NRI quota the Registrar has informed that the Hon'ble High Court of Karnataka has ruled that deemed universities are not under the purview of the State Govt. Further, the Hon'ble Supreme Court has also declared that the scheme in Unnikrishnan judgement is not applicable to the colleges run by the Govt. and University colleges. The Registrar has enclosed a copy of Govt. notification dated 01.06.1993 issued by the Govt. of India conferring the Deemed university status to these colleges. In the said order clause D reads as follows:-

“The Academy will not charge any capitation fee from the students and the tuition fee to be charged from the students for pursuing the professional courses should be as prescribed on the recommendations of the Expert Committee appointed in consultation with the UGC.”

The Committee so appointed recommended admission of 33.3% of the total intake by NRI/Foreign students but the university restricted admission only to 25%. This question was raised before the Hon'ble Supreme Court in WP No. 23/99 and the Court made the following orders dated 16.4.1999:-

“However in view of peculiar facts of this case, we order that for the year 1999-2000 only, the petitioner's institutions shall be permitted to continue their earlier policy of NRI quota, a fee fixation and admission.”

It was also informed that the UGC instructed all the universities to create 20% supernumerary seats in all the university departments special courses whether technical or professional or otherwise. These supernumerary seats are exclusively meant for foreign students.

Subsequently, the UGC reduced these supernumerary seats to 15%. This was in addition to 15% of the seats allowed by the Hon'ble Supreme Court.

Regarding admitting all of NRI's in KMC, Manipal resulting in the increase of quota of NRI/Foreign students to 50% in Manipal, it was informed that the entire admission process (medical, dental, nursing and other courses) is done through an all India entrance test, Open Counselling and a centralized admission procedure (which is as per UGC guidelines). Hence, based on the total number of seats available, the NRI/foreign and general category seats are fixed. Accordingly, out of 500 seats available for medical, the NRI/foreign quota becomes 125 which is distributed in both Manipal and Mangalore as per the option given by the students. Since most of the NRI/foreign students opted for Manipal it appears that there are more number of NRI/foreign students in Manipal. The Govt. category students selected through Karnataka entrance test are admitted in KMC, Mangalore because of the Govt. hospitals which are utilized by them only at Mangalore.

From the compliance submitted by the Registrar, MAHE in respect of KMC, Manipal and KMC, Mangalore it was also noted that all the deficiencies have not yet been rectified.

The Committee further considered the legal opinion obtained from the Council Advocate regarding NRI quota. He opined that UGC does not have the authority to create supernumerary seats in medical colleges. Creation of additional seats in medical colleges lies in the domain of the MCI. He further opined that reservation of 15% seats as NRI quota has to be institution-wise; it matters not if more than one institutions have acquired the character of deemed university. He also informed that the question whether the judgement of Unnikrishnan case would apply to deemed university or not, would become clear after judgement is delivered by a Bench of eleven judges of the Supreme Court.

In view of above, the Committee decided to recommend to the Council to initiate action u/s 19 of the I.M.C. Act, 1956 for withdrawal of recognition of MBBS degree granted by Manipal Academy of Higher Education in respect of students being trained at Kasturba Medical College, Manipal and Kasturba Medical College, Mangalore for not following the orders of the Hon'ble Supreme Court of India with regard to admission against NRI quota i.e 15% in each of the medical colleges and approximately 50% of the total seats being filled up by the NRI/foreign students each year at Kasturba Medical College, Manipal which is also a total violation of the NRI quota fixed by the Hon'ble Supreme Court for one particular medical college.

2. **Continuance of recognition of MBBS degree granted by Kerala University in respect of students being trained at T.D.Medical College, Alappuazha.**

Read : The Compliance received from the college authorities on the deficiencies pointed out in the periodical inspection report (April, 1998) for

Continuance of recognition of MBBS degree granted by Kerala University in respect of students being trained at T.D.Medical College, Alappuazha.

The Executive Committee considered the periodical inspection report (April,1998) along with the compliance received from the college authorities on rectification of the deficiencies pointed out in the inspection report and decided to verify the same by way of an inspection.

The Committee further appointed following Inspectors for carrying out the said inspection:-

3. Continuance of recognition of MBBS degree granted by The Tamil Nadu Dr.MGR Medical University in respect of students being trained at P.S.G.Medical College, Coimbatore.

Read : The Compliance received from the college authorities on the deficiencies pointed out in the periodical inspection report (21st & 22nd July 1999) for Continuance of recognition of MBBS degree granted by The Tamilnadu Dr.MGR Medical University in respect of students being trained at P.S.G.Medical College, Coimbatore.

The Executive Committee considered the Council Inspectors report (14th & 15th June,2001) along with the compliance received from the college authorities vide their letter dated 10.12.2001 on the deficiencies pointed out in the inspection report and decided to verify the same by way of an inspection.

The Committee further appointed following Inspectors for carrying out the said inspection:-

4. Continuance of recognition of MBBS degree granted by Ranchi University in respect of students being trained at Rajendra Medical College, Ranchi.

Read : The Compliance received from the college authorities on the deficiencies pointed out in the periodical inspection report (January, 1997) for Continuance of recognition of MBBS degree granted by Ranchi University in respect of students being trained at Rajendra Medical College, Ranchi.

The Executive Committee considered the Council Inspectors report (Jan.,1997) along with the compliance received from the college authorities vide their letter dated 09.01.2002 on the deficiencies pointed out in the inspection report and decided to verify the same by way of an inspection.

The Committee further appointed following Inspectors for carrying out the said inspection:-

5. Continuance of recognition of MBBS degree granted by Ranchi University in respect of students being trained at M.G.M. Medical College, Jamshedpur.

Read : The letter dt. February 2002 received from the Commissioner Cum Secretary, Govt. of Jharkand regarding Continuance of recognition of MBBS degree granted by Ranchi University in respect of students being trained at M.G.M. Medical College, Jamshedpur.

The Executive Committee considered the letter dated Feb.,2002 received from the Commissioner-cum-Secretary, Govt. of Jharkhand intimating the improvements made at M.G.M. Medical College, Jamshedpur after it came under the State of Jharkhand with the division of Bihar. Since the last inspection of the college was conducted in March,1997 which is more than five years back, the Committee decided to carry out fresh inspection of the institution to assess the facilities available at the college for teaching and training of undergraduate students as per MCI norms.

The Committee further appointed following Inspectors for carrying out the said inspection:-

6. Continuance of recognition of MBBS degree in respect of students being trained at Medical Colleges in Bihar State – Request received from the Commissioner & Secretary granting time upto 30.6.2002 for sending compliance.

Read : The letter dt. 27.12.2001 received from the Commissioner & Secretary, Govt. of Bihar requesting to grant time upto 30.6.2002 for sending the compliance on rectification of the deficiencies pointed out in the inspection report in respect of various medical colleges in the state of Bihar

The Executive Committee considered the letter dt. 27.12.2001 received from the Commissioner & Secretary, Govt. of Bihar requesting to grant time upto 30.6.2002 for sending the compliance on rectification of the deficiencies pointed out in the inspection report of various medical colleges in the state of Bihar carried out for continuance of recognition of MBBS degree. The Committee decided to grant time as requested and further decided to take up the matter after the expiry of time granted i.e. upto 30.6.2002.

7. Establishment of new medical college at Kolencherry, Ernakulam by Malankara Orthodox Syrian Church Medical Mission, Kolencherry u/s 10A of the IMC Act, 1956.

Read : The compliance verification inspection report carried out to verify the additional information to furnish by the college authorities vide their letter dt. 18.1.2002 for establishment of new medical college at Kolencherry, Ernakulam by Malankara Orthodox Syrian Church Medical Mission, Kolencherry u/s 10A of the IMC Act, 1956.

The Executive Committee noted that the Committee at its meeting held on 31.01.2002 considered the Council Inspectors report (26th & 27th Dec.,2001) carried out for establishment of new medical college at Kolencherry along with the additional information furnished by the college authorities vide their letter dt. 18.1.2002 and decided to verify the same by way of an inspection.

The Committee further considered the verification inspection report (24th & 25th April,2002) carried out as per its decision and decided to recommend to the Central Govt. to issue Letter of Intent for establishment of new medical college at Kolencherry, Ernakulam by Malankara Orthodox Syrian Church Medical Mission, Kolencherry u/s 10A of the IMC Act, 1956 with an annual intake of 100 (hundred) students for the academic session 2002-2003.

8. KAP Vishwanathan Govt. Medical College, Trichy - renewal of permission for admission of 5th batch of students.

Read : The Council Inspectors report (April, 2002) for renewal of permission for admission of 5th batch of students at KAP Vishwanathan Govt. Medical College, Trichy

The Executive Committee considered the Council Inspectors report (April, 2002) carried out for renewal of permission for admission of 5th batch of students at KAP Vishwanathan Govt. Medical College, Trichy and noted the following deficiencies with regard to infrastructural facilities which were required to be provided by 5th renewal of admissions:-

1. The auditorium is still under construction.

2. The animal house does not have facilities for experimental work. The number of experimental animal and variety is very less. It is not under the control and supervision of the department of Pharmacology.
3. In the central library system of cataloguing and coding is not being followed.
4. Health Centres:- There are 3 Primary Health Centers with the college, out of which one at Inamkulathur is the RHTC. It is partly under the control of the college. All the 3 PHCs should be taken under the control and management by the college.

The activities in the Rural Health Training Center are very inadequate. There is no residential accommodation for interns under training. Teaching programmes in the rural area are not being arranged properly and adequately.

5. In the hostels there is no facility for recreation of students. There is no visitors' room. Proper hostel for interns and resident doctors required to be constructed and made functional.
6. In the main hospital, the waiting space for patients is very inadequate. The furniture in the hospital both in OPDs and wards is very old and requires replacement in many places. The consulting rooms in OPD have not been provided x-ray viewing boxes and washbasins etc. in some of the places.

Very few teaching rooms are available in the wards. The wards do not have pantry, treatment rooms and duty rooms for doctors in some places.

Floor beds are provided for postnatal cases which is not acceptable.

7. In the central laboratory, all the necessary investigations required for OPD cases are not done. The specimens are sent to the college which is 2.5 km. away. This arrangement is not acceptable.

The arrangement and layout of the central laboratory is not satisfactory which requires to be totally reorganised.

8. The registration counters in the OPD are very much cramped. Space provided is less and overcrowded. More counters required to be created. Computerisation should be started for registration of patients.
9. The space provided for medical record section is inadequate and it also requires more trained staff.
10. In the casualty ICU beds should be provided for acute care of serious patients. The casualty also requires better trolleys and wheel chairs

for transportation of patients. The ambulances should be fitted with basis life support equipment.

11. The operation theatres require anaesthesia ventilators and more monitory equipment.
12. In the labour rooms the tables are provided without any partition between them.
13. The condition of the ICU is very primitive and is being run for the namesake.
14. The Central Sterile Supply Department is required to be reorganised and upgraded. There is no provision of an ethylene oxide sterilizer. The activities of the CSSD have to be increased and improved.
15. In pre and para clinical departments more furniture for demonstration rooms, library books and improvement of museums are required to be provided.
16. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Committee decided to recommend to the Central Govt. not to renew the permission for admission of 5th batch of students during 2002-2003 at K.A.P. Viswanathan Govt. Medical College, Trichy.

9. North Bengal Medical College, Darjeeling - renewal of permission for admission of 2nd batch of students against the increased intake i.e 50 to 100.

Read : The Council Inspector report (25th & 26th April 2002) for renewal of permission for admission of 2nd batch of students against the increased intake i.e 50 to 100 at North Bengal Medical College, Darjeeling

The Executive Committee considered the Council Inspectors report (25th & 26th April,2002) and noted the following:-

1. There is no college/hospital campus. It is an absolutely open and free for all campus with general public and stray animals (cats and dogs) having unrestricted movement. There is no fencing or boundary wall of even individual functioning movement. A thoroughfare runs through the campus and on the other side of it, there is a market place also. The surroundings are absolutely unkept and marshy.
2. The college/hospital building needs elaborate repair/remodelling. There is water seepage all around, plaster chipping, blackening of whitewash and blades of ceiling fans because of soot and cobwebs.

3. In the Central Library accession Register and other records are not maintained properly. The annual library budget is only Rs. 4 lacs and as such, no current foreign journal is available. The latest BMJ in the library is of the year 2000.
4. The hostels are in a pathetic state of cleanliness and maintenance. The walls and ceilings are absolutely black because of cobwebs and soot.
5. Registration and Medical Record Section is not computerised.
6. In various OPD sections are not provided with proper fitting and instruments for proper patient examination.
7. A CSSD centre, mechanized laundry, kitchen and an incinerator of required capacity are not provided.
8. X-ray department should be reinforced with an 800 MA machine with IICTV and CTSCAN.
9. Other observations/deficiencies pointed out in the inspection report.

In view of above, the Committee decided to recommend to the Central Govt. not to renew the permission for admission of 2nd batch of students against the increased intake i.e. 50 to 100 at North Bengal Medical College, Darjeeling for the academic session 2002-2003.

10. Increase of MBBS seats from 65 to 100 at Medical College, Silchar – Appointment of Inspectors thereof.

Read : The matter for appointment of inspectors for carrying out the inspection of Silchar Medical College, Silchar for increase of MBBS seats from 65 to 100 application of which was received through the Central Govt. u/s 10A of the IMC Act, 1956.

The Executive Committee appointed following Inspectors for carrying out the inspection of Silchar Medical College, Silchar for increase of MBBS seats from 65 to 100:-

11. Regarding additional attempt i.e. 5th attempt to appear in the 1st MBBS examination.

Read : The request of Sh. Dhiraj Kumar Pandey for permission to appear in the 1st MBBS examination (5th attempt).

The Executive Committee considered the request of Shri Dhiraj Kumar Pandey received through the Principal, SCB Medical College,

Cuttack for grant of additional attempt i.e. 5th attempt to appear in the 1st MBBS examination.

The Committee did not agree for the same in view of the recent decision taken by it at its meeting held on 31.1.2002 not to grant more than 4 chances within 3 years as prescribed in the regulations of the Council on Graduate Medical Education, 1997 which reads as under:-

“No student shall be permitted to join the Phase II (Para-clinical/clinical) group of subjects until he has passed in all the phase I (Pre-clinical) subjects for which he/she will be permitted not more than four chances (actual examination), provided four chances are completed in three years from the date of enrollment.”

12. Supplementary of the 2nd MBBS Examination.

Read : The matter with regard to supplementary of the 2nd MBBS examination.

The Executive Committee considered the letter received from the Controller of Examination, University of Rajasthan, along with the judgement dated 23.1.2001 of the Rajasthan High Court directing the university to make all necessary arrangements to permit the petitioners to complete their studies and to appear at II MBBS examination as per Regulation 7(7) as per the existing provision of the Graduate Medical Education Regulations-1997.

The Committee further noted the legal opinion of the Council Advocate stating that till the amendment is approved by the Central Govt. the existing regulations have to be followed but as far as Rajasthan High Court Order is concerned, the directions of the High Court have to be followed in the absence of the any stay or reversal of the judgement in Appeal.

The Committee also noted that the MCI Appeal against the Andhra Pradesh High Court Order was dismissed by the Hon'ble Supreme Court vide their order dated 26.4.2002 whereby students passing the Supplementary examination may be permitted to join the main batch for the next phase of study and examination .

The Committee decided to request the Central Govt. to expedite their approval on the amendments proposed by the Council immediately to avoid any further litigation.

13. Letter of Prof.A.Rajasekaran, Member, MCI regarding medical admission etc.

Read : The letter dt. 20th April, 2002 received from Prof.A.Rajasekaran, Member, MCI regarding medical admission etc.

The Executive Committee considered the letter dated 20th April, 2002 received from Prof. A. Rajasekaran, Member, MCI and noted with great concern the allegations made therein.

The Committee resolved that the allegations made by Prof. Rajasekaran are baseless and vague and further decided that he may be requested to substantiate his statements along with sufficient proofs. If he is unable to provide sufficient proofs he would have to withdraw his letter with regret.

14. To consider the need of biomedicine to be integrated for all appointments in medical colleges and research institutions.

Read : The letter dated 09.10.2001 from Dr. A.P.J. Abdul Kalam, Principal Scientific Adviser to the Govt. of India requesting to consider the need of biomedicine to be integrated for all appointments in medical colleges and research institutions.

The Executive Committee considered the letter dated 09.10.2001 from Dr. A.P.J. Abdul Kalam, Principal Scientific Adviser to the Govt. of India requesting to consider the need of biomedicine to be integrated for all appointments in medical colleges and research institutions and decided to obtain the detailed project report for further consideration in the matter.

15. Regarding guidance in respect of running of Pathology Laboratory by a Doctor possessing merely degree of MBBS.

Read : The letter dated 21.12.2001 from the Registrar Madhya Pradesh Medical Council regarding guidance in respect of running of Pathology Laboratory by a Doctor possessing merely degree of MBBS.

The Executive Committee considered the letter dated 21.12.2001 from the Registrar Madhya Pradesh Medical Council regarding guidance in respect of running of Pathology Laboratory by a Doctor possessing merely degree of MBBS and decided to circulate the same to the members of the Council to obtain their views/opinions for further consideration.

16. To consider the matter with regard to incurring expenditure on revision & Printing of IMR for the year 1993 from MCI own resources account till the grant in aid is received from the Central Govt. for the said purpose.

Read : The matter with regard to incurring expenditure on revision & Printing of IMR for the year 1993 from MCI own resources account.

The Executive Committee agreed to incur the expenditure from MCI's Own Resources Account on revision and printing of IMR for the year 1993 till the grant-in-aid is received from the Central Govt. for the said purpose. The same may be reimbursed to MCI's Own Resources Account after receiving the grant-in-aid from the Central Govt.

17. Provisional Extension of time period for completing the project and finalisation of electrical tender for the proposed Council building at Dwarka.

Read : The matter with regard to extension of time period for completing the project and finalisation of electrical tender for the proposed Council building at Dwarka.

The Executive Committee agreed to grant provisional extension of time upto 31.12.2002 to M/s L & T Ltd. as requested for completion of the project, however, it should not lead to revised estimates.

Regarding finalisation of electric tender the Executive Committee noted that recently meeting of the Building Committee was called on two occasions i.e. 01.03.2002 and 26.03.2002. The meetings were not held because Dr. B.C. Chhparwal, Chairman of the Committee conveyed his inability to attend the meeting on the said dates.

The Committee decided to call a meeting of the Building Committee immediately, if the Chairman again conveys his inability, the meeting shall be convened under the Chairmanship of Dr. B.Ray Chaudhuri.

18. Inspectors to be appointed to carry out the inspection of postgraduate Courses.

The Executive Committee appointed following Inspectors for carrying out the inspection of various postgraduate courses:-
