1. Website: Not available.
2. Construction: At present college has no building of its own. Some preclinical departments are shown in the basement parking place of District office complex and two rooms on its II floor. Anatomy department is shown on terrace of drug house where there is no construction and it is only empty space. On the proposed medical college land, leveling is going on but no construction has started.
3. Dean's office: Size is smaller than Regulations.
4. Lecture Theater: There is only 1 hall of capacity 180 against requirement of 2 lecture theaters of 180 capacity each. It is not of gallery type. Facility for E class is not available. It is not furnished. Audiovisual aids are not available. It is not air conditioned.
5. Central Library: Not available.
6. Common Rooms for Boys & Girls: Not available.
7. Central Photography Unit is not available.
8. Students' Hostels: Accommodation is available for 72 students against requirement of 113 as per Regulations. Boys' hostel is shown in abandoned jail quarters which are in poor shape. It is not furnished. Toilet facilities are inadequate. Mess is not available.
9. Residents' Hostel: Not available.

10. Nurses' Hostel: Accommodation is available for 12 Nurses against requirement of 34 as per Regulations.
11. Recreational facilities are not available.
12. OPD: Registration counters are not computerized. Only 2 examination rooms are available in OPDs of major departments against requirement of 4 rooms each as per regulations. There is no teaching area. There is no separate dressing room. Injection room is common for male & female patients. Plaster room & Plaster cutting room are same. Dressing room is not available in Ophthalmology OPD.
13. Audiometry room is available but it is not functional as there is no Audiometry Technician. Speech therapy is not available.

16. There is no Unit structure in clinical departments.
17. Clinical material is inadequate as under:

  - (b) Bed occupancy: daily average 56 % against requirement of 60 %.
  - (c) Radiological Investigations: (a) Plain X-rays: Daily average: 11.
  - (d) Laboratory Investigations: No Histopathology & Cytopathology work.
18. MRD is manual. ICD X classification is not followed for indexing.
19. Casualty: Separate casualty for OG is not available. Central oxygen & suction available partially. Resuscitation equipment is inadequate. There is no emergency OT.
20. O.T.s: Only 3 O.T.s are available against requirement of 5 as per Regulations. Central oxygen & Suction are not available. Resuscitation equipment is inadequate.
21. ICUs: ICCU & SICU are not available.

The Executive Committee of the Council considered the Council Assessor report (23<sup>rd</sup> and 24<sup>th</sup> May, 2014) and noted the following:-

1. Lecture Theaters: Facility for E class is not available.
2. Clinical material: Bed occupancy on day of assessment was 53 % against requirement of 60 %. The occupancy in was 49 patients in Gen. Surgery out of 90 beds (54 %), 36 patients in Gen. Medicine out of 72 beds (50 %) and 10 patients in Paediatrics out of 24 beds (i.e. 41 %).
3. ICUs: There was no patient in MICU on day of assessment. There were only 2 patients (i.e. occupancy 40 %) on day of assessment in SICU & NICU/PICU. Admitted patients were not of critical conditions. No serious patients are admitted in hospital & they are referred to other hospitals. The data of last 6 months showed that there was not a single patient put on ventilator.
4. Deficiency of teaching faculty is 13.33 % (i.e. 8 out of 60) as under:
  - (a) Professor: 2 (Biochemistry: 1, Gen. Medicine: 1)
  - (b) Asso. Prof.: 4 (Anatomy: 1, Biochemistry: 1, Pharmacology: 1, Microbiology: 1)
  - (c) Asst. Prof.: 1 (Anatomy: 1)
  - (d) Tutor: 1 (Anatomy: 1)
  - (e) Most of the senior staff are commuting from distant places like Meerut, Moradabad, Ghaziabad, etc. which are at a distance of 60-70 kms.
5. Shortage of Residents is 35.55 % (i.e. 16 out of 45) as under:
  - (a) Senior Resident: 9 (Gen. Medicine:1, Gen. Surgery: 3, ENT:2, Anaesthesiology: 2, O.G.: 1)
  - (b) Junior Resident: 7 (Gen. Medicine: 1, Gen. Surgery: 1, ENT: 1, Orthopaedics: 1, Ophthalmology: 1, O.G.: 2)
  - (c) Most of the Senior Residents are commuting from distant places like Meerut, Moradabad, Ghaziabad, etc. which are at a distance of 60-70 kms. which is not as per Regulations. Only 1 Senior Resident of Orthopaedics is staying in the campus.
6. Other deficiencies as pointed out in the assessment report.

3. Website: Not available.
4. Principal's Office: Area is 12 sq.m. against requirement of 36 sq.m. as per Regulations. Staff room is smaller than required as per Regulations.
5. Pharmacovigilance Committee: Absent.

6. Lecture Theaters: Both lecture theaters are unfurnished. They are not of gallery type. Audiovisual aids are not available. Facility for E class is not available. They are not air conditioned.
7. Central Library: Area is 474 sq.m. against 800 sq.m. required as per Regulations. Seating not arranged. Books are available but they are not displayed. Journals are not available. Staff is not available.
8. Common Rooms for Boys & Girls: Not available.
9. Central Photography Unit: Not available.
10. Students' Hostels: Not available.
11. Residents' Hostel: Not available.
12. Quarters: Only 5 quarters are available which are occupied by consultants of District Hospital and may be allotted to faculty. Hence no quarters as such are available for faculty. No quarters are available for non-teaching staff.

14. Medical Superintendent's office is not available in hospital.
15. OPD: Registration counters are not computerized. They are inadequate. Waiting area for patients is inadequate. Only a common room with partitions is shown as examination room for patients against requirement of 4 examination rooms for each major department. Teaching area is not available. Enquiry desk is not available. Injection room for males & females is common. Plaster cutting room is not available.
16. Audiometry & Speech Therapy are not available.
17. Teaching Beds: Only 150 beds are available against requirement of 300 beds. Thus qualifying criteria 6 (2) are not fulfilled. These beds are not distributed department wise and are designated as common male & female wards.
18. Clinical Material is inadequate as under:
  - (a) Average daily OPD attendance is 225 against requirement of 400.
  - (b) Radiological Investigations: Daily average of plain X-rays is 30.
19. MRD: It is manual. ICD X classification of diseases is not followed for indexing.
20. Casualty: Only 8 beds are available against requirement of 10 as per Regulations. Disaster Trolley & Crash cart are not available. Adequate instruments are not available in emergency O.T.
21. Central Clinical Laboratory: Different sections of Pathology, Microbiology & Biochemistry are not available.
22. O.T.s: There is only 1 general O.T. for major operations against requirement of 4 and only 1 general O.T. for minor operations against requirement of 2 as per regulations. Equipment is inadequate.
23. ICUs: There is a common ICU with 8 beds against requirement of 5 beds each for ICCU, MICU, RICU, PICU/NICU.
24. Labour Room: No separate beds for septic or eclampsia cases.
25. Radiodiagnosis Department: AERB approval is not available. There is only 1 static machine available against requirement of 2 as per Regulations. There is only 1 USG available against requirement of 2 as per Regulations.
26. Intercom: Not available.
27. Anatomy Department: It is nonfunctional. Construction is in process.
28. Physiology Department: It is nonfunctional. Construction is in process.
29. Biochemistry Department: It is nonfunctional. Construction is in process.
30. Faculty: Only 1 Professor of Medicine is available. No other faculty is available.
31. Residents: No Senior Resident or Junior Resident is available.
32. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission of 2<sup>nd</sup> batch of MBBS students against the increased intake i.e. from 50 to 100 u/s 10A and continuance of recognition of college for the award of MBBS degree for 50 seats u/s 11(2) of the IMC Act, 1956 in respect of MGM Medical College, Jamshedpur, Jharkhand under Kolhan University, West Singhbhum, Jharkhand for the academic year 2014-15.

114. **Assessment of the physical and other teaching facilities available for Increase of MBBS seats from 150 to 250 u/s 10A of the IMC Act, 1956 in respect of Mahatma Gandhi Medical College & Research Institute, Pondicherry under Sri Balaji Vidyapeeth University, Pondicherry for the academic year 2014-15.**

Read: the matter with regard to assessment of the physical and other teaching facilities available for Increase of MBBS seats from 150 to 250 u/s 10A of the IMC Act, 1956 in respect of Mahatma Gandhi Medical College & Research Institute, Pondicherry under Sri Balaji Vidyapeeth University, Pondicherry for the academic year 2014-15.

The Executive Committee of the Council considered the Council Assessor report (15<sup>th</sup> and 16<sup>th</sup> May, 2014) and decided to recommend to the Central Govt. to grant Letter of Permission for increase of MBBS seats from 150 to 250 u/s 10A of the IMC Act, 1956 in respect of Mahatma Gandhi Medical College & Research Institute, Pondicherry under Sri Balaji Vidyapeeth University, Pondicherry for the academic year 2014-15.

115. **Request for recognition as MCI Regional Center in Medical Education Technology (MET).**

Read: the matter with regard to requests for recognition as MCI Regional Center in Medical Education Technology (MET).

The Executive Committee of the Council accepted the recommendation of Chairman, Academic Committee which reads as under:

*“The perusal of the office summary pertaining to the four requests for new regional centres reveals that only Kasturba Medical College Manipal, prima-facie fulfills the prescribed requirements pertaining to recognition of a medical college as the regional centre under the National Faculty Development Programme of the Council. The other three applicants are deficient on one or the other count(s). It may be processed accordingly for the approval of the President, Medical Council of India to be itemized for the consideration of the Executive Committee at its ensuing meeting.”*

*For the present item, President, MCI recused herself since she had previously been Vice-Chancellor of Sumandeep Vidyapeeth University, Vadodara and therefore the Vice-President chaired the meeting for this item.*

116. **Complaint against the MCI officials with regard to the processing of application for increase of MBBS seats from 150 to 250 at SBKS Medical College, Piparia, Vadodara, Gujarat.**

Read: The complaint against the MCI officials with regard to the processing of application for increase of MBBS seats from 150 to 250 at SBKS Medical College, Piparia, Vadodara, Gujarat.

The Executive Committee of the Council considered the matter with regard to complaints against the MCI officials and processing the application for increase of MBBS seats from 150 to 250 at SBKS Medical College, Piparia, Vadodara, Gujarat from Mr. Chaman Bhai Patel and Mr. Kanti Bhai Patel, Gujarat Bhawan, New Delhi forwarded by the Central Vigilance Commission to CVO, MCI and noted that the complaint by Mr. Chaman Bhai Patel has no address for communication whereas in the case of 2<sup>nd</sup> complaint no person by the name of Mr. Kanti Bhai Patel could be traced on the address provided in the complaint.

The Committee further perused the CVC guidelines with regard to action to be taken in case of anonymous/pseudonymous petitions/complaints as per para 3(v) of the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training Resolution No. 371/20/99-AVD.III dated 4<sup>th</sup> April, 1999 as well as CVC instruction No. 3(v)/99/2 dated 29<sup>th</sup> June, 1999 and No.98/DSP/9 dated 11.10.2002 and noted that as per these guidelines no action is to be taken by departments/organizations, as a general rule, on anonymous/pseudonymous complaints received by them.

In view of above, the Committee decided to treat the matter as closed since both the complainants proved to be pseudonymous.

*The President, MCI again chaired the meeting.*

**117. Consideration of letter dated received from the Central Govt., Ministry of Health & FW with regard to application of Institute of Medical Sciences & SUM Hospital, Bhubaneswar for increase intake from 100 to 150.**

Read: The letter dated received from the Central Govt., Ministry of Health & FW with regard to application of Institute of Medical Sciences & SUM Hospital, Bhubaneswar for increase intake from 100 to 150.

The Executive Committee after considering the agenda item in the morning decided to seek opinion from the Law Officer as well as the Standing Counsel of the MCI in the matter immediately. Since the Standing Counsel was present in the council office he was requested to give his opinion on the further course of action in the matter.

The Executive Committee once again considered the agenda item in the evening by which time the Law Officer as well as the Standing Counsel had given their opinions, which were placed before the Executive Committee.

The Executive Committee after going through the opinions decided to process the application of the Institute of Medical Sciences and SUM Hospital, Bhubaneswar as well as Saraswati Institute of Medical Sciences, Hapur for increase of seats from 100-150 for the academic year 2014-15.

118. **Establishment of New Medical College at Visakhapatnam, Andhra Pradesh by Gandhi Institute of Technology & Management (GITAM), Visakhapatnam, Andhra Pradesh u/s 10A of the IMCAct,1956 for the academic year 2014-15.**

Read: The matter with regard to establishment of new Medical College at Visakhapatnam, Andhra Pradesh by Gandhi Institute of Technology & Management (GITAM), Visakhapatnam, Andhra Pradesh u/s 10A of the IMCAct,1956 for the academic year 2014-15.

The Executive Committee of the Council considered the matter alongwith letter dated 24.12.2013 from the Registrar, NTR University of Health Sciences, Vijayawada and letter dt. 27.12.2013 from Government of Andhra Pradesh and noted that the matter had already been disapproved and sent to the Central Government. Thereafter, the Council had received letter dated 10.02.2014 from the Central Government forwarding the representation of the college authorities which was placed before the Scrutiny Committee and the Committee disapproved the request/appeal of GITAM received through the Central Govt. and the Central Govt. was accordingly informed vide letter dt.11.03.2014. Thereafter, the Under Secretary, Ministry of Health & FW vide letter dt. 15.5.2014 had again forwarded letter from the Registrar, GITAM, Visakhapatnam, Andhra Pradesh dt. 15.03.2014 and another letter from the Vice Chancellor, GITAM dt.8.5.2014 requesting for reconsideration of the matter since the application was complete in all respect.

The Executive Committee also perused the legal opinion taken on the above representations which reads as under:

*"I have perused the letter dated 10.05.2013 received from the Central Government, wherein the Central Government has requested the Council to take appropriate action as per the IMC Act and regulations made thereunder applicable to "Deemed to be University." The Central Govt. has also forwarded the representation dated 08.05.2014 of the College with this letter and College has inter alia claimed that it is a Deemed University under UGC Act and hence Dr. NTR University of Health Sciences Act is not applicable to it. It has also claimed that the MOHFW on the advice of Council has granted permission to various Deemed to be Universities establish Medical Colleges under their ambit. In it representation dated 15.03.2014, the applicant has drawn attention to the name of Institution that have deemed University status and have been granted LOP by the Central Govt. The Competent Authority may consider directing the UG Section to examine such cases, and see whether there were objections raised by State Government in those cases also.*

2. *In this regard, on record is the State Government letter dated 27.12.13 in which it has requested asked the Council not to process the application for starting of MBBS course by GITAM Institute of Medical Sciences and Research, Vishakhapatnam without obtaining the consent of affiliation from Dr. N.T.R. University of Health Sciences, A.P., Vijayawada. The State Government has referred to section of Dr. NTR University of Health Sciences Act, 1986 [Act No. 6 of 1986] which has been quoted in the said letter and provides as under:-*

**6. Jurisdiction and admission to privileges.**

*(1) no medical college in the state of Andhra Pradesh imparting education in health sciences shall, save with the consent of the University and the sanction of Government be associated in any with or seek admission to any privileges of any other University in India.*

*(2) Any such privileges enjoyed from any other University before the appointed date shall be deemed to be withdrawn with effect from such date.*

3. *The State Government has further stated in its letter that in view of the provisions of the Act. 6 of 1986, without obtaining the affiliation from Dr. N.T.R. University of Health Sciences, A.P., Vijayawada no institution can establish a medical college under Deemed University status.*

4. *I am of the considered opinion that in view of the federal nature of Indian polity the Council/Central Government should give respect to the Act of State Legislature and accede to the request made by the State Government. Therefore, the Competent Authority may consider recommending to the Central Government that in view of the request made by the State Government on the basis of an Act of State it would not be appropriate to further process the application for starting of MBBS course by GITAM. “*

In view of above, the Committee decided to return the application recommending disapproval of the scheme for establishment of a new medical college at Visakhapatnam, Andhra Pradesh by Gandhi Institute of Technology & Management (GITAM), Visakhapatnam, Andhra Pradesh u/s 10A of the IMCA Act, 1956 for the academic year 2014-15. since there is no provision for keeping the application pending.

The meeting ended with a vote of thanks to the Chair.
