







































































































































Read: the matter with regard to assessment of the physical and other teaching facilities available for compliance verification assessment for increase of MBBS seats from 150 to 250 u/s 10A of the IMC Act, 1956 in respect of Prathima Institute of Medical Sciences (PIMS), Karimnagar, A.P. under Dr. NTR University of Health Sciences, Vijaywada for the academic year 2014-15.

The Executive Committee of the Council considered the compliance verification report (9<sup>th</sup> June, 2014) along with previous assessment report (5<sup>th</sup> & 6<sup>th</sup> March, 2014) as well as the summary report submitted by the Coordinator and the other Assessor and noted the following:

1. Daily average OPD in last 1 year is 2464 which is less than minimum prescribed as qualifying criteria under Opening of a New or Higher course of Study or training and increase of Admission Capacity in any course of Study or Training Regulations, 2000 - viz. 3,000. Thus the institute has failed to meet qualifying criteria at 6 (b) (ii) of Opening of a New or Higher course of Study or training and increase of Admission Capacity in any course of Study or Training Regulations, 2000. Deficiency remains as it is.
2. Residential quarters: Only 16 quarters are available for non-teaching staff against requirement of 36 as per Regulations. Deficiency remains as it is.
3. Deficiency of faculty is 12.79 % (i.e. 27 out of 211) as detailed in report as under:
  - (a) Asso. Prof.: 12
  - (b) Asst. Prof.: 11
  - (c) Tutor: 4
4. The college authorities had tried obstructive and delaying tactics.
5. College authority were adamant and had callous attitude for the assessment.
6. No declaration forms/original documents were provided for physical verification of faculty members and residents.
7. Other deficiencies as pointed out in the assessment report.

Average daily OPD attendance is 2464 which is less than 3000, which the minimum OPD attendance prescribed as Qualifying Criteria u/s 3<sup>6</sup>(A)(ii) of Opening of a new of higher course of study and increase of admission capacity in any course of study Regulations, 2000 which prescribes that "OPD strength per day not less than 3000", therefore, the institute does not meet the Qualifying Criteria.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision to return the application to the Central Govt. recommending disapproval of scheme for increase of seats from 150 to 250 u/s 10A of the IMC Act 1956 in respect of Prathima Institute of Medical Sciences (PIMS), Karimnagar, A.P. under Dr. NTR University of Health Sciences, Vijaywada for the academic year 2014-15.

96. **Adesh Institute of Medical Sciences & Research Bhathinda – complaint of Dr. Mohinder Kumar – regarding.**

The Executive Committee of the Council deliberated upon the complaint of Dr. Mohinder Kumar and decided to constitute a Sub-Committee comprising of Dr. C.V. Bhirmanandham and Dr. V.N. Jindal to study the complaint and place the report in the next Executive Committee.

Read: the matter with regard to assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 2<sup>nd</sup> batch (100 seats) of Indian Institute of Medical Sciences & Research, Jalna under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

The Executive Committee of the Council considered the compliance verification assessment report (9<sup>th</sup> June, 2014) along with previous assessment report (10<sup>th</sup> & 11<sup>th</sup> March, 2014) and noted the following:-

1. Radiological workload of Plain X-rays is still 30/day. Daily average of Special Investigations is only 1. Deficiency is not rectified .
2. On day of assessment, there were 4 Histopathology specimens, 2 FNAC & 5 Cytology which are inadequate. Deficiency is not rectified.
3. ETO sterilizer is not still available. Deficiency is not rectified.
4. RHTC is in a rented building. Out of 12 people claimed to have been appointed for running the RHTC, only 4 were present during assessment. There is no facility for vaccination and any laboratory investigation as claimed. Deficiency remains as it is.
5. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision of recommending to the Central Govt. not to renew the permission for admission of 2<sup>nd</sup> batch (100 seats) of Indian Institute of Medical Sciences & Research, Jalna under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

98. **Assessment of the physical and the other teaching facilities available for establishment of a new medical college at Nandurbar, Maharashtra by Govt. of Maharashtra under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2014-15.**

The Executive Committee of the Council considered the Council assessment report (3<sup>rd</sup> and 4<sup>th</sup> June, 2014) and noted the following:-

1. There is no establishment in the city in the name of Government Medical College, Nandurbar.
2. No Dean, Medical Superintendent, Staff (Technical & Non Technical) have been appointed.
3. There is no college or hospital building.
4. The plot of land on which the proposed medical college is to come up is a barren, vacant piece of government land. It was a total empty land, no sign board, no leveling, no excavation, no construction & no person to guide us.
5. There is no functional hospital. Deficiency of teaching beds is 100%. Thus the qualifying criteria u/s 3(2)(5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds is not met with.
6. Other deficiencies as pointed out in the assessment report.

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3 (2) (5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds,, the Executive Committee of the Council decided to return the application recommending

disapproval of the scheme for establishment of a new medical college at Nandurbar, Maharashtra by Govt. of Maharashtra under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2014-15 since there is no provision for keeping the application pending.

99. **Assessment of the physical and the other teaching facilities available for establishment of a new medical college at Chandrapur, Maharashtra by Govt. of Maharashtra under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2014-15.**

The Executive Committee of the Council considered the Council assessment report (4<sup>th</sup> & 5<sup>th</sup> June, 2014) and noted the following:-

1. College building is under construction.
2. Lecture Theaters: Under construction.
3. Central Library: Under construction. Staff not appointed yet.
4. Residents' Hostel: Not available.
5. Nurses' Hostel: Not available.
6. Teaching beds are deficient as under:

Thus the qualifying criteria u/s3(2)(5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds is not met with.

7. Histopathology workload is Nil.
8. MRD: It is manual.
9. O.T.s: Some O.T.s have more than 1 table which is not as per norms. Monitoring & resuscitation equipment is inadequate.
10. ICUs: ICCU is not available. SICU is not available.
11. Preclinical departments of Anatomy, Physiology & Biochemistry do not exist. They are under construction.
12. Deficiency of faculty is 100 %.
13. Shortage of residents is 100 %.
14. Other deficiencies as pointed out in the assessment report.

In view of above and as the applicant has failed to meet the qualifying criteria u/s 3 (2) (5) of Establishment of Medical College Regulations, 1999 pertaining to the person owning and managing a hospital of not less than 300 beds, the Executive Committee of the Council decided to return the application recommending disapproval of the scheme for establishment of a new medical college at Chandrapur, Maharashtra by Govt. of Maharashtra under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956 for the academic year 2014-15 since there is no provision for keeping the application pending.

The Executive Committee of the Council considered the Council assessment report (6<sup>th</sup> and 7<sup>th</sup> June, 2014) and noted the following:-

1. Lecture Theaters: Only 1 lecture theater is available against requirement of 2 as per Regulations. Facility for E class is not available.
2. Central Library: Seating capacity is 180 against requirement of 200 as per regulations. External room is not furnished and internal room is partly furnished. No journals are available.
3. OPD: Teaching area is not available.
4. Wards: There is no demonstration room in any ward.
5. Clinical Material is grossly inadequate as under:
  - (a) OPD attendance: Daily average 180 against requirement of 400. On day of assessment, it was 120.
  - (b) Bed occupancy: Daily average 46 % against requirement of 60 %. On day of assessment it was 42 %.
  - (c) Major Surgical operations: daily average 1-3. On day of assessment it was 2.
  - (d) Deliveries: Daily average of Normal deliveries: 0-1.
  - (e) More number of beds were occupied by persons who were not actual patients.
6. Radiological Investigations: Daily average of plain X-rays is 42 which is inadequate.
7. Histopathology work is not carried out.
8. Demonstration rooms are not properly furnished in the departments of Anatomy, Physiology & Biochemistry.
9. Deficiency of faculty is 30 % (i.e. 16 out of 54) as detailed in report as under:
  - (a) Professor: 2
  - (b) Asso. Prof.: 4
  - (c) Asst. Prof.: 8
  - (d) Tutor: 2
  - (e) Majority of staff did not have any proof of salary being paid to them.
10. Shortage of Residents is 25 % (i.e. 12 out of 48) as detailed in report as under:
  - (a) Senior Resident: 10
  - (b) Junior Resident: 2
11. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to return the application recommending disapproval of the scheme for establishment of a new medical college at Ponnambi, Vellarada, Trivandrum, Kerala by Ruckmoni Memorial Charitable Educational Health Trust, Trivandrum, Kerala under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2014-15 since there is no provision for keeping the application pending.

The Executive Committee of the Council considered the compliance verification assessment report (9<sup>th</sup> June, 2014) alongwith previous assessment report (21<sup>st</sup> & 22<sup>nd</sup> March, 2014) and noted the following:-

1. Deficiency of residents is 24.6 % as detailed in report.
2. Many of the indoor patients could have been treated as outdoor patients.
3. OPD: During verification, 227 patients were recorded in central registration upto 11:00 a.m. while of these, only 109 were registered in different departmental OPDs.
4. No special investigations are performed in Radiology. Laboratory workload is not as per registered outdoor & indoor patients.
5. Histopathology & Cytopathology workload is inadequate. (Daily average only 2 each).
6. There was no patient in ICCU, MICU, NICU/PICU on day of assessment.
7. Intercom facility is available in administrative block only.
8. RHTC & UHC are still not under control of Dean. Residential accommodation is not available at RHTC.
9. There is no lecture theater in hospital.
10. No record maintained of the patients to whom drugs are given.
11. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision of recommending to the Central Govt. not to renew the permission for admission of 4<sup>th</sup> batch (150 MBBS seats) of Chintpurni Medical College, Gurdaspur, Punjab under the Baba Farid University of Health Sciences, Faridkot, Punjab u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

The Executive Committee of the Council considered the Council assessment report (4<sup>th</sup> and 5<sup>th</sup> June, 2014) and noted the following:-

1. Main college building and new hospital building are still under construction. Adjacent offices for ancillary staff and other required facilities are not available in temporary office of Dean.
2. Lecture Theater: Out of 2 lecture theaters required as per Regulations, one is non-functional as civil work is going on. In another, seating arrangement is not proper. Facility for E class is not available.
3. Central library: Under construction. Temporary accommodation is grossly inadequate as its area is only 600 sq.m. against requirement of 2,400 sq.m. as per Regulations.
4. Common Rooms for Boys & Girls: Under construction.
5. Students' Hostel: Under construction.
6. Residents' Hostel: Under construction. Temporary accommodation outside campus is not permissible.
7. Nurses' Hostel: Under construction.
8. Residential Quarters: Under construction.
9. OPD: Each department has only 1 examination room against requirement of 4 examination rooms as per Regulations. Space is inadequate and there is no patient privacy. Teaching area is not available. ECG room is not available. Plaster room & Plaster cutting room are not available. In Ophthalmology, separate dark room & dressing room are not available.
10. Audiometry & Speech therapy are not available.
11. Teaching Beds: Ancillary facilities are not available as new building is under construction.
12. Clinical material is inadequate as under:
  - (a) OPD attendance of 553 on day of assessment against requirement of 600 as per Regulations;
  - (b) Bed occupancy 40 % on day of assessment against requirement of 60 % as per Regulations;
  - (c) No delivery – Normal or caesarean – on day of assessment.
13. Radiological investigations are inadequate – Daily average Plain X-rays: 56.
14. Histopathology work is not performed.
15. O.T.s: Only 1 major O.T. available against requirement of 5 as per Regulations. Monitoring & resuscitation equipment is inadequate.
16. ICUs: Various ICUs & ICCU are not demarcated. Patients are kept in casualty block for care. There was only 1 patient in NICU/PICU.
17. Anatomy department: Students' lockers are not available. Cadavers are not available. In museum, specimens are kept on tables as racks are not available. There is no

preparation room. Civil work is incomplete in dissection hall. Histology laboratory is still under construction. There is no meat cutting machine.

18. Physiology department: Under construction.
19. Biochemistry department: Under construction.
20. Deficiency of faculty is 11.11 % (i.e. 7 out of 60) as detailed in report as under:
  - (a) Professor: 1
  - (b) Asso. Prof.: 3
  - (c) Asst. Prof.: 3
21. Shortage of Residents is 11.11 % (i.e. 5 out of 45) as detailed in report as under:
  - (a) Senior Resident: 5
22. Other deficiencies as pointed out in the assessment report.

6. Shortage of Residents is 33.33 % (i.e. 15 out of 45) as detailed in report as under:
  - (a) Senior Resident: 13
  - (b) Junior Resident: 2
7. Other deficiencies as pointed out in the assessment report.

5. Laboratory Investigations: Histopathology workload (Average 22 / day) and Cytopathological workload (Average 10 / day) are inadequate and not commensurate with the number of patients and number of major and minor operations performed daily.
6. Microbiology Department: Catalogues in museum are inadequate.
7. Shortage of Senior Residents is 12.06 % (i.e. 17 out of 141) as under:
  - (a) Senior Resident: 17 (Gen. Medicine: 2, Paediatrics: 1, Gen. Surgery: 6, Orthopaedics: 2, Ophthalmology: 2, Anaesthesiology: 1, Radiodiagnosis: 3)
8. Central Library: Area is 1,642 sq.m. against requirement of 3,200 sq.m.
9. Nursing staff is inadequate in ICUs and wards as detailed in report.
10. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2<sup>nd</sup> batch of MBBS students against the increased intake i.e. from 150 to 200 of JSS Medical College, Mysore, Karnataka under JSS University, Mysore u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

123. **Assessment of the physical and other teaching facilities available for Renewal of Permission for admission of 2<sup>nd</sup> batch against the increased intake i.e. from 100 to 150 MBBS student u/s 10A of the IMC Act, 1956 and also continuance of recognition of college for the award of MBBS degree for 100 seats u/s 11(2) of the IMC Act, 1956 at Govt. Medical College, Latur, Maharashtra under Maharashtra University of Health Sciences, Nashik for the academic year 2014-15.**

Read: the matter with regard to assessment of the physical and other teaching facilities available for Renewal of Permission for admission of 2<sup>nd</sup> batch against the increased intake i.e. from 100 to 150 MBBS student u/s 10A of the IMC Act, 1956 and also continuance of recognition of college for the award of MBBS degree for 100 seats u/s 11(2) of the IMC Act, 1956 at Govt. Medical College, Latur, Maharashtra under Maharashtra University of Health Sciences, Nashik for the academic year 2014-15.

The Executive Committee of the Council considered the Council assessors report (22<sup>nd</sup> and 23<sup>rd</sup> May, 2014) and noted the following:-

1. Examination Hall cum Auditorium: Available area is 300 sq.m. against requirement of 800 sq.m.
2. Lecture Theaters: Capacity of 2 lecture theaters is 150 against requirement of 180. Lecture theater of capacity 250 is not available.
3. Central Library: Area available is 1,600 sq.m. against requirement of 2,400 sq.m. Available seating capacity is 200 against requirement of 300.
4. Common room for Girls is not available.
5. Central photography unit is not available.
6. Interns' Hostel: Separate hostel is not available. Accommodation is provided in staff quarters.
7. Residents' Hostel: Separate hostel is not available. Accommodation is provided in department offices & in staff quarters which is not as per norms.
8. OPD: Registration counters are partly computerized. Instead of 4 examination rooms for each major department, only 2 rooms are available except for Surgery where 3 rooms are available. Enquiry desk is not available. Plaster cutting room is not available.
9. Speech therapy is not available.
10. Wards: Demonstration rooms are nonfunctional and do not have any furniture or teaching aid.
11. OPD attendance: Daily average is 773 which is inadequate.
12. On day of assessment, there were no major operations because of university examination.
13. Radiological Investigations: C.T. scan is nonfunctional. Special investigations are not performed.
14. MRD: It is manual.
15. Casualty: Separate casualty for O.G. is not available. Disaster Trolley is not available. Defibrillator & Ventilator are not available.
16. ICUs: RICU & SICU are not available.
17. Radiodiagnosis department: AERB approval is available for 1 machine only. Only 2 mobile X-ray machines are available against requirement of 6. Only 2 static X-ray machines are available against requirement of 5. CT scan is nonfunctional.
18. CSSD: Receiving & Distribution points are not separate.
19. Deficiency of faculty is 40.26 % (i.e. 60 out of 149) as detailed in report as under:
  - (a) Professor: 10
  - (b) Asso. Prof.: 18

- (c) Asst. Prof.: 7
- (d) Tutor: 25
- 20. Shortage of residents is 40.36 % (i.e. 44 out of 109) as detailed in report as under:
  - (a) Senior Resident: 31
  - (b) Junior Resident: 13
- 21. Other deficiencies as pointed out in the assessment report

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 2<sup>nd</sup> batch against the increased intake i.e. from 100 to 150 MBBS student at Govt. Medical College, Latur, Maharashtra under Maharashtra University of Health Sciences, Nashik for the academic year 2014-15.

With respect to the matter of continuance of recognition for the award of MBBS degree with intake of 100 seats, the Committee further decided to direct the institute to submit the compliance report towards rectification of deficiencies within a period of 3 months.

124. **Assessment of the physical and other teaching facilities available for Renewal of permission for admission of 4<sup>th</sup> batch of MBBS students against the increased intake from 100 to 150 at Katuri Medical College & Hospital, Guntur under Dr. NTR University of Health Sciences, Vijayawada for the academic year 2014-15 u/s 10A of the IMC Act, 1956 – Compliance Verification Assessment thereof.**

Read: the matter with regard to assessment of the physical and other teaching facilities available for Renewal of permission for admission of 4<sup>th</sup> batch of MBBS students against the increased intake from 100 to 150 at Katuri Medical College & Hospital, Guntur under Dr. NTR University of Health Sciences, Vijayawada for the academic year 2014-15 u/s 10A of the IMC Act, 1956.

The Executive Committee of the Council considered the compliance verification report (9<sup>th</sup> June, 2014) and noted the following:-

1. Only 4 static X-ray machines are available. Deficiency is not rectified.
2. Shortage of Residents is 8.08 % (i.e. 11 out of 136) as detailed in report as under:
  - (a) Senior Resident: 2
  - (b) Junior Resident: 9
3. Faculty attendance sheets were not signed within the stipulated period. Attendance registers of college & hospital are not properly maintained.
4. Other deficiencies as pointed out in the assessment report

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision of recommending to the Central Govt. not to renew the permission for admission of 4<sup>th</sup> batch of MBBS students against the increased intake from 100 to 150 at Katuri Medical College & Hospital, Guntur under Dr. NTR University of Health Sciences, Vijayawada for the academic year 2014-15 u/s 10A of the IMC Act, 1956.

For the present item, Dr. B.S. Aulakh, Member recused himself

125. **Assessment of the physical and other teaching facilities available for increase of MBBS seats from 70-100 u/s 10A of the IMC Act, 1956 and also compliance verification for continuance of recognition of college for the award of MBBS degree for 70 seats u/s 11(2) of the IMC Act, 1956 at Dayanand Medical College & Hospital, Ludhiana under Baba Farid University of Health Sciences, Faridkot for the academic year 2014-15.**

Read: the matter with regard to assessment of the physical and other teaching facilities available for increase of MBBS seats from 70-100 u/s 10A of the IMC Act, 1956 and also compliance verification for continuance of recognition of college for the award of MBBS degree for 70 seats u/s 11(2) of the IMC Act, 1956 at Dayanand Medical College & Hospital, Ludhiana under Baba Farid University of Health Sciences, Faridkot for the academic year 2014-15.

The Executive Committee of the Council considered the Council Assessor report (3<sup>rd</sup> & 4<sup>th</sup> June, 2014) and noted the following:-

1. Lecture Theaters: One lecture theater in college of capacity 120 and one lecture theater in hospital of capacity 150 are of gallery type. Remaining lecture theaters are not of gallery type and are smaller with capacity of 65 each. Only 1 theater has facility for E class. In 4 lecture theaters, only plain plastic chairs are kept which is not as per norms. (P. 24)
2. There is one common room for boys & girls combined which does not have attached toilets. (P. 25)
3. Although 21 quarters are claimed to have been allotted to faculty, on random checking it was found that in majority of quarters, M.B;B.S. students and Nursing students were staying which is not as per norms. Only in 5-6 quarters actual faculty was residing. (P. 26)
4. OPD: Capacity of teaching areas in various departments is 20 which is inadequate. (P. 29)
5. Anatomy department: There is only 1 demonstration room against requirement of 2 as per Regulations. Faculty rooms are small and less in number than faculty. Museum area is small – 80 sq.m. against requirement of 150 sq.m. (P. 43)
6. Physiology department: Area of laboratories is smaller than required: (i) Amphibian laboratory – Available 60 sq.m. against requirement of 150 sq.m.; (ii) Mammalian laboratory – Available 150 Sq.ft. against requirement of 60 sq.m.; & (iii) Clinical Physiology – Available 150 sq.ft. against requirement of 60 sq.m. There is no preparation room. There are no audiovisual aids in demonstration room. Faculty rooms are small. (P. 43)
7. Biochemistry department: There is only one practical laboratory which is small – 50 sq.m. against requirement of 150 sq.m. There is no anteroom. Faculty rooms are small and less in number than faculty. There is no library / seminar room. (P. 44)
8. Pathology department: There are no practical laboratories. There is no museum. Faculty rooms are small and less in number than faculty. There is no library / seminar room. (P. 44)
9. Microbiology department: Practical laboratory is small – 50 sq.m. against requirement of 150 sq.m. There are no service laboratories. There is no museum. There are no audio visual aids in demonstration room. Faculty rooms are small and less in number than faculty. (P. 44)
10. Pharmacology department: Faculty rooms are small and less in number than faculty. (P. 45)
11. Forensic Medicine department: There is no autopsy room. There is no cold storage. There is no museum. There are no audio visual aids in demonstration room. Faculty rooms are small and less in number than faculty. (P. 46)
12. Community Medicine department: There is no catalogue in museum. Faculty rooms are small and less in number than faculty. (P. 46)

In view of above, the Executive Committee of the Council decided to return the application recommending disapproval of the scheme for increase of MBBS seats from 70-100 u/s 10A of the IMC Act, 1956 at Dayanand Medical College & Hospital under Baba Farid University of health Sciences, Faridkot u/s 10A of the IMC Act, 1956 for the academic year 2014-15 since there is no provision for keeping the application pending.

With respect to the matter of continuance of recognition for the award of MBBS degree with intake of 70 seats, the Committee further decided to direct the institute to



submit the compliance report towards rectification of deficiencies within a period of 3 months.

126. **Assessment of the physical and the other teaching facilities available for establishment of a new medical college at Thodupuzha, Kerala by Noorul Islam Trust, Thodupuzha, Kerala under Kerala University of Health Sciences, Thrissur, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2014-15.**

Read: the matter with regard to assessment of the physical and the other teaching facilities available for establishment of a new medical college at Thodupuzha, Kerala by Noorul Islam Trust, Thodupuzha, Kerala under Kerala University of Health Sciences, Thrissur, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2014-15.

The Executive Committee of the Council considered the Council Assessor report (5<sup>th</sup> and 6<sup>th</sup> June, 2014) and decided to recommend to the Central Govt. to issue Letter of Permission for establishment of new medical college with annual intake of 150 seats at Thodupuzha, Kerala by Noorul Islam Trust, Thodupuzha, Kerala under Kerala University of Health Sciences, Thrissur, Kerala u/s 10A of the IMC Act, 1956 for the academic year 2014-15.

127. **Assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 4<sup>th</sup> batch (150 seats) of Srinivas Institute of Medical Sciences & Research Centre, Srinivasnagar, Mangalore, Karnataka under Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015 - Compliance verification assessment thereof.**

Read: the matter with regard to assessment of the physical and other teaching facilities available for renewal of permission for MBBS course for 4<sup>th</sup> batch (150 seats) of Srinivas Institute of Medical Sciences & Research Centre, Srinivasnagar, Mangalore, Karnataka under Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015 - Compliance verification assessment thereof.

The Executive Committee of the Council considered the compliance verification assessment report (7<sup>th</sup> June, 2014) alongwith previous assessment report (28<sup>th</sup> & 29<sup>th</sup> March, 2014) and decided to recommend to the Central Govt. to renew the permission for admission of 4<sup>th</sup> batch (150 seats) of Srinivas Institute of Medical Sciences & Research Centre, Srinivasnagar, Mangalore, Karnataka under Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2014-2015.

128. **Subharati Medical College, Meerut, UP under Swami Vivekanand Subharti University, Meerut – renewal of permission for admission of 5<sup>th</sup> batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic year 2014-15-compliance reg.**

Read: the matter with regard to renewal of permission for admission of 5<sup>th</sup> batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic year 2014-15 at Subharati Medical College, Meerut, UP under Swami Vivekanand Subharti University, Meerut.

The Executive Committee of the Council considered the letter dated 09/06/2014 received from the college authorities furnishing the compliance report for rectification of deficiencies pointed out by the Council assessors in the Assessment

report as forwarded by the Central Government vide letter dated 13<sup>th</sup> June, 2014 as well as the report of the Sub-Committee meeting held on 12/06/2014 and noted that the tabulated statement purporting to be a compliance report itself shows that the deficiencies which have been pointed out in the assessment report dt. 11<sup>th</sup> and 12<sup>th</sup> April, 2014 have been agreed to and endorsed by the Dean. Further, the deficiencies have not been rectified and the college is only claiming that the deficiencies pointed out by the Council actually do not exist. Further this claim made by the college would be required to be physically verified. The same is not possible to be carried out by the MCI before 15.06.14 when the said authorities itself are claiming to remove the deficiencies after 15.06.14.

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 5<sup>th</sup> batch of MBBS students against the increased intake i.e. from 100 to 150 for the academic year 2014-15 at Subharati Medical College, Meerut, UP under Swami Vivekanand Subharti University, Meerut and returned the compliance to the Central Govt.

129. **Establishment of a new medical college at Jodhpur, Rajasthan by Kushal Education Trust, Jaipur, Rajasthan under Jodhpur National University, Jodhpur u/s 10A of the IMC Act,1956 for the academic year 2014-15.**

Read: the matter with regard to establishment of a new medical college at Jodhpur, Rajasthan by Kushal Education Trust, Jaipur, Rajasthan under Jodhpur National University, Jodhpur u/s 10A of the IMC Act,1956 for the academic year 2014-15.

The Executive Committee of the Council considered the Central Government fax letter dated 13<sup>th</sup> June, 2014 received in the Council on 13<sup>th</sup> June,2014 at 3.24 pm enclosing the observations of the Committee constituted by the Ministry on the hearing/documents submitted at the time of hearing by the authorized representatives of the medical college and the complaint dt. 25.05.2014 and noted that the tabulated statement purporting to be a compliance report itself shows that the deficiencies which have been pointed out in the assessment report dt. 25<sup>th</sup> and 26<sup>th</sup> April, 2014 have been agreed to and endorsed by the Dean. Further, the deficiencies have not been rectified and the college is only claiming that the deficiencies pointed out by the Council actually do not exist. Further this claim made by the college would be required to be physically verified. The same is not possible to be carried out by the MCI before 15.06.14 when the said authorities itself are claiming to remove the deficiencies after 15.06.14.

In view of above, the Executive Committee of the Council decided to reiterate its earlier decision to return the application to the Central Govt. recommending disapproval of scheme for establishment of a new medical college at Jodhpur, Rajasthan by Kushal Education Trust, Jaipur, Rajasthan under Jodhpur National University, Jodhpur u/s 10A of the IMC Act,1956 for the academic year 2014-15 and returned the compliance to the Central Govt.

130. **Recognition of Mahatma Gandhi Medical College & Hospital, Jaipur for increased intake from 100 to 150 seats u/s 11(2) of the IMC Act- reg.**

Read: the matter with regard to Recognition of Mahatma Gandhi Medical College & Hospital, Jaipur for increased intake from 100 to 150 seats u/s 11(2) of the IMC Act-reg.

The Executive Committee of the Council considered the compliance report of Mahatma Gandhi Medical College & Hospital, Jaipur for increased intake from 100 to 150 seats u/s 11(2) of the IMC Act dated 10<sup>th</sup> June, 2014 as forwarded by Ministry of Health & F.W., New Delhi dated 11<sup>th</sup> June, 2014 alongwith the legal opinion of the Law Officer of the Council which is as under:-



*“The representation dated 10.06.14 of the Mahatma Gandhi University of Medical Sciences & Technology, Jaipur has been forwarded by the Central Govt. vide letter dated 11.06.2014 to this Council for further necessary action as per provisions of IMC Act, 1956 and Regulations. It is mentioned in the covering letter that it is “Compliance Report-Recognition of Mahatma Gandhi Medical College & Hospital, Jaipur for increased intake from 100 to 150 MBBS seats”. This has been referred for my opinion.*

2. *I have perused the representation that has been quoted on pre-page notes 1-4. Briefly stated the contention of the College is that the decision dated 03.07.2013 of the Board of Governors not to approve for 150 seats and show cause u/s 8.3 (1) (c) was stayed vide Order dated 15.07.13 in SBCWP 12234 of 2013. This decision was communicated to the College vide Council letter dated 13.07.13 which the College states in its aforesaid representation was received by it on 15.07.13. Further, the College contends that this decision was taken in complete violation of the principles of natural justice and provisions of IMC Act. It has also been contended by the College that subsequently it has been granted recognition/increase in seats in respect of PG courses by the BOG, and in the light of this it has called upon the Central Government that the recommendation of the BOG dated 29.05.13 for grant of recognition against increased intake capacity from 100 to 150 and continuance of recognition be issued by the Government of India.*

3. *It is to be noted that Hon’ble High Court in its Order dated 15.07.13 in SBCWP 12234 of 2013 has inter alia passed the following order:-*

*“Taking note of the submissions made, but without expressing nay opinion, this Court considers appropriate to keep the decision of the respondent no. 1 dt. .3.7.2013 as regards the petitioner in abeyance however, that will not preclude the respondent from proceeding with the matter with due compliance of the principles of natural justice, but, at the same time, considers appropriate to grant liberty to the petitioner to proceed in accordance with the approval of minutes of meeting held on 29.5.2013. However, it is further made clear that the petitioner must indicate regarding such of the admissions that it will remain subject to outcome of the matter pending before the Court.”*

4. *The case has thereafter been heard on several dates and Council has also filed its reply affidavit in the matter. It is important to note that in hearing on 14.12.13 the Hon’ble Court was pleased to pass the following Order:-*

*“The matter is adjourned with the clear understanding that parties may come prepared on the next day and no further adjournment shall be granted considering that fifty students have been provisionally admitted by virtue of the interim-order passed by this Court and if eventually, the petition is dismissed, grave inconvenience would be caused to such students. The parties may file their written statement in advance.”*

5. *The College in its representation to the Central Government contended that the Court had not precluded the MCI from proceeding with the matter with due compliance to principles of natural justice. Further, it contends that the MCI “ought to have withdrawn the decision /communication dated 03.07.2013 – on its own and ought to have taken the necessary steps for making formal recommendation to the Govt. of India for the formal recognition of the medical college for MBBS course with 150 admissions annually”.*

6. *It may be noted that instead of replying to the Show-Cause dated 13.07.2013, the College vide its letter dated 09.09.13 had communicated to the Council inter alia as under:-*

*“....With response to above, it is informed that the issue raised in your aforesaid letter is already sub judice before the Hon’ble High Court judicature of Rajasthan, Jaipur Bench in SB Civil Writ Petition No. 12234/2013.*

*The MCI is already a party and notices have been served and reply has also been received by us. The Hon’ble Court has granted a stay on further proceeding and therefore no action can be taken under your letter under reference in view of lispendence and therefore no action can be taken on your letter under reference in view of lispendence...”*

7. *The aforesaid letter is not part of the Enclosures annexed with the representation of the College dated 10.06.14 addressed to the Central Government. Thus, the College instead of replying to the Show-Cause dated 13.07.13 chose to take the ground that because of the pendency of Court case MCI cannot take any action.*

8. *Now, in its representation dated 10.07.14 to the Central Government the College is alleging that MCI has not proceeded against it in accordance with the principles of natural justice. Suffice it to state that the stand taken by the College is self-contradictory. The College on the one hand contends that because of Court case in Rajasthan High Court the Council cannot proceed against it, while on the other hand, it alleges that the MCI has not complied with the Court Order by proceeding against it in accordance with natural justice.*

9. *Further, the Order of the Hon'ble High Court dated 15.07.13 was in respect of academic year 2013-14, and this is clearly noted by the Hon'ble High Court in its Order dated 14.12.13. Thus, based upon the Order dated 15.07.13 of the Hon'ble High Court the College cannot proceed to admit students for admission in MBBS for academic year 2014-15, as without there being issuance of notification u/s11 (2) of the Indian Medical Council Act, 1956 it is not permissible for the College to admit students in MBBS against the increased intake from 100 to 150. Moreover, as per the scheme of Regulations, a College has to apply six-months in advance for renewal of permission to admit students. The College has not made any such application within the prescribed six-months. Hence, the claim of the College to admit students based upon interim order dated 15.07.13 of the Hon'ble High Court cannot be considered. The Order dated 14.12.13 of the Hon'ble High Court is loud and clear that it is limited to fifty students who were provisionally admitted.*

10. *The representation of the College made to the Central Government may be disposed of stating the afore-said reasons if deemed appropriate."*

The Executive Committee of the Council accepted the above legal opinion and decided to return the compliance report/representation of the college to the Central Govt., Ministry of Health & F.W.
