The Executive Committee of the Council considered the Council Assessors report (07<sup>th</sup> & 08<sup>th</sup> November, 2014) and decided to recommend to the Central Govt.

Assessment of the physical and the other teaching facilities available for renewal of permission for MBBS course for 5<sup>th</sup> batch of 100 seats of Major S.D Singh Medical College and Hospital, Fatehgarh, Farrukhabad, Uttar Pradesh under Chhatrapati Shahuji Maharaj University, Kanpur u/s 10A of the IMC Act, 1956 for the academic year 2015-16.**

Read: the matter with regard to assessment of the physical and the other teaching facilities available for renewal of permission for MBBS course for 5<sup>th</sup> batch of 100 seats of Major S.D Singh Medical College and Hospital, Fatehgarh, Farrukhabad, Uttar Pradesh under Chhatrapati Shahuji Maharaj University, Kanpur u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Executive Committee of the Council considered the Council Assessors report (11<sup>th</sup> & 12<sup>th</sup> November 2014) and noted the following:-

1. Deficiency of teaching faculty is 61 % as detailed in the report.
2. Shortage of Residents is 82 % as detailed in the report.
3. OPD: Separate registration counters for OPD / IPD are not available. Staff is not adequate as there are only 2 counters. Enquiry desk is not available.
4. Wards: All indoor wards except a few were closed. There were no indoor patients / doctors / staff in these wards. Hospital is nearly non-functional.
5. OPD attendance was only 208 on day of assessment. Upto 10:45 a.m. only 8 patients registered in all OPDs. Till 11:30 a.m. no patient was registered in General Surgery, Paediatrics, ENT, Ophthalmology, Skin & VD and Psychiatry OPDs. On 08/11/2014 & 10/11/2014, number of patients in General Medicine OPD was NIL.
6. Bed occupancy was 1 % on day of assessment. There were only 2 patients in male Surgery ward.
7. There were no major or minor operations on day of assessment.
8. There were no normal or Caesarean sections on day of assessment.
9. There were no radiological investigations on day of assessment. After 30/10/2014, there was no entry in the X-ray register and after 02/11/2014, no entry in USG register.
10. Laboratory investigations were grossly inadequate. No patient was registered till 10:45 a.m. in Central clinical laboratory. There were only 33 investigations of Biochemistry + haematology on day of assessment. There were no investigations of Microbiology, Serology, Histopathology, Cytopathology.
11. Casualty: Only 10 beds are available against requirement of 20 as per regulations. There only 2 admissions on day of assessment.
12. O.T.s: Only 6 O.T.s are available against requirement of 7 as per Regulations.
13. There was no patient in ICCU, MICU, SICU, NICU/PICU on day of assessment.
14. Labour room was locked and closed.
15. Nursing staff: Only 15 nurses were verified in morning shift out of 227 required.
16. In the same campus and in proximity, same management runs Ayurvedic medical college & hospital. It appears that clinical material, staff, hostels, quarters, infrastructure are shared by both institutes.
17. Teaching & Non-teaching staff quarters, nursing hostels and Resident quarters of Ayurvedic Medical college were shown to assessors as for this institute. However on random verification they were found to be of Ayurvedic medical college.
18. Dr. S.K. Sharma, Professor of Paediatrics, Dr. Atiz Rashid, SR and some other faculty members & Residents had shown their addresses in Residents' or Teaching staff quarters in their D.F.; however on physical verification, some Ayurvedic doctors were found occupying the same quarters.



19. Data of clinical material supplied by the hospital does not match with registers.
20. There is no signage board of Unit wise doctors in OPD/O.T./Wards.
21. Declaration Forms of faculty & Residents were submitted very lately and were incomplete. Signature of Dean on these D.F. does not match with signature of present Dean.
22. College Council room is not available.
23. Details of Medical Education Unit like faculty of MEU, training undergone by the faculty, workshops & programmes organized during the year are not provided.
24. The institute has organized 4 CME programmes during the year; however no credit hours have been awarded for the same.
25. Examination hall cum Auditorium is under construction.
26. Lecture Theaters: One lecture theater of 250 capacity is under construction. Another one is under repair. Facility for E class is not available.
27. Interns' Hostel is not available.
28. Residents' Hostel: Accommodation is available for 80 Residents against requirement of 85 as per Regulations.
29. Dean's office is not available in the affiliated teaching hospital.
30. Paramedical & Non-teaching staff: Only 52 staff in morning shift could be verified against requirement of 179.
31. Website: Details are not updated. Details of admitted students and results of examination have not been updated since 2012.
32. RHTC: Residential accommodation is not available. Specialists' visits are not organized.
33. Videography was not arranged by the institute.
34. Assessment Form Part I was not provided by the institute.
35. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 5<sup>th</sup> batch (100 seats) of Major S.D Singh Medical College and Hospital, Fatehgarh, Farrukhabad, Uttar Pradesh under Chhatrapati Shahuji Maharaj University, Kanpur u/s 10A of the IMC Act, 1956 for the academic year 2015-2016 and further decided to apply clause 8(3)(1)(b) of Establishment of Medical College Regulation (Amendment), 2010 (Part II), dated 16<sup>th</sup> April, 2010 which reads as under:-

“8(3)(1).....

(b) *Colleges in the stage upto III renewal (i.e. Admission of fourth batch) till recognition of the institute for award of MBBS degree.*

*If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 20% and/or bed occupancy is <70%, such an institute will not be considered for renewal of permission in that Academic Year.”*

8. **Assessment of the physical and the other teaching facilities available for renewal of permission for MBBS course for 5<sup>th</sup> batch of 100 seats of Gold Field Institute of Medical Sciences & Research, Ballabgarh, Faridabad, Haryana under Pt. B.D Sharma University of Health Sciences, Rohtak, Haryana u/s 10A of the IMC Act, 1956 for the academic year 2015-16.**

Read: the matter with regard to assessment of the physical and the other teaching facilities available for renewal of permission for MBBS course for 5<sup>th</sup> batch of 100 seats of Gold Field Institute of Medical Sciences & Research, Ballabgarh, Faridabad, Haryana under Pt. B.D Sharma University of Health Sciences, Rohtak, Haryana u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Executive Committee of the Council considered the Council Assessors report (11<sup>th</sup> & 12<sup>th</sup> November 2014) and noted the following:-

1. Deficiency of faculty is 38.6 % as detailed in the report.

2. Shortage of Residents is 88.35 % as detailed in the report.
3. OPD attendance was only 157 at 2:30 p.m. on day of assessment which is grossly inadequate.
4. Bed occupancy was 41.3 % (i.e. 170 out of 402) at 2:30 p.m. on day of assessment. Computation sheet has been signed by Medical Superintendent also.
5. Students' Hostels: Some of the rooms in Boys' Hostel did not have adequate furniture. Study room is without working A.C. & computer. There is no music / TV in recreation room.
6. Residents' & Nurses' hostels do not have visitors' room, A.C. study room with computer & internet and recreation room. Male staff nurses were found staying in Residents' Hostel # 3. Rooms in the Residents' Hostel were not occupied by the Residents as per list provided by the college.
7. Casualty attendance was NIL on day of assessment.
8. There were only 7 major & 5 minor operations on day of assessment. There is no proper record available in the O.T. like specimen sent for Histopathology. Badly maintained Histopathology register reflects the scenario. Records in O.T. register appear to be manipulated.
9. Histopathology workload was only 5 and Cytopathology workload was only 7 on day of assessment.
10. Data of Radiological & Laboratory investigations submitted by the institute is not matching with actual observation by assessors. Till 12 noon, in OPD very few patients were seen at registration counters, waiting area & various OPDs.
11. O.T.s: A.C. in General Surgery O.T. is not working. Equipment like Multipara monitor, Defibrillator, Infusion Pumps is not available.
12. Details of patients in ICCU, ICUs are not provided.
13. Records of reported X-rays were not kept as hard copy or in the register.
14. Laboratory investigations on first day of assessment till 1:00 p.m. was as under:
  - (a) Biochemistry: 45 OPD samples (100 tests) & 16 IPD samples (110 tests);
  - (b) Microbiology: 12 OPD & 1 IPD samples;
  - (c) Serology: 51 OPD & 10 IPD tests;
  - (d) Cytopathology: 1 repeat sample.
15. Ten faculty members & 08 Residents cannot be considered due to reasons mentioned in detail in the report.
16. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 5<sup>th</sup> batch (100 seats) of Gold Field Institute of Medical Sciences & Research, Ballabgarh, Faridabad, Haryana under Pt. B.D Sharma University of Health Sciences, Rohtak, Haryana u/s 10A of the IMC Act, 1956 for the academic year 2015-2016 and further decided to apply clause 8(3)(1)(b) of Establishment of Medical College Regulation (Amendment), 2010 (Part II), dated 16<sup>th</sup> April, 2010 which reads as under:-

*"8(3)(1).....*

*(b) Colleges in the stage upto III renewal (i.e. Admission of fourth batch) till recognition of the institute for award of MBBS degree.*

*If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 20% and/or bed occupancy is <70%, such an institute will not be considered for renewal of permission in that Academic Year."*

The Executive Committee of the Council further noted that the institute has admitted students for 2014-2015 pursuant to order of Hon'ble Supreme Court after filing two undertakings dated 27.09.2014 in the name of Krishan Lal Adlakha and Shashi Adlakha which state as under:

*“1. I say that the deficiencies recorded by the Medical Council of India appointed assessors on 23<sup>rd</sup> and 24<sup>th</sup> April, 2014 in relation to our institute have been duly rectified and there exists no deficiency as on today in the medical college run by the Sanstha of the Respondent No. 1*

*2. I say that if the above statement is found to be incorrect at the time of next inspection, the deposit of the institution with MCI shall stand forfeited.”*

In view of the deficiencies listed above, it is amply evident that the institute has failed to rectify previous deficiencies which are still persisting.

The Executive Committee of the Council also perused the order of Hon'ble Apex Court dt. 18/09/2014 & 25/09/2014, the operative part of which reads as under:

*“The relevant portion of the order dated 18.09.2014 passed in W.P. (C) No. 469/2014 by the Hon'ble Supreme Court is reproduced hereunder:-*

*“ Heard the learned senior counsel appearing for both the sides.*

*Looking at the peculiar facts and circumstances of the case and, especially, when several seats for medical admission are likely to remain vacant for the academic year 2014-15, we are of the view that these matters require urgent consideration and we are giving these interim directions under the provisions of Article 142 of the Constitution of India.*

*There is one more reason for passing this interim order. We are conscious of the fact that number of physicians in our country is much less than what is required and because of non-renewal of recognition of several medical colleges, our citizens would be deprived of a good number of physicians and therefore, we are constrained to pass this order, whereby at least there would be some increase in the number of physicians after five years. We are running against time because the last date for giving admissions to MBBS Course for the academic year 2014-15 is 30th September, 2014.*

*We also desire to reconsider the directions given by this Court in the judgment of Priya Gupta v. State of Chhattisgarh [(2012) 7 SCC 433], but at this juncture, as we do not have sufficient time to decide all these petitions finally, we are passing this interim order and the matter with regard to reconsideration of the aforesaid judgment would be considered while finally disposing of this group of petitions.*

*It has been submitted on behalf of the learned senior counsel appearing for all the petitioners/ respondents, who are managing medical colleges, that the defects which had been recorded at the time of the last inspection by the representatives of the Medical Council of India have been duly rectified and at present, the defects pointed out in the reports do not exist. The said fact can be ascertained only by having a fresh Compliance Verification/Inspection. However, the stand taken by the Central Government and the Medical Council of India is to the effect that no such inspection can be undertaken in the present academic session because of paucity of time and it would violate the time schedule laid down by this Court in the case of Priya Gupta (supra).*

*The learned senior counsel appearing for the Medical Council of India has also submitted that the petitioners do not have any legal right for getting renewal of the recognition, especially in view of the fact that the Verification/Inspection Reports are not available for the period in question. The learned senior counsel has relied upon some of the Judgments to substantiate his case and according to him, it would not be just and proper to permit the said medical colleges to take fresh batch of students.*

*Looking at the peculiar facts of the case and the circumstances stated hereinabove, we direct the petitioners to file undertakings by President/Chairman and Secretary of the petitioners' institutions running medical colleges within 10 days from today, to the effect that there is no defect in the medical colleges run by them and they would also state that their deposit with the MCI, which is around Rs.10 Crores, be forfeited by way of penalty if the statement made in the undertaking is found to be incorrect at the time of the next inspection. A draft undertaking has been given to this Court. A copy of the undertaking, which might be filed by the institutions, shall be served upon the office of the Medical Council of India as well as to the Ministry of Health and Family Welfare, Govt. of India, New Delhi.*

*We also record the fact that in the recent past, the Medical Council of India has renewed recognition of Government Medical Colleges on the basis of undertakings and therefore, we see no reason not to permit the private colleges to admit students on the basis of undertakings given by their office bearer as a special case.*

*Notwithstanding any direction given in the case of Priya Gupta (supra), if undertakings as stated hereinabove are filed by the institutions managing medical colleges for the academic year 2014-15, admissions shall be given to the students from the merit list*



prepared by the States and they shall be charged fees prescribed by the Government Medical Colleges of their respective States. The State Authorities, i.e., the Directorate of Medical Education & Research, of the respective States shall send students, in order of their merit, to the medical colleges run by the petitioners, which are situated within their States, within one week from the date of receipt of a copy of this order and the said students shall be admitted to the MBBS Course in accordance with the rules and regulations of the MCI and also regulations dated 16.04.2010 framed by the Medical Council of India, provided undertakings as mentioned above are filed on behalf of the concerned institutions.

It is also clarified that there would be no further counseling in respect of the students who are to be given admission, even if it might result into some heartburning among other students, but in the peculiar facts of the case, we give this direction.

In no case, the admission shall be given after 30<sup>th</sup> September, 2014. This order shall also apply to all the institutions which had filed their petitions earlier for renewal of their recognition for the academic year 2014-15, but their petitions were rejected or withdrawn for whatever reason, provided undertakings as stated hereinabove are filed by President/Chairman and the Secretary of those institutions. All those petitions shall be deemed to have been revived and this order shall be deemed to have been passed in those cases also. This order shall only be in respect of renewal of recognition and not for creation of additional seats or for new colleges.

We also record that the Union of India has supported the petitioners in the interest of students. We also direct the Union of India to give wide publicity to this order in print as well as electronic media in the interest of the concerned students.

It is directed that the list of students getting admission in pursuance of this order shall be placed on record of this Court by 1st October, 2014 by the concerned institutions and a copy thereof shall also be sent to the MCI.

These matters shall be treated as part-heard and shall be notified for further hearing in the month of December, 2014."

The Hon'ble Supreme Court thereafter vide its order dated 25.09.2014 issued certain clarification in respect to the order dated 18.09.2014 in W.P. (C) No. 469/2014, which are reproduced hereunder:-

"After hearing the learned counsel for the parties we deem it appropriate to issue following clarifications with regard to our earlier order dated 18th September, 2014. These clarifications shall be read into the said order as if they were always part thereof:-

1. The order dated 18th September, 2014 shall also apply to cases where colleges or institutions were seeking increase in intake capacity and in the current year have been denied permission to admit students after first or second or third or fourth renewal/inspection. In our view such institutions where Renewal/Inspection with respect to increase in capacity were conducted in the present academic year are also entitled to the benefit under the order dated 18<sup>th</sup> September, 2014.

2. We also clarify that fees chargeable from the students admitted pursuant to our order dated 18<sup>th</sup> September, 2014 shall be at the same rates as applicable to the students in Government medical colleges in respective States and such fees shall be at the same levels as that of the Government medical colleges till the students so admitted pass out from the private medical colleges or institutions.

3. Our order shall also apply to all similarly situated institutions irrespective of the fact whether any petitions were or are pending in this Court or in any of the High Courts or even if they had not approached any court at all. This order shall also apply even in cases where there were orders of stay in favour of the Medical Council of India restraining the colleges from admitting students for the current academic session.

4. The order shall not apply to colleges or institutions which have been disqualified by the Medical Council of India and/or the Central Government and have been prohibited from making any admissions for the current academic year 2014-15.

5. In cases where two separate lists are prepared and sent by the State agencies one relating to State quota and the other relating to management quota in private institutions, we clarify that for the current academic year there shall be only one list and that shall be the "State quota" alone. There shall not be any management quota list to be sent to the private colleges or institutions taking the benefit under our order dated 18th September, 2014. The Management quota shall also be filled through

*the State list and the fees chargeable for the management quota shall also be charged at the same levels and rates as applicable to State quota list.*

*6. We further clarify that private institutions taking benefit under our order dated 18th September, 2014 shall have to take students only from the State agencies and at fees chargeable for students in Government medical colleges as stated above, regardless of their status or claim as Minority Institutions or Deemed Universities.”*

In view of above, the members of the Executive Committee further decided to revoke the Bank Guarantees submitted by the Institute and directed the Institute to submit fresh bank guarantees within 2 weeks.

**9. Assessment of the physical and the other teaching facilities available for renewal of permission for MBBS course for 3<sup>rd</sup> batch of 100 seats of Shaheed Hasan Khan Mewati Government Medical College, Nalhar, Mewat, Haryana under Pt. B.D Sharma University of Health Sciences, Rohtak, Haryana u/s 10A of the IMC Act, 1956 for the academic year 2015-16.**

Read: the matter with regard to assessment of the physical and the other teaching facilities available for renewal of permission for MBBS course for 3<sup>rd</sup> batch of 100 seats of Shaheed Hasan Khan Mewati Government Medical College, Nalhar, Mewat, Haryana under Pt. B.D Sharma University of Health Sciences, Rohtak, Haryana u/s 10A of the IMC Act, 1956 for the academic year 2015-16.

The Executive Committee of the Council considered the Council Assessors report (11<sup>th</sup> & 12<sup>th</sup> November 2014) and noted the following:-

1. Deficiency of faculty is 25 % as detailed in the report.
2. Shortage of Residents is 57 % as detailed in the report.
3. The institute has conducted CME programmes during the year; however no details about credit hours awarded for the same have been provided.
4. Central Library: Reading room for Residents is not available. Deputy librarian is not available.
5. Radiological Investigations: Workload of special investigations like Ba, IVP is NIL on day of assessment as well as on 3 randomly selected days.
6. Histopathology workload is only 7 on day of assessment.

8. Bed occupancy is < 60 % on day of assessment. At 5:30 p.m. on 11/11/2014, male Medicine ward was empty. In General Surgery ward there were only 6 patients, in Orthopaedics ward only 4 & in labour room only 3 patients. This suggests gross mismatch of clinical workload.

5. No workshop in Medical education technology has been conducted by the institute during the year.
6. Lecture Theaters: No lecture theater of capacity 180 is available against requirement of 2 as per Regulations. Lecture theater in hospital is not available. (
7. Central Library: Area available is 900 sq.m. against requirement of 2,400 sq.m. as per Regulations. Capacity of reading room (outside) is 64 & of reading room (inside) is 108 against requirement of 150 for both as per Regulations.

8. Common rooms for Boys & Girls: There is only 1 common room between boys & girls. It is smaller than required as per Regulations.
9. Interns' Hostel: No separate hostel is available for interns. They are accommodated with PG students.
10. No residential quarters are available for teaching faculty & non-teaching staff in the campus.
11. Medical Superintendent's office is smaller than norms. Dean's office is not available in the hospital.
12. OPD: Ophthalmology OPD has one hall with no cubicles. Teaching areas are smaller with capacity of 20 against requirement of 30. Separate injection rooms for males & females are not available. Male & female dressing room is common. Minor O.T. is not available. Plaster room & Plaster cutting room are common.
13. Audiologist & Speech therapist are not available.
14. Wards: Distance between 2 beds is less and highly congested. There is no separate Skin & VD ward. It is shared with General Medicine ward. Examination/Treatment room & Doctors'/Students room are not available in several wards. Pantry is not available in any ward. Demonstration room in General Surgery has capacity of only 8-10.
15. Casualty: Disaster Trolley & Ventilator are not available.
16. ICCU: There is no Pulse Oxymeter & Ventilator.
17. NICU: There are 2-3 babies in each warmer which is not only not as per norms but potential threat of cross infection.
18. Only 2 mobile X-ray machines are available against requirement of 6 as per Regulations. Out of these, only 1 is functional.
19. Only 4 static X-ray machines are available against requirement of 5 as per Regulations.
20. AERB approval for the college is not obtained.
21. Blood separation facility is not available.
22. ETO sterilizer is not available. Receiving & Distribution points are not separate.
23. Nursing staff: 395 nursing staff is available against requirement of 403.
24. Anatomy department: There is only 1 demonstration room against requirement of 2 as per Regulations. Mounted specimens are only 97.
25. Pathology department: Mounted specimens are only 100.
26. RHTC: It is under the control of Vijaywada Municipal Corporation and not under the Dean. Residential accommodation & mess are not available. There is no Epidemiologist in Community Medicine department.
27. Other deficiencies as pointed out in the assessment report.

3. Hostels: Some rooms do not have adequate furniture.
4. Nurses' hostel is not available.
5. Residential quarters: Only 35 quarters are available for teaching faculty against requirement of 51. Only 22 quarters are available for non-teaching staff against requirement of 40.
6. OPD: Dressing room for male/female is common. Plaster room & Plaster cutting room are common. Waiting areas are too small and overcrowded. Viewing boxes are not provided in most of OPDs.
7. Wards: In some wards, distance between two beds is less than 1.5 m. Capacity of demonstration rooms is 10-20 only. Doctors' duty room is not available. There is no pantry in any ward. There is no lift or ramp for the patient.
8. MRD is manual.
9. Casualty: Only 16 beds are available against requirement of 30.
10. Website: it is sketchy. Details of faculty & non-teaching staff, CMEs, affiliated University, infrastructure, citizens' charter, list of admitted students, results of examinations are not provided.
11. Anatomy department: There is shortage of 1 demonstration room. Capacity of 2 available demonstration rooms is 50 against requirement of 60-75 each.
12. Physiology department: Demonstration rooms have less capacity. Haematology & Clinical Physiology laboratories are common in one room.
13. Biochemistry department: Two demonstration rooms have less capacity. Students' laboratory has less seats.
14. Pharmacology department: Two demonstration rooms have less capacity. Clinical Pharmacology laboratory is not available.
15. Forensic Medicine department: Two demonstration rooms have less capacity.
16. Community Medicine department: Only 2 demonstration rooms are available against requirement of 3.

17. RHTC: Residential accommodation is of dormitory type. Mess is not available. Specialists' visits are not organized. There is no vehicle.
18. UHC: It is under control of Municipal Corporation and not under Principal. Specialists' visits are not organized.
19. Intercom is not available in OPD.
20. O.T.: Preanaesthetic room has only 1 bed. Postoperative recovery room is not available.
21. CSSD: No records are available regarding material being sterilized. Sterilization validation is not available. It is open on all sides with chances of flies and dust coming in.
22. Adequate rooms for faculty are not available.
23. Other deficiencies as pointed out in the assessment report.

8. Website: It is sketchy. Information regarding teaching faculty, non-teaching staff, CMEs, affiliating University, infrastructure, Citizens' charter, list of admitted students, results of examinations, anti-ragging committee, toll free number to report ragging is not provided.
9. Physiology department: Clinical Physiology laboratory has 6 beds against requirement of 12. Capacity of 1 demonstration room is smaller than required.
10. Biochemistry department: Capacity of 1 demonstration room is smaller than required.
11. Pathology department: Capacity of 1 demonstration room is smaller than required.
12. Microbiology department: Capacity of 1 demonstration room is smaller than required.
13. Pharmacology department: Capacity of 1 demonstration room is smaller than required.
14. RHTC: Cold chain equipment is not available.
15. Other deficiencies as pointed out in the assessment report.

11. There is only 1 demonstration room available each in departments of Physiology, Biochemistry, Pathology, Microbiology, Pharmacology, Forensic Medicine against requirement of 2 in each department.
12. RHTC: Specialists' visits are not organized.
13. UHC: It is under control of Siliguri Municipal Corporation and not under control of principal which is not as per Regulations. Specialists' visits are not organized.
14. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 3<sup>rd</sup> Batch of MBBS students against the increased intake i.e. from 100-150 of North Bengal Medical College, Darjeeling under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.

**51. Consideration of Compliance Verification Assessment with regard to continuance of recognition of MBBS degree granted by Vinayaka Mission's University, Salem in respect of students being trained at Aarupadai Veedu Medical College and Hospital, Puducherry.**

Read: the matter with regard to consideration of Compliance Verification Assessment with regard to continuance of recognition of MBBS degree granted by Vinayaka Mission's University, Salem in respect of students being trained at Aarupadai Veedu Medical College and Hospital, Puducherry.

The Executive Committee of the Council considered the compliance verification assessment report (10<sup>th</sup> September, 2014) and noted the following:-

1. OPD: In Ophthalmology OPD, Dressing room / Minor procedure room is not functional. In Paediatric OPD, Immunization clinic is not optimally functional. Child guidance clinic & Child rehabilitation clinic are not available. (P. 36)
2. OPD attendance on day of assessment was 793. The figures provided by the college appear to be inflated. (P. 38)
3. Bed occupancy on day of assessment was 15-20 %. (P. 38)
4. There were only 2 major operations in the hospital on day of assessment. (P. 38)
5. CT scan is not available. (P.39)
6. Histopathology workload on day of assessment is only 3 which is grossly inadequate. (P. 40)
7. RICU is not available. (P. 45)
8. Intercom is non functional. (P. 47)
9. Deficiency of faculty is 9 % as detailed in report. (P. 57)
10. Shortage of Residents is 22 % as detailed in report. (P. 57)
11. O.T.: Most of O.T.s wore deserted look. It did not seem that operations were done on regular basis. (P. 58)
12. Figures provided by institute of investigations appear to be inflated. (P. 58)

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Vinayaka Mission's University, Salem in respect of students being trained at Aarupadai Veedu Medical College and Hospital, Puducherry and further decided that the institute be asked to submit the compliance of rectification of the above deficiencies within 3 months.

The Executive Committee of the Council considered the Council Assessors report (13<sup>th</sup> & 14<sup>th</sup> October, 2014) and noted the following:-

1. Deficiency of faculty is 26.75 % as detailed in report.
2. Shortage of Residents is 33.75 % as detailed in the report.
3. MEU: No workshop on Medical Education technology has been conducted during the year.
4. Lecture Theater: lecture hall of 500 capacity is not gallery type. Facility for E class are not available.
5. Central Library: Details like area, sitting capacity, number of books & journals are not provided.
6. Common Room for Girls is not available.
7. OPD: Registration counters are not computerized. Number of examination rooms are less than required in all major departments.
8. Wards: Beds are overcrowded. Pantry & utility rooms are not available. (P. 25)
9. MRD is manual.
10. O.T.: There are 43 tables in 13 O.T.s indicating more than 1 table in each O.T. which is not as per norms. Equipment is inadequate.
11. Only 4 mobile X-ray machines are available against requirement of 6 as per Regulations.
12. CSSD: Bowl sterilizer & Instrument washing machine are not available.
13. Forensic Medicine department: Only 1 Demonstration Room is available against requirement of 2. Autopsy & cold storage room does not look appropriately in use and is not as per norms.
14. RHTC: It is under control of Dy. Director of Health Services & not under Dean.
15. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by the Tamil Nadu Dr. M.G.R. Medical University, Chennai in respect of students being trained at Madurai Medical College, Madurai and further decided that the institute be asked to submit the compliance of rectification of the above deficiencies within 3 months.

**59. Consideration of compliance verification assessment with regard to continuance of recognition of MBBS degree granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Govt. Medical College, Anantapur.**

Institute of Medical Sciences, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore for the academic year 2015-16.

**61. Kempegowda Institute of Medical Sciences, Bangalore – Renewal of Permission for admission of 4<sup>th</sup> Batch of MBBS students against the increased intake i.e. from 120-150 for the academic session 2015-16.**

**62. Increase of seats in MBBS course from 150 to 200 at Sri Siddhartha Medical College, Tumkur u/s 10A of the IMC Act, 1956.**

Read: the matter with regard to increase of seats in MBBS course from 150 to 200 at Sri Siddhartha Medical College, Tumkur u/s 10A of the IMC Act, 1956.

The Executive Committee of the Council considered the letter dated 08.10.2014 received from the Principal, Sri Siddhartha Medical College, Tumkur stating that “they are not eligible for increase of MBBS seats at present and like to withdraw application and requested not to post the assessors for inspection of the institution for increase of MBBS seats from 150 to 200.

In view of the above, the Executive Committee of the Council decided to return the application for increase in MBBS seats from 150 to 200 at Sri Siddhartha Medical College, Tumkur for the academic year 2015-16 recommending disapproval of the scheme to the Central Govt. as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the Regulations framed therein to keep the application pending in the Council office for the next academic year.

Read: the matter with regard to increase of seats in MBBS course from 150-250 for the academic session 2015-16 at Sree Balaji Medical College & Hospital, Chennai in pursuance of Hon'ble Supreme Court order dated 17.10.2014 in CA No. 6564/2014-MCI Vs. Sree Balaji Medical College & Hospital, Chennai.

The Executive Committee of the Council considered the Council Assessors report (29th & 30th October, 2014) alongwith copy of Hon'ble Supreme Court order dated 17.11.2014 in IA No.3/2014 in CA No. 6564/2014- MCI Vs. Sree Balaji Medical College & Hospital, Chennai and a letter dated 26.11.2014 received from Dean, Sree Balaji Medical College & Hospital, Chennai and decided to recommend to the Central Govt. to issue Renewal of Permission for admission of 3<sup>rd</sup> batch for increase of seats in MBBS course from 100 to 150 at Sree Balaji Medical College & Hospital, Chennai under Bharath University, Chennai for the academic year 2015-16 u/s 10A of the Indian Medical Council Act,1956.

The Executive Committee of the Council further decided that since Sree Balaji Medical College & Hospital, Chennai is not yet recognized for 150 admissions, it is not eligible for further increase from 150 to 250 as per their earlier decision dated 14.03.2014.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4<sup>th</sup> Batch of MBBS students against the increased intake i.e. from 100-150 of Father Muller's Medical College, Mangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 for the academic year 2015-2016.
