It has been stated by Dr. A.K. Singh that the patient was brought to him on 04/10/2012, again on 05/10/2012 & on 06/10/2012; thus was under his care for only 36 hours off and on. It is also stated by him that *"It is learnt that the child was admitted on 08/10/2015 at Srijan Hospital, Allahabad till 22/10/2012 when he was referred to SGPGIMS, Lucknow where he was admitted on 23/10/2012. He was discharged from SGPGIMS, Lucknow with diagnosis of Acute on Chronic CKD (Bilateral small kidneys), Advanced Renal Failure, Nonoligouric"*.

Further, the appellant Shri R.K. Shrivastava has not appeared before Ethics Committee. It is also not on record that doctors at either Srijan Hospital or SGPGIMS have been examined by Ethics Committee. The case records of both Srijan Hospital or SGPGIMS have not been brought on record. From the record it appears that Dr. A.K. Singh himself is a qualified Paediatrician.

In view of above, the finding recorded by the Ethics Committee that Dr. A.K. Singh failed to determine cause of Anaemia and Chronic Renal failure in the patient and he has not referred the patient to a specialist or some other big hospital needs to be reexamined.

Referred back to Ethics Committee with above observations.

The Executive Committee of the Council perused the minutes of the Registration & Equivalence Committee meeting held on 25<sup>th</sup> February, 2016 and approved the minutes in respect of item nos. 4,7,9,10,11,13 & 15 and rest of the items, the Committee decided as under:-

**2. Grant of registration of the Membership of the Royal College of Emergency Medicine (MCEM) in respect of various applicants u/s 26 of the IMC Act, 1956.**

*It be verified by section whether Dr. Srinivas, Dr. Gurusamy, Dr. C K Reddy, Dr. T K Seth and Dr. H A Patel have acquired the abovesaid qualification after passing the examination or not. If it is after passing the examination, Additional Registration be granted by REC sub-committee without further reference to Executive Committee.*

**3. Grant of Registration for Additional Qualifications i.e. (i) Diplomat American Board of Family Medicine, (ii) Diplomat American Board of Family Medicine with added qualification in Geriatric Medicine and (iii) Diplomat American Board of Family Medicine with added qualification in Hospital and Palliative Medicine in respect of Dr. Ram Mohan Rao B.V u/s 26(1) of the IMC Act, 1956.**

*It is not clearly recorded whether Dr. Ram Mohan Rao has passed two separate Board examinations of Family Medicine & Geriatric Medicine or not. It is also not clear whether he has acquired the qualification after passing the examinations or not. It may be noted the system followed in India is of Basic Registration & Additional Registration. There is no prevailing system like "Added Qualification". This also needs to be clarified.*

*Referred back to REC Sub-committee with above observations to take appropriate decision after considering all aspects.*

**5. Grant of Registration for Additional Qualifications i.e. Diplomate American Board of Internal Medicine in respect of Dr. Kochhar Divya u/s 26(1) of the IMC Act, 1956.**

*It be verified by section whether Dr. Divya Kochhar has acquired the abovesaid qualification after passing the examination or not. If it is after passing the examination, Additional Registration be granted by REC sub-committee without further reference to Executive Committee.*

**6. Grant of Registration for Additional Qualifications i.e. Diplomate American Board of Internal Medicine in respect of Dr. Rajat Prakash u/s 26(1) of the IMC Act, 1956.**

*It be verified by section whether Dr. Rajat Prakash has acquired the abovesaid qualification after passing the examination or not. If it is after passing the examination, Additional Registration be granted by REC sub-committee without further reference to Executive Committee.*

**8. Grant of Registration for Additional Qualifications i.e. MS (Orthopedics) awarded by University of Aberdeen International, South Dakota in respect of Dr. Blkas Mandal u/s 26(1) of the IMC Act, 1956.**

*The item is deferred; however the reasons for doing so are not recorded in the minutes.*

**12. Issuance of Eligibility Certificate in respect of Ms. Kesha Chhaya under Clause 4(1) of the Screening Test Regulation, 2002.**

*Eligibility certificate is required to pursue medical course by Indian citizen who had pass 10+2 examination from India in foreign country. Here the candidate has passed qualifying examination from Tanzania. Hence Legal opinion be obtained from Law officer whether eligibility certificate can be issued by MCI to such a candidate.*

*Further, Regulation 4(2)(c) of GME Regulations reads as under:*

*"(c) The pre-professional/pre-medical examination with Physics, Chemistry and Biology/Bio-technology, after passing either the higher secondary school examination, or the pre-university or an equivalent Examination. The pre-professional/pre-medical examination shall include a practical test in Physics, Chemistry and Biology/Bio-technology and also English as a compulsory subject;"*

*It is not recorded in the Minutes whether Ms. Kesha Chhaya has passed Pre-Medical examination with above subjects. This be verified by section and placed before REC sub-committee.*

**14. Grant of Registration for Additional Qualification i.e. Master of Public Health awarded by The University of North Carolina in respect of Dr. Arvind Nath u/s 26(1) of the IMC Act, 1956.**

*It be verified by section that Dr. Arvind Nath has obtained M.P.H. qualification after having passed the examination. If so, Additional Registration be granted by the REC sub-committee without further reference to the Executive Committee.*

Read: the matter with regard to recognition/approval of Bundelkhand Medical College, Sagar, Madhya Pradesh for the award of MBBS degree (100 seats) granted by Dr. Hari Singh Gaur University, Sagar u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the compliance verification assessment report (10<sup>th</sup> February, 2016) alongwith the previous compliance verification assessment report (20<sup>th</sup> November, 2015 & 9<sup>th</sup> Sept., 2015) and decided to recommend to the Central Government for recognition/approval of Bundelkhand Medical College, Sagar, Madhya Pradesh for the award of MBBS degree (100 seats) granted by Dr. Hari Singh Gaur University, Sagar u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

1. Bed occupancy 50.92 % (i.e. 331 out of 650 beds) at 10 a.m. on day of assessment.
2. Wards: Most of the Demonstration rooms were small & cramped.
3. Data of clinical material like OPD attendance, Casualty attendance, Number of admissions, Minor operations, Radiological investigations given by the institute are grossly inflated.
4. Majority of patients in all the wards were not genuine; having been admitted for minor complaints like cough, backache, abdominal pain, joint pain, etc. and did not merit admission.
5. There were only 09 Major operations for the whole hospital on day of assessment.
6. Histopathology samples given by the institute on day of assessment is 22 which is grossly inflated; there many surgeries were not performed on day of assessment.
7. There was mismatch in the date of admission of patients and the entries in ward register. In a female Surgical ward, 11 patients shown as admitted on 23/02/2016 were not found in the ward on verification.
8. In some wards, there were no entries in the ward register of patients shown as having been admitted 3-4 days prior suggesting patients were kept on day of assessment with intentional manipulation in the date of admission.
9. In the common ward of Ophthalmology & ENT, the nursing staff did not know the patients belonging to their department.
10. Casualty: There were 12 patients in Casualty at 10:30 a.m. on 24/02/2016; only 3 of them were genuine. Rest did not have case papers.
11. ICUs: There were only 2 patients in ICCU on day of assessment.
12. Shortage of Residents is 5.95 % on day of assessment.
13. Lecture Theater: Hospital Lecture Theater has capacity of 140 against requirement of 200.
14. Students' Hostel: Sanitation around Boys' Hostel is poor.
15. Residents' Hostel: Certificates issued by Dean do not match with some of the residing in the hostel.
16. Residential Quarters: Only 6 quarters are provided for non-teaching staff against requirement of 36.
17. Anatomy department: There are only 135 mounted specimens.
18. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognise/approve Srinivas Institute of Medical Sciences & Research Centre, Mangalore for the award of MBBS degree (150 seats) granted by Rajiv Gandhi University of Health Sciences, Bangalore u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2(two) weeks for further consideration of the matter.

4. Wards: Demonstration rooms are not available in many wards. Ancillary facilities are not fully available as detailed in the report.
5. Workload of Special investigations like Ba, IVP is NIL on day of assessment.
6. Casualty: Separate Casualty for O.G. is not available. Mobile X-ray is not available.
7. O.T.s: Only 1 Minor O.T. is available against requirement of 2. Equipment like Infusion Pumps, Defibrillators are inadequate.
8. ICUs: MICU, SICU are not air-conditioned. ABG Analyzer is not available.
9. Available mobile X-rays are 5 against requirement of 6.
10. Available USG machines are 2 against requirement of 3.
11. Out of 6 static X-ray machines, 1 machine of 800 mA is not functioning.
12. Nursing Staff: 342 Nurses are available against requirement of 372.
13. Dietician is not available.
14. Lecture Theaters: Out of 4 Lecture Theaters available, capacity of 2 is 110 & 90 respectively against requirement of 180 each.
15. Central Library: It is not air-conditioned. Only 10 Internet Nodes are available against requirement of 40.
16. Central Photography Section is not available.
17. Students' Hostels: Available accommodation is only 350 against 565 required.
18. Interns' Hostel: There is no separate Interns' hostel. Accommodation available is for 78 Interns against requirement of 150.
19. Residents' Hostel: Visitors' room, A.C. Study room with computer & Internet are not available.
20. Anatomy department: Cold storage chambers for dead bodies are not available. Band Saw is not available. Capacity of both Demonstration rooms is only 40 each which is inadequate. Audiovisual aids are not available.
21. Demonstration rooms of Physiology department (1), Biochemistry department (both), Pathology (1), Microbiology (1), Forensic Medicine

(both), Community Medicine (All 3) have inadequate capacity as detailed in the report. Audiovisual aids are not available. There is only 1 Demonstration room in Microbiology department against requirement of 2.

22. UHC: Specialists' visits are not organized.
23. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognize/approve Mysore Medical College and Research Institute, Mysore for the award of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2 (Two) weeks for further consideration of the matter.

Educational & Research Institute, Deemed to be University, Chennai u/s 10A of the IMC Act, 1956 for admitting a fresh batch of 150 (One hundred fifty) MBBS students for the academic year 2016-17.

The Executive Committee of the Council considered the compliance verification assessment report (22.02.2016) along with earlier compliance verification assessment report (10.03.2015) and previous assessment report (11<sup>th</sup> & 12<sup>th</sup> September, 2014) and noted the following:-

1. Clinical material in own hospital is still inadequate as under:
  - (a) OPD attendance: 350;
  - (b) Number of major operations: 06;
  - (c) Bed occupancy: 73 %.
2. Shortage of Residents is 6.06 % as detailed in the report.
3. Static & Mobile X-ray machines are inadequate at own hospital as under:
  - (a) Static: 2 available against 5 required;
  - (b) Mobile: 2 available against 5 required.
4. RHTC is still in rented place with agreement of only 5 years.
5. Residential quarters are not available for faculty. Rented accommodation is provided for non-teaching staff. Deficiency remains the same.
6. Separate data of clinical material for 2 hospitals are not provided.
7. Other deficiencies as pointed out in the assessment report.

In view of above, the Executive Committee of the Council decided to reiterate its earlier decision of applying clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment), 2010 (Part II), dated 16<sup>th</sup> April, 2010 and decided that the institute be asked to submit the compliance after rectification of the above deficiencies within one month.

Clause 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment), 2010 (Part II), dated 16<sup>th</sup> April, 2010 which reads as under:-

8(3)(1).....

- (c) Colleges which are already recognized for award of MBBS degree and/or running postgraduate courses

*If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 10% and/or bed occupancy is <80%, such an institute will not be considered for processing applications for postgraduate courses in the Academic year and will be issued show cause notices as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses."*

In view of above, it was decided not to consider the Institute for processing applications for postgraduate courses in the current Academic year (2017-18 and to issue show cause notice as to why the recommendation for withdrawal of recognition of the courses run by the institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses.

The Executive Committee of the Council further decided to intimate the Postgraduate Section of application of clause 8(3)(1)(c) for this Institute for information and further necessary action.

4. Casualty: Pulse Oxymeter was not working at time of assessment.
5. O.T.: Septic O.T. is not available.
6. Radio-diagnosis department: Only 2 mobile X-ray machines are available against requirement of 4. Only 4 static X-ray machines are available against requirement of 5.
7. CSSD: It is presently non-functional. ETO Sterilizer is not available.
8. MRD is partly computerized.
9. Lecture Theaters: Hospital lecture theater is not available.
10. Central Library: It is not air-conditioned, except computer room. Only 79 journals are available against requirement of 100.
11. Students' Hostels: Visitors' room, A.C. Study room with Computer & Internet, Recreation room are not available.
12. Interns' Hostel: Visitors' room, A.C. Study room with Computer & Internet, Recreation room are not available.
13. Residents' Hostel: Available accommodation is 50 against requirement of 67. Visitors' room, A.C. Study room with Computer & Internet, Recreation room are not available.
14. Dietician is not available.
15. Central Research Laboratory is not available.
16. Microbiology Department: Available Service laboratories are 6 against requirement of 7.
17. Pharmacology Department: In museum, Models are not available.
18. RHTC: Hostel accommodation is available but not inhabitable. Messing facilities are not available.
19. Eclampsia room is not adequately equipped.

12. CSSD is very small & congested. ETO Sterilizer is not available.
13. Lecture Theaters: Hospital lecture theaters are required to be fitted with writing tables / benches.
14. Central Library: Main library has 3 split A.C.s out of which 2 are out of order. Other areas are not air-conditioned. Capacity of Resident reading room is inadequate. Internet Nodes are inadequate.
15. Common rooms for Boys & Girls are smaller than required. There are no recreational facilities. Girls' common room does not have attached toilet.
16. Students' Hostels: Available accommodation is 340 against 375 required. A.C. Study room with Computer & internet was not seen.

22. RHTC: There is no RHTC. PHC Singasandra was purportedly shown as RHTC but on visit alongwith HOD, Community Medicine Department, it was found that it is not attached to the institute. It is a PHC of Karnataka Government. In fact, i/c M.O. of PHC even questioned the authority of the assessor to inspect & assess the PHC in front of Professor & HOD of Community Medicine. Thereafter Principal informed that RHTC is developed at Halasoor which is 80 km. away from institute and hence not permissible as per Regulations.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being

trained at SDM College of Medical Sciences & Hospital, Dharwad and further decided that the institute be asked to submit the compliance after rectification of the above deficiencies within one month.

**27. Continuance of recognition of MBBS degree granted by Dr. NTR University of Health Sciences, Vijayawada in respect of students being trained at Bhaskar Medical College, Hyderabad.**

Resuscitation & Monitoring equipment is inadequate. PICU 1 & NICU has 2 beds against requirement of 5 beds each. There was NIL patient in either PICU/NICU on day of assessment. Central O<sub>2</sub> and Central Suction are not available. Resuscitation & Monitoring equipment is inadequate.
9. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by The Tamilnadu Dr. MGR Medical University in respect of students being trained Perundurai Medical College and Institute of Road Transport, Perundurai and

5. Students' Hostels: In Boys' hostel, there is no Visitor's room. In Girls' hostel, Study room is not air-conditioned. There is no Visitors' room.
6. Wards: Pantry is not available in wards.
7. Casualty: Separate Casualty for O.G. is not available.
8. Microbiology Department: Media preparation facility, Autoclaving & Washing Room are available but empty and non-functional. All 7 Service laboratories are empty & not-functional.
9. Pharmacology Department: Museum facilities are inadequate.
10. Other deficiencies as pointed out in the inspection report.

1. Deficiency of faculty is 8.02 % as detailed in the report.
2. Shortage of Residents is 13.97 % as detailed in the report.
3. OPD: Records of Minor O.T. & Dressing room in Surgery department are common. Family Welfare Clinic is not available. Child Rehabilitation clinic, Ante Natal Clinic are not separately available.
4. Wards: In some wards, Nursing station is just a table & a chair. There is no numbering of beds in all the wards.
5. Admission & Discharge registers of several wards had entries without mentioning the diagnosis raising doubts about genuineness of the entered data. There were blank columns in some registers.
6. Many admitted patients in General Medicine, ENT were such who did not merit hospitalization.
7. Data of Major operations as given by institute are inflated as found after cross verifying from preoperative & Postoperative wards. There were NIL Minor operations on day of assessment.
8. Data of Special investigations like Ba, IVP as given by the institute are doubtful as patients requiring such investigations were not there in General Surgery or General medicine wards as cross checked with admission & discharge registers.
9. Data of Histopathology investigation as given by the institute are doubtful as these many cases were not there at all in O.T.s.
10. Casualty: Disaster Trolley, Ventilator are not available.
11. ICUs: There was NIL patient in ICCU & only 2 patients in PICU on day of assessment.
12. Radio-diagnosis Department: One Mobile X-ray machine of 100 mA & 1 Static X-ray machine of 600 mA & 2 machines of 800/1000 mA are deficient.
13. Several O.T. lists of General Surgery & ENT had entry of patients for operation without mentioning Ward & Bed numbers raising doubt about genuineness of data.
14. On cross checking O.T. list for day of assessment, 5 patients could not be verified. They were present neither in ward nor in any laboratory, Radio-diagnosis department, preoperative ward or postoperative ward.
15. Residents' Hostel: Many rooms are not occupied by Residents.
16. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Dr.

NTR University of Health Sciences, Vijayawada in respect of students being trained at Shadan Institute of Medical Sciences, Hyderabad, A.P. and further decided that the institute be asked to submit the compliance after rectification of the above deficiencies within one month. *If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 10% and/or bed occupancy is <80%, such an institute will not be considered for processing applications for postgraduate courses in the Academic year and will be issued show cause notices as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses."*

In view of above, it was decided not to consider the Institute for processing applications for postgraduate courses in the current Academic year (2017-18) and to issue show cause notice as to why the recommendation for withdrawal of recognition of the courses run by the institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses.

The Executive Committee of the Council further decided to intimate the Postgraduate Section of application of clause 8(3)(1)(c) for this Institute for information and further necessary action.

**31. Change of affiliation of University from Guru Ghasidas University, Bilaspur to Ayush & Health Sciences University of Chhattisgarh, Raipur in respect of students being trained at Chattishgarh Institute of Medical Sciences, Bilashpur, Chattishgarh.**

Read: the matter with regard to consideration of change of affiliation of University from Guru Ghasidas University, Bilaspur to Ayush & Health Sciences University of Chhattisgarh, Raipur in respect of students being trained at Chattisgarh Institute of Medical Sciences, Bilashpur, Chattisgarh.

The Executive Committee of the Council observed as under:

- The compliance verification assessment report on (15<sup>th</sup> January, 2016) along with previous compliance verification assessment report (2<sup>nd</sup> November, 2015) and assessment report (10<sup>th</sup> & 11<sup>th</sup> September, 2014), the matter with regard to Pre-PG& COR of MBBS degree granted by Guru Ghasidas University in respect of students being trained at Chhattisgarh Institute of Medical Sciences, Bilaspur for 100 seats was circulated to the Members of the Executive Committee for consideration on 16.01.2016 & 18.01.2016.
- The comments/observations has been received on 18<sup>th</sup> & 19<sup>th</sup> Jan., 2016 from the Executive Committee:-

*“After verifying the documents regarding appointments of Senior Residents submitted by the college, it is observed that five SRs are eligible. After considering these, now the deficiency of SR comes to 5.88%.*

*In view of above, we may approve the college.”*

In view of above, the Executive Committee of the Council decided to recommend to the Central Govt. for change of affiliation of university from Guru Ghasidas University, Bilaspur to Ayush & Health Sciences University of Chhattisgarh, Raipur in respect of students being trained at Chhattisgarh Institute of Medical Sciences, Bilaspur, Chhattisgarh for students admitted in the year 2009-2010 onwards.

The Committee further decided to place the matter before the General Body of the Council and also to inform Delhi Medical Council accordingly.

**32. Minutes of the Academic Committee meeting held on 04<sup>th</sup> March, 2016.**

Read: the matter with regard to minutes of the Academic Committee meeting held on 04<sup>th</sup> March, 2016.

The Executive Committee of the Council decided to defer the consideration of the matter for the next meeting.

**33. Admission of MBBS student at Belgaum Institute of Medical Sciences, Belgaum, Karnataka for the Academic Year 2014-15.**

Read: the matter with regard to admission of MBBS student at Belgaum Institute of Medical Sciences, Belgaum, Karnataka for the Academic Year 2014-15.

The Executive Committee of the Council perused opinion from Council Advocate, operative part of which reads as under:

*“...8. In view of the above, I am of the considered opinion that since the Graduate Medical Education Regulations, 1997 provides for relaxation of marks to be obtained in CET by candidates under the reserved categories thus a candidate who is entitled to admission under the physically handicapped category and is also a reserved category candidate, he shall have to obtain a minimum of 40% marks in the qualifying examination as well as the competitive entrance examination in order to avail the reservation provided for the physically handicapped candidates.”*

After due deliberations, the Executive Committee decided to approve the opinion of Council Advocate.

In view of above, the Committee further decided to revoke discharge notice.

**34. Admission of MBBS student at Mount Zion Medical College, Chayalode, Ezhamkulam Adoor, Pathanamthitta, Kerala for the Academic Year 2014-15.**

Read: the matter with regard to admission of MBBS student at Mount Zion Medical College, Chayalode, Ezhamkulam Adoor, Pathanamthitta, Kerala for the Academic Year 2014-15.

The Executive Committee of the Council perused the opinion from Council Advocate, operative part of which reads as under:

*"...5. In view of the above factual matrix, I am of the view that since the medical college is approved for intake of 100 MBBS seats thus the medical college could have made 15 admissions under NRI quota hence the 3 excess admissions in NRI quota is in violation of the judgment of the Hon'ble Supreme Court in the case of P A Inamdar Vs State of Inamdar – (2005) 6 SCC 537. Further the aforesaid 03 candidates also could not have been granted admission since they did not fulfill the minimum requirements of the Graduate Medical Regulations, 1997 since they did not obtain 50% marks in the CET as general category candidates. A general category candidate cannot be adjusted or accommodated under the NRI Quota since only genuine NRI candidates can claim admission on NRI seats. In my considered opinion the querist may direct the Medical College to discharge the said 03 candidates from the MBBS course who had failed to obtain the minimum marks as prescribed by the querist in the CET."*

After due deliberations, the Executive Committee of the Council decided to approve the opinion of Council Advocate.

In view of above, the Committee further decided to issue discharge notice in respect of the following students:

**35. Regarding Government quota vacant seats in MBBS/Postgraduate Courses.**

Read: the matter with regard to regarding Government quota vacant seats in MBBS/Postgraduate Courses.

The Executive Committee of the Council observed that the Postgraduate Committee at its meeting held on 06.11.2015 while considering the recommendations of the Monitoring Sub-Committee has also decided as under:-

*".....If the Government failed to fill up its quota by due date due to any reason, the management is free to fill those seats from management quota, those seats cannot be allowed to remain vacant and there will be no deduction in management quota against those seats in the next year. A copy to be sent to the Executive Committee for uniform decision for UG and PG. Monitoring Committee may communicate a suitable date every year by which Govt. Quota seats should be filled".*

After due deliberations the Executive Committee of the Council decided that the ratio of decision of PG Committee be also followed in respect of UG



admissions as well and the decision be implemented uniformly for both UG/PG admissions..

The Committee directed the Office to place this decision before Monitoring Sub Committee.

**36. Recognition/Approval of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna for the award of MBBS degree (100 seats) granted by Indira Gandhi Institute of Medical Sciences, Patna u/s 11(2) of the IMC Act, 1956..**

Read: the matter with regard to recognition/approval of Indira Gandhi Institute of Medical Sciences, Sheikhpura, Patna for the award of MBBS degree (100 seats) granted by Indira Gandhi Institute of Medical Sciences, Patna u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment reports (28.01.2016 and 2<sup>nd</sup> & 3<sup>rd</sup> March 2016) and noted the following :-

1. Deficiency of faculty is 13.33 % as detailed in the report.
2. Promotion of Dr. Amarendra Kumar, Dean is irregular. He has been promoted to the post of Associate Professor after only 2(two) years and 11 months as compared to the requirement of 5 years as per T.E.Q. Regulations prevalent at that time.
3. Administrative experience of Dr. A.K. Sinha, Medical Superintendent is not provided; hence it cannot be verified whether he possesses minimum 10 y administrative experience required for the post or not.
4. College Council: It has met only 3 times during the last year against requirement of minimum 4 meetings.
5. Lecture Theater: Furnishing of Hospital Lecture Theater is in progress. It is not of gallery type.
6. Central Library: Available area is 900 sq.m. against requirement of 1,600 sq.m.
7. Anatomy department: Only 76 specimens are available.
8. RHTC: Residential accommodation is available on rent.
9. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognise/approve Indira Gandhi Institute of Medical Sciences, Patna for the award of MBBS degree (100 seats) by Indira Gandhi Institute of Medical Sciences, Patna u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2(two) weeks for further consideration of the matter.

**37. Compliance Inspection conducted by Medical Council of India in Government Medical College, Kannauj (U.P.) for grant of Fourth Renewal Permission for admission of 5<sup>th</sup> Batch of MBBS in the academic session 2016-17.**

Read: the matter with regard to compliance inspection conducted by Medical Council of India in Government Medical College, Kannauj (U.P.) for grant of Fourth Renewal Permission for admission of 5<sup>th</sup> Batch of MBBS in the academic session 2016-17.

The Executive Committee of the Council perused the letter dated 24.02.2016 from Shri Alok Ranjan I.A.S., Govt. of Uttar Pradesh, Lucknow stating therein as under:-

*“This is with reference to the Compliance Inspection of Government Medical College, Kannauj, Uttar Pradesh conducted by Medical Council of India on 22<sup>nd</sup> February, 2016. Principal, Govt. Medical College, Kannauj and Director General, Medical Education, U.P. Have communicated to us that there was a serious roadside accident at the entry gate of the Medical College on 22.02.16 which resulted in local road blockage by irate villagers, thereby hampering the functioning of the Medical College on the day of the inspection. Consequently some faculty members and hospital patients could not reach the hospital on that day. In view of this, we request you kindly to grant one more opportunity to the college authorities for compliance verification for the academic session 2016-17. “*

In view of above, the Executive Committee of the Council decided to grant one more opportunity to the college by conducting another assessment.

**38. Explanation for Essentiality Certificate issued by Department of Health & Family Welfare, Govt. of West Bengal for Durgapur Institute of Advanced Technology and Management Society, Durgapur, West Bengal.**

Read: the matter with regard to explanation for Essentiality Certificate issued by Department of Health & Family Welfare, Govt. of West Bengal for Durgapur Institute of Advanced Technology and Management Society, Durgapur, West Bengal.

The Executive Committee of the Council perused the letter dated 15/02/2016 from the Director of Medical Education & Ex Officio Secretary, Department of Health & Family Welfare, Government of West Bengal stating therein as under:-

*“In response to your letter No.MCI-34(41)(e-106)/2015-Med./163599, dated 31/01/2016, I would like to state that Durgapur Institute of Advanced Technology and Management Society, Durgapur, West Bengal has a 300 bedded well equipped Hospital Named as Gouri Devi Hospital and Research Institute. The said Hospital is running well for Last 5 years. It is the mother organization under which the proposed Gouri Devi Institute of Medical Sciences and Hospital, Durgapur is being made.*

*An extension of the afford mention Hospital a new construction with the additional capacity of 300 bed teaching Hospital as Gouri Devi Institute of Medical Sciences and Hospital, Durgapur is being prepared which is located adjacently and within the premises of same campus.*

*The Essentiality Certificate have been issued keeping in mind the presence of already running 300 bedded Hospital named Gouri Devi Hospital and Research Institute within the same campus. Essential documents enclosed.”*

In view of above, the Executive Committee of the Council decided that no further action is required in the matter.

**39. Recognition/Approval of College of Medicine & Sagore Dutta Hospital, Kolkata, West Bengal for the award of MBBS degree (100 seats) granted by West Bengal University of Health Sciences, Kolkata u/s 11(2) of the IMC Act, 1956.**

Read: the matter with regard to recognition/approval of College of Medicine & Sagore Dutta Hospital, Kolkata, West Bengal for the award of MBBS degree (100 seats) granted by West Bengal University of Health Sciences, Kolkata u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment reports (09.02.2016 and 10<sup>th</sup> & 11<sup>th</sup> March, 2016) and noted the following :-

1. Deficiency of faculty is 11.43 % as detailed in the report.
2. OPD: Registration counters are partly computerized.
3. There were NIL patients in the wards of Tb & Chest, Skin & VD and Psychiatry departments on day of assessment.
4. Casualty: Defibrillator, Ventilator are not available.
5. ICUs: ICCU & SICU are not available. There was only 1 patient in NICU/PICU on day of assessment.
6. Radiodiagnosis department: Only 2 mobile X-ray machines are available against requirement of 4. Only 3 static X-ray machines are available against requirement of 5. Only 2 USG machines are available against requirement of 3.
7. Central Research Laboratory is not available.
8. MRD: It is partly computerized. ICD X classification of diseases is not followed for indexing.
9. Nursing staff: Only 213 Nurses are available against requirement of 247.
10. Paramedical & Non-teaching staff: Only 62 paramedical & Non-teaching staff are available against requirement of 179.
11. Lecture Theaters: One lecture theater is of "flat" type.
12. Central Library: It is not air-conditioned. Available books are 6,158 against 7,000 required. Total 39 Journals are available against 100 required. Only 5 Internet Nodes are available against 25 required.
13. Common Rooms for Boys & Girls are smaller than required.
14. Nurses' Hostel: Available accommodation is for 24 Nurses only against requirement of 48.
15. Anatomy department: Only 30 specimens are available.
16. RHTC: Specialists' visits are not organized.
17. Website: Toll free number to report ragging is not provided.
18. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognise/approve College of Medicine & Sagore Dutta Hospital, Kolkata, West Bengal for the award of MBBS degree (100 seats) granted by West Bengal University of Health Sciences, Kolkata u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2(two) weeks for further consideration of the matter.

**40. Report of the Sub-committee constituted by the Executive Committee for MCI digital mission mode project (MCI-DMMP).**

Read: the matter with regard to report of the Sub-committee constituted by the Executive Committee for MCI digital mission mode project (MCI-DMMP).

The Executive Committee of the Council perused the report of e-Governance sub-committee and observed that the reasons given in the report about for the quotation of L 1 bidder being higher by 90 % (i.e. almost double the estimate) than project estimates are not convincing. It is impossible that various factors cited by NISG in its presentation like change in the software requirement from COTS to BESPOKE, increase in US \$ rate, increase in

requirement of hardware would lead to 90 % increase. It is also not clear in the report why software requirement was required to be changed.

With regard to eLibrary, the position of MCI has consistently been that till the issue of connectivity and associated problems with it like downloading are resolved, eLibrary cannot be a substitute for physical library as the Regulations prescribed by MCI have to be applied throughout India and it is a fact that on several occasions assessors have remarked about non-availability of connectivity or availability at very low speed leading to considerable time consumption for downloading full text articles or chapters from text books. Till these issues are resolved throughout the country, MCI as a statutory body cannot accept and recommend any proposition which cannot be implemented effectively. It is difficult to comprehend how eLibrary is connected with eGovernance that the sub-committee has made a recommendation that *“without e-Library as a part of the MCI-DMMP solution the road map and the action plan of e-Governance project would be incomplete.”*

The Committee also does not agree with the recommendation that *“The work of scanning of old files and documents should be removed from the scope of the MCIDMMP solution and can be done separately.”* Preservation of old records in digital form from where they can be retrieved easily is a top priority area for MCI.

In view of above, the Executive Committee of the Council approved the recommendation of re-tendering for the DMMP project as one project by a single vendor after incorporating above observations. The Committee also decided to invite tenders by wide publicity in major national newspapers and also on websites.

**41. Amendment in the Regulations on Graduate Medical Education, 1997 – Eligibility criteria based upon the physical disability of a person.**

Read: the matter with regard to amendment in the regulations on Graduate Medical Education, 1997 – Eligibility criteria based upon the physical disability of a person.

The Executive Committee considered the letter dated 26.02.2016 received from the Under Secretary, MOHFW stating that the addition of sub-clause 3(a) to clause 4 of GMER, 1997 be finalized such that unfilled seats are filled by respective category candidates.

The Committee further noted that the Council had revised the amendment accordingly and now, the proposed amendment would be as under:-

- 4 (3). *3% seats of the annual sanctioned intake capacity shall be filled up by candidates with locomotory disability of lower limbs between 50% to 70%.*

*Provided that in case any seat in this 3% quota remains unfilled on account of unavailability of candidates with locomotory disability of lower limbs between 50% to 70% then any such unfilled seat in this 3% quota shall be filled up by persons with locomotory disability of lower limbs between 40% to **less than 50%** - before they are included in the annual sanctioned seats for **Respective** Category candidates.*

*Provided further that this entire exercise shall be completed by each medical college / institution as per the statutory time*

*schedule for admissions and in no case any admission will be made in the MBBS course after 30th of September.”*

**“3.a. Persons with upper limb disability, auditory disability, and visual disability of category I and above shall not be eligible to pursue MBBS course as such persons cannot completely or partially acquire the skills recommended as desirable for the Bachelor of Medicine and Bachelor of Surgery contained in Appendix B to these Regulations.”**

In view of above, the Executive Committee of the Council approved the above amendment in the regulations on Graduate Medical Education, 1997 – Eligibility criteria based upon the physical disability of a person and directed the office to place the same before the General Body of the Council.

**42. Continuance of recognition of MBBS degree granted Utkal University in respect of students being trained at Hi-Tech Medical College & Hospital, Bhubaneswar.**

Read: the matter with regard to continuance of recognition of MBBS degree granted Utkal University in respect of students being trained at Hi-Tech Medical College & Hospital, Bhubaneswar.

The Executive Committee of the Council considered the assessment report (4<sup>th</sup> and 5<sup>th</sup> March, 2016) and noted the following:-

1. Deficiency of faculty is 10.9 % as detailed in the report.
2. Air-conditioning in Central Library is under repair.
3. Common rooms for Boys & Girls need improvement in furniture & recreation facilities.
4. Central Research Laboratory needs upgradation.
5. Anatomy department: Embalming room is not available. Dissection tables are less by 5 no. Cadavers are less as only 3 cadavers are available.
6. Biochemistry department: Capacity of Practical Laboratory is only 32 which is inadequate.
7. Microbiology department: Only 1 Service Laboratory is available against requirement of 7.
8. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Utkal University in respect of students being trained at Hi-Tech Medical College & Hospital, Bhubaneswar and further decided that the Institute be asked to submit the compliance of rectification of the above deficiencies within 01 month. The Committee further decided to apply clause 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment), 2010 (Part II), dated 16<sup>th</sup> April, 2010 which reads as under:-

8(3)(1).....

(c) Colleges which are already recognized for award of MBBS degree and/or running postgraduate courses

*If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 10% and/or bed occupancy is <80%, such an institute will not be considered for processing applications for postgraduate courses in the Academic year and will be issued show cause notices as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are*

**43. Continuance of recognition of MBBS degree granted by Maharashtra Univ. of Health Sciences, Nashik in respect of students being trained at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati.**

Read: the matter with regard to continuance of recognition of MBBS degree granted by Maharashtra Univ. of Health Sciences, Nashik in respect of students being trained at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati.

The Executive Committee of the Council considered the assessment reports (29<sup>th</sup> February & 1<sup>st</sup> March, 2016) and noted the following:-

1. Deficiency of teaching faculty is 29 % as detailed in the report.
2. Shortage of Residents is 52 % as detailed in the report.
3. Bed occupancy was 62 % (i.e. 304 out of 490 beds) on day of assessment.
4. Dr. L.S. Lawankar, Medical Superintendent has only 7 y 8 m administrative experience against requirement of 10 y and hence not eligible to hold the post.
5. OPD: IPD Registration counters are not computerized. Staff at Registration Counters is inadequate. Examination rooms are inadequate for several departments. Teaching areas are not available. Injection room for males/females is not separate. Dressing room for male/female is not available. Minor O.T. is not properly equipped. In Ophthalmology OPD, Dressing room / Minor procedure room is not available. Specialty clinics are not available in Paediatrics / O.G. OPD.
6. Speech Therapy is not available.
7. Teaching beds are inadequate as under:

8. Wards: Demonstration rooms are very small. They are not available in Paediatrics, Psychiatry, Skin & VD, ENT departments. In some wards, patients are admitted in Doctors' Duty room.
9. Casualty is under construction. No patients in casualty were seen.

10. There was NIL Major & NIL Minor operation on day of assessment.
11. There was NIL Normal Delivery & NIL Caesarean Section on day of assessment.
12. Workload of Radiological investigations like Ba, IVP, CT Scan, USG was NIL & that of Plain X-rays was only 05 on day of assessment.
13. Casualty: Only 12 beds are available against requirement of 20. CMOs are not available. Separate Casualty for O.G. is not available. Minor O.T. is not available.
14. O.T.s: Only 6 O.T.s are available against requirement of 7. There are 2 tables in Surgery & O.G. O.T. which is not as per norms. Post-operative & Post-operative beds available are 04 each which is inadequate.
15. Only 3 Static X-ray machines are available against requirement of 5.
16. ETO Sterilizer is not available.
17. MRD: It is partly computerized.
18. Intercom is available in a few departments only.
19. CME: Details of CME programmes conducted during the year are not provided.
20. Central Library: It is not air-conditioned. Students' reading Room (Outside) is not available. Only 3 Internet Nodes are available.
21. Common Rooms for Boys & Girls are smaller than required.
22. Students' Hostels: A.C. Study room with Computer & Internet & Recreation room are not available. Toilet facilities are inadequate.
23. Interns' Hostel: A.C. Study room with Computer & Internet & Recreation room are not available. Toilet facilities are inadequate.
24. Residents' Hostel: A.C. Study room with Computer & Internet & Recreation room are not available. Toilet facilities are inadequate.
25. Residential Quarters: Only 6 quarters are available for faculty & 12 quarters are available for non-teaching staff against requirement of 21 & 36 respectively.
26. Central Kitchen: It is closed. There is only 1 canteen which is common for patients, students & staff.
27. Nursing staff: Only 169 Nurses are available against requirement of 247.
28. Integrated teaching programme is not carried out.
29. Anatomy department: Only 54 Lockers are available against requirement of 100.
30. RHTC: Students are not posted. Only Physician & Dentists visit as Specialists. Survey is not done. Immunization is not done. Registers are not available for Immunization or FP activity. Activities under National health programmes are not carried out. Cold chain equipment is not available.
31. UHC: Specialists' visits are not provided. Students are not posted.
32. Website: Toll free number to report ragging is not available.
33. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Maharashtra Univ. of Health Sciences, Nashik in respect of students being trained at Dr. Panjabrao Alias Bhausahab Deshmukh Memorial Medical College, Amravati and further decided that the Institute be asked to submit the compliance of rectification of the above deficiencies within 01 month. (c) Colleges which are already recognized for award of MBBS degree and/or running postgraduate courses

*If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 10% and/or*

*bed occupancy is <80%, such an institute will not be considered for processing applications for postgraduate courses in the Academic year and will be issued show cause notices as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses.”*

In view of above, it was decided not to consider the Institute for processing applications for postgraduate courses in the current Academic year (2017-18) and to issue show cause notice as to why the recommendation for withdrawal of recognition of the courses run by the institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses.

The Executive Committee of the Council further decided to intimate the Postgraduate Section of application of clause 8(3)(1)(c) for this Institute for information and further necessary action.

**44. Continuance of recognition of MBBS degree granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at KanyaKumari Government Medical College, Asaripallam.**

Read: the matter with regard to continuance of recognition of MBBS degree granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at KanyaKumari Government Medical College, Asaripallam.

The Executive Committee of the Council considered the compliance verification assessment report (3<sup>rd</sup> March, 2016) along with the previous assessment reports (10<sup>th</sup> & 11<sup>th</sup> June, 2015 & 5<sup>th</sup> November, 2015) and noted the following:-

1. Deficiency of faculty is 10.7 % as detailed in the report.
2. OPD attendance was 514 on day of assessment against 800 required.
3. Workload of Special Investigations like Ba, IVP was NIL on day of assessment.
4. There was only 1 Normal Delivery & 1 Caesarean Section on day of assessment.
5. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at KanyaKumari Government Medical College, Asaripallam and further decided that the Institute be asked to submit the compliance of rectification of the above deficiencies within 01 month.

**45. Consideration of compliance verification assessment with regard to continuance of recognition of MBBS degree granted by Pravara Institute of Medical Sciences (Deemed University), Loni in respect of students being trained at Rural Medical College, Loni.**

Read: the matter with regard to consideration of compliance verification assessment with regard to continuance of recognition of MBBS degree granted by Pravara Institute of Medical Sciences (Deemed University), Loni in respect of students being trained at Rural Medical College, Loni.



The Executive Committee of the Council considered the compliance verification assessment report (11<sup>th</sup> March, 2016) along with previous assessment reports (9<sup>th</sup> & 10<sup>th</sup> July, 2015 & 25<sup>th</sup> January, 2016) and noted the following:-

1. Shortage of Residents is 8.9 % as detailed in the report.
2. Other deficiencies as pointed out in the inspection report.

In view of the above, the Executive Committee of the Council decided not to recommend continuance of recognition of MBBS degree granted by Pravara Institute of Medical Sciences (Deemed University), Loni in respect of students being trained at Rural Medical College, Loni and further decided that the Institute be asked to submit the compliance of rectification of the above deficiencies within 01 month and further decided to revoke clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment), 2010 (Part-II), dated 16.04.2010.

**46. Consideration of compliance verification assessment report with regard to continuance of recognition of MBBS degree granted by Banaras Hindu University in respect of students being trained at Institute of Medical Sciences, Varanasi.**

Read: the matter with regard to consideration of compliance verification assessment report with regard to continuance of recognition of MBBS degree granted by Banaras Hindu University in respect of students being trained at Institute of Medical Sciences, Varanasi.

The Executive Committee of the Council considered the compliance verification assessment report (11<sup>th</sup> March, 2016) along with the previous assessment report (26<sup>th</sup> & 27<sup>th</sup> June, 2014) and decided to recommend that recognition of MBBS degree granted by Banaras Hindu University in respect of students being trained at Institute of Medical Sciences, Varanasi be continued restricting the number of admission to 84 (Eighty four) students.

**47. Quantum of Punishment to be awarded to different persons, who have been found to provide false information to the MCI during the inspections – Ethics Committee recommendations.**

Read: the matter with regard to quantum of punishment to be awarded to different persons, who have been found to provide false information to the MCI during the inspections – Ethics Committee recommendations.

The Executive Committee of the Council perused the proceedings of the Ethics Committee and decided as under:-

Part A – Penalty proposed for supplying false, incorrect and misleading information during MCI assessments:

Name of Dean, HOD, concerned teacher and resident be removed from IMR for one year.

Part B – Penalty proposed for providing Fake/Forged documents or for presenting non-medical person as medical teacher/resident only as under:

Name of Dean, HOD, concerned teacher and resident be removed from IMR for three years.

FIR to be lodged against the non-medical person posing as Faculty.

**48. Al-Ameen Medical College & Hospital, Bijapur– Renewal of Permission for admission of 4<sup>th</sup> Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2016-17.**

Read: the matter with regard to Al-Ameen Medical College & Hospital, Bijapur– Renewal of Permission for admission of 4<sup>th</sup> Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2016-17.

The Executive Committee of the Council considered the assessment report (04.03.2016 & 05.03.2016) and noted the following:-

1. Deficiency of faculty is 26.81 % as detailed in the report.
2. Shortage of Residents is 54.16 % as detailed in the report.
3. Dr. S.M. Rashinkar has only 09 years of administrative experience against requirement of 10 y and hence not qualified to hold the post.
4. Many Residents are not staying in the campus.
5. Many of Senior/Junior Residents do not each other. They also do not know their duty hours.
6. Bed occupancy is 20.19 % on day of assessment.
7. OPD attendance is 355 against requirement of 1,200 on day of assessment.
8. OPD: Waiting area is not adequate. Examination rooms are very small cubicles. Teaching areas are small cubicles. Dressing room for males/females is not available. Minor O.T. is not as per norms. In Ophthalmology OPD, Minor Procedure room is not available.
9. Patients having minor complaints like Fever, Bodyache, Joint Pain are admitted in General Medicine, Paediatrics, Orthopaedics wards.
10. In Orthopaedics ward, not a single patient with plaster POP or Back slab was found, implying ward was filled with patients just to fill in the numbers.
11. Wards: Demonstration rooms are very small. Many wards, like Psychiatry ward, are not as per MSR Regulations.
12. There were only 3 Major & 2 Minor operations on day of assessment.
13. Radiological investigation workload is grossly inadequate on day of assessment as under:
  - (a) Plain X-rays: 32;
  - (b) Ba, IVP: NIL;
  - (c) CT Scan: 2.
14. Laboratory investigation workload is inadequate.
15. Histopathology workload was only 02 & Cytopathology workload was only 01 for the day of assessment.
16. O.T.s: Central O<sub>2</sub> & Central Suction and Infusion Pumps are not available in some O.T.s. Defibrillators are not available.
17. ICUs: There was NIL patient in SICU, 1 in NICU & 2 in PICU on day of assessment.
18. Radiodiagnosis Department: Only 2 Mobile X-ray machines are available against requirement of 6. Only 2 Static X-ray machines are available against requirement of 5. AERB approval is not available. Only 2 USG machines are available against requirement of 3.
19. Central Research Laboratory is not available.
20. Audiometry & Speech therapy rooms are available but very small in size.
21. MRD: ICD X classification is not followed.
22. MEU: No activity has been undertaken by MEU during the year.
23. Lecture Theaters: Capacity of Hospital Lecture Theater is only 140 which is inadequate. E class facility is not available in 2 Lecture Theaters out of

- 4 in the college and also in Hospital Lecture Theater. Audiovisual aids are not available in 2 Lecture Theaters.
24. Central Library: Air-conditioning is non-functional. Capacity of Students' reading Room (Inside) is 110 against requirement of 150. Separate Staff reading room is not available.
  25. Students' Hostels: Recreation room is not available. Study room is available but it is not air-conditioned and Computer with Internet is not available. (P. 22)
  26. Interns' hostels: Available accommodation is 70 against requirement of 100. Recreation room is not available. Study room is available but it is not air-conditioned and Computer with Internet is not available.
  27. Residents' Hostels: Available accommodation is 50 against requirement of 115. Recreation room is not available. Study room is available but it is not air-conditioned and Computer with Internet is not available.
  28. Anatomy Department: MRI & CT films are not available.
  29. Microbiology Department: Only 2 Service Laboratories are available against requirement of 7.
  30. Some Demonstration Rooms are not in use. Some are smaller than required.
  31. RHTC: PHC Tikota which is shown as RHTC belongs to Govt. of Karnataka. All the staff are of Govt. of Karnataka. No students are posted. Two commercial shops are shown as hostel which do not have windows, toilets or mess facilities. Specialists' visits are not available. Activities under National Health Programmes are carried out by Govt. staff.
  32. UHC: Specialists' visits are not organized.

In view of the above, the Executive Committee of the Council decided to recommend to the Central Govt. not to renew the permission for admission of 4<sup>th</sup> batch of MBBS students against the increased intake i.e. from 100-150 of Al-Ameen Medical College & Hospital, Bijapur under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 for the academic year 2016-2017 and further decided to apply clause 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment), 2010 (Part II), dated 16<sup>th</sup> April, 2010 which reads as under:-

8(3)(1).....

(c) Colleges which are already recognized for award of MBBS degree and/or running postgraduate courses

*If it is observed during any regular inspection of the institute that the deficiency of teaching faculty and/or Residents is more than 10% and/or bed occupancy is <80%, such an institute will not be considered for processing applications for postgraduate courses in the Academic year and will be issued show cause notices as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses."*

In view of above, it was decided not to consider the Institute for processing applications for postgraduate courses for the Academic year (2017-18) and to issue show cause notice as to why the recommendation for withdrawal of recognition of the courses run by that institute should not be made for undergraduate and postgraduate courses which are recognized u/s 11(2) of the IMC Act, 1956 alongwith direction of stoppage of admissions in permitted postgraduate courses...."

**49. Recognition/approval of JSS Medical College, Mysore for the award of MBBS degree granted by JSS University, Mysore against the increased intake i.e. from 150 to 200 seats u/s 11(2) of the IMC Act, 1956.**

Read: the matter with regard to recognition/approval of JSS Medical College, Mysore for the award of MBBS degree granted by JSS University, Mysore against the increased intake i.e. from 150 to 200 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment reports (8<sup>th</sup> February, 2016 & 10<sup>th</sup> /11<sup>th</sup> March, 2016) and decided to recommend to the Central Government for recognition/approval of JSS Medical College, Mysore for the award of MBBS degree granted by JSS University, Mysore against the increased intake i.e. from 150 to 200 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The Committee decided to place the matter before the General Body of the Council.

**50. Recognition/approval of NRS Medical College, Kolkata for the award of MBBS degree granted by The West Bengal University of Health Sciences, Kolkata against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.**

Read: the matter with regard to recognition/approval of NRS Medical College, Kolkata for the award of MBBS degree granted by The West Bengal University of Health Sciences, Kolkata against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment report (06.02.2016) and (10.03.2016 & 11.03.2016) and noted the following:-

1. Deficiency of faculty is 10.16 % as detailed in the report.
2. OPD: Teaching areas in General Surgery, Orthopaedics, Ophthalmology, ENT & O.G. departments are small with inadequate capacity & without audiovisual aids. Injection room is common for males/females. There is no emergency tray in Injection room. ECG machine in OPD is out of order. Specialty clinics are not available in Paediatrics & O.G. OPD.
3. Audiometry & Speech Therapy are not available in OPD.
4. Wards: Several wards do not have Demonstration rooms.

5. ETO Sterilizer is not available.
6. Examination Halls: Out of 3 Examination Halls, 1 does not have any furniture.
7. Central Library: It is not air-conditioned. Capacity of Students' Reading room (Inside) is 200 against requirement of 250. Resident/PG Reading room is not available. Only 25 Internet Nodes are available against requirement of 50.
8. Girls' Common Room is locked & used as Stores room.
9. Students' Hostels: Study room is not available.
10. Residents' Hostels: 40 rooms are 4 seater which is not permissible. Resultantly, available accommodation is less than required.
11. Residential Quarters: Only 22 quarters are available for faculty against 38 required.
12. Demonstration Rooms of Anatomy, Physiology departments are smaller in capacity than required.
13. Biochemistry Department: Practical laboratory is smaller than required.
14. RHTC: No specialist except Eye specialists visit RHTC.
15. UHC: Specialists' visits are not provided.
16. Website: Toll free number to report ragging is not available.
17. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognize/approve NRS Medical College, Kolkata for the award of MBBS degree granted by The West Bengal University of Health Sciences, Kolkata against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2 (Two) weeks for further consideration of the matter.

**51. Recognition/approval of Sri Ramachandra Medical College & Research Institute, Chennai for the award of MBBS degree granted by Sri Ramachandra University, Chennai against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.**

Read: the matter with regard to recognition/approval of Sri Ramachandra Medical College & Research Institute, Chennai for the award of MBBS degree granted by Sri Ramachandra University, Chennai against the increased intake i.e. from 150 to 250 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

1. Dr. Sikha Banerjee, Medical Superintendent has only 5 y administrative experience against requirement of 10 y; hence not qualified to hold the post.
2. OPD: Teaching areas are inadequate.
3. Wards: Demonstration rooms are inadequate. Distance between 2 beds is < 1.5 m. Pantry is not available in all the wards.
4. Workload of Special investigations like Ba, IVP is NIL on day of assessment.
5. ETO Sterilizer is not available.
6. Examination Hall: Requirement is 3 Examination halls of capacity 250 each – i.e. total 750. One Examination Hall of capacity 700 is available; thus there is shortfall of 50.
7. Central Library: Capacity of Reading room (Outside) & Reading room (Inside) is 150 each against requirement of 250 each. Only 32 journals are available against requirement of 100. Only 10 Internet Nodes are available against requirement of 50.
8. Boys' & Girls' Common rooms are smaller than required.
9. Students' Hostels: Available accommodation is 652 against requirement of 937. In all rooms 4 students are accommodated in the room which is not permissible; hence deficit would be even larger.
10. Interns' Hostel: Available accommodation is 200 against requirement of 250.
11. Residents' Hostels: In all rooms 4 Residents are accommodated in the room which is not permissible.
12. Residential Quarters: Quarters for faculty are not available in the campus.
13. Demonstration Rooms: 3 Demonstration rooms are available in the departments of Physiology, Biochemistry & 2 Demonstration rooms are available in Pathology, Microbiology, Pharmacology, Forensic Medicine departments against requirement of 4 in each department.
14. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognize/approve Govt. Medical College Kolkata for the award of MBBS degree granted by The West Bengal University of Health Sciences, Kolkata against the increased intake i.e. from 155 to 250 seats u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to

submit the compliance for rectification of the above deficiencies within 2 (Two) weeks for further consideration of the matter.

**53. Recognition/approval of Dr. Rajendra Prasad Govt. Medical College, Tanda for the award of MBBS degree granted by Himachal Pradesh University, Shimla against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956.**

Read: the matter with regard to recognition/approval of Dr. Rajendra Prasad Govt. Medical College, Tanda for the award of MBBS degree granted by Himachal Pradesh University, Shimla against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment report (23.12.2015) and (14.03.2016 & 15.03.2016) and noted the following:-

1. Deficiency of faculty is 27.61 % as detailed in the report.
2. Shortage of Residents is 13.4 % as detailed in the report.
3. Bed occupancy is 69 % on day of assessment.
4. OPD: Injection room is common for males & females. Dressing room is common for males & females. Plaster room & Plaster Cutting room are in one room. In Paediatrics OPD, Child Rehabilitation clinic is not available.
5. Wards: Demonstration room is not available in some rooms & in some wards it is smaller.
6. Casualty: NIL patient was admitted in Casualty on day of assessment.
7. O.T.s: Central O<sub>2</sub> and Central Suction are not available.
8. MRD: It is partially computerized. ICD X classification of diseases is used partially for indexing of diseases.
9. Paramedical & Non-teaching staff: Total 144 Paramedical & Non-teaching staff are appointed against requirement of 179.
10. Lecture Theater: Requirement is 4 Lecture Theaters of 120 capacity each in the college & 1 of 150 capacity in hospital. Available are 3 of capacity 150 each & 3 of 100 each in the college & 1 of capacity 150 in the hospital. Thus capacity of 1 Lecture Theater in college is less than required.
11. Central Library: Available Internet Nodes are 15 against requirement of 25.
12. Common Rooms for Boys & Girls are smaller than required. Attached toilets are not available.
13. Students' Hostels: Available accommodation is 360 against requirement of 375. Out of this, accommodation for 20 is in Dormitory which is not permissible.
14. Physiology Department: Seats in Haematology laboratory are less.
15. Biochemistry Department: Seats in Practical laboratory are less.
16. RHTC: Residential accommodation is available but not used.
17. Website: It is not regularly updated. Details of University, Citizens' Charter, List of students admitted are not updated. Toll free number for to report ragging is not provided.
18. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognize/approve Dr. Rajendra Prasad Govt. Medical College, Tanda for the award of MBBS degree granted by Himachal Pradesh University, Shimla against the increased intake i.e. from 50 to 100 seats u/s 11(2) of the IMC Act, 1956 and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2 (Two) weeks for further consideration of the matter.

**54. Recognition/approval of Govt. Medical College, Kota for the award of MBBS degree granted by Rajasthan University of Health Sciences, Jaipur against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956.**

Read: the matter with regard to recognition/approval of Govt. Medical College, Kota for the award of MBBS degree granted by Rajasthan University of Health Sciences, Jaipur against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956.

The Executive Committee of the Council considered the assessment report (06.02.2016) and (14.03.2016 & 15.03.2016) and noted the following:-

1. Deficiency of faculty is 11.34 % as detailed in the report.
2. OPD: Dressing room is common for males & females. In Ophthalmology OPD, Dark room, Refraction room & Minor Procedure room are combined into 1 room instead of 3 separate rooms.
3. Teaching Beds: Although PG courses are run in Tb & Chest and Psychiatry departments, available beds are 20 & 15 respectively instead of minimum 30 beds in each.
4. MRD: It is partly computerized. ICD X classification of diseases is not used for indexing.
5. Dietician is not available.
6. Examination Halls: One Examination Hall of capacity 150 is available against requirement of 2 of 250 capacity each.
7. Common Rooms for Boys & Girls are smaller than required.
8. Students' Hostels: Available accommodation is 486 against requirement of 565. Rooms are small. Hygiene is poor. Visitors' room, A.C. Study room with Computer & Internet & Recreation room are not available.
9. Interns' Hostel: Available accommodation is 96 against requirement of 150.
10. Nurses' Hostel: Available accommodation is 36 against requirement of 75.
11. Central Library: It is not air-conditioned. Available area is 1,200 sq.m. against requirement of 2,400 sq.m. Capacity of Students' Reading Room (Inside) & Students' Reading Room (Outside) is 70 & 80 respectively against requirement of 150 each. Staff Reading room has capacity of 10 against requirement of 30. Available books are 9,646 against requirement of 11,000. 95 Journals are available against requirement of 100.
12. Anatomy Department: Only 100 Lockers are available against requirement of 150.
13. There is only 1 Demonstration Room in Physiology, Biochemistry, Pharmacology, Forensic Medicine departments against requirement of 2 in each department.
14. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognize/approve Govt. The Executive Committee of the Council considered the compliance verification assessment report (11.03.2016) along with assessment report (20.08.2015, 15<sup>th</sup> April, 2015 & 6<sup>th</sup> & 7<sup>th</sup> January, 2015) and noted the following:-

1. Deficiency of teaching faculty is 6.68 % as detailed in the report.
2. Bed occupancy is 68.30 % on day of assessment.
3. In Orthopaedics ward, many patients were admitted who did not merit admission.
4. ICUs: In ICCU there was only 1 patient on day of assessment. Not all patients in MICU & MICU needed intensive care.
5. OPD: At 09: 30 a.m., very few patients were found at the registration counters. During round of OPDs between 10 & 11 a.m., not many patients were found in various OPDs.
6. In O.G. OPD, no separate Cancer Detection clinic & Family Planning clinic was available. In Paediatrics OPD, Dietician's room is used as Child Rehabilitation clinic.
7. In Endoscopy room of ENT OPD, Inj. Lignocaine with expiry date of December 2012 was kept. Audiometry room is not soundproof. No Speech therapy room, machines, staff are available.
8. Out of 6 Major operations mentioned in Orthopaedics OT register in last 3 days, only 1 was present in the ward. Others could not be traced.
9. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to reiterate its earlier decision with regard to application of clause 8(3)(1)(c) of Establishment of Medical College Regulations (Amendment),2010(Part II), dated 16<sup>th</sup> April, 2010 and to return the postgraduate applications of Maharashtra Institute of Medical Sciences & Research, Talegaon, Pune recommending disapproval of the scheme.

The Executive Committee of the Council further decided that since the gross deficiencies of teaching faculty, residents, & infrastructure are still persisting inspite of repeated opportunities being given to the institute to rectify the same over a period of time, why the recognition for the award of MBBS degree granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Maharashtra Institute of Medical Sciences & Research, Talegaon, Pune be not withdrawn u/s 19 of the IMC Act, 1956. It was further decided that the institute be directed not to make further admissions from the academic year 2016-17 onwards.

The Committee further decided to place the matter before the General Body of the Council.

30. Students' Hostels: Available accommodation is total 127 rooms of which a few are triple seated. Hence it is inadequate against requirement of

1. Shortage of Residents is 22.72 % as detailed in the report.
2. Some Residents were found to be not staying in their allotted rooms in Residents' hostel.
3. Wards: About 20 % of patients in General Medicine, General Surgery & O.G. were admitted for minor complaints and did not merit admission. Majority of Paediatric patients were not genuine. In Orthopaedics ward, 26 out of 46 admitted patients were admitted for minor complaints like backache, osteoarthritis, etc. In Psychiatry, Ophthalmology & ENT, male & female wards are combined.
4. Bed Occupancy was 73.6 % but many patients did not merit admission as shown above.
5. Data of OPD attendance, Minor operations as provided by institute are highly inflated.
6. There were only 05 Major operations till 12 noon on day of assessment.
7. There was NIL Normal Delivery & 1 Caesarean Section on day of assessment.
8. Cytopathology workload was only 08 on day of assessment.
9. Obstetric O.T. has 2 tables which is not as per norms.
10. ICUs: ICCU & PICU are not air-conditioned. SICU air-conditioning is not adequate. There were only 2 genuine patients in NICU. There were NIL patients on Ventilators.
11. Equipment in Central research Laboratory are not adequate.
12. Central Library: It is not air-conditioned. Staff Reading room is not clearly demarcated.
13. Common Rooms for Boys & Girls: Size is less than required.
14. Central Photography Section: There is no staff & no equipment.
15. Students' Hostels: Available accommodation is for 357 students against requirement of 375. Girls' hostel is ½ km. away from campus in Dental College campus. In Recreation room, only TV is available. Study Room with Computer & Internet is not available.

16. Interns' Hostel: Female Interns' hostel is ½ km. away from campus in Dental College campus. Drainage work is in progress. In Recreation room, only TV is available. Study Room with Computer & Internet is not available.
17. Residents' Hostel: In Recreation room, Study Room with Computer & Internet is not available.
18. Anatomy department: Proper Drainage facility is not available.
19. Pharmacology Department: Museum is not properly organized. There are no models.
20. Forensic Medicine Department: Details regarding Museum are not provided & not demonstrated.
21. Other deficiencies as pointed out in the assessment report.

In view of the above, the Executive Committee of the Council decided to recommend not to recognise/approve Career Instt. of Medical Sciences & Hospital, Lucknow for the award of MBBS degree(100 seats) granted by Dr. RML Avadh University, Faizabad, Uttar Pradesh u/s 11(2) of the I.M.C. Act, 1956\_ and further decided that the Institute be asked to submit the compliance for rectification of the above deficiencies within 2(two) weeks for further consideration of the matter.

5. OPD attendance was only 350 on day of assessment at 2 p.m. as observed by assessors.
6. OPD: Separate Registration counters for males/females are not available. Reception area is too small. Injection room is not available in General Medicine OPD. There is no equipment in Plaster Cutting room in Orthopaedics OPD. Minor Procedure room is only vacant space without any equipment.
7. Wards: Demonstration rooms in wards are too small. They are not furnished and are non-functional.
8. Teaching Beds: 05 teaching beds are deficient as only 85 beds are available against 90 required.
9. Data of OPD attendance, Casualty attendance, Major & Minor operations, Normal Deliveries & Caesarean Section, Radiological & Laboratory investigations provided by institute are inflated.
10. Cytopathology workload was only 06 on day of assessment.
11. MRD: ICD X classification of diseases is not followed for indexing.
12. Casualty: Room labeled as O.G. Casualty seems to be non-functional.
13. ICUs: ICCU & MICU are combined.
14. Eclampsia room is not equipped to manage the cases.
15. Radiodiagnosis Department: NIL Mobile X-ray machines is available. 3 Static X-ray machines are available against requirement of 5. CT Scan is not OF minimum 16 slice. Only 2 USG machines are available against requirement of 3.
16. Central Research Laboratory is non-functional.
17. There was a patient in General Surgery ward by name of Chinnapaiyan (IPD # 795167). He was diagnosed as having "Perianal Abscess". During examination he was found to have nothing.
18. In General Medicine, Paediatrics & O.G. wards, patients were just lying on cots & had no complaints at all.
19. In General Surgery ward, there was not a single Post-operative patient found.
20. In Orthopaedics ward, not a single patient had operative intervention.
21. Nurses: Nursing Council Registration numbers were not available either with Nurses or with the management. Night Duty is not performed.
22. Lecture Theaters: Capacity of 3 Lecture Theaters is 144, 160 & 164 against requirement of 180 each. Hospital lecture Theater is not of gallery type.
23. Central Library: It is not air-conditioned. Most of the Computers are not connected & non-functional.
24. Common Rooms for Boys & Girls are much smaller than required. Attached toilets are in poor shape.
25. Students' Hostels: Available accommodation is 365 against requirement of 563. It is not properly furnished. Toilet facilities are inadequate.

- Visitors' room, A.C. Study room with Computer & Internet & Recreation room are not available. Hygiene is poor. Mess is not available.
26. Interns' Hostel: It is not available.
  27. Residents' Hostels: Available accommodation is 20 + 2 flats against requirement of 85. It is not properly furnished. Toilet facilities are inadequate. Visitors' room, A.C. Study room with Computer & Internet & Recreation room are not available. Hygiene is poor. Mess is not available.
  28. Nurses' Hostel: It is not properly furnished. Toilet facilities are inadequate. Visitors' room, A.C. Study room with Computer & Internet & Recreation room are not available. Hygiene is poor.
  29. Playground is not available.
  30. Anatomy Department: Only 70 Lockers are available against requirement of 150.
  31. Demonstration Rooms: Only 1 Demonstration room has Audiovisual aids in the department of Anatomy, Physiology, Biochemistry, Pathology, Microbiology, Pharmacology, Forensic Medicine & Community Medicine.
  32. Biochemistry Department: Number of seats in Practical Laboratory are only 70 against 90 required.
  33. Pathology Department: Only 60 specimens are available.
  34. Microbiology department: Only 7 Service laboratories are available against requirement of 7.
  35. Pharmacology Department: Models are not available in the museum.
  36. Community Medicine Department: Number of seats in Practical Laboratory are less.
  37. RHTC: Details of Residential accommodation are not provided. Cold Chain equipment is not available. NIL activities under National Health Programmes are undertaken.
  38. UHC: There are no registers of surveys / MCH / Immunization / Family Planning activities. It is not as per norms. H2
  39. Other deficiencies as pointed out in the assessment report.

13. Students' Hostels: All rooms were locked. Keys were not available with warden or Hostel Superintendent.
14. Interns' Hostel: Female Interns' hostel is under construction. Male Interns' hostel is partly furnished. Visitors' room, A.C. Study room with Computer & Internet & recreation room are not available.
15. Residents' Hostel: Some rooms are partially furnished. Rooms in hospital are not furnished.
16. Physiology Department: Details of demonstration rooms are not provided.
17. RHTC: Cold Chain Equipment is not available. It is run in building taken on lease from Apex Hospital & Trauma Center. Display board shows Apex Hospital & Trauma Center. Only 1 MSW was present at time of assessment. Posts of Health Inspectors & Health Educator are vacant.
18. UHC: It is run in basement of building taken on lease from Dr. Namita Agrawal. Display board shows Shreeram Medicare. Only 1 MSW was present at time of assessment. Posts of Health Inspectors & Health Educator are vacant.
19. Website: It is not updated. List of admitted students, results of all examinations of previous year, members of Anti ragging Committee are not provided on website.
20. Other deficiencies as pointed out in the assessment report.
