3. Resultantly, infrastructure is inadequate.
4. Flourescein angiography equipment, contract lens sets & B Scan are not available.
5. Resultantly, instrumentation is inadequate.
6. Other deficiencies/observations as pointed out in the inspection report.

- (b) The shortage of Residents is 41.17% as under :-
  - i) Sr. Resident 20 (Medicine-4, TB & Chest-1, Dermatology-1, Psychiatry-1, Paediatrics-2, Surgery-4, Ophthalmology-1, Orthopaedics-2, Anaesthesia-4)
  - ii) Jr. Resident 15 (Medicine-5, Paediatrics-2, Orthopaedics-3, ENT-2, Obgy-3)

Remarks: In Biochemistry Department Professor & Head is non-medical. Non -Medical Teachers are more than 50%.

2. Daily OPD attendance is : 842 and Bed Occupancy is 84%. These high OPD and bed occupancy do not commensurate with other clinical data like CT Scan, Microbiological investigations and histopathology (major surgeries -15). Data reported by Medical Superintendent.
3. Bed occupancy was 81.30% at 5.00 pm as reported by the Medical Superintendent. The Inspectors Team took the round of all the wards at 7.00 pm and observed that the overall bed occupancy in all wards was 57%.
4. Casualty attendance, major surgeries, minor surgeries, microbiology investigations and parasitology investigations do not commensurate with OPD attendance and bed occupancy.
5. Total number of Journals subscribed are 17 Indian and 13 Foreign as against the requirements 70 Indian and 30 Foreign. Meddler facility is not available.
6. Auditorium is not available.
7. Examination hall is not available.
8. Common room for 50 boys in basement of the college building without toilets and for 50 girls it is on ground floor without toilet.
9. Hostel accommodation available for undergraduate boys is 200 and girls 250. Total accommodation available is 450 as against the requirement of 500.
10. The hostel for Interns Residents & Nurses are not available.
11. There are 4 lecture theaters in the college, 2 are gallery type and, 2 are level type, which is not as per norms.
12. All OPD registrations are done manually with the help of 6 clerks. Waiting area is inadequate. Teaching facilities like x-ray view box, examination tray are not provided in all rooms. There are only two teaching areas each having capacity for 25-30. These teaching areas are shared by various departments.
13. In many wards side laboratories not functional. Wards are congested, the space between the beds is not sufficient. Beds are numbered but unit wise distribution of the bed is not seen. Patients of dermatology and psychiatry are kept in the medicine ward which is not allowed.
14. There is a medical record section located in a old heritage hut. There is no medical record officer. A MBBS doctor is performing the show. There is a computer but the record is not computerized. ICD X WHO classification is not followed.
15. Total 15 beds are available in two rooms of casualty area, one room is having 7 beds with central oxygen supply. Both the rooms are without central suction, another room is not having central oxygen supply.
16. Separate ICCU, Surgical ICU, Burns ICU, Pediatric ICU, Respiratory ICU are not available.
17. Two static units of 300 mA are available as the against the requirement of 1-800 mA, 1-500 mA and 1-300 mA in the department of Radio-diagnosis.
18. Service of the dietician is not available. There is no provision to supply therapeutic diet.
19. Para Medical Staff: The specific technical paramedical staff is not provided.
20. Residential Quarters - Total 12 quarters are available for teaching faculty, which is inadequate against the requirement of 60 at this stage.
21. Anatomy Department : Toilet for staff members is inadequate. 36 students lockers are available, which is inadequate against the requirement for 100. Research Laboratory is not available. Deficiencies remain as it is.
22. Pharmacology Department: Toilet for staff members is inadequate. Research Laboratory is not available. Deficiencies remain as it is.
23. Physiology Department: toilet for staff members is inadequate. Research Laboratory is not available. Deficiencies remain as it is.
24. Pathology Department: Research Laboratory is not available. Space and toilet for staff members is inadequate. Deficiencies remain as it is.
25. Microbiology Department: Space and toilet for staff members is inadequate. Deficiencies remain as it is.
26. Forensic Medicine Department: Space and toilet for staff members is inadequate. Deficiencies remain as it is.
27. Community Medicine Department: Research Laboratory is not available. Toilet for staff members is inadequate. Deficiencies remain as it is.
28. Other deficiencies pointed out in the inspection report.

**32. Starting of MD (Radio-Diagnosis) course at M.N.R. Medical College, Sangareddy under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MD (Radio-Diagnosis) course at M.N.R. Medical College, Sangareddy under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 because of the following reasons:-

1. MRI & Mammography are not available.
2. Resultantly, instrumentation is incomplete.
3. Dr. V.H. Yadhikar, Professor & Dr. K.J. Reddy, Assoc.Prof., do not possess recognized postgraduate qualification.
4. Promotion of Dr. Vijay Govind Hanchate, Assoc. Prof. is not as per MCI norms.
5. Other deficiencies/observations as pointed out in the inspection report.

**33. Starting of MS (General Surgery) course at M.N.R. Medical College, Sangareddy under NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Dec, 2008) on the physical and other teaching facilities available at M.N.R. Medical College, Sangareddy under NTR University of Health Sciences, Vijayawada for starting of MS (General Surgery) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of MS (General Surgery) course at M.N.R. 7. There is no properly structured separate burn unit.
8. There is no departmental museum.

The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**42. Increase of seats in MD(General Medicine) course at Govt. Medical College, Kottayam under Mahatma Gandhi University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Oct, 2008) on the physical and other teaching facilities available at Govt. Medical College, Kottayam for increase of seats in MD (General Medicine) course under Mahatma Gandhi University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Oct., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for increase of seats in MD (General Medicine) course at Govt. Medical College, Kottayam under Mahatma Gandhi University u/s 10A of the I.M.C. Act, 1956 because of the following:-

1. Dr. K. Vijay Kumar, Professor is an Honorary faculty member & Dr. Rekha P., Lecturer, is a part time faculty member - hence both of them cannot be considered as faculty members.
2. Promotion of Dr. P.P. Mohanan, Professor & Incharge of Unit-II is not as per MCI norms.
3. Other deficiencies/observations as pointed out in the inspection report.

**43. Increase of seats in MD(Anaesthesiology) course at SCB Medical College, Cuttack under Utkal University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Dec, 2008) on the physical and other teaching facilities available at SCB Medical College, Cuttack for increase of seats in MD (Anaesthesiology) course under Utkal University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Anaesthesiology) course at SCB Medical College, Cuttack under Utkal University u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 6(Six) to 12(Twelve) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**44. Increase of seats in MD(General Medicine) course at Calcutta National Medical College, Kolkata under West Bengal University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Dec, 2008) on the physical and other teaching facilities available at Calcutta National Medical College, Kolkatta under West Bengal University of Health Sciences for increase of seats in MD (General Medicine) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (General Medicine) course at Calcutta National Medical College, Kolkatta under West Bengal University of Health Sciences u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 4(Four) to 10(Ten) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**45. Increase of seats in MD (Paediatrics) course at Burdwan Medical College, Burdwan under West Bengal University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Nov, 2008) on the physical and other teaching facilities available at Burdwan Medical College, Burdwan for increase of seats in MD (Paediatrics) course under West Bengal University of Health Sciences u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2008) and noted that Dr. Badal Chandra Mondal, Professor, Dr. Snehanshu Chakraborty, Assoc. Prof. & Dr. Tarak Nath Ghosh, Asst.Prof. of Unit-IV do not possess recognized postgraduate qualification.

However, the teaching faculty complement other than the teacher mentioned above is adequate and complete and hence decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Paediatrics) course at Burdwan Medical College, Burdwan under West Bengal University of Health Sciences u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 1(One) to 4(Four) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**46. Increase of seats in MD (Anaesthesia) course at Burdwan Medical College, Burdwan under West Bengal University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Dec, 2008) on the physical and other teaching facilities available at Burdwan Medical College, Burdwan for increase of seats in MD (Anaesthesia) course under West Bengal University of Health Sciences u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Anaesthesia) course at Burdwan Medical College, Burdwan under West Bengal University of Health Sciences u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 3(Three) to 6(Six) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**47. Increase of seats in MD (Radio-Diag.) course at Mahatma Gandhi Medical College & Research Institute, Pondicherry under Pondicherry University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Dec, 2008) on the physical and other teaching facilities available at Mahatma Gandhi Medical College & Research Institute, Pondicherry for increase of seats in MD (Radio-Diag.) course under Pondicherry University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Radio-Diag.) course at Mahatma Gandhi Medical College & Research Institute, Pondicherry under Pondicherry University u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 2(Two) to 4(Four) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**48. Starting of MD (Community Medicine) course at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Oct, 2008) on the physical and other teaching facilities available at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala for starting of MD (Community Medicine) course under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Oct., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Community Medicine) course at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 5(Five) students per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**49. Starting of MD (Radio-Diag.) & DMRD courses at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Nov, 2008) on the physical and other teaching facilities available at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala for starting of MD (Radio-Diag.) & DMRD courses under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Nov., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Radio-Diag.) & DMRD courses at M.M. Instt. Of Medical Sciences & Research, Mullana Ambala under Maharishi Markandeshwar University u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 3(Three) students in MD(Radio-Diagn.) & 2(Two) students in DMRD per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**50. Starting of MD(Biochemistry) course at Vydehi Institute of Medical Sciences & Research Centre, Bangalore under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector's report (Dec, 2008) on the physical and other teaching facilities available at Vydehi Instt. of Medical Sciences & Research Centre, Bangalore for starting of MD (Biochemistry) course under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector's report (Dec., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for starting of MD (Biochemistry) course at Vydehi Instt. of Medical Sciences & Research Centre, Bangalore under under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956 prospectively i.e. from the academic session 2009-2010 restricting the number of admission to 2(Two) students per year, till the first batch admitted appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**51. Starting of various Postgraduate courses at Katuri Medical College, Guntur - deferment of applications to the next academic year.**

Read: the letter dated 30.10.2008 for withdrawal of application for starting of various PG courses at Katuri Medical College, Guntur and letter dated 28.11.2008 for consideration of application for starting of Biochemistry, Dermatology and Pulmonary Medicine courses u/s 10A of the IMC Act, 1956.

The members of the Postgraduate Committee observed that vide letter dated 30.10.2008 of Chairman, Katuri Medical College & Hospital, Guntur has requested the Council to consider the application for the following courses for the academic session 2010-11:-

- 1 Anatomy.
- 2 Physiology.
- 3 Forensic Medicine.
- 4 SPM
- 5 Psychiatry.

The members of the Postgraduate Committee decided to return the application to the Central Govt. recommending disapproval of the Scheme for starting of Anatomy, Physiology, Forensic Medicine, SPM & Psychiatry courses at Katuri Medical College, Guntur received u/s 10A of the IMC Act, as there is no provision u/s 10A of the Indian Medical Council Act, 1956 or the regulations framed therein to keep the application pending in the Council office for the next academic year.

**52. Starting of 9 PG degree courses at Mediciti Institute of Medical Sciences, Rangareddy - Permission of Central Govt. - regarding.**

Read: the letter dated 11.11.2008 received from the Central Govt. Ministry of Health & F.W., New Delhi requesting to consider the applications for starting of various PG courses u/s 10A of the IMC Act, 1956 at Mediciti Institute of Medical Sciences, Rangareddy.

The Postgraduate Committee considered the letter dated 11.11.2008 received from the Central Govt. Ministry of Health & F.W., New Delhi requesting to consider the applications for starting of various PG courses u/s 10A of the IMC Act, 1956 at Mediciti Institute of Medical Sciences, Rangareddy and observed that as per time Schedule

prescribed in the Opening of a new or higher course of study or training (including Postgraduate course of study or training) and increase of admission capacity in any course of study or training (including a postgraduate course of study or training) Regulations, 2000, the last date for submission of application for starting of various postgraduate courses is 31<sup>st</sup> July as under:-

*“Schedule*

1.	<i>Receipt of applications by the Central Government</i>	<i>1<sup>st</sup> May to 30<sup>th</sup> June</i>

It was noted that various applications for starting of postgraduate courses at Mediciti Institute of Medical Sciences, Rangareddy, A.P. was received from the Central Govt. on 8<sup>th</sup> August, 2008 which is after the last date prescribed for forwarding of application to the Council by the Central Govt. i.e. 31<sup>st</sup> July, 2008, for the academic year 2009-10.

It was further observed that the Regulations being statutory Regulations are mandatory and binding in character and therefore required to be adhered to by all the authorities including MCI. It was further observed that the Hon’ble Supreme Court also passed various pronouncements and directed all the authorities to strictly adhere to the time schedule prescribed in the Regulations.

In view of above, it was decided to reiterate the decision taken by the Council to return the applications for starting of various postgraduate courses at Mediciti Institute of Medical Sciences, Rangareddy, A.P., to the Central Govt

**53. Starting of MS (ENT) & DLO courses at NDMVP Samaj’s Medical College, Nashik under Maharashtra University of Health Sciences, Nashik u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector’s report (Dec., 2008) on the physical and other teaching facilities available at NDMVP Samaj’s Medical College, Nashik under Maharashtra University of Health Sciences, Nashik for starting of MS (ENT) & DLO courses u/s 10A of the IMC Act, 1956 and fax letter from the Dean dt. 29.12.2008.

The Postgraduate Committee considered the Council Inspector’s report (Dec., 2008) and noted that the Dean of the institute vide fax letter dated 29.12.2008 has communicated that the final inspection for the Blood Bank License has been carried out by the joint inspection team of Govt. of India and Govt. of Maharashtra. Its decision is expected at any moment, which would be submitted to the Council immediately upon receipt.

In view of above, the Postgraduate Committee decided to defer the consideration of the matter till the Blood Bank License submitted by the institute is received.

**54. Starting of MD (Paediatrics) & DCH courses at Dr. Ghatge Paediatrics Hospital & PG Institute, Sangli Maharashtra - Permission of Central Govt. - regarding.**

Read: the matter with regard to starting of MD (Paediatrics) & DCH courses at Dr. Ghatge Paediatrics Hospital & PG Institute, Sangli Maharashtra.

The Postgraduate Committee considered the matter with regard to starting of MD (Paediatrics) & DCH courses at Dr. Ghatge Paediatrics Hospital & PG Institute, Sangli Maharashtra and observed that the institute has applied for starting of MD (Paediatrics) & DCH courses, although it is not running any MBBS course. It was further observed that the Regulations 8(1) and 8(1A) of the Postgraduate Medical Education Regulations, 2000 read as under:-

**“8. GENERAL:**

- (1) *The institutions recognized by the Medical Council of India for running Post Graduate courses prior to the commencement of the Indian Medical Council (Amendment) Act, 1993 and those medical colleges recognized for running Bachelor of Medical and Bachelor of Surgery (MBBS) course or institutions established by the Central Government for the purpose of imparting Post Graduate medical education shall be eligible for starting any Post Graduate degree or diploma and higher speciality course.*
- (1A) *The Central Government shall exempt any such existing/proposed non-teaching institution or specialist institution or autonomous body owned and managed by the central government/state government from fulfilling the prescribe provision of having an undergraduate teaching facility, and allow starting Post Graduate medical course.”*

As Dr. Ghatge Paediatrics Hospital & PG Institute, Sangli Maharashtra is not an institute owned and managed by the Central Govt. /State Govt., the exemption available under 8(1A) is not applicable in the instance case.

In view of above, the members of the Postgraduate Committee decided to return the application to the Central Govt. recommending disapproval of the Scheme.

**55. Increase of seats in MD (Paediatrics) & D.C.H courses at M.V.J Medical College & Research Hospital, Bangalore under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: the Council Inspector’s report (Dec., 2008) on the physical and other teaching facilities available at M.V.J. Medical College & Research Hospital, Bangalore under Rajiv Gandhi University of Health Sciences for increase of seats in MD (Paediatrics) & D.C.H. courses u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the Council Inspector’s report (Dec., 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD (Paediatrics) & D.C.H. courses at M.V.J. Medical College & Research Hospital, Bangalore under Rajiv Gandhi University of Health Sciences u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 2(Two) to 3(Three) students per year for each course, till the first batch admitted against the increased number appears in the final examination of the said courses. The institution be advised to apply for recognition of the qualifications for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**56. Excess admission made in MD(Physiology) course for the academic session 2007-2008 at J.N. Medical College, Aligarh.**

Read: the legal opinion obtained from the retainer advocate regarding excess admission made in MD (Physiology) course for the academic session 2007-2008 at J.N. Medical College, Aligarh.



The Postgraduate Committee perused the legal opinion obtained from the retainer advocate regarding excess admission made in MD (Physiology) course for the academic session 2007-2008 at J.N. Medical College, Aligarh, which reads as under:-

*“The Postgraduate Committee considered the letter dated 26.3.2008 received from the Dean, Aligarh Muslim University, Aligarh and noted that the institute has admitted 5 students instead of 4 in the year 2007-08 and they have requested to regularize the seat by reducing 1 seat in the coming year. Taking into consideration all the aspects the Postgraduate Committee decided to obtain legal section in the matter.”*

*After perusing the case file as well as the decision of Postgraduate Committee dated 2.7.2008, it has been observed by me that J.N. Medical College, Aligarh had admitted excess student in M.D. (Physiology) course i.e. 5 students instead of 4 against the permitted intake by the MCI in the academic session 2007-08. The council vide its letter dated 17.1.2008 had already conveyed the decision of the postgraduate committee dated 6.9.2007 by which it was decided to initiate action against the said college under section 10B of IMC Act, 1956 and therefore, it was requested to the Dean, J.N. Medical College to immediately discharge the said student admitted beyond the permissible intake capacity who stands lower in merit and to send the compliance immediately.*

*The Dean, Faculty of Medicine, Aligarh Muslim University vide its letter dated 27.3.2008 has informed the council that to compensate one extra admission in the said sessions, they are ready to admit only three students in the current session i.e. one less than the permitted number of MCI.*

*The provision of section 10B of the Act makes it absolutely clear that each college imparting MBBS/PG/Superspeciality course is required to seek recognition from the MCI. The provision of section 10B is reproduced hereunder:*

10B Non-recognition of the medical qualification in certain cases:-

- 1) Where any medical college is established except with the previous permission of the Central Govt. in accordance with the provisions of section 10A, no medical qualification granted to any student of such medical college shall be recognized medical qualification for the purpose of this Act.
- 2) Where any medical college opens a new or higher course of study or training (including a postgraduate course of study or training) except with the previous permission of Central Govt. in accordance with the provisions of section 10A, no medical qualification granted to any student of such medical college on basis of such study or training shall be a recognized medical qualification for the purpose of this Act.
- 3) Where any medical college increases its admission capacity in any course of study or training except with the previous permission of the Central Govt. in accordance with the provision of section 10A, no medical qualification granted to any student of such medical college on the basis of the increase of its admission capacity shall be a recognized medical qualification for the purposes of this act.

Explanation: For the purpose of this section, the certificate for identifying a student who has been granted a medical qualification on the basis of such increase in the admission capacity shall be such as may be prescribed.

The perusal of the above mentioned section 10B(3) clearly provided that where any medical college increases its admission capacity in any course of study or training except with the previous permission of the Central Govt. in accordance with the provision of section 10A, no medical qualification granted to any student of such medical college on the basis of the increase of its admission capacity shall be a recognized medical qualification for the purposes of this act. The candidate would also not entail any benefit of registration and practice of that specialty of medicine. The academic seats for admission is limited for that academic session only, has been held by the Hon'ble Supreme Court in the judgment in Shefali Nandwani Vs. State of Haryana (2002) 8 SCC 152.

9. The clause in the prospectus makes it clear that there would be no change in the subject or readmission into a different course once the last date of admission was over. To permit respondent No. 4 to take admission in MD(Medicine) for the subsequent academic session would not only be a contravention of the prospectus but would also amount to an increase in the permissible seats for postgraduate students in MD(Medicine) for the subsequent year. This is impermissible under Regulation 10(A) of the Medical Council of India Regulations on Graduate Medical Education, 1997 which provided, inter-alia that no medical college shall increase its admission capacity in any course of study or training (including a postgraduate course of study or training) except with the previous permission of the Central Government. An academic seat is limited to an academic session. It cannot like a vacant government post be "carried forward" to the next year.

The Hon'ble Supreme Court in the case titled as MCI V/s G. Udhaya Bharathi & Ors; cancelled the admission of the student admitted in the 1st year of the MBBS course for the academic year 2003-04 on both the grounds i.e. admission year 2003-04 on both the grounds i.e. admission of the candidate in the MBBS course after the last date of admissions and that it was beyond/over & above the annual intake capacity fixed by the MCI.

Therefore, in my opinion, the excess admission made by the said college in the academic session 2007-08 in MD (Physiology) course beyond the permissible intake capacity granted by MCI is in violation of the statutory provision of the IMC Act, 1956 and also in violation of the settled principle of law as mentioned above".

In view of above, the Postgraduate Committee decided to reiterate its earlier decision to issue the discharge notice directing the institute to discharge the candidate who is admitted in excess and who is lowest in merit and report of compliance to the Council immediately, as there is no provision for carry forward or neutralization to next year.

**57. Request received from Ministry of Health & Quality of Life, Government of Mauritius for assistance in post graduate studies of Mauritius doctors in specialized fields of medicine.**

Read: the letter dt.23.10.2008 received from Mr. M.Sen, Gupta Under Secretary, Ministry of External Affairs, Chanakyapuri addressed to Shri K.V.S Rao, Ministry of Health and Family Welfare and copy to this council requesting for assistance in postgraduate studies of Mauritian doctors in specialized fields of medicine.

The Postgraduate Committee considered the letter dt.23.10.2008 received from Mr. M.Sen, Gupta Under Secretary, Ministry of External Affairs, Chanakyapuri addressed to Shri K.V.S Rao, Ministry of Health and Family Welfare and copy to this Council requesting for assistance in postgraduate studies of Mauritian doctors in specialized fields of medicine and observed that the Screening Test Regulations are applicable only to the Indian nationals who wish to obtain the Provision/Permanent Registration for doing internship or medical practice in India. This Regulation are not applicable those who are not citizen of India.

It was further observed that Section 14 of the Indian Medical Council Act, 1956 pertaining to grant of temporary registration to the person holding medical qualifications granted by the medical institutions in any country outside India, reads as under:-

- "14. (1) The Central Government after consultation with the Council, may, by notification in the Official Gazette, direct that medical qualifications granted by medical institutions in any country out-side India in respect of which a scheme of reciprocity for the recognition of medical qualifications is not in force, shall be recognised medical qualification for the purposes of this Act or shall be so only when granted after a specified date:  
Provided that medical practice by persons possessing such qualifications: -  
(a) shall be permitted only if such persons are enrolled as medical practitioners in accordance with the law regulating the registration of medical practitioners for the time being in force in that country;

- (b) shall be limited to the institution to which they are attached for the time being for the purposes of teaching, research or charitable work ; and
- (c) shall be limited to the period specified in this behalf by the Central Government by general or special order.
- (2) In respect of any such medical qualification the Central Government, after consultation with the Council may, by notification in the Official Gazette direct that it shall be a recognised medical qualification only when granted before a specified date."

In view of above, the members of the Postgraduate Committee decided that all such applications for temporary registration made by the persons who are not citizen of India in taking admission any postgraduate course in India be dealt with in accordance of the provisions of Section 14 of the Indian Medical Council Act, 1956 and regulations framed therein.

**58 Proposal from Indian Society of Hematology & Transfusion Medicine (ISHTM) to include DM(Hemato-Patho.) degree in the list of DM degrees, regulated under PG Medical Education Regulations, 2000 of MCI.**

Read: the report of the Sub-committee alongwith the letter dated 21.4.2008, received from the president, Indian Society of Hematology of Transfusion Medicine with regard to inclusion of DM(Hemato-Patho) degree in the list of DM degrees regulated under Postgraduate Medical Education Regulations 2000 of MCI.

The Postgraduate Committee considered the report of the Sub-committee alongwith the letter dated 21.4.2008, received from the president, Indian Society of Hematology of Transfusion Medicine with regard to inclusion of DM (Hemato-Patho) degree in the list of DM degrees regulated under Postgraduate Medical Education Regulations 2000 of MCI and decided to approve the report of the Sub-Committee, which reads as under:-

"DM course in Haematology: division into subspecialties

The goal of teaching haematology as a postgraduate superspecialty course is to provide the community a specialist well versed and capable of dealing with all aspects of diagnosis, treatment and prevention of disorders of the haematopoietic, haemostatic and lymphatic system. The curriculum for the course should be designed in such a way that training is provided to the residents in diagnostic and therapeutic haematology.

The contention that advances in laboratory haematology and clinical haematology are so extensive that it is impractical for a resident to be competent in both fields is not in conformity with the fact that the resident should be given competence in diagnostic, laboratory and therapeutic practices which would give him/her a thorough knowledge of the science of haematology. Laboratory procedures are invariably carried out in all established medical institutions by highly trained and competent technicians but unless the resident doctor is knowledgeable in these procedures, he cannot evaluate the laboratory results and correlate them with the clinical profile. He is not required to acquire skill in this but knowledge is essential. Bifurcation of the curriculum would lead to considerable duplication since residents studying Clinical Haematology would have to be taught Haematopathology and those studying Haematopathology will need exposure to Clinical Haematology.

Subsequent to his superspecialty training, the specialist has ample opportunities to further narrow down his area of specialization to Clinical Haematology or Haematopathology would restrict the competence acquired by the resident and narrow the knowledge and vision of the specialist,

further, the resident training only in Haematopathology may become only a service provider for those trained in clinical Haematology.

In Countries like UK, division of DM Haematology course into DM Clinical Haematology and DM Haematopathology does not exist even today. Such division in a resource poor country may not be relevant now."

**59 Information under RTI Act, 2005 regarding practice of chemotherapy by doctor with MD(Radiotherapy) qualification.**

Read: the report of the sub-committee alongwith the letter received from Dr. Aditya Narayan seeking information under RTI act, 2005 regarding the practice of Chemo-therapy by doctor with MD(Radio-therapy) qualification.

The Postgraduate Committee considered the report of the sub-committee alongwith the letter received from Dr. Aditya Narayan seeking information under RTI act, 2005 regarding the practice of Chemo-therapy by doctor with MD(Radio-therapy) qualification and decided to accept the report of the Sub-Committee, which reads as under:-

"One Dr. Aditya Narayan sought information under RTI Act, 2005 regarding the practice of Chemo-therapy by doctor with MD (Radio-therapy) following which a meeting of the Sub-Committee constituted by the Postgraduate Committee of this Council on 24.01.2008, was held on 04.08.2008 to deliberate upon the matter of Chemo-therapy by a doctor with MD(Radio-therapy).

The sub-Committee was attended by the following members:-

2. Dr. P.K. Julka
3. (Lt.Col.(Retd.) Dr. A.R.N. Setalvad), Secretary, MCI

The complainant alongwith his query has also referred to a letter No.MCI-23(1)/98-Med./21511, dated 13.11.1998 along with the certified photo copy to this Council.

In our opinion, the matter had already been sorted out by the previous Committee referred to by Dr. Aditya Narayan, which has clearly mentioned as under:-

*The Postgraduate Committee considered the communication from the Director, Regional Cancer Centre, Thiruvethapuram with regards to practice of Chemo-therapy by the physicians having M.D. (Radio-therapy) qualification and decided that if one of the theory papers in the M.D. (Radio-Therapy) examination pertains to the subject of Chemotherapy, such physicians possessing M.D. (Radiotherapy) qualification can be permitted to practice Chemo-Therapy as well.*

The present Committee agrees with this recommendation.

*As far as the question of practice of Chemo-therapy by Surgical Oncologists, the Committee is of the view that anybody who possesses a postgraduate qualification in the concerned speciality and has adequate experience is competent to practice Chemo-therapy".*

**Office Note:-** The office of the Council further directed to inform the applicant accordingly.

**60 Change of nomenclature of the Degree of MD in Tuberculosis and Chest Disease to MD in Pulmonary Medicine.**

Read: the letter dated 18.09.2008 received from the Registrar, Padamashree Dr. D.Y. Patil University, Navi Mumbai regarding change in nomenclature of the Degree of MD in Tuberculosis and Chest Disease to MD in Pulmonary Medicine.

The Postgraduate Committee considered the letter dated 18.09.2008 received from the Registrar, Padamashree Dr. D.Y. Patil University, Navi Mumbai regarding change in nomenclature of the Degree of MD in Tuberculosis and Chest Disease to MD in Pulmonary Medicine and noted that MD in Tuberculosis and Chest Disease is permitted u/s 10A of the IMC Act, 1956 in respect of Padamashree Dr. D.Y. Patil University, Navi Mumbai and now has been recommended for recognition of the said degree by the General Body of this Council at meeting held on 13.11.2008; decided to recommend to the Central Govt. for notification recognizing the degree by the nomenclature of MD (Pulmonary Medicine).

**61 Increase of seats in 5 PG degree courses at Dr. B.R. Ambedkar Medical College & Hospital, Bangalore - Permission of Central Govt. - Regarding.**

Read: the matter with regard to applications received for increase of seats in various PG courses at Dr. B.R. Ambedkar Medical College & Hospital, Bangalore alongwith the decision of the Postgraduate Committee meeting held on 09.10.2003 regarding stoppage of admissions.

The Postgraduate Committee considered the matter with regard to applications received for increase of seats in various PG courses at Dr. B.R. Ambedkar Medical College & Hospital, Bangalore alongwith the decision of the Postgraduate Committee meeting held on 09.10.2003 regarding stoppage of admissions and observed that the General Body of the Council at its meeting held on 10.03.2007 decided as under:-

*"The Council approved the following recommendations of the Executive Committee/Adhoc Committee:-*

3. The college hospital has 410 beds out of which 350 are teaching beds which are inadequate. Additional 150 beds - 30 each in Gen. Medicine, Paediatrics, Gen. Surgery, Orthopaedics & O.G. - have been provided by Govt. of Karnataka for 20 years from 01.01.1988. Such an arrangement is not as per Regulations. There is no separate teaching area available in the OPD & wards in the General Hospital.

4. There is no unit of TB & Chest Diseases. In addition, the teaching beds after considering the requirements of undergraduate and postgraduate courses are deficient as under:-

5. Only 4 O.T.s are available against the requirement of 10. No TV with camera attachment is available. Resuscitation & monitoring equipment is shared by different O.T.s.

6. ICCU, Burns ICU & PICU are not available. Casualty is ill equipped. Ventilator & pulse oxymeter are not available. Only 10 beds are available in the casualty against the requirement of 20. Central monitoring facilities are not available in ICU. Central Oxygen or suction are not available in ICU.

7. Number of static & mobile X-ray units is not as per norms. C.T. scan is not available.

8. No CSSD is available. Sterilization is done in the respective O.T.s with 2 horizontal & 1 vertical autoclaves which is inadequate.

9. Nursing staff is inadequate. Only 103 nurses are available against requirement of 159.

10. Hostel accommodation is available only for 279 students against the requirement of 500.

11. There is no hostel for interns & PGs. They are accommodated in boys & girls' hostels.

12. Only 4 staff quarters are available in the campus which is not as per Regulations.

13. Medical education unit is poorly equipped. No computer is available. No medical education programme has been conducted in last 1 year.

14. Auditorium has capacity of 400 against the requirement of 500.

15. Veterinary officer is part time.

16. No foreign journals are available against the requirement of 70. Total journals available are 72 against the requirement of 100.

17. UHC is under the control of Municipal Corporation & not under the control of the Dean which is not as per Regulations.

18. *Dietician is not available. There is no provision to supply special diet as recommended by the physician.*
19. *In the Physiology department, no separate mammalian laboratory is available. Two demonstration rooms have capacity of 25 each which is not as per regulations.*
20. *Departmental libraries are inadequate in P.S.M., Tb & Chest, Psychiatry, Paediatrics, Gen. Surgery, E.N.T., Orthopaedics, Ophthalmology, O.G. & Anaesthesia.*
21. *Lecture theater at the hospital is of flat type with capacity of 70 which is not as per Regulations.*
22. *There is no canteen available except 1 stall located on the roadside. It has no sitting arrangement for doctors & staff.*
23. *In Pharmacology department, experimental Pharmacology has 30 seats & clinical Pharmacology has 25 seats which is not as per Regulations.*
24. *Other deficiencies pointed out in the inspection report.*

*In view of above and as the deficiencies of teaching faculty, teaching beds, distribution of units, availability of paramedical staff and other infrastructure are still persisting, the members of the Adhoc Committee appointed by the Hon'ble Supreme Court and of the Executive Committee of the Council decided to recommend to the General Body of the Council for withdrawal of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Dr. B.R. Ambedkar Medical College, Bangalore u/s 19 of the I.M.C. Act, 1956 and further decided that the Central Govt. be requested to direct the institute not to admit any further batch of students for academic year 2007-2008.*

*It was observed that as per the time schedule prescribed for admissions in postgraduate courses, the first round of counselling/admissions has to be over by 15<sup>th</sup> April and the last date to join the allotted college and course is 20<sup>th</sup> April.*

*In view of above urgency of adhering to the time schedule, the members of the Adhoc Committee and of the Executive Committee further decided to recommend to the General Body of the Council that the authorities of Dr. B.R. Ambedkar Medical College, Bangalore be directed to henceforth stop admissions in MD(Anaesthesia) & D.A., MD(Dermatology) & D.V.D., MD (Forensic Medicine), MD(Microbiology), MD(Obst. & Gynae.) & D.G.O., MS(ENT), MS(Ophthalmology), DCH, DCP, DOMS, D.Ortho., MD (Anatomy), MD (Physiology), MD (Biochemistry), MD (Pharmacology), MD (Pathology), MD (Comm. Medicine), MD (General Medicine), MD (Paediatrics), MS (General Surgery), MD (Radiology), MS (Orthopaedics) courses being run at the college from the ensuing academic session 2007-2008."*

This decision was communicated to the Central Govt. vide letter dt. 18.05.2007.

It was further observed that the matter is still pending with the Central Govt. and no response has been forthcoming from the Central Govt. in this regard.

In view of the above, the members of the Postgraduate Committee decided to return the applications for increase of seats in 5 degree course (1) MS(OBG) (2) MS(ENT) (3) MS(Orthopaedics) (4) MD(Pathology) (5) MS(Ophthalmology) at Dr. B.R. Ambedkar Medical College & Hospital, Bangalore to the Central Govt. recommending disapproval of the Scheme received u/s 10A of the IMC Act.

**62. Increase of seats in MS (Obst. & Gynae.) course at Dr. D.Y. Patil Medical College, Pimpri, Pune under Dr. D.Y. Patil University u/s 10A of the IMC Act, 1956.**

The Secretary informed that the institute has asked for withdrawal of application vide its letter received through fax by the office of the Council on 23.12.2008.

In view of above, the members of the Postgraduate Committee decided to return the application to the Central Govt. recommending disapproval of the Scheme for increase of seats in MS (Obst. & Gynae.) course under Dr. D.Y. Patil University u/s 10A of the IMC Act, 1956.

**63 Starting of M.Ch.(Plastic Surgery) course at J.N. Medical College, Belgaum under KLE Academy of Higher Education and Research, Belgaumn, (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the compliance verification report (Oct., 2008) on the physical and other teaching facilities available at J.N. Medical College, Belgaum for starting of M. Ch.(Plastic Surgery) course under KLE Academy of Higher Education and Research, Belgaumn, (Deemed University) u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance verification report (Oct., 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M. Ch.(Plastic Surgery) course at J.N. Medical College, Belgaum under KLE Academy of Higher Education and Research, Belgaumn, (Deemed University) u/s 10A of the IMC Act, 1956 because of the following reasons:-

1. Bed strength is not as per MCI norms.
2. OPD runs twice weekly. Attendance 50-55 per day. Operative workload is 2 per day.
3. Resultantly, clinical material is inadequate.
4. Other deficiencies/observations as pointed out in the inspection report.

**64 Starting of MD(Physiology) course at Mahatma Gandhi Medical College & Hospital Jaipur under University of Rajasthan u/s 10A of the IMC Act, 1956.**

Bacteriology) to M.D.(Pathology & Microbiology) since 1976 onwards. The department of Pathology & Microbiology bifurcated into separate departments of Pathology & Microbiology in 1983. Thus a MCI inspection of M.D.(Pathology & Microbiology) could not take place.

The Principal further informed that the first degree by nomenclature of M.D.(Pathology & Microbiology) was awarded in September,1974 and the last degree was awarded in June,1986.

In view of above, the Postgraduate Committee decided that as the qualification by nomenclature of M.D.(Pathology & Bacteriology) of this college was already recognized by the Council, the qualification by the nomenclature of M.D.(Pathology & Microbiology) be also considered to be deemed recognized for the students who acquired the qualification of SMS Medical College, Jaipur

**97. Nagpur University/RTM Nagpur University - Recognition of MS (Orthopaedics) qualification in respect of students being trained at Govt. Medical College, Nagpur.**

Read: the compliance togetherwith the Council Inspector's report (May, 2007 & Feb., 2008) on the standard of examination and other teaching facilities available at Govt. Medical College, Nagpur for purpose of recognition of MS (Orthopaedics) qualification granted by Nagpur University/RTM Nagpur University.

The Postgraduate Committee considered the compliance togetherwith the Council Inspector's report (May, 2007 & Feb., 2008) and decided to reiterate its earlier decision taken at its meeting held on 14.03.2008 not to recognize MS (Orthopaedics) qualification granted by Nagpur University/RTM Nagpur University in respect of students being trained at Govt. Medical College, Nagpur because of the following: -

1. Out of 4 Units, 2 units do not have PG complement i.e. in Unit III & IV as far as faculty is concerned.
2. Other deficiencies as pointed out in the inspection report.

The Committee further decided to direct the institution authorities to henceforth stop admissions in M.S. (Orthopaedics) course from the academic session 2009-2010.

**98. Increase of seats in MD (Radio-therapy) course at Tata Memorial Hospital, Mumbai under Homi Bhabha National Institute (Deemed University) u/s 10A of the IMC Act, 1956.**

Read: the compliance together with the Council Inspector's report (October, 2008) on the physical and other teaching facilities available at Tata Memorial Hospital, Mumbai under Homi Bhabha National Institute, Mumbai for increase of seats in MD(Radio-therapy) course u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance together with the Council Inspector's report (October, 2008) and decided to recommend to the Central Govt. to issue Letter of Permission for increase of seats in MD(Radio-therapy) course at Tata Memorial Hospital, Mumbai under Homi Bhabha National Institute, Mumbai u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2009-2010 from 5(Five) to 7(Seven) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

99. **Starting of M.Ch. (Paediatric Surgery) course at Indira Gandhi Institute of Child Health, Bangalore under Rajiv Gandhi University of Health Sciences u/s 10A of the IMC Act, 1956.**

Read: the compliance together with the Council Inspector's report (September, 2008) on the physical and other teaching facilities available at the Indira Gandhi Institute of Child Health, Bangalore for starting of M.Ch. (Paediatrics Surgery) course under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956.

The Postgraduate Committee considered the compliance togetherwith the Council Inspector's report (September, 2008) and decided to recommend to the Central Govt. not to issue Letter of Intent for starting of M.Ch. (Paediatrics Surgery) course at Indira Gandhi Institute of Child Health, Bangalore under Rajiv Gandhi University of Health Sciences, Bangalore u/s 10A of the IMC Act, 1956 because of the following:-

1. The Consultant experience of Dr. Ramchandra, Professor & HOD, includes 11 years at Manipal Hospital, Bangalore, which is not a teaching institute imparting PG. Education, which cannot be considered; hence not eligible.
2. Resultantly, teaching faculty complement is incomplete.
3. Other deficiencies/observations as pointed out in the inspection report.

100. **Recognition of Master of Medicine (M. Medicine) programme in Uganda Universities.**

Read: the letter dt.14.11.2008 from the Registrar, Uganda Medical and Dental Practitioners Council regarding M. Med. postgraduate programme in Uganda Universities is recognized by other world medical regulatory authorities.

The Postgraduate Committee considered the letter dt. 14.11.2008 from the Registrar, Uganda Medical and Dental Practitioners Council regarding M. Med postgraduate programme in Uganda Universities is recognized by other world medical regulatory authorities and decided that authorities of Uganda University may be advise to follow the prescribed rule u/s 12 of the Indian Medical Council Act, 1956, the reciprocity of degree granted by the Uganda University.

The members of the Postgraduate Committee observed that Section 12 of the Indian Medical Council Act, 1956 pertaining to reciprocity is as under:-

“RECOGNITION OF MEDICAL QUALIFICATIONS GRANTED BY MEDICAL INSTITUTIONS IN COUNTRIES WITH WHICH THERE IS A SCHEME OF RECIPROCITY

12. (1) The medical qualifications granted by medical institutions outside India which are included in the Second Schedule shall be recognised medical qualifications for the purposes of this Act.
- (2) The Council may enter into negotiations with the Authority in any country outside India which by the law of such country is entrusted with the maintenance of a register of medical practitioners, for the settling of a scheme of reciprocity for the recognition of medical qualifications and in pursuance of any such scheme, the Central Government may, by notification in the official Gazette, amend the Second Schedule so as to include therein the medical qualification which the Council has decided should be recognised and any such notification may also direct that an entry shall be made in the last column of the Second Schedule against such medical qualification declaring that it shall be a recognised medical qualification only when granted after a specified date.
- (3) The Central Government, after consultation with the Council, may, by notification in the Official Gazette, amend the Second Schedule by directing that an entry be made therein in respect of any medical qualification declaring that it shall be recognised medical qualification only when granted before a specified date.
- (4) Where the Council has refused to recommend any medical qualification which has been proposed for recognition by any Authority referred to in sub-section (2) and that

Authority applies to the Central Government in this behalf, the Central Government, after considering such application and after obtaining from the council a report, if any, as to the reasons for any such refusal, may by notification in the Official Gazette, amend the Second Schedule so as to include such qualification therein and the provisions of sub-section (2) shall apply to such notification”.

In view of above, the Postgraduate Committee decided that Uganda Medical & Dental Practitioners Council may accordingly be advised to apply through the Govt. of Uganda to the Govt. of India for mutual recognition of degrees as per the Schedule prescribed under Section 12 of the Indian Medical Council Act, 1956 pertaining to reciprocity or registration.
