**1. Minutes of the last meeting of the Postgraduate Medical Education Committee – confirmation of.**

The minutes of the Postgraduate Medical Education Committee meeting held on 24/09/2015 were confirmed in the meeting itself.

**2. Minutes of the last meeting of the Postgraduate Medical Education Committee – action taken thereon.**

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

**3. Increase of seats in MD (General Medicine) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (09/08/2015) on the physical and other teaching facilities available at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar for Increase of seats in MD (General Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (09/08/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in MD (General Medicine) course at Institute of Medical Sciences & SUM Hospital, Bhubaneswar under Siksha "O" Anusandhan University Bhubaneswar u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. How the OPD of Medicine department can be 1549 at 4 P.M. On the day of assessment, the MRI were 4 and CT Scan were 6 in the entire hospital, which indicates inadequate clinical material.
2. Out of total 238 deaths in the Hospital last year, 170 are in Medicine department, which is not realistic.
3. Journals available upto 2014.
4. The Professor & HoD (Graded Specialist, Classified Specialist for 3 years) is not eligible for Assoc. Professor. Hence, his promotion is irregular.
5. Santosh Singh (DNB), Asst. Professor is not eligible. He has no 3 years experience & 1 year post DNB experience at the time of appointment.
6. Dr. Pramod Kumar Upadhyay, Professor, Unit-IV has never been Advisor. Hence, not eligible to be appointed as Professor.
7. Dr. Chandan Dass, Assoc. Professor has been shown as working in Hi-Tech Medical College, Rourkela.
8. Bed occupancy in ICU were 59% only.
9. Information about SICU, RICU, NICU, PICU were left blank.
10. Journal Club: 3; Case Presentation: 4 and Group discussions: 9 in one year, which is grossly inadequate. Postgraduate teaching not being done.
11. Three Professors are from Army. Period and Place of posting of all Faculty members as Graded, Classified Specialist and Advisor signed by competent authority from the Office of DGAFMS has not been attached without which their equivalent academic designations cannot be calculated.
12. Other deficiencies as pointed out in the Assessment Report.

**4. Increase of seats in MS(ENT) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10th August 2015) on the physical and other teaching facilities available at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai for Increase of seats in MS(ENT) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Assessment Report (10th August 2015) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MS(ENT) course at Coimbatore Medical College, Coimbatore, Tamilnadu under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session

2016-2017 from 1(One) to 3(Three) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**5. Increase of seats in MD(Anaesthesia) course at R G Kar Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10th August 2015) on the physical and other teaching facilities available at R G Kar Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata for Increase of seats in MD(Anaesthesia) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10th August 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in MD(Anaesthesia) course at R G Kar Medical College, Kolkata, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. The College authorities have used wrong SAF, which is not prescribed for the year 2016-17.
2. Promotion of Professor & HoD is not as per Regulations. He has been Assoc. Professor for 2 years 11 months.
3. Total number of Major operations has decreased from 19,598 in Year 2 to 18,842 in Year 3. If 18842 of Major Operations in the 3rd year, then daily average should be 63 operations per day. However, Major Surgery on the day of Assessment were 31 only. This is a data mismatch.
4. MRD is not fully computerized.
5. ICD X classification is not being followed.
6. There is no CSSD; autoclaving is done in respective OT blocks.
7. There is only 1 foreign journal of which last issue available is of December 2013.
8. Details of experience of Dr. Gautam Chaudhary are not given in the faculty table.
9. Separate internet facility for students to access online articles at central library is not existing.
10. Other deficiencies as pointed out in the Assessment Report.

**6. Increase of seats in MD (Anaesthesia) course at Andhra Medical College, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Andhra Medical College, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada for Increase of seats in MD (Anaesthesia) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Assessment Report (10/08/2015) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MD (Anaesthesia) course at Andhra Medical College, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2016-2017 from 9(Nine) to 12(Twelve) students per year till the first batch admitted against the increased

number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**7. Starting of MD (Transfusion Medicine) course at Andhra Medical College, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Andhra Medical College, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada for Starting of MD (Transfusion Medicine) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/08/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MD (Transfusion Medicine) course at Andhra Medical College, Visakhapatnam under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. There is no Professor.
2. There are NIL Senior Residents & NIL Tutors.
3. Certificates of special training in the subject for 2 years are not available for any faculty.
4. The OPD on the day of Assessment 2500 & 1500 and IPD 145. Transfusion department does not have any OPD or IPD, thus, wrong data has been provided.
5. Column 17 on page 21 about list of different services provided by the department has been left blank.
6. Teaching experience of Dr. Venkata Laxmi, Associate Professor having teaching experience of 15 years in Pathology and one month in department of Immuno Haematology and Blood Transfusion as per experience certificate submitted by the college authority. There is no document showing 2 years of teaching experience or special training in the department of Immunoheamatology and blood transfusion as per MCI Minimum Qualification for Teacher in Medical Institutions Regulations, 1998 (Amended upto November, 2010)
7. Teaching experience of Dr. Guntur Roda Sumanlatha, Assistant Professor having teaching experience of 2 years and 10 months in pathology and one month in department of Immunoheamatology and Blood Transfusion as per experience certificate submitted by the college authority. There is no document showing 2 years of teaching experience or special training in the department of Immunoheamatology and blood transfusion as per MCI Minimum Qualification for Teacher in Medical Institutions Regulations, 1998 (Amended upto November, 2010)
8. Teaching experience of Dr. Divyasree Neeli, Assistant Professor having teaching experience of only 8 days in department of Immunoheamatology and Blood Transfusion as per experience certificate submitted by the College authority. There is no document showing 2 years of teaching experience or special training in the department of Immunoheamatology and blood transfusion as per MCI Minimum Qualification for Teacher in Medical Institutions Regulations, 1998 (Amended upto November, 2010)
9. Other deficiencies as pointed out in the Assessment Report.

**8. Starting of MS (Orthopaedics) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka for Starting of MS (Orthopaedics) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/08/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MS (Orthopaedics) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. Bed occupancy was 71% on day of assessment and occupancy in SICU 60%.
2. There was only 1 Major & 2 Minor operations on day of assessment.
3. Total number of Major operations is only 435 in 2014 implying average of 1.45/day which is inadequate.
4. MRI is not available. CT is not available.
5. Deficiency of faculty: (a) Asso. Prof.: 1; (b) Asst. Prof.: 1.
6. Shortage of Senior Resident: 1.
7. Unit B has only 1 faculty & it is headed by Asst. Prof.; hence it cannot be considered as a teaching Unit all; resultantly there is deficiency of 1 Unit.
8. Instruments for Joint Replacement & Arthroscopy are not available.
9. No records of specialty clinics are provided.
10. No latest edition has been purchased in last 3 years in the departmental library.
11. Specialty clinic like Hand Clinic is not run.
12. The Institute had instruments for trauma and spine operations including one Image intensifier but did not have instruments for joint replacement and arthroscopy.
13. The Research work in the department is very poor. The Institute had only two articles published (one case report and one case series) and one case report accepted for publication in the last three years and those too in non-indexed journals. The head of the department had no publication in the last three years.
14. The office space for the junior faculty was not there. There was only a room for the head of the department at present.
15. There are only two foreign and one Indian Journal in the Central Library. But the latest issues of journals were not there. The number of books was satisfactory but need to have recent editions also.
16. Other deficiencies as pointed out in the Assessment Report.

**9. Starting of MS (OBG) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka for Starting of MS (OBG) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/08/2015) and decided to recommend to the Central Govt. to

disapprove the scheme for Starting of MS (OBG) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. There are 2 Units, each having 53 beds which is not as per norms.
2. All clinical parameters like OPD attendance, IPD admissions, Major & Minor operations, have decreased by 10-40% during the period of last 3 years.
3. Deficiency of faculty: (a) Asso. Prof.: 1.
4. Shortage of Junior Resident: 1.
5. No separate departmental OPD registers are maintained.
6. Specialty clinics like Cancer clinic, Infertility clinic, Gynaec. Endocrine clinic, Menopausal clinic are not run.
7. Unit B is headed by Asst. Prof.; hence it cannot be considered as teaching Unit; resultantly there is shortage of 1 Unit.
8. Equipment like Colposcope, Infusion Pumps are not available.
9. CT is not available.
10. Other deficiencies as pointed out in the Assessment Report.

10. **Starting of MS (ENT) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka for Starting of MS (ENT) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/08/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MS (ENT) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. Shortage of Junior Resident: 1.
2. Audiology work is outsourced.
3. Equipment like Impedance Audiometry, BERA, OAE, flexible Endoscope, Microdebrider are not available.
4. Specialty clinics are not run.
5. Speech Therapy workload is NIL on day of assessment as well as on randomly selected days. Speech Therapy room is not available.
6. Daily Major operations are only 1.5 which is inadequate.
7. Average bed occupancy is 50%.
8. Investigative facilities like Nerve Conduction, EMG are not available.
9. There is a single room for all the faculty.
10. The department does not participate in National programme for Prevention & Control of Deafness.
11. CT is not available.
12. There is only 1 Indian Journal and 2 Foreign Journals pertaining to ENT in the Central Library.
13. Other deficiencies as pointed out in the Assessment Report.

**11. Starting of MS (Ophthalmology) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka for Starting of MS (Ophthalmology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (10/08/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Starting of MS (Ophthalmology) course at Belagavi Institute of Medical Sciences, Belagavi under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. Bed occupancy is 15% on day of assessment. Average bed occupancy is 43.33%.
2. No Major or Minor operation was scheduled on day of assessment.
3. Space for OPD rooms & waiting area for patients is inadequate.
4. Equipment like B Scan, Fundus Camera (FFA), Posterior Vitrectomy, OCT, Slit lamp attachment of Application Tonometry, Fundus Examination (+ 90 D & + 78 D Lenses) are not available.
5. Facilities for Retinal Surgery are not available.
6. Departmental Library facilities are not adequate.
7. CT & MRI are not available.
8. There is no Asso. Prof. in the only Unit; resultantly faculty complement is incomplete.
9. Specialty clinic like Squint clinic is not run.
10. Equipments, space, specialized services provided by the department are inadequate.
11. Casualty Inadequate.
12. Registration Certificate of Eye Bank as per the "Transplantation of Human Organ Rule, 1995" was not found.
13. Overall clinical material and infrastructure facilities related to Ophthalmology are inadequate.
14. Other deficiencies as pointed out in the Assessment Report.

**12. Increase of seats in MD (Microbiology) course at Osmania Medical College, Hyderabad under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (10/08/2015) on the physical and other teaching facilities available at Osmania Medical College, Hyderabad under Dr. NTR University of Health Sciences, Vijayawada for Increase of seats in MD (Microbiology) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Assessment Report (10/08/2015) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MD (Microbiology) course at Osmania Medical College, Hyderabad under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2016-2017 from 8(Eight) to 15(Fifteen) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

1. Deficiency of faculty: (a) Tutor: 1. (As number of post-mortems is > 500).
2. Non teaching staff is deficient by 2 Technicians.
3. Medico legal examination of cases of sexual assault victims is carried out by department of Obstetrics & Gynaecology and not by this department.
4. Equipment like Weighing Balance for Dead Bodies, Weighing Machine for Organs are not functional.
5. Academic parameter like Group Discussions (15/year) is inadequate.
6. Other deficiencies as pointed out in the Assessment Report.

6. Ancillary departments like Biochemistry, Pathology, Microbiology were not shown to assessor under the plea that they closed at 4 p.m.
7. None of the faculty has received any training in Emergency Medicine. Dr. T.N.S. Prakash, Asso. Prof. of Anaesthesiology has been shown as in charge Professor in the department of Emergency Medicine.
8. There is no death in the department of Emergency Medicine during last one year. This obviously means, Emergency department has no independent beds and does not admit any serious patients under their care without which, the training of the PG students will be inadequate.

9. All staff has been shifted to Emergency department in the month of August just before assessment, which means the department was not in existence prior to that.
10. SAF has been given to the Assessor on 13/08/2015 i.e. after the day of Assessment at the Visakhapatnam airport, which has not been accepted by the Assessor.

10. OPD and IPD data of 3 years differ in tables on page 2 and 24.

6. There were only 2 Minor operations on day of assessment. Weekly average of Minor operations is only 6 implying daily average of 1 which is inadequate.
7. Services like Joint replacement, Arthroplasty, Arthroscopy are not available.
8. Investigative facilities like Nerve Conduction, EMG are not available.
9. Office space for faculty other than Professor is not available.
10. Each O.T. has 2 Tables, which is not permissible.
11. Other deficiencies as pointed out in the Assessment Report.

51. **Increase of seats in MS (General Surgery) course at Kakatiya Medical College, Warangal under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (17/08/2015) on the physical and other teaching facilities available at Kakatiya Medical College, Warangal under Dr. NTR University of Health Sciences, Vijayawada for Increase of seats in MS (General Surgery) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (17/08/2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in MS (General Surgery) course at Kakatiya Medical College, Warangal under Dr. NTR University of Health Sciences, Vijayawada u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. Bed occupancy was 86 Males + 35 Females = 121 out of 198 – i.e. 61% on day of assessment.
2. Only 198 dedicated teaching beds are available for the department which is inadequate against requirement of 210 beds for 7 Units. Distance between 2 beds is < 1.5 m. Additional 30 beds of Infectious Diseases ward were claimed under General Surgery department but were not shown to assessor.
3. Distribution of these 198 beds is highly skewed towards males – 141 beds are for males (71%) while only 57 (29%) are for females.
4. Unit III has only 2 faculty; hence it cannot be considered as PG Unit.
5. Specialty clinics like Surgical Gastroenterology clinic, Surgical Oncology clinic are not run.
6. In OPD, patient Examination room is temporary structure, Dressing Room is small, minor Procedure Room is not available.
7. Space for faculty rooms was not shown to assessor.
8. O.T. register was not shown in spite of repeated requests.
9. Details of experience of Senior Residents is not shown in the faculty table.
10. There are no publications from the department in indexed journals in last 3 years.
11. Details of Academic activities were not provided in spite of repeated requests.
12. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee also observed that the existing facilities (faculty, infrastructure, clinical material) are not sufficient even for 10 already existing seats. Some of the observations of the Assessors are reproduced below:-

- (a) In the OPD section of the Department, patient examination room is temporary structure, Dressing Room is inadequate in space, minor procedure room is absent. Out patient department surgical patient records/register were requested but not available.
- (b) In the department the 2nd/3rd/4th Professor room were not shown, Associate Professor rooms insufficient and inadequate, Departmental library books/journal were not as per MCI rules, in number and type.
- (c) Details of Clinical teaching program, journal reading activities, Clinicopathological meetings, surgical resident log book, recent papers/publication/ poster, college council meetings details were not available on request.

The Committee further decided that the Dean may be asked to submit the comments before any further action is taken in the matter.

3. Spectrum of cases is narrow for training of PG students.
4. Wards are ill organized for a clean working atmosphere to train PGs.
5. Teaching facilities are not available in OPD. There is too much congestion.
6. PG students are not posted to handle newborn resuscitation in maternity hospitals where Paediatrics faculty are working and posted.
7. No Child Psychiatry services or Clinical psychologist is available.
8. Details of experience of several Senior Residents are not shown in the faculty table.
9. Academic parameters like Theory Classes (12/year), Clinical Seminars (12/year), Journal Clubs (12/year), Group Discussions (12/year) are inadequate.
10. Other deficiencies as pointed out in the Assessment Report.

9. There is no service laboratory for Clinical pathology. All the samples are sent to corporate laboratory.
10. Histopathology samples are 98 in 115 days implying daily average of < 1.
11. No instruments of modern technology are available in the department.
12. SAF was given only at 07: 15 p.m. and was incomplete in many aspects as detailed in the report.
13. It is not clear whether Teachers & PGs would be permitted in corporate laboratory for training.
14. Cytopathology workload is NIL on day of assessment.
15. Pathological post-mortems are not performed.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (25<sup>th</sup> August 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in MS(Orthopaedics) course at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. On the day of inspection, total surgeries: 20 (Major 6 & Minor 14).
2. However, report of Anaesthesia department (just next day) is reproduced below:
  1. *"There were only 5 Major operations & 1 Caesarean Sections – i.e. Total 6 - on day of assessment till 03:30 p.m. which is grossly inadequate.*
  2. *Record of operations performed in 2014 was not made available to assessor for verification; hence data of operations could not be verified.*
  3. *Although there were only 5 Major operations on day of assessment, Histopathology workload is shown as 16 which is not feasible. There is data mismatch.*
  4. *Birth register was not made available to assessor for verification.*
  5. *Clinical material is inadequate. Most of the patients listed for operation on 26/08/2015 were neither admitted in the wards nor proper investigation reports were available with Bed head Ticket. Many cases were found admitted on private clinic prescription of consultants of Surgical departments without proper admission.*
  6. *Number of patients admitted in ICUs were very few.*
  7. *Only 3 Senior Residents are shown in faculty table; out of them 2 do not possess required experience of 3 y as Resident in the department in a medical college.*
  8. *Resultantly, there is deficiency of Senior Resident: 3.*
  9. *Daily average of Major operations is only 10 which is inadequate."*

It is evident that surgical workload is grossly inadequate and college authorities did not provide many information sought by the Assessor. This is also confirmed by the fact that there were only 3 deaths in the department during last year out of 4203 patients admitted (0.07%). In a department like Orthopaedics, which deals with Trauma, such low death rate indicate that no serious orthopaedics emergencies are admitted without which, the training of PG students will be inadequate. 2-3 units of blood used daily also support the above contention.

3. The college authorities have not provided details of PG students admitted during last 5 years.

4. The Institution was granted two seats last year and with above observations there is no justification for any further increase.
5. Nitin Saudhy, Senior Resident with DNB qualification is not eligible. He has no 3 years experience at the time of appointment.
6. One Asst. Professor and one Senior Resident joined only few days prior to inspection. It seems they are collected for assessment only.
7. Other deficiencies as pointed out in the Assessment Report.

5. Other deficiencies as pointed out in the Assessment Report.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (25th August 2015) and decided to recommend to the Central Govt. to disapprove the scheme for Increase of seats in MS(OBG) course at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. Operative workload of Major operations was only 2 on day of assessment.
2. As per the report of the Anaesthesia department, there were only 5 Major operations & 1 Caesarean Sections – i.e. Total 6 - on day of assessment till 03:30 p.m. which is grossly inadequate.
3. There are only 2 publications from the department in indexed journals in last 3 years. There has been no publication for last 2 ½ years.
4. Designation of Dr. Zohra Abbas is not clear. In the faculty table on P. 21, she has been shown as Asst. Prof.; however it is not clear whether she is Asst. Prof. or Antenatal Medical officer or Senior Resident.
5. Academic parameter like Group Discussion (18/year) is inadequate.
6. Other deficiencies as pointed out in the Assessment Report.

**148. Increase of seats in MD(Paediatrics) course at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

The Postgraduate Medical Education Committee considered the Assessment Report (25th August 2015) and decided to recommend to the Central Govt. to issue Letter of Permission for Increase of seats in MD(Paediatrics) course at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur u/s 10A of the I.M.C. Act, 1956 prospectively i.e. from the academic session 2016-2017 from 3(Three) to 6(Six) students per year till the first batch admitted against the increased number appears in the final examination of the said course. The Teaching Institution be advised to apply for recognition of the qualification for the additional increased intake at the time of first available examination as per the provision of Section 11(2) of the IMC Act, 1956.

**149. Starting of MS(General Sugery) course at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.**

Read: the Council Assessor's Report (25th August 2015) on the physical and other teaching facilities available at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur for Starting of MS(General Sugery) course u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (25th August 2015) and decided to recommend to the Central Govt. to disapprove the scheme for starting of MS(General Surgery) course at Geetanjali Medical College & Hospital, Udaipur, Rajasthan under Geetanjali University, Udaipur u/s 10A of the IMC Act, 1956 for the academic year 2016-17, because of the following facts:-

1. On the day of assessment, total surgeries: 53 (Major 20; Minor 31 & Day care 2)
2. However, report of Anaesthesia department (just next day) is reproduced below:
  1. *"There were only 5 Major operations & 1 Caesarean Sections – i.e. Total 6 - on day of assessment till 03:30 p.m. which is grossly inadequate.*
  2. *Record of operations performed in 2014 was not made available to assessor for verification; hence data of operations could not be verified.*
  3. *Although there were only 5 Major operations on day of assessment, Histopathology workload is shown as 16 which is not feasible. There is data mismatch.*
  4. *Birth register was not made available to assessor for verification.*
  5. *Clinical material is inadequate. Most of the patients listed for operation on 26/08/2015 were neither admitted in the wards nor proper investigation reports were available with Bed head Ticket. Many cases were found admitted on private clinic prescription of consultants of Surgical departments without proper admission.*
  6. *Number of patients admitted in ICUs were very few.*
  7. *Only 3 Senior Residents are shown in faculty table; out of them 2 do not possess required experience of 3 y as Resident in the department in a medical college.*
  8. *Resultantly, there is deficiency of Senior Resident: 3.*
  9. *Daily average of Major operations is only 10 which is inadequate."*

It is evident that surgical workload is grossly inadequate and college authorities did not provide many information sought by the Assessor.

3. Number of emergency admissions are less (5 per day through casualty) which means number of serious surgical emergencies is inadequate without which training of P.G. students will be inadequate. This is also confirmed by 0.8% death rate of last year, in the department.
4. Dr. Ashutosh Soni, Ex. Professor of Plastic Surgery, it is unexpected that he will work as Asst. Professor in General Surgery.
5. Dr. Udai Bhaumik, Asst. Professor worked as Asst. Professor of Neurology at Kota. He cannot be Asst. Professor in Surgery.
6. Joining details of Dr. Narsee Ram Dewasi, Asst. Professor has not been provided.
7. 4 out of 6 Senior Residents joined only 6 days, 6 days, 14 days and 1 month prior to assessment. It seems they have been collected for assessment. Most of the Senior Residents had provisional registration, which cannot be accepted. Hence, they are not eligible. Provisional registration is only acceptable during internship.
8. Other deficiencies as pointed out in the Assessment Report.

1. There were only 5 Major operations & 1 Caesarean Sections – i.e. Total 6 - on day of assessment till 03:30 p.m. which is grossly inadequate.

3. Although there were only 5 Major operations on day of assessment, Histopathology workload is shown as 16 which is not feasible. There is data mismatch.

5. Histopathological workload on day of assessment was NIL. Average Histopathological workload is only 3/day which is inadequate. (P. 2)
6. Only 2 Asst. Prof. & 2 Tutors were present when assessment started. Remaining faculty arrived after 2 p.m.
7. Pathological post-mortems are not performed.
8. Surgical Pathology services, Frozen Section, Histochemistry, Immunohistochemistry are not available.
9. Bone Marrow Biopsy workload is NIL.
10. Other deficiencies as pointed out in the Assessment Report.
