The Chairman welcomed the members of the Postgraduate Medical Education Committee.

**1. Minutes of the last meeting of the Postgraduate Medical Education Committee – confirmation of.**

The minutes of the Postgraduate Medical Education Committee meeting held on 28/08/2015 were confirmed in the meeting itself.

**2. Minutes of the last meeting of the Postgraduate Medical Education Committee – action taken thereon.**

The Postgraduate Medical Education Committee noted & approved the action taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

**3. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Paediatrics) qualification against increased intake from 02 to 03 seats in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification against increased intake from 02 to 03 seats at A. J. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Paediatrics) qualification against increased intake from 02 to 03 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore because of the following facts:-

1. Data of clinical material on day of assessment as well as on randomly selected days are not provided.
2. Knowledge of students is less than average.
3. Data of beds occupied in NICU/PICU on day of assessment are not provided.
4. 3 out of 4 Publications cited are in non-indexed journals (one is in Journal of Evolution of Medical and Dental Sciences)
5. IPD yearly: 21875, which means 73 admissions per day against 90 beds, which is not feasible or non-genuine patients admitted, which are discharged (80%) on same day.
6. 213000 IPD of entire Hospital in 1 year means 710 admissions per day, which is not feasible.
7. Promotion of Dr. Prasad Nayak, Assoc. Professor, Unit-I is not as per Regulations. He has been Asst. Professor for 4 years 1 month against the requirement of 5 years. Out of 4 publications cited 3 are in non-indexed Journal (one is in Institutional Journal, 2 in Karnataka Paediatrics Journal). Consequently, there is no Assoc. Professor in Unit-I.
8. Promotion of Dr. Amitha Rao Aroor, Professor is irregular. She has been Asst. Professor for 3 years 1 month. Consequently, there are 2 faculty in Unit-II.
9. Dr. B.S. Chandrasekhar, Senior Resident not eligible. He has DNB qualification without 3 years experience at the time of appointment.
10. Dr. Jaishree Hegde, Senior Resident is not eligible. She has DNB qualification without 3 years experience at the time of appointment. Consequently, there are no Senior Residents in Unit-III.
11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 3 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely,

prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**4. Rajiv Gandhi University of Health Sciences, Bangalore - Renewal of recognition of MS(OBG) qualification for 01 seat in respect of students being trained at Al-Ameen Medical College, Bijapur.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MS(OBG) qualification for 01 seat at Al-Ameen Medical College, Bijapur granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that recognition of MS(OBG) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Al-Ameen Medical College, Bijapur be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**5. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MS(Ophthalmology) qualification against increased intake from 02 to 04 seats and renewal of recognition of MS(Ophthalmology) and DO qualifications for 01 seat each in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MS(Ophthalmology) qualification against increased intake from 02 to 04 seats and renewal of recognition of MS(Ophthalmology) and DO qualifications for 01 seat each at Alluri Sitarama Raju Academy of Medical Sciences, Eluru granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MS(Ophthalmology) qualification against increased intake from 02 to 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee also decided to recommend to the Central Government that recognition of MS(Ophthalmology) and DO qualifications for 01 seat each granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition.

Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**6. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MS(ENT) qualification against increased intake from 01 to 02 seats and Renewal of recognition of MS(ENT) & DLO qualifications for 01 seat each in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MS(ENT) qualification against increased intake from 01 to 02 seats and Renewal of recognition of MS(ENT) & DLO qualifications for 01 seat each at Alluri Sitarama Raju Academy of Medical Sciences, Eluru granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MS(ENT) qualification against increased intake from 01 to 02 seats and not to renew the recognition of MS(ENT) & DLO qualifications for 01 seat each granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru because of the following facts:-

1. BERA workload is only 2-3 / week.
2. Speech Therapy workload is < 1/ day.
3. Workload of Laryngectomy is NIL in last 3 years & that of Laryngo/Tracheoplasty is only 09/year & Maxillectomy is 06/year.
4. Academic parameters like Theory Classes are shown at 212/year & Case presentations are shown as 182/year which appear to be not feasible.
5. The department does not participate in National Programme for Prevention & Control of Deafness.
6. There are only 2 faculty in Unit II; hence it cannot be considered as PG Unit.
7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these number of seats i.e. against increased intake from 1 to 2 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

Admissions done (if any) against these seats i.e. 1 seat each for degree and diploma till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*“...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course”*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**7. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Renewal of recognition of MD(Paediatrics) qualification for 02 seats in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MD(Paediatrics) qualification for 02 seats at Alluri Sitarama Raju Academy of Medical Sciences, Eluru granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that recognition of MD(Paediatrics) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Alluri Sitarama Raju Academy of Medical Sciences, Eluru be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**8. Delhi University, Delhi - Recognition of MS(OBG) qualification for 02 seats in respect of students being trained at Army Hospital Research & Referral, New Delhi.**

Read: the Council Assessor's Report (April, 2015) on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification for 02 seats at Army Hospital Research & Referral, New Delhi granted by Delhi University, Delhi.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MS(OBG) qualification for 02 seats granted by Delhi University, Delhi in respect of students being trained at Army Hospital Research & Referral, New Delhi because of the following facts:-

1. Shortage of Resident: (a) Senior Resident: 1; (b) Junior Resident: 1.
2. Total number of patients in OPD has decreased from 91, 279 in 2012 to 89, 858 in 2014.
3. Total number of Minor operations has decreased from 1, 935 in 2012 to 1, 902 in 2014.

4. Workload of Operative Vaginal Deliveries is only 43/year which is inadequate. There was NIL Operative Vaginal delivery on day of assessment as well as on randomly selected days.
5. Academic parameters like Theory Classes (18/year), Clinical Seminars (19/year), Journal Clubs (10 in no.), Group Discussions (12/year) are inadequate.
6. There were 300 to 400 deliveries in a year, which means 1 per day, which is grossly inadequate. Average daily deliveries quoted in report are 3, which does not match with the above yearly data.
7. Professor & Head, Brig. Surender Mohan passed M.S. in 1998. He could not be considered Asst. Professor from 1986. His period after qualifying date is 2 year 6 months as Asst. Professor against the requirement of 5 years. Thus, his promotion is not as per Regulations and he cannot be considered as Professor & Head.
8. The year of passing of all other Faculty members has not been mentioned in the Faculty Table, without which, their eligibility to the designation they are holding cannot be decided.
9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. **9. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Paediatrics) qualification for 01 seat in respect of students being trained at Belgaum Institute of Medical Sciences, Belgaum.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Paediatrics) qualification for 01 seat at Belgaum Institute of Medical Sciences, Belgaum granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Paediatrics) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Belgaum Institute of Medical Sciences, Belgaum because of the following facts:-

1. Deficiency of faculty: (a) Asso. Prof.: 1; (b) Asstt. Prof. : 1.
2. Shortage of Residents: (a) Senior Resident: 2; (b) Junior Resident: 2.

3. Unit A does not have any Asso. Prof. There are only 2 faculty in the Unit; hence it cannot be considered as PG Unit.
4. Unit B has only 2 faculty; hence it cannot be considered as PG Unit.
5. Resultantly, there is no Unit which can be considered as PG Unit.
6. Specialty clinics like Paediatric Haematology, Paediatric Nephrology & Paediatric Nephrology are not run.
7. Asthma & Thalassemia clinics are not available.
8. Paediatric Ventilator is not available.
9. Services like Dialysis, Parenteral Nutrition are not provided.
10. Paediatric Bronchoscopy, PFT are not available.
11. No new books have been added to Departmental Library in last 3 years.
12. CPC is not held.
13. Equipment like Upper GI Endoscope, ECHO, ECG, Crash Cart, USG, Defibrillator are not available.
14. Academic parameters like Case presentation (17/year), Group Discussion (10 in no.) is inadequate.
15. There is only 1 research publication from the department in indexed journals in last 3 years. Even this publication deals with knowledge & practice of menstruation in adolescent girls and does not deal with any Paediatric problem as such.
16. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 01 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Pharmacology) qualification for 02 seats at Belgaum Institute of Medical Sciences, Belgaum granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Pharmacology) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Belgaum Institute of Medical Sciences, Belgaum be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**11. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Renewal of recognition of MS(General Surgery) qualification for 04 seats in respect of students being trained at Deccan College of Medical Sciences, Hyderabad.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery) qualification for 04 seats at Deccan College of Medical Sciences, Hyderabad granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that recognition of MS(General Surgery) qualification for 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Deccan College of Medical Sciences, Hyderabad be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**Note:** The College Authorities be directed to pay Stipend at Government rates to students admitted during previous 2 years, who are working as 2<sup>nd</sup> and 3<sup>rd</sup> year Residents at present. Action taken shall be intimated to the Council.

**12. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Physiology) qualification for 02 seats in respect of students being trained at Dr. Pinnammaneni Siddhartha Institute of Medical Sciences & Research Foundation, Chinnaoutpalli.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification for 02 seats at Dr. Pinnammaneni Siddhartha Institute of Medical Sciences & Research Foundation, Chinnaoutpalli granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Physiology) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Dr. Pinnammaneni Siddhartha Institute of Medical Sciences & Research Foundation, Chinnaoutpalli be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.



**13. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Anaesthesiology) qualification against increased intake from 03 to 05 seats in respect of students being trained at Dr. Pinnammaneni Siddhartha Institute of Medical Sciences & Research Foundation, Chinnaoutpalli.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification against increased intake from 03 to 05 seats at Dr. Pinnammaneni Siddhartha Institute of Medical Sciences & Research Foundation, Chinnaoutpalli granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 03 to 05 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Dr. Pinnammaneni Siddhartha Institute of Medical Sciences & Research Foundation, Chinnaoutpalli be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

2. Other medico-legal work like examination of sexual assault victims & accused, etc. is not done by the faculty & PG students of the department.
3. Open Mortuary with fly proofing arrangement is not available.
4. Academic parameters like Journal Clubs (06 in no.) is inadequate.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 03 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. 3. Average daily OPD is 111, which is just adequate to start PG course and the Institution is asking for recognition of 8 seats. 111 OPD for a department admitting 8 PG students is inadequate.
4. Academic parameter like Group Discussions (16/year) is inadequate.
5. Promotion of Dr. Rajesh S.M., Assoc. Professor, Unit-A is not as per Regulations. He has been Asst. Professor for 4 years 6 months against the requirement of 5 years without any publication.
6. Promotion of Dr. Ravi Kiran, Assoc. Professor, Unit-B is not as per Regulations. He has been Asst. Professor for 4 years against the requirement of 5 years.
7. Promotion of Dr. Sowmin P. Kamath, Assoc. Professor, Unit-C is not as per Regulations. He has been Asst. Professor for 4 years against the requirement of 5 years.

8. Promotion of Dr. Sushetha S. Rao, Assoc. Professor, Unit-I is not as per Regulations. He has been Asst. Professor for 4 years against the requirement of 4 years.
9. The Institute is running DNB courses in various Super-Specialities.
10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 5 to 8 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 4. Academic parameters like Theory Classes (10 in no.), Journal Clubs (08 in no.), Group Discussions (09 in no.) are inadequate.
5. Dr. Krishna Nanda Prabhu R.V., Professor & HoD has been promoted on 01/03/2015 (after the cut-off date) without any publications, which is not as per Regulations.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 2. Total OPD on day of assessment is 2, 260 upto 3 p.m. which is inadequate as minimum OPD of 3,000 is required for a college with 250 intake.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 6 to 9 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. Admissions done (if any) against these seats i.e. 04 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. 1. As per OT register, operations like head & Neck Surgeries, Mastoidectomy, Stapedectomy, Rhinoplasty, Tumour Surgery are not routinely carried out.
2. Record keeping of special clinics like Deafness clinic, Allergy clinic is not proper as there is no mention of diagnosis against the patient.
3. Although 4 Senior Residents are shown, experience of 3 years working in the department in a teaching institution in respect of 3 of them is not shown in the faculty table.
4. Workload of BERA is only 108/day – i.e. 0.33/day which is inadequate.
5. Workload of Bronchoscopy is 7, of Laryngo\Tracheoplasty 1, Angiofibroma is NIL during the year.
6. Specialty clinic like cancer related clinic is not run.
7. Academic parameter like Group Discussion (18/year) which is inadequate.
8. There are only 3 publications. All other cited are case reports, which cannot be considered. No full references/ reprint of these publications have been provided.
9. Professor, Dr. Ravi Kumar Raju has been promoted on 10/02/2015 (after the cut-off date) without any publications. Hence, his promotion is not as per Regulations.



10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. Medical College, Bangalore because of the following facts:-

1. Clinical material is insufficient. Figures as supplied by authorities regarding patients in OPD & samples in laboratories were not observed on day of assessment. Only a few patients were seen in Paediatrics OPD, other OPDs & Radiology department. (
2. Latest editions of books are not available in Central & Departmental libraries. It is underutilized as not a single person – faculty, Residents, PG & UG students – was seen in the Central Library at the time of visit.
3. OPD attendance was 74 on day of assessment which is inadequate.
4. No full reference/ reprints of any of the publications have been provided.
5. Shortage of Senior Resident: 1. Dr. Mohd. Younus with DNB qualification is not eligible. He has no 3 years teaching experience at the time of appointment.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate

1. Average daily Histopathological workload of Histopathology + Autopsy + Immunohistochemistry combined is only 8.09 which is inadequate.
2. Stipend paid by the institute to I/II/III year Residents is only Rs. 5,000 p.m. which is inadequate & much less than that paid by the Govt. of Karnataka to I/II/III year Residents (i.e. Rs. 25,000 p.m.) and is contrary to PG Medical Education Regulations as amended from time to time.
3. Pathological post-mortems of adults are not performed.
4. Workload of Bone Marrow Biopsy is only 18/year which is inadequate.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MS(General Surgery) qualification against increased intake from 04 to 06 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Maharajah Institute of Medical Sciences, Nellimarella be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**30. Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh - Recognition of MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats in respect of students being trained at Narayana Medical College, Nellore.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats at Narayana Medical College, Nellore granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Forensic Medicine/Forensic Medicine & Toxicology) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at Narayana Medical College, Nellore because of the following facts:-

1. If there is no permission for doing post-mortem, then how the post-mortem data provided from the department can be there?
2. Deficiency of faculty: (a) Tutors: 1. (Total 709 post-mortems are done in a year; hence 2 additional Tutors are required.)
3. Workload of Examination of Sexual Assault Accused & Victims is NIL on day of assessment as well as on randomly selected days. Even during the period of last 3 years, it is NIL.
4. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

1. In the entire of Hospital, on the day of assessment there were only 4 MRI, which indicate grossly inadequate clinical material.
2. In the department of Orthopaedics, last year, there were 3 deaths out of 6575 admissions, which indicate no serious trauma patients are admitted without which the training of PG Students is grossly inadequate.
3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**33. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(General Medicine) qualification against increased intake from 04 to 08 seats in respect of students being trained at Navodaya Medical College, Raichur.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 04 to 08 seats at Navodaya Medical College, Raichur granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(General Medicine) qualification against increased intake from 04 to 08 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Navodaya Medical College, Raichur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**34. Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification against increased intake from 02 to 05 seats in respect of students being trained at Osmania Medical College, Hyderabad.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification against increased intake from 02 to 05 seats at Osmania Medical College, Hyderabad granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Social & Preventive Medicine / Community Medicine) qualification against increased intake from 02 to 05 seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at Osmania Medical College, Hyderabad because of the following facts:-

1. Deficiency of faculty: (a) Asst. Prof.: 4; (b) Lecturer in Statistics: 1; (c) Tutors: 4.
2. Qualifications of Epidemiologist and Statistician (M.Sc. Entomology and M.A.) cannot be considered. Hence, deficiency stay.
3. Dr. Shravan Kumar, Assoc. Professor has worked at 11 places as Asst. Professor in 6 years. His contribution to teaching cannot be significant.
4. Lecturer cum M.O. is not available for RHTC & UHC. Lady Medical officer is not available at UHC. Paramedical & other non-teaching staff are not available at UHC.
5. Family care study section is not available in the department.
6. Academic parameters like Journal Clubs (06 in no.), Group Discussions (08 in no.) are inadequate.
7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 5 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Pathology) qualification against increased intake from 02 to 04 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at P.E.S. Institute of Medical Sciences & Research, Kuppam be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Anaesthesia) qualification against increased intake from 02 to 06 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at P.E.S. Institute of Medical Sciences & Research, Kuppam because of the following facts:-

1. From 3 years data, average daily major operations come to 45.3. However, on the day of Assessment, there were 24 major operations. This is a data mismatch.
2. Average no. of operations both Major & Minor figure is highly inflated. On an average 15 major & 12 minor cases per day could be counted.
3. Anaesthesia records register was not maintained properly.
4. Monthly/ yearly serial numbers were missing, pages were not in order and few were left blank and missing.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 6 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek

timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(Emergency Medicine) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, Andhra Pradesh in respect of students being trained at P.E.S. Institute of Medical Sciences & Research, Kuppam because of the following facts:-

1. There are 2 Units in the department. Out of these 2 Units, 1 Unit does not have any bed in Emergency Medicine ward as all its beds are in Casualty (25 beds) & ICUs (15 beds). Second Unit has only 15 beds in Emergency Medicine ward & the rest are in HDU & ERICU. Resultantly, no Unit has full fledged 30 bedded Emergency Medicine ward.
2. Although none of the faculty is having PG qualification in General Medicine & Paediatrics, 3 beds each in MICU & NICU and 2 beds in PICU are allocated to the department of Emergency Medicine which is highly irregular.
3. There are only 2 publications from the department in indexed journals in last 3 years, which are both case reports and cannot be considered.
4. The faculty table does not specify the experience details (subject in which faculty members have experience in different ranks). No Certificate of experience from place of work has been provided.
5. No faculty has PG Degree in Emergency Medicine or 2 years special training in Emergency Medicine, without which, they cannot be considered eligible for the designations they are holding.
6. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the



concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MD(Physiology) qualification against increased intake from 2 to 4 seats granted by Pondicherry University, Puducherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry because of the following facts:-

1. Stipend paid by the institute to I/II/III year Residents is only Rs. 5,000; Rs. 6,000 & Rs. 7,000 p.m. respectively which is much less than paid by the Central Govt. institute in Pondicherry to I/II/III year residents and is contrary to PG Medical Regulations.
2. Yoga laboratory is not available.
3. Academic parameters like Journal Clubs (05 in no.), Group Discussions (12/year) are inadequate.
4. Postgraduate Degree of Dr. Sushila Veliath, Professor & HoD is not recognized.
5. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2015) and decided to recommend not to recognize MD(Anaesthesiology) qualification against increased intake from 3 to 4 seats granted by Pondicherry University, Puducherry in respect of students being trained at Pondicherry Institute of Medical Sciences, Pondicherry because of the following facts:-

1. There is NIL Senior Resident in the department.
2. Total number of Major operations has decreased from 4, 715 in 2012 to 3, 757 in 2014.
3. Total number of Minor operations has decreased from 5, 765 in 2012 to 4, 231 in 2014.
4. Consumption of Blood components like Fresh frozen, Platelets has also decreased in 3 year period from 2012 to 2014 reflecting upon the quality of Major operations.
5. Stipend paid by the institute to I/II/III year Residents is only Rs. 10,000; Rs. 11,000 & Rs. 12,000 p.m. respectively which is much less than paid by the Central Govt. institute in Pondicherry to I/II/III year residents and is contrary to PG Medical Regulations.
6. No equipment is available in RICU. No Theory Classes are held for PG students.
7. On the day of Assessment, Major Operations were 14 in the entire Hospital, which is grossly inadequate.
8. Promotion of Dr. R.V. Ranjan, Assoc. Professor is not as per Regulations. He has been Asst. Professor for 4 years against the requirement of 5 years. Consequently, faculty deficiencies: Assoc. Professor: 1; Asst. Professor: 1 and Senior Residents: 4.
9. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 3 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

3. Promotion of Dr. Savitha K.S., Asso. Prof. is not as per Regulations as she has been promoted as Asso. Prof. with experience of only 1 y 4 m as Asst. Prof. against the requirement of 5 y as per Regulations.
4. Promotion of Dr. Bindu George, Asso. Prof. is not as per Regulations as she has been promoted as Asso. Prof. with experience of only 4 y 1 m as Asst. Prof. against the requirement of 5 y as per Regulations.
5. With regard to Senior Residents, experience as Junior Resident / Resident has not been shown for any Senior Resident in the faculty table.
6. There is discrepancy in the data of clinical material of last 3 years in two tables on P. 4 & P. 25 as under:

3. There are only 33 textbooks pertaining to Pulmonary Medicine in the Central Library which are inadequate. Good reference books are also inadequate.
4. Departmental office is non-functional without a Steno/Clerk/ Computer Operator.
5. Yearly IPD 9729, which means 32 admission daily on 30 beds, which is not feasible.
6. Other deficiencies as pointed out in the Assessment Report.

**63. D.D.U. University, Gorakhpur - Renewal of recognition of MD(Anaesthesia) qualification for 3 seats & DA qualification for 1 seat in respect of students being trained at BRD Medical College, Gorakhpur.**

2. Deficiency of faculty: (a) Asst. Prof.: 2.
3. Shortage of Senior Residents: 1.
4. ICU under Anaesthesiology department is not yet functional.
5. Details of beds occupied in ICU & Post-operative area on day of assessment are not provided.
6. There are NIL publications from the department in indexed journals in last 3 years.
7. Academic parameter like Group Discussion (10 in no.) is inadequate.
8. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 03 seats for degree and 1 seat for diploma till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. 2. There are only 3 portable X-ray machines against requirement of 4 as per Regulations.
3. Workload of MRI is <10/day which is inadequate.
4. There are NIL Senior Residents.
5. Workload of USG guided FNAC/Aspiration & DSA is NIL during the period of last 3 years.
6. Workload of investigations like Ultrasound, Ba & IVP, Mammogram, CT & US guided FNAC, DSA on day of assessment is not provided.
7. DSA is not available.
8. AERB approval is not available for all the machines.
9. Departmental Library facilities are inadequate. There are only 20 books.
10. Space for the faculty & departmental office is inadequate.
11. Details of Academic parameters like Group Discussions, Guest Lectures are not provided.
12. Other deficiencies as pointed out in the Assessment Report.

Several instruments like Nessler Comparator, Fotin Barometer, Fat Extraction Apparatus, Pasteur Filter, Berkfeld Filter, Hydrometers, Electric Incubator, Museum Jars, Clinical Centrifuge, baby Weighing Machine, Callipers, Still for Distilled Water, Autoclave, Electric Sterilizer are not available.
2. Library facilities – both Central & Departmental - are inadequate. No journal pertaining to Community Medicine is available.
3. Dr. Lucy Raphael, Professor cannot be considered as a teacher of this institute because the date of relieving order from Govt. Medical College, Kozhikode is w.e.f. 29/06/2015 A.N. while the date of joining t this institute is shown as 29/06/2015 F.N. which is not feasible. There is no Form 16 submitted.
4. Ms. Rejani P.P., Lecturer in Statistics cannot be considered as there is no joining order in this department. At present she is working in Department of Psychiatry.
5. UHC: Family cards are not maintained. FP registers are not available. Health Educator, Social Worker are not available. Activities under National Health Programmes are not adequate. There are no Specialists' visits. Space for various functions is not adequate.
6. RHTC: Lady Medical officer is absent on day of assessment. Family cards are not maintained. FP registers are not available. Health Educator, Social Worker are not available. Activities under National Health Programmes are not adequate. Deliveries are not conducted. There are no Specialists' visits. Space for various functions is not adequate.
7. There is no separate hostel for PGs & Interns.

8. Deficiency of faculty: (a) Assoc. Prof.: 1; (b) Asst. Professor: 03; (c) lecturer in Statistics: 1; (d) Tutor: 1.
9. Academic parameters like Journal Clubs (06 in no.), Group Discussions (10 in no.) are inadequate.
10. Other deficiencies as pointed out in the Assessment Report.

Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**82. Krishna Institute of Medical Sciences University(Deemed), karad - Renewal of recognition of MS(OBG) qualification against increased intake from 1 to 2 seats and Recognition against increased intake from 6 to 7 seats in respect of students being trained at Krishna Institute of Medical Sciences, Karad.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MS(OBG) qualification against increased intake from 1 to 2 seats and Recognition against increased intake from 6 to 7 seats at Krishna Institute of Medical Sciences, Karad granted by Krishna Institute of Medical Sciences University(Deemed), karad.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to renew the recognition of MS(OBG) qualification against increased intake from 1 to 2 seats and not to recognize against increased intake from 6 to 7 seats granted by Krishna Institute of Medical Sciences University(Deemed), Karad in respect of students being trained at Krishna Institute of Medical Sciences, Karad because of the following facts:-

1. Total number of Major operations has decreased from 997 in 2012 to 841 in 2014.
2. Total number of deliveries has decreased from 3, 055 in 2012 to 2, 892 in 2014.
3. Shortage of Senior Residents: 1.
4. PG degree of Dr. R.P. Patange, Professor & HOD is not recognized.
5. Data of number of Normal Deliveries/Caesarean Sections & Bed Occupancy on selected random days are not provided.
6. Data of beds occupied in HDU, NICU on day of assessment are not provided.
7. Academic parameters like Theory Classes (12/year), Clinical Seminars (13/year), Group Discussions (06 in no.) are inadequate.
8. From average of 3 years data there were 3 major operations per day, which is inadequate.
9. On the day of Assessment, there were 11 CT Scan in the entire hospital, which indicates inadequate clinical material.
10. There is no designation like Registrar/ Lecturer / Resident, which the college authorities have shown in faculty table.
11. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 1 to 2 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course"*

As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**Note:** College should apply for recognition of the remaining 3 seats when the students admitted in 2013 appear in final examination.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend to the Central Government that MD (Physiology) qualification for 3 seats granted by Geetanjali University, Udaipur, Rajasthan in respect of students being trained at Geetanjali Medical College & Hospital, Udaipur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**85. Maharashtra University of Health Sciences, Nashik - Renewal of recognition of MS(General Surgery) qualification for 4 seats in respect of students being trained at N.K.P. Salve Institute of Medical Sciences, Nagpur.**

Read: the Council Assessor's Report (June, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery)

qualification for 4 seats at N.K.P. Salve Institute of Medical Sciences, Nagpur granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2015) and decided to recommend not to renew the recognition of MS(General Surgery) qualification for 4 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at N.K.P. Salve Institute of Medical Sciences, Nagpur because of the following facts:-

1. No Senior Resident eligible in Unit-I because they have no 3 years experience at the time of Appointment.
2. PG students do not have any posting in Superspeciality departments during the period of their training.
3. Distance between 2 beds is less than prescribed under the Regulations.
4. There is no isolation of septic cases.
5. OPD registers are not maintained by faculty or Residents.
6. On cross verification, it was observed that minor operations purportedly performed in Minor O.T. near OPD were falsely entered in Minor O.T. register.
7. More than 90 % of beds in Casualty were vacant at 2:30 p.m. on day of assessment.
8. Admissions of emergency Surgical cases & also emergency Surgeries were less.
9. OPD upto 2:30 p.m. on day of assessment was only 65 which is inadequate.
10. Specialty clinic like Surgical Gastroenterology clinic is not run.
11. Academic parameter like Group Discussion (13/year) is inadequate.
12. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 04 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**87. Padamshree Dr. D.Y. Patil University, Navi Mumbai - Renewal of recognition of MD(General Medicine) qualification for 6 seats and Recognition against increased intake from 6 to 15 seats in respect of students being trained at Padamshree Dr. D.Y. Patil Medical College, Navi Mumbai.**

Read: the Council Assessor's Report (June, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MD(General Medicine) qualification for 6 seats and Recognition against increased intake from 6 to 15 seats at Padamshree Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padamshree Dr. D.Y. Patil Medical College, Navi Mumbai because of the following facts:-

1. Total number of patients in OPD has decreased from 2, 05, 200 in 2012 to 1, 87, 759 in 2014.
2. Total number of patients in IPD has decreased by 39 % from 13, 967 in 2012 to 8, 538 in 2014.
3. Institute has stated that stipend paid by Govt. of Maharashtra to I/II/III year Residents is Rs. 20,000; Rs. 23,000 & Rs. 26,000 p.m. respectively which is wrong. It has also tried to show that by paying the same stipend, it is paying stipend at the same rate as that of Govt. of Maharashtra which is not only wrong but also amounts to fraud.
4. Specialty clinics like Gastroenterology clinic, Neurology clinic are not run.
5. No print journals are available in Departmental Library.
6. Academic parameters like Clinical Seminars (10 in no.), Group Discussions (10 in no.) are inadequate.
7. Dr. Prashant Purkar, Asso. Prof. in Unit VI, has been promoted as Asso. Prof. with experience of only 2 y 10 m as Asst. prof. against requirement of 5 y as per Regulations; he cannot be accepted as faculty. Resultantly there only 2 faculty in Unit VI and it cannot be considered as PG Unit.
8. Publications quoted 27 but no full reference/ reprint of any of the publication have been provided.
9. Faculty details of Unit-I has not been provided in the SAF.
10. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 6 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations

(notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course"*

Admissions done (if any) against these number of seats i.e. increased intake from 6 to 15 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**88. Maharashtra University of Health Sciences, Nashik - Recognition of MD(Community Medicine) qualification for 2 seats in respect of students being trained at Padmashri Dr. Vithalrao Vikhe Patil Foundations Medical College, Ahmednagar.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification for 2 seats at Padmashri Dr. Vithalrao Vikhe Patil Foundations Medical College, Ahmednagar granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Community Medicine) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Padmashri Dr. Vithalrao Vikhe Patil Foundations Medical College, Ahmednagar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**89. MJP Rohilkhand University - Recognition of MD(Pathology) qualification against increased intake from 2 to 6 seats in respect of students being trained at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification against increased intake from 2 to 6 seats at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly granted by MJP Rohilkhand University.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Pathology) qualification against increased intake from 2 to 6 seats granted by MJP Rohilkhand University in respect of students being trained at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**90. MJP Rohilkhand University - Recognition of MD(Radiotherapy) qualification for 4 seats in respect of students being trained at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Radiotherapy) qualification for 4 seats at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly granted by MJP Rohilkhand University.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Radiotherapy) qualification for 4 seats granted by MJP Rohilkhand University in respect of students being trained at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**91. MJP Rohilkhand University - Recognition of MD(Physiology) qualification against increased intake from 01 to 04 seats in respect of students being trained at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification against increased intake from 01 to 04 seats at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly granted by MJP Rohilkhand University.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MD(Physiology) qualification against increased intake from 01 to 04 seats granted by MJP Rohilkhand University in respect of students being trained at Shri Ram Murti

Smarak Instt. of Medical Sciences, Bareilly be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**92. Srimanta Shankardeva University of Health Sciences - Recognition of MS(ENT) qualification against increased intake from 02 to 03 seats in respect of students being trained at Silchar Medical College, Silchar.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MS(ENT) qualification against increased intake from 02 to 03 seats at Silchar Medical College, Silchar granted by Srimanta Shankardeva University of Health Sciences.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend to the Central Government that MS(ENT) qualification against increased intake from 02 to 03 seats granted by Srimanta Shankardeva University of Health Sciences in respect of students being trained at Silchar Medical College, Silchar be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**93. Srimanta Shankardeva University of Health Sciences - Recognition of MD(General Medicine) qualification against increased intake from 04 to 07 seats in respect of students being trained at Silchar Medical College, Silchar.**

Read: the Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification against increased intake from 04 to 07 seats at Silchar Medical College, Silchar granted by Srimanta Shankardeva University of Health Sciences.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and decided to recommend not to recognize MD(General Medicine) qualification against increased intake from 04 to 07 seats granted by Srimanta Shankardeva University of Health Sciences in respect of students being trained at Silchar Medical College, Silchar because of the following facts:-

1. Total number of patients has decreased from 80, 493 in 2012 to 79, 935 in 2014.
2. Total number of patients in IPD has decreased from 11, 503 in 2012 to 10, 874 in 2014.
3. Two faculty & 6 Senior Residents have been shown at other medical colleges during assessments conducted by MCI after 01/03/2014. Resultantly, there is shortage of Senior Residents: 5.
4. ICCU has only 3 beds.
5. Services like Endoscopy, Dialysis, Bronchoscopy, Investigative facilities like Nerve Conduction, EMG are not provided by the department.



6. Academic parameters like Clinical Seminars (20/year), Group Discussions (12/year) are inadequate.
7. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 7 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**95. Srimanta Shankardeva University of Health Sciences - Recognition of MS(Orthopaedics) qualification against increased intake from 02 to 04 seats in respect of students being trained at Silchar Medical College, Silchar.**
