**21. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Community Medicine) qualification in respect of students being trained at Mandya Institute of Medical Sciences, Mandya.**

Read: the Council Assessor's Report (May, 2014), Compliance dated 01/09/2014 submitted by the College Authorities and representation dated 27/01/2015 on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification at Mandya Institute of Medical Sciences, Mandya granted by Rajiv Gandhi University of Health Sciences, Bangalore.

**22. King George's Medical University, U.P. Lucknow (Deemed University) - Recognition of M.Ch(Surgical Gastroenterology/G.I. Surgery) qualification in respect of students being trained at King George's Medical University, U.P. Lucknow.**

Read: the Council Assessor's Report (July, 2014) and Compliance dated 05/11/2014 submitted by the College Authorities on the standard of examination and other teaching facilities for Recognition of M.Ch(Surgical Gastroenterology/G.I. Surgery) qualification at King George's Medical University, U.P. Lucknow granted by King George's Medical University, U.P. Lucknow (Deemed University).

The Postgraduate Medical Education Committee considered the Council Assessor's Report (July, 2014) and Compliance dated 05/11/2014 submitted by the College Authorities and decided to recommend not to recognize M.Ch(Surgical Gastroenterology/G.I. Surgery) qualification granted by King George's Medical University, U.P. Lucknow (Deemed University) in respect of students being trained at King George's Medical University, U.P. Lucknow because of the following facts:-

1. Clause 11(1)(b) of PG Regulations quoted by the Institute Authorities that out of the 3 Faculty in the department atleast 2 of them should hold degree of DM/ M.Ch. in the concerned discipline. The above rule has been amended on 20/10/2008 and the last line has been deleted. The amended regulation is reproduced below:

*"(b) In a Department, training candidates for Super Speciality, there shall be a minimum of three faculty members with requisite Post Graduate qualification and experience, one shall be Professor, One Associate Professor/ Reader and one Assistant Professor/ Lecturer"*

Hence, deficiency of 1 Faculty stays as such.

2. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or

compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. 1. Postgraduate Degree of Dr. C. Shridhar, is not recognized. In the Faculty Table of SAF signed by the Dean and Assessor it is shown that Dr. C. Shridhar passed M.D. from Kasturba Medical College, Mangalore, which is not recognized. Now, in compliance, it has been said that he passed from Kasturba Medical College, Manipal but no documentary proof has been attached.
2. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. 3. If Unit in Vishwanathan Chest Hospital is the Unit earmarked for DM, then how Dr. Ashok Kumar Shah (who is not in this Unit) was second internal examiner.
4. Dr. S.N. Gaur, who is Head of this Unit, is MD, Ph.D. in Medicine and not eligible, since, he has no DM Degree.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and Compliance dated 22/10/2014 submitted by the College Authorities and decided to recommend not to recognize MD(Radio Diagnosis) qualification against increased intake from 2 to 5 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Command Hospital Air Force, Bangalore because of the following facts:-

1. In case of Dr. H. Sahni, retrospective change in designation (Asst. Professor to Senior Resident) is not allowed.
2. No Certificate from competent Authority about place of posting and period for which the Officers have worked as Graded Specialist, Classified Specialist and Advisor has been provided.
3. Deficiency remains as such.
4. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**80. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(DVL) qualification against increased intake from 04 to 05 seats in respect of students being trained at Bangalore Medical College and Research Institute, Bangalore.**

Read: the Council Assessor's Report (May, 2014) and Compliance dated 07/10/2014 submitted by the College Authorities on the standard of examination and other teaching facilities for Recognition of MD(DVL) qualification against increased intake from 04 to 05 seats at Bangalore Medical College and Research Institute, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and Compliance dated 07/10/2014 submitted by the College Authorities and decided to recommend not to recognize MD(DVL) qualification against increased intake from 04 to 05 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Bangalore Medical College and Research Institute, Bangalore because of the following facts:-

1. Unit I has no Asso. Prof. Resultantly it cannot be considered as PG Unit. Deficiency remains as it is as the deficit which was originally in Unit II has been transferred to Unit I. If Dr. Leelawati is promoted as Professor and shifted to Unit-II, then there is no Assoc. Professor in Unit-I and Unit-I cannot be considered as a PG Unit.
2. Other deficiencies as pointed out in the Assessment Report.

The seats were permitted in 2010 and still not recognized.

In view of the above, the Postgraduate Medical Education Committee is of the considered opinion that the failure on the part of your Institution to timely rectify the deficiencies show that the standard of Postgraduate medical education is not maintained in your Institute and therefore, you are called upon to submit the reply as to why directions for stoppage of admissions in Postgraduate Courses (DVL) be not issued from academic year 2015-2016.

The reply to this Show-Cause must reach to the office of the Council within a period of 15 days from the issue of the Notice failing which the Council may decide the matter on the basis of available material.

1. Postgraduate Degrees of Dr. B. Praveen, Professor and Dr. H.D. Fernandes, Assoc. Professor are not recognized.
2. Earlier deficiencies remains as such.
3. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats.
