**1. Minutes of the last meeting of the Postgraduate Medical Education Committee – confirmation of.**

The minutes of the Postgraduate Medical Education Committee meeting held on 27/05/2015 were read out and confirmed in the meeting itself.

**2. Minutes of the last meeting of the Postgraduate Medical Education Committee – action taken thereon.**

The Postgraduate Medical Education Committee noted that the action is being taken on the minutes of the previous meeting of the Postgraduate Medical Education Committee.

**3. University of Delhi, Delhi - Recognition of DM(Pulmonary Medicine) qualification for 02 seats in respect of students being trained at VP Chest Institute of Medical Sciences, Delhi.**

Read: the Council Assessor's Report (July, 2014) and compliance dated 27/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of DM(Pulmonary Medicine) qualification for 02 seats at VP Chest Institute of Medical Sciences, Delhi granted by University of Delhi, Delhi.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (July, 2014) and compliance dated 27/04/2015 submitted by the college authorities and decided to recommend not to recognize DM(Pulmonary Medicine) qualification for 02 seats granted by University of Delhi, Delhi in respect of students being trained at VP Chest Institute of Medical Sciences, Delhi because of the following facts:-

Compliance is not satisfactory. Deficiencies stay as such i.e.

1. Deficiency of Endobronchial ultrasound still remains. Institute has stated it will be procured once MCI permission is given cannot be accepted.
2. Deficiency of Thoracic Surgeon still remains.
3. Appointment of Dr. Ashok Kumar Shah as examiner is not as per Regulations.
4. Dr. S.N. Gaur, who is Head of this Unit, is MD, Ph.D. in Medicine and not eligible, since, he has no DM Degree.
5. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**4. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(Pathology) qualification 02 seats in respect of students being trained at Belgaum Institute of Medical Sciences, Belgaum.**

Read: the Council Assessor's Report (May, 2014) and compliance dated 13/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification 02 seats at Belgaum Institute of Medical Sciences, Belgaum granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and compliance dated 13/04/2015 submitted by the college authorities and decided to recommend not to recognize MD(Pathology) qualification 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Belgaum Institute of Medical Sciences, Belgaum because of the following facts:-

All deficiencies stay as such i.e.

1. There is no Pentahead microscope. Equipment is inadequate.
2. Deficiency of faculty for PG: (a) Asso. Prof.: 1; (b) Asst. Prof.: 1.

3. Average daily Histopathological workload is 4.88 which is inadequate.
4. Annual specimens processed for Pathology has decreased from 2, 161 in 2011 to 1, 784 in 2013.
5. Annual specimens processed for Cytology has decreased from 1, 484 in 2011 to 1, 037 in 2013.
6. Frozen section is not available. Immunohistochemistry is not available.
7. L.E. cell examination is not performed.
8. Other deficiencies pointed out in the assessment report.

College authorities in the compliance have said that the faculty deficiencies have been rectified but no details of persons appointed or their appointment letters and Declaration Forms have been attached.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

5. **Kerala University of Health Sciences, Thrissur - Recognition of MD(Pathology) qualification for 01 seat in respect of students being trained at Jubilee Mission Medical College & Research Institute, Kerala.**

Read: the Council Assessor's Report (December, 2014) and compliance dated 24/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification for 01 seat at Jubilee Mission Medical College & Research Institute, Kerala granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (December, 2014) and compliance dated 24/04/2015 submitted by the college authorities and decided that the Institute be asked to submit compliance when Cryostat is installed and functional.

6. **Kerala University of Health Sciences - Recognition of MS(General Surgery) qualification against increased intake from 20 to 24 seats in respect of students being trained at Government Medical College, Thiruvananthapuram.**

Read: the Council Assessor's Report (December, 2013) and compliance dated 19/12/2014 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(General Surgery) qualification against increased intake from 20 to 24 seats at Government Medical College, Thiruvananthapuram granted by Kerala University of Health Sciences.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (December, 2013) and compliance dated 19/12/2014 submitted by the college authorities and decided to verify compliance by way of Assessment.

7. **Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of DM(Cardiology) qualification against increased intake from 10 to 21 seats in respect of students being trained at Sri Jayadeva Institute of Cardiology, Bangalore.**

Read: the Council Assessor's Report (August, 2013) and compliance dated 10/04/2015 submitted by the college authorities on the standard of examination and

other teaching facilities for Recognition of DM(Cardiology) qualification against increased intake from 10 to 21 seats at Sri Jayadeva Institute of Cardiology, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (August, 2013) and compliance dated 10/04/2015 submitted by the college authorities and decided to recommend to the Central Government that DM(Cardiology) qualification against increased intake from 10 to 21 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Sri Jayadeva Institute of Cardiology, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**8. Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MD(Radio-Diagnosis) qualification for 02 seats in respect of students being trained at Santhiram Medical College, Nandyal.**

Read: the Council Assessor's Report (May, 2014) and compliance dated 16/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radio-Diagnosis) qualification for 02 seats at Santhiram Medical College, Nandyal granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and compliance dated 16/04/2015 submitted by the college authorities and decided to recommend to the Central Government that MD(Radio-Diagnosis) qualification for 02 seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at Santhiram Medical College, Nandyal be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**9. Chhatrapati Shahuji Maharaj Medical University, Lucknow - Recognition of MD(Radio-Diagnosis) qualification for 02 seats in respect of students being trained at Command Hospital, Lucknow.**

Read: the Council Assessor's Report (May, 2014) and compliance dated 07/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radio-Diagnosis) qualification for 02 seats at Command Hospital, Lucknow granted by Chhatrapati Shahuji Maharaj Medical University, Lucknow.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and compliance dated 07/05/2015 submitted by the college authorities and decided to recommend not to recognize MD(Radio-Diagnosis) qualification for 02 seats granted by Chhatrapati Shahuji Maharaj Medical University,

Lucknow in respect of students being trained at Command Hospital, Lucknow because of the following facts:-

1. Following Faculty Members mentioned in the compliance were not present in the department at the time of Assessment:
  - a. Dr. R.K.P. Sharma, Assoc. Professor.
  - b. Dr. Akhilesh Rao, Asst. Professor.
  - c. Dr. Ashok Kumar, Senior Resident
  - d. Dr. P. Aravind, Senior Resident
  - e. Dr. Shweta, Senior Resident
  - f. Dr. Pokharia was Junior Resident at the time of Assessment.

Out of the Faculty members present at the time of Assessment, only Dr. Saxena, Professor and Dr. Pimpalwar are present now, which mean all others have been transferred. If there are some students admitted against Dr. Rastogi and their thesis work is midway, how the thesis work of those students will be supervised by Dr. Rastogi. Similar have been the observations in other departments as well.

2. Dr. P. Aravind, Senior Resident and Dr. Shweta, Senior Resident are having only MBBS qualification without any 3 years teaching experience in the department of Radio-Diagnosis. Hence, they are not eligible to be appointed as Senior Resident. Consequently, there is a deficiency of 2 Senior Resident.
3. As per the certificate attached with the Compliance, Dr. Pimpalwar has never been Graded Specialist against the requirement of 3 years. Hence, his promotion is not as per Regulations.

Earlier decision dated 31/07/2014 is reiterated.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**10. Dr. N.T.R. University of Health Sciences, Vijaywada - Recognition of M.Ch.(Cardio Thoracic Surgery) qualification for 01 seat in respect of students being trained at N.R.I. Medical College and Hospital, Guntur.**

Read: the Council Assessor's Report (July, 2014) and compliance dated 27/03/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(Cardio Thoracic Surgery) qualification for 01 seat at N.R.I. Medical College and Hospital, Guntur granted by Dr. N.T.R. University of Health Sciences, Vijaywada.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (July, 2014) and compliance dated 27/03/2015 submitted by the college authorities and decided to recommend not to recognize M.Ch.(Cardio Thoracic Surgery) qualification for 01 seat granted by Dr. N.T.R. University of Health Sciences, Vijaywada in respect of students being trained at N.R.I. Medical College and Hospital, Guntur because of the following facts:-

Deficiencies at point no. 1 & 2 stay as such i.e.

1. Promotion of Dr. N. Vijaya Kumar, Professor & HOD is not as per Regulations as he has been promoted to the post of Professor without any experience as Asso. Prof.
2. There are no publications from the department in indexed journals in last 3 years.
3. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**11. Dr. NTR University of Health Sciences, Vijayawada, A.P. - Recognition of MD(Anaesthesiology) qualification against increased intake from 02 to 05 seats in respect of students being trained at Siddhartha Medical College, Vijaywada.**

Read: the Council Assessor's Report (November, 2014) and compliance dated 17/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification against increased intake from 02 to 05 seats at Siddhartha Medical College, Vijaywada granted by Dr. NTR University of Health Sciences, Vijayawada, A.P..

The Postgraduate Medical Education Committee considered the Council Assessor's Report (November, 2014) and compliance dated 17/04/2015 submitted by the college authorities and decided to recommend not to recognize MD(Anaesthesiology) qualification against increased intake from 02 to 05 seats granted by Dr. NTR University of Health Sciences, Vijayawada, A.P. in respect of students being trained at Siddhartha Medical College, Vijaywada because of the following facts:-

1. Deficiency of Blood component facility still remain. MOU with outside agency is not acceptable.
2. Average Major Operations of randomly selected 3 days is only 12 & Minor operations is only 5, which is inadequate.
3. There are no publications from the department in Indexed Journals in preceding 3 years.
4. Academic parameters like Journal Club (Only 6), Case Presentation (Only 3), Group Discussion (only 3) are inadequate.
5. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**12. Guru Nanak Dev University - Recognition of MD(Sports Medicine) qualification for 01 seat in respect of students being trained at Guru Nanak Dev University, Amritsar.**

Read: the Council Assessor's Report (October, 2014) and compliance dated 31/03/2015 submitted by the college authorities on the standard of examination and

other teaching facilities for Recognition of MD(Sports Medicine) qualification for 01 seat at Guru Nanak Dev University, Amritsar granted by Guru Nanak Dev University.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (October, 2014) and compliance dated 31/03/2015 submitted by the college authorities and decided to recommend not to recognize MD(Sports Medicine) qualification for 01 seat granted by Guru Nanak Dev University in respect of students being trained at Guru Nanak Dev University, Amritsar because of the following facts:-

1. Designated Professor Dr. J.S. Sindhu is away on deputation to Govt. of India; resultantly the department is headed by Dr. Shweta Shenoy, Asso. Prof., which is not as per the Regulations.
2. There are no Senior Residents.
3. Both Asso. Prof. are non-medical teachers having Ph.D. qualification; resultantly there is no medical teacher in the department.
4. One of the hospital with, which attachment is claimed is Fortis Escorts Hospital, Amritsar, which is a non-teaching hospital.
5. All 3 External Examiners were from the same state, which is not as per Regulations and cannot be accepted.
6. Other deficiencies as pointed out in the Assessment Report.

The department does not fulfill any of requirements.

In view of the above, the Postgraduate Medical Education Committee is of the considered opinion that the failure on the part of your Institution to timely rectify the deficiencies show that the standard of Postgraduate Medical Education is not maintained in your Institute and therefore decided to recommend to the Central Government to stop admissions in MD (Sports Medicine) course with immediate effect.

**13. Maharashtra University of Health Sciences, Nashik - Recognition of M.Ch.(Urology) qualification against increased intake from 02 to 03 seats in respect of students being trained at Topiwala National Medical College, Mumbai.**

Read: the Council Assessor's Report (August, 2014) and compliance dated 30/03/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(Urology) qualification against increased intake from 02 to 03 seats at Topiwala National Medical College, Mumbai granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (August, 2014) and compliance dated 30/03/2015 submitted by the college authorities and decided to recommend not to recognize M.Ch.(Urology) qualification against increased intake from 02 to 03 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Topiwala National Medical College, Mumbai because of the following facts:-

Compliance not satisfactory.

1. The deficiency of Research Lab stay as such.
2. Examination was not inspected by the Assessor. The College Authorities should have taken him to the Examination Centre, if it was being conducted at some other Centre.
3. There is no Senior Resident and deficiency of Senior Resident stay as such.
4. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**Note:** The Assessor may be asked that why he did not visit the examination Centre and gave his comments about standard of examinations.

**14. Padamshree Dr. D.Y. Patil University, Navi Mumbai - Recognition of M.Ch.(Paediatrics Surgery) in respect of students being trained at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai.**

Read: the Council Assessor's Report (July, 2013) and compliance dated 27/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(Paediatrics Surgery) at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padamshree Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (July, 2013) and compliance dated 27/04/2015 submitted by the college authorities and decided to recommend not to recognize M.Ch.(Paediatrics Surgery) granted by Padamshree Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padamshree Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

All deficiencies stay as such i.e.

1. Seats were permitted in 2008. The College Authorities have said that first admission was made in 2010. Whether the candidates were not available or the College was not prepared for admission in 2008 may be clarified.
2. There are no publications. The College Authorities have said that publications are in the process of preparation. The 2 Publications cited are only case reports, which cannot be accepted.
3. SMO is not inter-changeable with Senior Resident and deficiency of Senior Resident stay as such.
4. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course (but not later than 6 weeks).

**15. Maharashtra University of Health Sciences, Nashik - Recognition of MD(Pharmacology) qualification for 02 seats in respect of students being trained at Dr. Panjabrao Alias Bhausaheb Deshmukh Memorial Medical College, Amravati.**

Read: the Council Assessor's Report (December, 2014) and compliance dated 20/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pharmacology) qualification for 02 seats



at Dr. Panjabrao Alias Bhausahab Deshmukh Memorial Medical College, Amravati granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (December, 2014) and compliance dated 20/04/2015 submitted by the college authorities and decided that the Institute be asked to resubmit compliance when deficiency of one Asst. Professor (for which process of appointment is initiated) is rectified.

**16. Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of DCH qualification for 01 seats in respect of students being trained at S. Nijalingappa Medical College & HSK Hospital & Research Centre, Bagalkot.**

Read: the Council Assessor's Report (May, 2013) and compliance dated 27/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of DCH qualification for 01 seats at S. Nijalingappa Medical College & HSK Hospital & Research Centre, Bagalkot granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2013) and compliance dated 27/04/2015 submitted by the college authorities and decided to recommend to the Central Government that DCH qualification for 01 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at S. Nijalingappa Medical College & HSK Hospital & Research Centre, Bagalkot be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**17. Sri Balaji Vidyapeeth University, Puducherry - Recognition of MD(Respiratory Medicine) against increased intake from 01 to 02 seats in respect of students being trained at Mahatma Gandhi Medical College & Research Institute, Pondicherry.**

Read: the Council Assessor's Report (April, 2014) and compliance dated 18/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Respiratory Medicine) against increased intake from 01 to 02 seats at Mahatma Gandhi Medical College & Research Institute, Pondicherry granted by Sri Balaji Vidyapeeth University, Puducherry.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2014) and compliance dated 18/04/2015 submitted by the college authorities and decided to verify compliance by way of Assessment.

**18. Chhatrapati Shahuji Maharaj Medical University, Lucknow - Recognition of MD(Pathology) qualification for 01 seats in respect of students being trained at Command Hospital, Lucknow.**

Read: the Council Assessor's Report (May, 2014) and compliance dated 07/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification for 01 seats at

Professor and their thesis work is midway, how the thesis work of those students will be supervised by Dr. Sunita B.S., Professor & HoD at that time and Dr. Majid Khan, Assoc. Professor. Similar have been the observations in other departments as well.

2. Dr. P. Sen Gupta has been Assoc. Professor for 3 years against the requirement of 4 years and hence, his promotion is not as per Regulations. His publications cited are all Case Reports and he is third Author in some of them. Hence, they cannot be accepted.
3. Dr. A. Agarwal, Tutor is MD (Microbiology), Dr. Nandita Hajra is MD (Microbiology), Dr. Rakhi Negi is MD (Biochemistry) and Dr. Mukul Bajpai is MD (Microbiology). Hence, they are not eligible to be appointed as Tutor in Pathology.
4. Other deficiencies as pointed out in the Assessment Report.

Earlier decision is reiterated.

Malhotra, Assoc. Professor and their thesis work is midway, how the thesis work of those students will be supervised by Dr. M. Malhotra, Assoc. Professor. Similar have been the observations in other departments as well.
2. Dr. Ashok Kumar and Dr. Lakshmi Kant are with MBBS qualification without any teaching experience in Anaesthesia. Hence, they are not eligible to be appointed as Senior Resident. Consequently, there is a deficiency of 2 Senior Residents.
3. Faculty deficiency: Asst. Professor-1; Senior Residents-2.
4. Other deficiencies as pointed out in the Assessment Report.

3. Dr. Anju Nag and Dr. Rahmani S. Khan have no 3 years teaching experience in OBG. Hence, they cannot be accepted as Senior Residents. Consequently, there is a deficiency of 3 Senior Residents.
4. Other deficiencies as pointed out in the Assessment Report.

3. Bed Occupancy 60% only.

4. Daily OPD given is 72 per day but calculated from 3 years data it is 5 per day.
5. Other deficiencies as pointed out in the Assessment Report.

3. OPD attendance was only 30 on day of assessment. Average daily OPD is 48 which is inadequate.
4. Bed occupancy was 60 % on day of assessment. Average is 62 % which is inadequate.
5. There was NIL BERA Audiometry & Impedance Audiometry on day of assessment. Workload of BERA Audiometry in last 3 years is NIL.
6. Rhinology related special clinic is not run.
7. Diagnostic Endoscopy equipment is not available.
8. BERA is not available.
9. The department does not participate in National Programme for Control of Deafness.
10. Other deficiencies as pointed out in the Assessment Report.

2. Other deficiencies as pointed out in the Assessment Report.

If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. 2. Other deficiencies as pointed out in the Assessment Report.

If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. The Postgraduate Medical Education Committee considered the Council Assessor's Report (27-28.05.2014) and compliance dated 27/04/2015 submitted by the college authorities and decided to recommend not to recognize MD(General Medicine) qualification for 4 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at ESI-PGIMSR, ESI-Hospital, Rajajinnagar, Bangalore because of the following facts:-

All the deficiencies stay as such i.e.

1. Dialysis facilities – both peritoneal & haemo – are not available.
2. Number of deaths are very less – 9 deaths in 3 months & 108 deaths in last 3 years as serious cases are referred to other centers. It will certainly affect critical care training of students.
3. Declaration Forms of faculty & Residents are incomplete as detailed in the assessment report.
4. Unit 1 does not have Asso. Prof.; hence faculty complement is incomplete. It has only 2 faculty hence it cannot be considered as PG Unit.
5. Unit 3 has only 1 faculty; hence it cannot be considered as a teaching Unit at all.
6. Teaching facilities are inadequate in OPD.
7. Investigative facilities like nerve conduction, EMG are not available.
8. Other deficiencies pointed out in the assessment report.

Seats were permitted in 2010, which have not been recognized.

In view of the above, the Postgraduate Medical Education Committee is of the considered opinion that the failure on the part of your Institution to timely rectify the deficiencies show that the standard of Postgraduate medical education is not maintained in your Institute and therefore, you are called upon to submit the reply as to why directions for stoppage of admissions in Postgraduate Courses MD (General Medicine) be not issued from academic year 2015-2016.

1. There is no Professor.
2. Deficiency of faculty is: (a) Professor: 1; (b) Asso. Prof.: 1; (c) Asst. Prof.: 2; (d) Tutor: 3.
3. Examination was conducted with no examiner from the institute.
4. Other deficiencies pointed out in the assessment report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

Read: the matter with regard to recognition of MS (Anatomy) qualification under Karnataka University, Dharwad from 1968 to 1994 in respect of Karnataka Medical College, Hubli along with the letter dated 16/03/2015 received from the Ministry of Health & Family Welfare, New Delhi.

The Postgraduate Medical Education Committee considered the matter with regard to recognition of MS (Anatomy) qualification under Karnataka University, Dharwad from 1968 to 1994 in respect of Karnataka Medical College, Hubli along with the letter dated 16/03/2015 received from the Ministry of Health & Family Welfare, New Delhi and noted that the College was affiliated to the Karnataka University, Dharwad from 1968 to 1994 and the University never applied for recognition of MS (Anatomy). Now the College is with Rajiv Gandhi University of Health Sciences from 1996. For recognition of MS (Anatomy) for the period 1968 to 1994, request should have come from Karnataka University, Dharwad and not Rajiv Gandhi University of Health Sciences. Rajiv Gandhi University has taken fresh permission under section 10A of the IMC Act, 1956 to start MD (Anatomy) afresh from the year 2013. The present request cannot be accepted.

1. The College authorities have intimated in the compliance that there are 11 publications from the department of ophthalmology during the last 3 years. On perusal of the same, the Committee noted that 6 of the above articles (mostly Case Reports) are from P.E.S. Institute of Medical Sciences, Kuppam with which, this Institution has no concern. 2 of the Articles are purely Anatomical studies, which are in no way related to the subject of Ophthalmology. Hence, cannot be counted. This amounts to giving false information. Consequently, deficiencies of publications stay as such.
2. The earlier deficiencies stay as such.
3. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

Consequently, his promotion is not as per Regulations. He has not been Asst. Professor and he was Assoc. Professor for 3 years 6 months against the requirement of 4 years.
2. Other deficiencies as pointed out in the Assessment Report.

Read: the Council Assessor's Report (April, 2012 and April, 2014) and compliance dated 04/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Community Medicine) qualification for 04 seats at Mahatama Gandhi Medical College & Research Institute, Pondicherry granted by Sri Balaji Vidyapeeth University, Puducherry.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2012 and April, 2014) and compliance dated 04/05/2015 submitted by the College authorities and decided to recommend not to recognize MD(Community Medicine) qualification for 04 seats granted by Sri Balaji Vidyapeeth University, Puducherry in respect of students being trained at Mahatama Gandhi Medical College & Research Institute, Pondicherry because of the following facts:-

1. Only those Degrees of JIPMER, which were recognized under Madras University stand automatically recognized by the Pondicherry University. However, MD (Community Medicine) of students passing from JIPMER (when it was affiliated to Madras University) is not recognized. Hence, P.G. Degree of Dr. K.R. Narayan, Professor & HoD, who passed from Madras University is not recognized.
2. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**110. Maharashtra University of Health Sciences, Nashik - Recognition of MD(DVL) qualification against increased intake from 3 to 4 seats in respect of students being trained at Armed Forces Medical College, Pune.**

Read: the Council Assessor's Report (May, 2014) and compliance dated 11/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(DVL) qualification against increased intake from 3 to 4 seats at Armed Forces Medical College, Pune granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and compliance dated 11/05/2015 submitted by the College authorities and decided that the College Authorities be asked to give posting profile (place of posting and designation as Graded Specialist, Classified Specialist and Advisor) signed by competent authority from the office of Director General, Armed Forces only. The Item is deferred till then.

**111. MGM Institute of Health Sciences, Navi Mumbai - Renewal of Recognition of MD/MS(OBG) qualification against increased intake from 2 to 6 seats in respect of students being trained at MGM Mission's Medical College, Navi Mumbai.**

Read: the Council Assessor's Report (April, 2014) and compliance dated 04/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of Recognition of MD/MS(OBG) qualification against increased intake from 2 to 6 seats at MGM Mission's Medical College, Navi Mumbai granted by MGM Institute of Health Sciences, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2014) and compliance dated 04/05/2015 submitted by the college authorities and decided to verify compliance by way of Assessment.

**112. Deemed University, UP - Recognition of DM (Cardiology) qualification against increased intake from 2 to 8 seats in respect of students being trained at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow.**

Read: the Council Assessor's Report (June, 2014) and compliance dated 14/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of DM (Cardiology) qualification against increased intake from 2 to 8 seats at Sanjay Gandhi Postgraduate Institute of Medical Sciences, Lucknow granted by Deemed University, UP.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2014) and compliance dated 14/05/2015 submitted by the college authorities and decided that the college authorities be asked to supply following information:

1. Seats were increased from 2 to 4 in 2007. However, their recognition assessment, which was due in 2010 was not done and admission was

continued contrary to Regulations i.e. *"The permission for starting/ increase of seats and admission of students will be till such time the first batch of students admitted against the permitted seats appears for the first final examination in the subject. Failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

2. The application dated 10/03/2010 (requesting for recognition inspection) submitted by the College Authorities was not forwarded by the Central Government to MCI and hence, could not be considered and intimation to this effect was given to the Institution on 07/04/2010.
3. In the present assessment (2014) only 6 students appeared, whereas, the college authorities in the compliance have demanded recognition for 8 seats. Seats were increased from 4 to 8 in 2010, then why only 6 students appeared? Whether 2 seats were vacant or 2 students did not appear.

**113. Rajasthan University of Health Sciences, Jaipur - Recognition of DIHBT qualification in respect of students being trained at SMS Medical College, Jaipur.**

Read: the Council Assessor's Report (July, 2014) and compliance dated 29/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of DIHBT qualification at SMS Medical College, Jaipur granted by Rajasthan University of Health Sciences, Jaipur.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (July, 2014) and compliance dated 29/05/2015 submitted by the college authorities and decided that the college authorities be requested to provide information regarding:

1. Number of seats permitted in 1988 for which recognition has been sought. A copy of the letter of permission from the Central Government specifying the number of seats be supplied. Number of admissions since, 1988 (Year-wise) be provided.
2. A perusal of the entire long correspondence quoted by the Dean, show that Rajasthan University never applied for recognition of these seats. It is only for the first and last time that Rajasthan University of Health Sciences applied for recognition of these seats on 29/08/2012. It was for the College Authorities to take up the matter with Rajasthan University authorities to apply for recognition of these seats, well in time. Now on the request of Rajasthan University of Health Sciences it cannot be recognized when affiliation was with Rajasthan University.

**114. Vinayaka Mission's University, Salem - Renewal of Recognition of MD(Paediatrics) qualification for 2(Two) seats & recognition against increased intake from 02 (Two) to 03 (Three) seats in respect of students being trained at Vinayaka Mission's Medical College & Hospital, Karaikal, Puducherry.**

Read: the Council Assessor's Report (April, 2014) and compliance dated 30/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of Recognition of MD(Paediatrics) qualification for 2(Two) seats & recognition against increased intake from 02 (Two) to 03 (Three) seats at Vinayaka Mission's Medical College & Hospital, Karaikal, Puducherry granted by Vinayaka Mission's University, Salem.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2014) and compliance dated 30/04/2015 submitted by the college authorities and decided to verify compliance by way of Assessment.

**115. Maharashtra University of Health Sciences, Nashik - Recognition of M.Ch.(Plastic Surgery) qualification against increased intake from 2 to 4 seats in respect of students being trained at Topiwala National Medical College, Mumbai.**

Read: the Council Assessor's Report (August, 2014) and compliance dated 14/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(Plastic Surgery) qualification against increased intake from 2 to 4 seats at Topiwala National Medical College, Mumbai granted by Maharashtra University of Health Sciences, Nashik.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (August, 2014) and compliance dated 14/05/2015 submitted by the college authorities and decided to verify the compliance by way of Assessment at the time of next examination.

**116. Sambalpur University - Recognition of MD(Radio-Diagnosis) qualification against increased intake from 2 to 3 seats in respect of students being trained at V.S.S. Medical College, Burla, Sambalpur.**

Read: the Council Assessor's Report (June, 2014) and compliance dated 15/04/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Radio-Diagnosis) qualification against increased intake from 2 to 3 seats at V.S.S. Medical College, Burla, Sambalpur granted by Sambalpur University.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (June, 2014) and compliance dated 15/04/2015 submitted by the College authorities and decided to recommend not to recognize MD(Radio-Diagnosis) qualification against increased intake from 2 to 3 seats granted by Sambalpur University in respect of students being trained at V.S.S. Medical College, Burla, Sambalpur because of the following facts:-

All deficiencies stay as such i.e.

1. Deficiency of faculty: (a) Asst. Prof.: 1.
2. Shortage of Senior Residents: 6.
3. Only 4 static X-ray machines are functional against requirement of 6 as per Regulations.
4. AERB approval is not available for all the machines.
5. Other deficiencies as pointed out in the Assessment Report.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**117. MGM Institute of Health Sciences, Navi Mumbai - Renewal of Recognition of DGO qualification for 2 seats in respect of students being trained at MGM Mission's Medical College, Navi Mumbai.**

Read: the Council Assessor's Report (April, 2013) and compliance dated 04/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of Recognition of DGO qualification for 2 seats at



MGM Mission's Medical College, Navi Mumbai granted by MGM Institute of Health Sciences, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (April, 2013) and compliance dated 04/05/2015 submitted by the college authorities and decided to verify compliance by way of Assessment.

**118. The Tamil Nadu Dr. M.G.R. Medical College University, Chennai - Recognition of MD(Anaesthesiology) qualification against increased intake from 02 to 04 seats in respect of students being trained at K.A.P. Viswanathan Govt. Medical College, Tiruchirapalli.**

Read: the Compliance Verification Assessment Report (09.03.2015) along with Council Assessor's Report (April, 2014) and compliance dated 29/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification against increased intake from 02 to 04 seats at K.A.P. Viswanathan Govt. Medical College, Tiruchirapalli granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (09.03.2015) along with Council Assessor's Report (April, 2014) and compliance dated 29/05/2015 submitted by the college authorities and decided to verify compliance by way of Assessment.

**119. MGM Institute of Health Sciences, Navi Mumbai - Recognition of MD(Pathology) qualification against increased intake from 02 to 06 seats in respect of students being trained at MGM Mission's Medical College, Navi Mumbai.**

Read: the Compliance Verification Assessment Report (16.03.2015) along with Council Assessor's Report (April, 2014) and compliance dated 04/05/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Pathology) qualification against increased intake from 02 to 06 seats at MGM Mission's Medical College, Navi Mumbai granted by MGM Institute of Health Sciences, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (16.03.2015) along with Council Assessor's Report (April, 2014) and compliance dated 04/05/2015 submitted by the College authorities and decided to recommend not to recognize MD(Pathology) qualification against increased intake from 02 to 06 seats granted by MGM Institute of Health Sciences, Navi Mumbai in respect of students being trained at MGM Mission's Medical College, Navi Mumbai because of the following facts:-

All deficiencies stay as such i.e.

1. Number of special investigations are still less:
  - (a) Total Leukemias: 19 / year;
  - (b) Facility for Tumour / Leukemia for Cytogenic analysis is not available.
  - (c) Frozen section investigations: 4 to 5 / month.
2. Flow cytometer is not available.
3. Electrophoresis machine is available; but number of investigations is only 103 / year.
4. Pathological post-mortems are not performed.
5. Other deficiencies as pointed out in the Assessment Report.

MOU with other institutions for these investigations cannot be accepted.

In case, the College Authorities desire to submit compliance, the same should be received in this office within 6 weeks. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the Postgraduate Course against the above mentioned seats. As per provisions of section 11(2) of the IMC Act, 1956 (and stipulated in LoP) failure to seek timely recognition/ renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**120. Consideration of applications for starting of/ Increase of seats/ Recognition of/ Renewal of Recognition of Postgraduate Courses – Clarifications regarding.**

Read: the matter with regard to clarifications required for consideration of applications for starting of/ increase of seats/ recognition of/ renewal of recognition of Postgraduate courses.

The Postgraduate Medical Education Committee considered the matter with regard to clarifications required for consideration of applications for starting of/ increase of seats/ recognition of/ renewal of recognition of Postgraduate courses and decided to defer the matter.
